Notes to Financial Statements

Note 1: Description of Plan

The following description of the Avvale, Inc. 401(k) Profit Sharing Plan (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of Avvale, Inc. (the "Company") who are 21 years of age or older and have completed three consecutive months of service, provided the employee is not a union employee, a nonresident alien, a leased employee, or a resident of Puerto Rico. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Contributions

Each year, participants may contribute up to 100% of their annual compensation on either a pretax or after tax (Roth) basis, as defined in the Plan, up to the maximum allowed by the Internal Revenue Code (IRC). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollovers). Participants direct the investment of their contributions into various investment options offered by the Plan under a group annuity contract (GAC).

The Company provides for a safe harbor matching contribution, which is equal to 100% of the participant's deferral contribution, not to exceed 3% of the employee's eligible compensation, plus 50 percent of the participant's contribution between 3 percent and 5 percent of the employee's eligible compensation. Total safe harbor matching contributions were \$373,596 for the year ended December 31, 2024.

Additionally, the Plan provides for a discretionary matching contribution as determined by the Company. The Plan also provides for a discretionary profit-sharing contribution as determined by the Company to be allocated in the same ratio as each participant's eligible compensation bears to the total eligible compensation for all participants. To be eligible for the discretionary profit-sharing contribution, a participant must be employed on the last day of the plan year and have completed 1,000 hours of service during the plan year, as defined by the Plan. The Company did not make any additional discretionary matching contributions or discretionary profit sharing contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's voluntary contributions, the Company's safe harbor matching contributions, the Company's discretionary match contribution, if any, and allocations of (a) the Company's discretionary profit sharing contribution, if any, and (b) Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings (losses), account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Note 1: Description of Plan (Continued)

Vesting

Participants are immediately vested in their contributions as well as the Company's safe harbor matching contributions plus actual earnings (losses) thereon. Vesting in the Company's discretionary match and profit sharing contribution portion of their accounts plus actual earnings (losses) thereon is based on years of service. Participants vest at a rate of 25% per year beginning with the first year of service and become fully vested after four years of service. Participants are immediately fully vested upon normal retirement (age 65), death, or total and permanent disability.

Notes Receivable From Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of the participant's vested account balance. The notes are secured by the balance in the participant's account and bear interest at the prime rate plus 1.00%, which is commensurate with local prevailing rates as determined by the Plan administrator. Interest rates on notes outstanding at December 31, 2024 ranged from 8.00% to 9.50%. The term of the note cannot exceed five years, unless the note is used to acquire a principal residence. Participants may not have more than one outstanding loan at any given time. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

On termination of service due to death, disability, retirement, or for any other reason, a participant may elect to receive an amount equal to the vested interest in his or her account as a lump-sum distribution, a partial withdrawal or substantially equal installments. In addition, hardship distributions out of the participant's vested account balance are permitted if certain criteria are met. The Plan also allows for in-service distributions upon a participant attaining age 59 1/2.

Forfeitures

Forfeited nonvested account balances may be used to pay administrative expenses of the Plan or reduce future Company contributions. Forfeitures may also, at the discretion of the Company, be reallocated to participants as though they are additional Company contributions. Forfeited nonvested account balances at December 31, 2024 and 2023 amounted to \$0 and \$9,430, respectively. Forfeitures in the amount of \$9,766 were used to reduce Company contributions during the year ended December 31, 2024.

SECURE 2.0 Act

In December 2022, Securing a Strong Retirement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management has evaluated those provisions and determined there is no material impact on the Plan for the years ended December 31, 2024 and 2023. Plan management will evaluate and determine which optional provisions, if any, to elect in the future.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in conformity with GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant notes receivable are recorded as benefit payments on the basis of the terms of the Plan document.

Investment Valuation and Income Recognition

The Plan's investments are reported at fair value except for the group annuity contract which is a fully benefit-responsive investment contract (FBRIC). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

FBRICs are reported at contract value, which is the amount participants would normally receive if they were to initiate permitted transactions under the terms of the Plan.

Payment of Benefits

Benefit payments are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are allocated proportionately to Plan participants based on their respective account balances and are included in net appreciation in fair value of investments.

Subsequent Events

The Plan has evaluated subsequent events through October 7, 2025, which is the date the financial statements were available to be issued.

The Plan's management has decided to change its service provider from Ameritas Life Insurance Corp. (Ameritas), the Custodian of the Plan, to Principal Trust Company, as anticipated to be effective as of January 1, 2026.

Note 3: Fair Value Measurements

GAAP establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consists of unadjusted quoted prices in active markets for identical assets and have the highest priority level. Level 2 inputs consist of observable inputs other than quoted prices for identical assets (Level 1). Level 3 inputs are unobservable and have the lowest priority. The Plan uses appropriate valuation techniques based on the available inputs to measure the fair value of its investments. When available, the Plan measures fair value using Level 1 inputs because they generally provide the most reliable evidence of fair value. Level 2 inputs are used for investments for which Level 1 inputs were not available. Level 3 inputs would only be used if Level 1 or Level 2 inputs were not available. There are no Plan assets requiring the use of Level 2 or Level 3 inputs for the periods presented.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual funds held in pooled separate accounts: Fair value is estimated using the net asset value (NAV) per unit of the issuer of the pooled separate accounts. Fair value is based on the fair value of the underlying investments held by the pooled separate accounts. The redemption frequency and redemption notice period is daily and there are no unfunded commitments.

Note 4: Contract with Insurance Company

The Plan has entered into a group annuity contract with Ameritas, which maintains these contributions in a "general account" referred to as the Guaranteed Investment Account. The account is credited with earnings on the underlying investments and charged for Plan participant withdrawals and administrative expenses by the Custodian. Ameritas is contractually obligated to repay the principal and a specified interest rate guaranteed to the Plan. The general account is included in the financial statements at contract value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses, because it is fully benefit-responsive. The general account is considered fairly valued at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer, but may not be less than 1.5%. The weighted average credit rates for the years ended December 31, 2024 and 2023 were 3.52% and 2.95%, respectively. Such interest rates are reviewed on a quarterly basis for resetting.

Certain events may limit the ability of the Plan to transact at contract value with Ameritas. The Plan administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring. There are no events that allow the issuer to terminate the contract and that require the Plan sponsor to settle an amount different than contract value paid either within 90 days or over time.

Note 5: Information Prepared and Certified by the Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation in fair value of investments, interest and dividends, and interest income on notes receivable from participants for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Ameritas, the Custodian of the Plan.

Note 6: Related Party and Party-In-Interest Transactions

Certain Plan investments are managed by the Custodian, as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. These transactions are not considered prohibited transactions under the ERISA regulations. Fees paid by the Plan to the Custodian for administrative expenses amounted to \$13,715 for the year ended December 31, 2024. In addition, certain administrative functions are performed by employees of the Company, for which no compensation is received from the Plan for their services.

Notes receivable from participants also qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules of ERISA.

Note 7: Tax Status

The Company has adopted a restated and amended Non-Standardized Pre-Approved Profit-Sharing/Money Purchase/CODA Plan ("Prototype Plan") sponsored by Ameritas Life Insurance Corp. The Prototype Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service (IRS) stated that the Prototype Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter; however, the Plan administrator believes the Plan is currently designed, and being operated, in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax. In addition, the Company has identified and corrected certain operational errors related to Company contributions for Plan participant missed deferral opportunities. The estimate for corrections related to these errors was \$14,525 and has been recorded as an other receivable on the statements of net assets available for benefits. No provision for income taxes has been included in the Plan's financial statements related to these operational errors as the Plan administrator believes the Plan continues to be qualified and the tax status of the related trust continues to be exempt. Subsequent to year end, during 2025, the Company remitted \$14,525 to the Plan to correct for the operational errors.

Note 8: Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their Company discretionary contributions. Any unallocated assets of the Plan would be allocated to participant accounts and distributed in such a manner as the Company may determine.

Note 9: Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.
