INDEPENDENT AUDITORS' REPORT

To the Trustees and Participants of the
Ohio Valley Flooring, Inc. Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Ohio Valley Flooring, Inc. Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the years then ended, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

Basis for Opinion

1. DESCRIPTION OF THE PLAN:

The Ohio Valley Flooring, Inc. Retirement Savings Plan (the "Plan") is a defined contribution plan which was formed effective January 1, 1989. The following brief description of the Plan is provided for general information purposes only. Participants should refer to the Plan Agreement for more complete information.

General

The Plan covers substantially all employees of Ohio Valley Flooring, Inc. (the Company or Employer), other than nonresident aliens and those employees covered by a collective bargaining agreement. Participation commences on the earlier of January 1 or July 1 of the plan year after which the employee has reached twenty and one-half years of age. Effective June 30, 2023, the Plan was amended to allow employees to participate beginning on the first day of the Plan quarter following their hire date, with no age or service requirements. However, effective January 1, 2025, the Plan was further amended to reinstate the age requirement. Employees must once again be at least 20½ years old to be eligible to participate.

Contributions

Participants may make contributions on a pre-tax basis each plan year subject to limitations determined by the Internal Revenue Code (IRC). Effective June 30, 2023, participant Roth contributions were permitted. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans.

Effective January 1, 2022, the Plan was amended to become a safe harbor plan under a Qualified Automatic Contribution Arrangement (QACA). The QACA provides automatic deferral provisions for newly eligible participants, as well as current participants who have not elected a salary reduction. Automatically enrolled participants have their initial deferral rate set at 3% of eligible compensation. Automatically enrolled participants' deferral percentages increase by 1% each Plan year subsequent to their enrollment up to a maximum of 6%. Automatically enrolled participants may affirmatively elect not to participate in the Plan or elect to enroll at a contribution percentage set by the participant.

Under the QACA, the Company contributes a safe harbor matching contribution of 100% of the first 1% of deferred wages, plus 50% of the next 5% of deferred wages. The Company may also contribute an additional discretionary amount to the Plan as determined annually by the Company's Board of Directors. The Company did not make an additional discretionary contribution in 2024 and 2023.

Participant accounts

Each participant's account is credited with the participant's elective contributions and the Company's related matching contributions and an allocation of (a) the Company's discretionary contribution, if any, (b) Plan earnings, and (c) forfeitures. Investment earnings are allocated to eligible participants based on their relative account balance. Discretionary contributions are allocated to eligible participants based on their relative compensation for the plan year. All other allocations are based on participant compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Notes receivable from participants

The Plan permits participants to borrow from their vested account. The maximum amount that may be borrowed is the lesser of \$50,000 or 50% of the vested balance of the account. Participants are permitted to carry two loans against their account at any given time. The loan interest rate is set at the prime rate, at the time of the loan, plus 1%. Loans are payable within five years except for those used to acquire a principal residence. Principal and interest are paid ratably through payroll deductions.

Payment of benefits

Participants are eligible for benefits at their retirement date. The normal retirement date is the first day of the month coinciding with or following the participant's 65th birthday. Early retirement may be elected after completing 10 years of service and reaching 55 years of age. Benefits are also payable upon death, permanent disability, or termination. There are various benefit payment options.

Advance distribution for hardship

Participants may withdraw from their fund accounts in any one plan year up to the lesser of 100% of the participant's elective and rollover accounts valued as of the last valuation date or the amount necessary to satisfy the immediate and heavy financial need of the participant.

Vesting

Accounts become fully vested upon termination of employment due to normal retirement, early retirement, death, or permanent disability. Vesting of the QACA safe harbor contributions and the tiered matching contributions at termination of employment for reasons other than above is as follows:

Non-vested amounts are forfeited at termination and may be allocated to eligible participants based on relative balances or used to pay Plan expenses. Participant contributions are always 100% vested.

Forfeited accounts

At December 31, 2024 and 2023, the balance of forfeited nonvested accounts totaled \$60,574, and \$120,213, respectively. These accounts will be used to reduce future Company contributions or to pay the Plan's administrative expenses. During 2024 and 2023, administrative expenses were reduced by \$33,705 and \$1,200 from forfeited nonvested accounts, respectively.

2. SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The accompanying financial statements have been presented on the accrual basis of accounting.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

Investment valuation and income recognition

Investments are reported at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year. Other income includes revenue sharing between the trustee and the Company.

Payment of benefits

Benefits paid to participants are recorded when amounts are distributed.

Administrative expenses

Certain costs of administering the Plan are paid for by the Company and are excluded from these statements. At times, administrative expenses are charged directly to participant accounts or paid by the Plan using forfeitures of nonvested accounts.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Subsequent events

The Company evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The Plan has evaluated subsequent events through September 30, 2025, the date the financial statements were available to be issued.

3. FULLY BENEFIT-RESPONSIVE INVESTMENT CONTRACT:

The Plan has a fully benefit-responsive traditional investment contract Empower Annuity Insurance Company of America (Formerly Massachusetts Mutual Life Insurance Company (MassMutual)) with a balance of \$4,647,276 and \$4,480,671 at December 31, 2024 and 2023, respectively. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. The crediting rate is reviewed on a quarterly basis for resetting. The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date. The contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Empower, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, or (4) a material amendment to the agreement without consent of the issuer.

4. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodology used for assets measured at fair value. There have been no changes in the methodology used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The following table sets forth by level, within the fair value hierarchy, the Plan's investments at fair value as of December 31, 2024 and 2023. Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement:

5. TAX STATUS:

The Company adopted a non-standardized pre-approved profit sharing plan with a cash or deferral arrangement which received a favorable opinion letter from the IRS dated November 14, 2022. The IRS stated in the letter that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has since been amended. While the Company has not obtained its own determination letter on the Plan, management believes that the Plan currently is designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

6. CERTIFIED FINANCIAL INFORMATION:

Plan management has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Empower Annuity Insurance Company of America and Empower Trust Company, LLC, qualifying institutions, have certified to the completeness and accuracy of all investments and participant notes receivable reflected on the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023, the supplemental schedule of assets (held at end of year) as of December 31, 2024, and the related investment activity and interest income from participant notes receivable reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

7. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

8. RELATED PARTY AND PARTY IN INTEREST TRANSACTIONS:

Certain Plan investments are managed by Empower Annuity Insurance Company of America and Empower Trust Company, LLC, which are the qualified institutions as defined by the Plan and therefore, qualify as parties-in-interest. Fees incurred by the plan for the investment management services are included in net appreciation in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. The Plan Sponsor pays directly any other fees related to the plan's operations.

9. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.
