Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matters - Supplemental Schedules Required by ERISA

The supplemental schedule of Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Their report dated October 3, 2024 indicated that (a) the amounts and disclosures in the 2023 financial statements, other than those agreed to or derived from the certified investment information, were presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America, and (b) the information in the 2023 financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C). Their report also indicated that the form and content of the 2023 supplemental schedule, other than the information in the 2023 supplemental schedule that agreed to or is derived from the certified investment information, was presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA; and the information in the 2023 supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determines meets the requirements of ERISA Section 103(a)(3)(C).

NOTE 1 – PLAN DESCRIPTION

The following is a brief description of the Core BTS 401(k) Retirement Plan (the “Plan”), which is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan’s provisions.

A. GENERAL

The Plan is a qualified defined contribution plan covering eligible employees of Core BTS, Inc. (the “Company”) and its related subsidiaries. The plan provides deferred compensation benefits and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). Fidelity is the Plan’s record-keeper. The Plan administrator is responsible for overseeing and ensuring compliance with the Plan document.

The Plan was restated effective April 15, 2022, and these changes are reflected in the following details of the Plan.

B. ELIGIBILITY

The Plan covers all eligible employees of the Company who have attained the age of 21. The Plan excludes those employees who are: (1) employees covered by a collective bargaining agreement (2) leased employees and (3) nonresident aliens. All employees are eligible for automatic enrollment in the Plan upon meeting eligibility requirements. For all who are eligible and choose to participate, the entry date is immediate upon meeting eligibility requirements.

C. CONTRIBUTIONS

Under the Plan, participants may contribute up to 100% of the participant’s eligible compensation, not to exceed the limits by the Internal Revenue Code (“IRC”). A participant shall be permitted to irrevocably designate a portion of their deferral contributions allowed under the Plan as a Roth deferred contribution. Participants are permitted to make direct rollover contributions to the Plan. The plan also permits participants to make catch-up contributions in accordance with Internal Revenue Service (“IRS”) regulations. The Plan includes an automatic enrollment feature and contribution arrangement. Participants always have the option to opt-out.

The Plan sponsor provides a discretionary matching contribution. During the year ended December 31, 2024, the match was equal to 50% of a participant’s contributions, up to 6% of the participant’s eligible deferred compensation. This matching formula was consistent with the prior year. The Plan sponsor may also make other discretionary contributions; however, no additional discretionary contributions were made during 2024.

Contributions from Plan participants and matching contributions from the employer are recorded in the year in which the employee contributions are withheld from compensation.

D. PARTICIPANT ACCOUNTS

Each participant’s self-directed account is credited with the participant’s contribution, Company discretionary matching and nonelective contributions, if any, and an allocation of Plan earnings (losses). Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participants’ compensation or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All loans must be repaid in level payments on at least a quarterly basis over a five-year period unless the loan is for the purchase of a principal residence in which case the loan may be repaid over a 10-year period. The loans are secured by the balance of the participant's vested account and bear interest at a rate commensurate with market rates ranging from 4.25% to 9.50%.

F. VESTING

Participants are immediately 100% vested in their deferrals, rollover contributions and Plan earnings thereon. All participants, except the active employees merged in from Aptera Software, Inc 401(k) plan on February 25, 2022, which are vested at 100%, are vested in the Company's matching contributions, if any, plus actual earnings as detailed below.

Upon reaching retirement age, death, or disability while employed, a participant becomes 100% vested.

G. PAYMENT OF BENEFITS

Participants or their beneficiaries can request a distribution if they sever employment, retire, become disabled, die, have a hardship or have attained age 59 ½. Participant account balances less than \$1,000 will be automatically distributed as a lump sum distribution. If the account balance exceeds \$1,000, then the distribution will be made as a lump sum or partial withdrawals or installments subject to minimum required distribution as per the IRC.

H. TERMINATION PRIORITIES

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contribution at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination or partial termination, each participant would become 100% vested in their account balance.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A. FINANCIAL REPORTING FRAMEWORK

The accompanying financial statements are prepared according to accounting principles generally accepted in the United States of America ("GAAP"), as promulgated by the Financial Accounting Standards Board ("FASB") in the Accounting Standards Codification ("ASC").

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES – (CONTINUED) –

B. BASIS OF ACCOUNTING

The accompanying financial statements of the Plan are prepared under the accrual method of accounting.

C. ESTIMATES

The preparation of financial statements in accordance with GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts and disclosures. Actual results may differ from these estimates.

D. VALUATION OF INVESTMENTS

The Plan's investments are stated at fair value (except for the fully benefit-responsive investment contract, which is stated at contract value, see Note 7). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 8 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year. Dividends are recorded on the ex-dividend date. Interest income is recorded on the accrual basis.

E. NOTES RECEIVABLE FROM PARTICIPANTS

Notes receivable from participants are valued at cost, which approximates fair value. Delinquent participant loans are reclassified as distributions based upon the repayment terms of the loan. No allowance for credit losses has been recorded as of December 31, 2024 and 2023.

F. ADMINISTRATIVE EXPENSES

Administrative expenses may be paid out of the Plan or by the Company. Administrative expenses that are to be paid from the Plan are first paid from forfeitures, if any, and any remaining amounts are paid from the Plan's trust funds and allocated to all participants on a pro rata basis.

G. PAYMENT OF BENEFITS

Benefit payments to participants or beneficiaries are recorded when paid.

H. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

I. SUBSEQUENT EVENTS

The Plan has evaluated subsequent events through October 3, 2025, which is the financial statement issuance date. All items which are required for disclosure have been included in the accompanying financials and notes thereto.

NOTE 3 – FORFEITED ACCOUNTS

Upon termination of employment, participants forfeit their non-vested balances. In accordance with Plan documents, forfeitures may be used to reduce future Company contributions or to pay administrative expenses of the Plan at the discretion of the Company. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$75,052 and \$3,802, respectively. The forfeited amounts that were used to reduce employer contributions during the year ended December 31, 2024, were \$336,571.

NOTE 4 – INFORMATION PREPARED AND CERTIFIED BY TRUSTEE

The Plan's investments are held in a trust fund administered by Fidelity Management Trust Company (the "Investment Custodian" of the Plan or "Trustee"). The following information included in the accompanying financial statements and supplemental schedule was obtained from data that has been prepared and certified to as complete and accurate by the Investment Custodians:

- Investments and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) and interest income on notes receivable from participants, as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, line 4i - schedule of assets (held at end of year) as of December 31, 2024.

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

NOTE 5 – TAX STATUS

The Plan obtained its latest determination letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype Plan, as designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has been amended since receiving the determination letter. The Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

NOTE 6 – PARTY-IN-INTEREST

Investments in a guaranteed return account and pooled separate accounts managed by Fidelity Management and Trust Company, the trustee of the Plan, are considered party-in-interest transactions. As of December 31, 2024 and 2023, such investments totaled \$83,910,809 and \$81,610,332. In addition, certain expenses are charged to the Plan by service providers for record-keeping, investment advisory and professional services. These transactions qualify as party-in-interest transactions. The Plan paid Fidelity Management and Trust Company \$34,887 in administrative fees for the year ended December 31, 2024. Notes receivable from participants also qualify as party-in-interest transactions, and were \$903,251 and \$902,440 as of December 31, 2024 and 2023, respectively.

NOTE 7 – INVESTMENTS IN A COMMON AND COLLECTIVE TRUST

The Plan invests in the Invesco Stable Asset Fund, a collective trust managed by Invesco Trust Company. The Fund seeks to preserve principal and provide interest income consistent with maintaining liquidity. The Fund invests exclusively in the Invesco Stable Value Trust, which primarily holds synthetic guaranteed investment contracts and short-term investment funds. Since these investments are fully benefit-responsive, contract value is the relevant measurement attribute. Contract value represents the amount of contributions deposited, plus interest credited, less participant withdrawals and administrative expenses. Units are maintained at \$1.00 and income is accrued daily and distributed monthly. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. The account balance was \$1,471,993 and 1,623,463 as of December 31, 2024 and 2023, respectively.

Certain events limit the Plan's ability to transact at contract value with Invesco, including plan termination and other events as specified in the contracts. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. The contracts may not terminate at any amount less than the contract value.

NOTE 8 – FAIR VALUE MEASUREMENTS

FASB ASC 820, *Fair Value Measurements*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurement) and the lowest priority to unobservable inputs (level 3 measurements).

In accordance with the framework, the Plan groups assets and liabilities measured at fair value into three levels based on the markets in which the assets and liabilities are traded and the reliability of the assumptions used to determine fair value. These levels are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

NOTE 8 – FAIR VALUE MEASUREMENTS – (CONTINUED) –

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used between December 31, 2024 and 2023:

- *Mutual Funds*: valued based on the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
