Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the **Stevens Towing Company, Inc 401(k) Profit Sharing Plan and Trust** (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023, and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 2 to the financial statements, is complete and accurate

Opinion

In our opinion, based on our audits and the procedures performed as described in the *Auditor's Responsibilities for the Audit of the Financial Statements* section of our report:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (GAAP); and
- the information in the accompanying financial statements related to assets held by and certified by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by a qualified institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

Note 1. Description of Plan

The following description of the Stevens Towing Company, Inc. 401(k) Profit Sharing Plan and Trust (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) defined contribution plan covering all employees of Stevens Towing Company and members of a controlled group of businesses under common control or ownership (collectively, the Company) except for employees covered by a collective bargaining agreement, non-resident aliens, and leased employees. Each employee is eligible to participate in the Plan on the first plan entry date following the attainment of age 21 and 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act (ERISA) of 1974.

The Plan trustees oversee the governance of the Plan, including determining the appropriateness of the investment offerings and monitoring investment performance.

Plan amendments

The Setting Every Community Up for Retirement Enhancement (SECURE) 2.0 Act of 2022 (the Act) was enacted to enhance retirement savings opportunities and improve retirement plan administration in the United States. The Act provides a broad range of mandatory and optional provisions affecting retirement plans, including increasing participation, improving portability of retirement savings, and expanding penalty-free withdrawal options for certain circumstances. Plan sponsors may elect to adopt certain provisions voluntarily before their mandatory effective dates. For the year ended 2024, the Plan adopted the following voluntary provision under the SECURE 2.0 Act:

- The automatic cash-out threshold for former participants' account balances was increased from \$5,000 to \$7,000.

Management has evaluated the impact of this amendment and determined that it does not materially affect the financial statements as of and for the year ended December 31, 2024. This change is intended to improve participant experience and administrative efficiency in accordance with recent legislative developments.

Administration

The Company is the Plan administrator.

Contributions

Each year participants may contribute a percentage of their annual compensation, as defined by the Plan, subject to the limitations as defined in the Internal Revenue Code (IRC). Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans (rollovers).

The Company has adopted safe harbor matching provisions. Under these provisions, the Company contributes safe harbor matching contributions equal to 100% of contributions made by a participant that do not exceed 3% of the participant's compensation plus 50% of the contributions made by a participant that exceed 3% of the participant's compensation but that do not exceed 5% of the participant's compensation.

Contributions (continued)

The Company may also make qualified non-elective contributions for the benefit of all participants eligible to make elective deferrals who are employed by the Company during the plan year. The qualified non-elective contributions will be allocated to the qualified non-elective contribution account of each participant eligible to share in such allocations in the ratio that such participant's compensation bears to the compensation of all eligible participants. The Company made no qualified non-elective contributions to the Plan for the years ended December 31, 2024 and 2023.

Participant accounts

Individual accounts are maintained for each participant to reflect the participant's contributions and related Company contributions. Each participant's account is credited with the participant's contribution, the Company's safe harbor matching contribution, and allocations of (a) the Company's qualified non-elective contributions, (b) plan earnings, and (c) charged with an allocation of administrative expenses. Allocations are based on participant earnings or account balances as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are immediately vested in their contributions, the Company's safe harbor matching contributions, and qualified non-elective contributions plus actual earnings thereon.

Upon reaching the minimum retirement age or if a participant dies or becomes disabled, the participant will become 100% vested in all contributions. Participants are 100% vested in rollover and transfer contributions.

Investment options

Upon enrollment in the Plan, participants may direct their contributions, the Company's safe harbor matching, and qualified non-elective contributions, if any, into various investment options offered by the Plan. Participants may change their investment options at any time.

Notes receivable from participants

Participants may borrow from their accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested balance. The loans are secured by the balance in the participant's account and accrue interest at a rate of 2% above prime which is commensurate with local prevailing rates as determined quarterly by the Plan Administrator. Principal and interest are paid ratably through bi-weekly payroll deductions.

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses have been recorded as of December 31, 2024 and 2023. If a participant ceases to make note receivable repayments and the Plan administrator deems the participant note receivable to be in default, the participant note receivable balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the plan document.

Withdrawal and payment of benefits

On termination of service, if a participant's vested account balance does not exceed \$7,000, (previously \$5,000) (excluding rollover contributions and earnings thereon), the Plan will automatically distribute the participant's vested account balance in a lump sum. If a participant's balance exceeds \$7,000 (excluding rollover contributions and earnings thereon), a participant may leave his or her balance in the Plan or elect to receive the value of the participant's vested interest in his or her account in the form of a single lump sum, partial payments, or roll over the vested balance into an IRA or other qualified plan.

Participants still employed may withdraw all or part of their account balance attributable to his or her contributions, excluding earnings, upon furnishing proof of financial hardship, however, not more than once in any plan year.

Basis of accounting

The financial statements of the Plan are prepared under the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by the investment advisors and custodians.

Purchases and sales of securities are recorded on a trade-date basis; interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation and depreciation include the Plan's gains and losses on investments bought and sold as well as held during the year.

Contributions

Employee contributions and employer safe harbor match contributions are recorded in the period during which the Company makes payroll deductions from the participant's earnings.

The Company's qualified non-elective contributions are accrued and paid based on amounts to be funded for each year under the Plan provisions and the applicable requirements of the IRC.

Payment of benefits

Benefits are recorded when paid.

Administrative expenses

Personnel within the Company perform many administrative duties of the Plan, including maintenance of personnel files and reconciliation of payroll records, at no charge to the Plan. Certain administrative expenses are paid by the Company; other administrative expenses are paid from the Plan.

Note 2. Information Prepared and Certified By Trustees

Certain information related to investments disclosed in the accompanying financial statements and supplemental schedules, including investments, loans, and related interest income held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments, interest and dividend income for the years then ended, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by First Citizens Bank and Trust Company.

Note 3. Fair Value Measurements

The fair value measurement accounting literature establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specific (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

- *Shares of registered investment companies (mutual funds):* Valued at the net asset value (NAV) of shares held by the Plan at year end.

Note 4. Income Tax Status

The Plan obtained its latest determination letter on November 30, 2020, in which the Internal Revenue Service (IRS) states that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the plan administrator believes the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 5. Plan Termination

Although it has not expressed any interest to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

Note 6. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participant's account balances and the amounts reported in the statement of net assets available for benefits.

Note 7. Party-In-Interest Transactions

Newport Group served as the Plan's third-party administrator (TPA) through November 13, 2024. Administrative fees totaled \$59,216 for the year ended December 31, 2023, and \$56,877 for January 1 to November 13, 2024. Effective November 14, 2024, Ascensus, LLC became the TPA. No fees were paid to Ascensus for the remainder of 2024.

All of these party-in-interest transactions are exempt from the prohibited transaction rules under ERISA.

These contributions are considered non-exempt party-in-interest transactions which may result in an imposition of a 15% excise tax on the amount of the transaction. The Company has compensated participants for any lost earnings associated with the delay in remitting contributions.

Note 11. Subsequent Events

The Plan has evaluated subsequent events through October 1, 2025, the date the financial statements were available to be issued. There were no material subsequent events requiring disclosure as of this date.
