A. PLAN DESCRIPTION

The following description of the Presto 401(k) Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

1. GENERAL

The Plan is a defined contribution plan covering all employees of National Presto Industries, Inc. and related employers (the "Company") and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

In December 2022, Setting Every Community Up for Retirement Enhancement Act (SECURE 2.0) was passed into law. The provisions of SECURE 2.0 continue the themes and reforms that began with the 2019 CARES Act. The effective date of the provisions of SECURE 2.0 vary from becoming effective immediately through 2028. Those provisions include both required and optional elements. Plan management will determine the optional provisions to elect in the future.

2. ELIGIBILITY

All employees who have completed three months of service and have attained 18 years of age are eligible to participate in the Plan, provided that they are not covered by a collective bargaining agreement. Eligibility for non-elective Company contributions and Company matching contributions requires one year of service.

3. CONTRIBUTIONS

Participants in the Plan may contribute up to 90% of their annual compensation, as defined by the Plan. Participants who have attained the age of 50 before the end of the Plan year are eligible to make catch-up contributions. Roth contributions are allowed by the Plan. Participants may also contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. The Plan has an automatic deferral provision. Once eligibility is met, employees are automatically enrolled in the Plan at a rate of 3% of eligible compensation unless the employee elects a different percentage or waives participation. The Plan has an auto escalation rate of 1% annually until a deferral 15% is reached. Company safe harbor (SH) matching contributions are 100% of the participants' contributions on the first 4% of the participants' annual compensation. The first 2% of the Company SH matching contribution is made in National Presto Industries, Inc. common stock ("Company Stock") and the second 2% is made in cash. An additional 3% of total compensation is contributed for active participants employed by National Presto Industries, Inc. before April 1, 2009. During the year ended December 31, 2024, the Company made contributions of \$1,882,291 to the Plan. Plan contributions are subject to certain Internal Revenue Service (IRS) limitations.

4. VESTING

Plan benefits attributable to Company safe harbor matching contributions and participant salary deferral contributions are immediately fully vested and nonforfeitable. Participants are considered to have completed one year of service for purpose of vesting upon the completion of 1,000 hours of service at any time during 12 consecutive months. Plan benefits attributable to the Company's discretionary contribution vest at 100% after three years of service.

5. PAYMENT OF BENEFITS

On termination of service, a participant may elect to receive a lump-sum distribution equal to the value of the participant's vested interest in his or her account. In addition, hardship distributions out of the participant's voluntary contributions account are permitted if certain criteria are met. The Plan also allows for in-service distributions upon attaining age 59 1/2.

6. PARTICIPANTS' ACCOUNTS

Participants' accounts are credited with participant salary deferrals, Company safe harbor matching contributions, an allocation of the Company's discretionary contributions, and Plan earnings or losses. Allocations of Plan earnings or losses are based on account balances, as specified in the Plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

7. TRANSFERS BETWEEN FUNDS

Assets of the Plan are held in participant-directed funds except for the Company Stock fund, which is considered non-participant-directed. Participants may transfer their interest between participant-directed funds in five percent increments as prescribed in the Plan document.

The Pension Protection Act of 2006 allows employees to divest any portion of their account balances invested in employer securities (i.e. Company Stock) and reinvest the proceeds in other Plan investment options provided employees are not in possession of material non-public information. For employees who have access to material non-public information, certain restrictions apply.

8. NON-PARTICIPANT-DIRECTED INVESTMENTS

The first 2% of the Company's SH matching contribution is made in Company Stock. Thereafter, employees may divest any portion of their account balances invested in Company Stock. Nevertheless, because the initial Company SH contribution is required to be invested in Company Stock, it is considered to be non-participant directed. As of December 31, 2024 and 2023, net assets invested in Company Stock was \$11,963,108 and \$9,053,764, respectively.

9. FORFEITURES

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$3,190 and \$1,748, respectively. These accounts may be used to pay administrative expenses or to reduce future Company contributions. No forfeitures were used for the year ended December 31, 2024.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements are as follows:

1. BASIS OF ACCOUNTING

The Plan follows accounting principles generally accepted in the United States ("GAAP") set by the Financial Accounting Standards Board (FASB). The financial statements of the Plan are prepared on the accrual basis of accounting.

2. USE OF ESTIMATES

Preparation of the Plan's financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from the estimates used by management.

3. INVESTMENT VALUATION AND INCOME RECOGNITION

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See B.4 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

4. FAIR VALUE MEASUREMENTS

The Plan utilizes the methods of fair value as described in FASB Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures* to value its financial assets. ASC 820 utilizes a three-tier fair value hierarchy, which prioritizes the inputs used in measuring fair value. These tiers include: Level 1, defined as observable inputs such as quoted prices in active markets; Level 2, defined as inputs other than quoted prices in active markets that are either directly or indirectly observable; and Level 3, defined as unobservable inputs in which little or no market data exists, therefore requiring an entity to develop its own assumptions.

An asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

4. FAIR VALUE MEASUREMENTS (Continued)

The following is a description of the valuation methodologies used for Plan assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the net asset value (NAV) of shares held by the Plan as of the end of the year. The funds' assets are determined primarily on the basis of observable market quotations or official closing prices in active markets.

Common Stocks: Valued at the closing price reported in the active markets in which the individual securities are traded.

Common collective trust - Fidelity Managed Income Portfolio: Fair value is estimated using NAV as a practical expedient. NAV is determined by using the estimated fair values of the underlying assets held in the Fund at year-end. The Fund primarily invests in investment contracts issued or sponsored by various insurance companies, commercial banks, and investment funds. The use of NAV as fair value is deemed appropriate since the collective trust funds do not have finite lives, unfunded commitments relating to these types of investments, or significant restrictions on redemptions.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

D. TRUSTEE CERTIFICATION

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Certain information disclosed in the accompanying financial statements and supplemental schedule, including investments held at December 31, 2024 and 2023, net appreciation in fair value of investments, dividends and interest, and other income for the year ended December 31, 2024, was obtained or derived from information supplied to the Plan administrator and certified as complete and accurate by Fidelity Management Trust Company ("FMTC", the Trustee of the Plan).

E. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

F. TAX STATUS

The IRS has determined and informed the Plan by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since the date of the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified and the related trust is tax-exempt.

G. PARTY-IN-INTEREST TRANSACTIONS

The Plan owned 121,545 and 112,772 shares of Company Stock as of December 31, 2024 and 2023, respectively, the fair value of which is presented in Note A.8. Dividend and interest income from Company Stock was \$512,545 in 2024.

Certain Plan investments are managed by FMTC. FMTC is the Trustee as defined by the Plan; therefore, these transactions qualify as exempt party-in-interest transactions. Fees applied/paid by the Plan for investment management and distribution fees amounted to \$1,218 for the year ended December 31, 2024.

Officers of the Company (Plan Administrator) are Trustees for the Plan. Their services are provided at no expense to the Plan. Administrative expenses, including audit and legal fees, are paid by the Company.

H. PLAN TERMINATION

Although the Company has not expressed any intent to do so, the Company has retained the right to terminate or partially terminate the Plan. In the event the Plan is terminated, the amounts credited to a participant's account at such time shall be nonforfeitable. Net assets of the Plan will be distributed to the Plan participants as prescribed by the Plan agreement.
