We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of ESL Federal Credit Union Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about ESL Federal Credit Union Savings Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the plan; and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about ESL Federal Credit Union Savings Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including their form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF PLAN

The following description of the ESL Federal Credit Union (the Credit Union) Savings Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering all employees of the Credit Union who are age 21 or older. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Administration

The Plan is administered by the Credit Union's Employee Benefit Plans Committee (the Committee). The Committee administers the Plan in accordance with its terms and applicable laws and has all necessary and appropriate powers to carry out the provisions of the Plan. The assets of the Plan are held by T. Rowe Price Trust Company (the Trustee), who also serves as the recordkeeper.

Contributions

Participants are permitted to contribute up to 100% of their eligible compensation on a pre-tax basis or Roth deferral after-tax basis, subject to certain limitations under terms of the Plan and the Internal Revenue Code (the IRC).

The Plan has an automatic enrollment provision in which newly eligible participants are enrolled in the Plan to defer 6% of eligible compensation unless otherwise directed by the participants.

The Credit Union makes nonelective safe harbor matching contributions equal to 100% of the first 1% and 50% of the next 5% of a participant's eligible compensation that a participant contributes to the Plan, as defined by the Plan. Employer nonelective contributions may be contributed to the Plan at the discretion of the Credit Union, subject to certain limitations. During the year ended December 31, 2024, the Credit Union made employer nonelective contributions in the amount of \$1,976,458. The Credit Union did not make any employer nonelective contributions during the year ended December 31, 2023.

Rollover contributions may be made to the Plan in a lump-sum distribution from another qualified defined contribution or defined benefit plan.

Participants are able to direct the investment of their contributions, all Credit Union contributions, and related earnings thereon into various investment options offered by the Plan.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of: (a) the Credit Union's contributions and (b) the participant's share of Plan earnings/losses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

1. DESCRIPTION OF PLAN (Continued)

Vesting

Participants are immediately vested in their voluntary contributions plus actual earnings/losses thereon. Vesting in the Credit Union's contributions and earnings/losses thereon is based on years of credited service. A participant becomes 100% vested after two years of credited service. Additionally, participants become fully vested upon attainment of normal retirement age, death, or total disability, regardless of years of service.

Notes Receivable from Participants

Participants may borrow from their pre-tax account balance a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of the participant's vested account balance, subject to certain conditions as defined in the Plan document. The loan and interest thereon shall be repaid over a period not to exceed 5 years (except for certain residential loans which can extend up to 15 years). The loans are secured by the balance in the participants account and bear interest at the prime rate on the date of the loan. Principal and interest is paid ratably through payroll deductions. Participant loans in default, including a loans that are deemed distributed, are treated as outstanding loans for purposes of determining the number of loans outstanding to a participant until they are repaid or actually offset against the participant's account balance.

Payment of Benefits

On termination of service, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in his or her account, or annual installments over the expected life span of the participant. The Plan provides for mandatory minimum distributions of a participants vested account balance following severance from employment when the participant's account balance is less than \$1,000.

In-Service Withdrawals

Participants may elect disbursement of all or part of their vested account balance upon the attainment of age 59 ½.

Hardship Withdrawals

Hardship withdrawals from the Plan are permitted from the participant's pre-tax and Roth elective contributions (excluding any earnings thereon), post-1988 income on participant's elective contributions, and the participant's pre-tax and Roth rollover contributions (including any earnings thereon). All hardship withdrawals are subject to the Committee's approval and must comply with the rules relating to hardships, which are uniformly applicable to all participants.

Administrative Expenses

The Plan sponsor pays substantially all recurring administrative fees of the Plan.

Forfeited Accounts

Forfeitures of non-vested account balances are used to reduce future employer contributions. For the years ended December 31, 2024 and 2023, there were \$25,974 and \$24,320 in forfeitures, and earnings thereon, of non-vested account balances, respectively. No amounts were applied to reduce employer contributions in 2024. The Company applied \$20,562 to reduce employer contributions in 2023. At December 31, 2024 and 2023, forfeited non-vested account balances available to reduce future employer contributions totaled \$29,749 and \$3,775, respectively.

1. DESCRIPTION OF PLAN (Continued)

Plan Termination

Although it has not expressed any intent to do so, the Credit Union has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America.

Employer Non-elective Contributions

Employer non-elective contributions are recognized in the period in which they are received by the Plan.

Investments and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Changes in the current value of investments held during the year, including realized gains and losses on assets bought and sold during the year, are reflected in the statements of changes in net assets available for benefits as net appreciation or depreciation in the fair value of investments. Purchases and sales of securities are recorded on a trade-date basis. Interest is recorded on the accrual basis. Dividend income is recorded on the ex-dividend date. All investments are participant directed.

Notes Receivable from Participants

In the normal course of plan operations, participants are permitted to borrow against their accounts. Repayments are made through normal payroll deductions. The notes receivable are charged interest at the prime rate (7.50% and 8.50% at December 31, 2024 and 2023, respectively). Delinquent loans will be repaid at the time a participant requests a distribution from the Plan. The balance of the receivable represents any unpaid principal and unpaid but accrued interest on outstanding loans at year-end.

Fair Value Measurement - Definition and Hierarchy

The Plan uses various valuation techniques in determining fair value. Financial Accounting Standards Board *Accounting Standards Codification 820 (ASC 820)* establishes a hierarchy for inputs used in measuring fair value that maximizes the use of observable inputs and minimizes the use of unobservable inputs by requiring that the observable inputs be used when available. The hierarchy is broken down into three levels based on the reliability of inputs as follows:

- Level 1 - Valuations based on quoted prices in active markets for identical assets or liabilities that the Plan has the ability to access.
- Level 2 - Valuations based on quoted prices in markets that are not active or for which all significant inputs are observable, directly or indirectly.
- Level 3 - Valuations based on inputs that are unobservable and significant to the overall fair value measurement.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (Continued)

Fair Value Measurement - Definition and Hierarchy (Continued)

A description of where the Plan's investments fall within the hierarchy is presented in Note 4.

In certain cases, the inputs used to measure fair value may fall into different levels of the fair value hierarchy. In such cases, for disclosure purposes, the level in the fair value hierarchy is determined based on the least reliable input that is significant to the fair value measurement.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Risks and Uncertainties

Investment securities are exposed to various risks, such as interest rate, market, economic conditions, world affairs, and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the accompanying financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan administrator to make estimates and assumptions that affect the amounts reported in the financial statements and accompanying notes. Actual results could differ from those estimates.

(a) In accordance with the FASB authoritative guidance regarding fair value measurement, certain investments that were measured at net asset (NAV) value per share (or its equivalent) have not been classified in the fair value hierarchy. The fair value amounts presented in this table are intended to permit reconciliation of the fair value hierarchy to the line items presented in the statements of net assets available for benefits.

There were no changes in valuation techniques used during 2024 or 2023. The following is a description of the valuation methodologies used for assets measured at fair value:

Mutual funds: Valued at fair value by quoted prices in active markets for identical assets.

Common trust funds: Valued at the NAV of units of the collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. There are no other restrictions or unfunded commitments, other than what is documented below.

Relative to the T. Rowe Price Stable Value Fund (the SVF), each investor's beneficial interest in the net assets of the trust is represented by units, an unlimited number of which are authorized. Unit transactions are subject to terms, conditions, and limitations defined in the Declaration of Trust. Except as otherwise provided in the Declaration of Trust, trust units are generally issued and redeemed only on a valuation date and at the net asset value per unit computed on that date. Trust units may be redeemed on a daily basis to meet benefit payments and other participant-initiated withdrawals permitted by retirement plans invested in the trust. Under the terms of the Declaration of Trust, retirement plans invested in the trust are required to provide either 12 or 30 months' advance written notice to the trustee prior to redemption of trust units; the notice period may be shortened or waived by the trustee in its sole discretion.

4. FAIR VALUE MEASUREMENTS (Continued)

Relative to the T. Rowe Price Retirement Trust funds, each investor's beneficial interest in the net assets of a Retirement Trust is represented by units, an unlimited number of which are authorized. Unit transactions are subject to terms, conditions, and limitations defined in the Declaration of Trust. Units are issued and redeemed only on a valuation date and at the net asset value per unit computed on that date. Under the terms of the Declaration of Trust, unitholders may be required to provide up to 30-days advance written notice to the trustee prior to redemption of trust units; the notice period may be shortened or waived by the trustee in its sole discretion.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation method is appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

5. PARTY-IN-INTEREST TRANSACTIONS

T. Rowe Price Trust Company is the Custodian of the Plan's assets and the Trustee of the Plan. As such, transactions between T. Rowe Price Trust Company and the Plan qualify as party-in-interest transactions. Transactions involving notes receivable from participants also qualify as party-in-interest transactions.

6. TAX STATUS

The Plan received its latest determination letter on August 19, 2020, in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan has been amended since receiving the determination letter. The Plan's administrator and tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable regulations of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.
