We have performed audits of the accompanying financial statements of Artera Services, LLC 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

**1. DESCRIPTION OF PLAN**

The following description of the Artera Services, LLC 401(k) Plan (the Plan) is provided for general information purposes only. The Plan, originally named PowerTeam Services LLC 401(k) Plan, amended its name on July 30, 2020. The financial statements and notes to the financial statements reflect this amendment. The following information describes the Plan's provisions for the years indicated and participants should refer to the respective Plan document for a more complete description of the Plan's provisions. The Plan is subject to provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. The Plan is a defined contribution plan established by Artera Services, LLC (the Company, Employer or Plan Sponsor) to help its employees save for retirement.

**Plan Administration**

Fidelity Management Trust Company serves as trustee and custodian of the Plan. Fidelity Workplace Services, LLC serves as the recordkeeper of the Plan. The Plan is administered by the Company.

**General**

The Plan, effective January 1, 2006, and subsequently amended, is established for benefit of eligible employees of the Company under the provisions of Section 401(a) of the Internal Revenue Code (IRC), which includes a qualified cash or deferred contribution arrangement as described in Section 401(k) of the IRC. The Company's employees, employees of entities affiliated with the Company, including Southeast Connections, LLC; HydroExcavators, LLC; HydroExcavators II, LLC; Otis Minnesota Services, LLC (OMS); Miller Pipeline, LLC (Miller Pipeline); Feeney Utility Services Holdco, LLC (Feeney), including its wholly owned subsidiary DDS Holdco, LLC (DDS); and Versiv Solutions, LLC are eligible to participate, provided they satisfy the conditions for participation.

**Eligibility**

Generally all employees of the Company who have attained the age of 18 and who have completed three months of service are eligible to participate on the date they meet the eligibility requirements, except for residents of Puerto Rico, employees covered by a collective bargaining agreement (unless the agreement requires the employees to be included under the Plan), leased employees, nonresident aliens with no income from a U.S. source, or co-ops and interns. However, if an employee is a co-op or an intern, the employee is eligible to participate in the Plan on the first entry date upon reaching age 21 and completion of 1,000 hours of service during an eligibility computation period, as defined in the Plan.

**Contributions**

Eligible employees may contribute up to 90% of their eligible compensation to the Plan, subject to certain limitations under the IRC. Employees are subject to automatic enrollment and escalation provisions consistent for the entire Company. Effective January 1, 2020, participants are auto enrolled at 4% of their eligible compensation and elective deferrals are automatically increased each January 1 until the participant is contributing 10%. Participants may opt out of both the auto enrollment and auto escalation features of the Plan. The Plan allows participants to contribute to the Plan through pretax elective deferrals or post-tax Roth elective deferrals. Participants who

have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Employees may rollover eligible amounts from other qualified plans.

Upon completing three months of service, as defined by the Plan, the Plan provides for matching Employer contributions equal to 50% of an employee's salary deferrals up to 6% of eligible compensation. All contributions are participant-directed.

**Participant Accounts**

Each participant's account is credited with the participant's contributions, allocations of the Employer's matching contributions and Plan earnings, and charged with the participant's distributions, Plan losses and an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Investment of Assets**

Participants direct their contributions, the Plan Sponsor's contributions and any related earnings to one or more investment options provided by the Plan in 1% increments. Participant accounts are segregated for the purpose of determining the gains or losses on investments. The Plan Sponsor's Benefit Committee is responsible for oversight of the Plan, determining the appropriateness of the investment offerings and monitoring investment performance.

**Vesting**

Participants are immediately vested in salary deferral amounts contributed to the Plan and balances rolled over into the Plan from other qualified plans. Company contributions and earnings thereon vest in accordance with the provisions of the Plan as follows:

Certain Plan participants maintain a separate vesting schedule; see Plan document for further details.

**Forfeitures**

The Plan Sponsor may choose to use forfeitures of nonvested participant accounts to reduce administrative expenses of the Plan or to reduce the Plan Sponsor's matching contribution as permitted by the Plan document. During the 2024 Plan year, forfeitures of approximately \$57 and \$504,875 were used to offset administrative expenses and matching contributions, respectively. As of December 31, 2024 and 2023, the forfeited balance was approximately \$315,580 and \$128,500, respectively.

**Payment of Benefits**

Upon death, disability, termination of employment or attainment of age 59½, a participant, or their beneficiary, may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or installments as defined by the Plan. Distributions for hardships

are permitted from the participant's balance upon meeting the financial burden statutory requirements. The minimum amount of withdrawal for a financial hardship is \$500.

**Notes Receivable from Participants**

Participants are allowed to borrow from their accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1%, which are commensurate with local prevailing rates as determined quarterly by Fidelity. Principal and interest are paid ratably through payroll deductions. A participant can have no more than two loans outstanding from the Plan at any time.

**2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

**Basis of Presentation**

The accompanying financial statements have been prepared using the accrual basis of accounting in accordance with accounting principles generally accepted in the United States (GAAP).

**Use of Estimates**

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions which affect the reported amounts in the financial statements and the accompanying notes. Actual results could differ from those estimates.

**Risks and Uncertainties**

Investment securities, in general, are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

**Investment Valuation and Income Recognition**

The Plan's investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Quoted market prices are used to value investments. Shares of mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end. Investments in common collective trusts are valued based on the NAV provided by the fund. The NAV is based on the fair value of the underlying investments held by the fund. See Note 3 for a discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when incurred.

**Payment of Benefits**

Benefits are recorded as paid. As of December 31, 2024 and 2023, there were no benefit payments requested and not yet disbursed.

**Administrative Expenses**

As permitted by the Plan document, fees related to the administration and maintenance of notes receivable from participants and processing distributions are charged directly to the participant's account and included in administrative expenses. Plan administrative expenses for recordkeeping, trustee and investment advisory services are paid by the Company.

**3. FAIR VALUE MEASUREMENTS**

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) Topic 820, *Fair Value Measurement*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under this standard are described as follows:

- Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 – Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
- Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

*Mutual funds* – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Securities and Exchange Commission (SEC). These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

*Common collective trust fund* – This investment is a public investment vehicle valued using the daily NAV provided by the administrator of the fund. The NAV is based on the value of the underlying assets owned by the fund, minus its liabilities and then divided by the number of shares outstanding. There are no significant restrictions such as redemption terms, or holding periods, which would limit the ability of the Plan or the participants to transact at the NAV. Participant transactions may occur daily.

These methods may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, the Plan believes its valuation methods are appropriate and consistent with other market participants. The use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**5. INCOME TAX STATUS**

The Plan adopted a nonstandardized preapproved profit-sharing prototype plan sponsored by Fidelity Management & Research, LLC. The Internal Revenue Service (IRS) has determined and informed Fidelity Management & Research, LLC by letter, dated June 30, 2020, that the prototype document satisfies the applicable sections of the IRC. The Plan itself has not received a determination letter from the IRS. Although the Plan has been amended since receiving the opinion letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Accordingly, the accompanying financial statements do not include a provision for income taxes.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that is more likely than not to not be sustained upon examination by the IRS. The Plan is subject to audit by taxing jurisdictions, however, there are currently no audits for any tax periods in progress.

**6. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS**

Certain Plan investments are held in shares of mutual funds managed by Fidelity Management Trust Company. Fidelity Management Trust Company is the Plan's trustee and custodian of the Plan, and therefore, transactions under the Plan qualify as party-in-interest transactions.

During the year ended December 31, 2024, fees, including investment advisory and audit fees, were paid to the Plan's recordkeeper from participants' account balances when participants requested loans and distributions. These expenses, along with notes receivable from participants, qualify as party-in-interest transactions.

**7. PLAN TERMINATION**

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to terminate the Plan, subject to the provisions of ERISA. Upon termination, all amounts credited to participant accounts become 100% vested.

**8. SUBSEQUENT EVENTS**
