Management is also responsible for maintaining a current plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibility

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. The supplemental Schedule of Assets Held at End of Year is presented for the purpose of additional analysis and is not a required part of the financial statements but is supplemental information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under the ERISA. Supplemental information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audit of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the the financial statements themselves, and other additional procedures in accordance GAAS.

In forming our opinion on the supplemental information, we evaluated whether the supplemental information, including their form and content, are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024, AND 2023

NOTE. 1 DESCRIPTION OF PLAN

General - The following description of the Chapel Haven, Inc. and Chapel Haven West, Inc. 403(b) Tax Deferred Annuity Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

The Organization established the Plan to provide employees with a systematic means of savings and investing for the future. All permissible employees of the Plan, as defined in accordance with the universal availability standards are eligible to enroll on their date of hire. Deferrals begin on the first day of the month subsequent to enrollment. The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Plan Contributions - The Plan is a defined contribution plan with an employee tax deferred and employer discretionary contribution component. There is no special age or service requirements for the employee tax deferred component. For the employer discretionary contribution component, you must reach the age of 21 and complete 2 consecutive years of service to be eligible to participate. Participants may contribute a percentage of their annual compensation, provided however, that such contribution does not exceed the IRS prescribed limitations. The Plan allows participants who have attained age 50 by the end of the Plan year to make catch-up contributions in accordance with the Internal Revenue Code (IRC) Section 402(g)(4). Additionally, the Plan allows participants who have completed 15 years of service to make additional deferrals in accordance with the IRC Section 402(g)(3). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan may also elect to make a discretionary nonelective contribution.

Such contributions are allocated to eligible participants, as a uniform percentage of the participant's compensation. The Plan's discretionary nonelective contribution to all eligible employees was 0% for the years ended December 31, 2024, and 2023, respectively. The Plan sponsor adopted a resolution, effective June 1, 2018, to set the discretionary nonelective contribution at 0%. Employee and employer contributions are accounted for as exchange transactions.

Participant Accounts - Each eligible participant's account is credited with the participant's contributions, the Plan's discretionary contributions and the account's investment results and expenses. Allocation of earnings for each fund is allocated to the applicable participant's accounts based on the ratio of each participant's account balance to the total of all participant's account balances in that fund, as defined.

Vesting - Participants are immediately vested in their voluntary contributions and actual earnings thereon. In addition, vesting in the Plan's discretionary contribution is immediate.

NOTE. 1 DESCRIPTION OF PLAN (continued)

Investment Options - Upon enrollment in the Plan, participants may direct the investment of their contributions and the Plan's contributions into various investment contracts and annuity options offered by the Plan.

Payment of Benefits - Upon termination of service due to retirement, disability, or other cause, a participant's entire undistributed vested interest in the Plan (reduced by any security interest held by the Plan by reason of an outstanding loan to the participant) shall be available to be distributed to the participant (or their beneficiary) in a single, lump sum cash payment or a single sum distribution of a portion of their account balance. Participants may also withdraw their vested interest in the Plan under certain hardship conditions, as defined in the Plan document. Benefits are recorded when paid.

Participants Loans - Loans are available to participants, subject to certain limitations. Plan loans are issued directly from funds owned by the Plan participant, and loan proceeds are removed from the participant's account balance. The participant's vested account balance is used as collateral. In general, the maximum amount that can be borrowed is the lesser of 50% of a participant's vested interest of \$50,000, at reasonable rate of interest. During the year ended December 31, 2024 the interest rate is 4.25%. Interest is paid ratably through payroll deductions. In the event of retirement, death, disability or termination of employment, the loan becomes payable in full.

At December 31, 2024 and 2023, participants had outstanding Plan loan balances of \$17,407 and \$13,098, respectively.

There were no Plan loan defaults during the years ended December 31, 2024 and 2023.

Plan Loans - Participants may borrow from TIAA-CREF using a portion of their plan account as security for the loan. The minimum loan is \$1,000 and may be up to the lesser of \$50,000 or 50% of their account balance. The loans bear interest at rates that range 4.25% to 9.00% at December 31, 2024, and 2023, respectively, which are commensurate with local prevailing rates as determined periodically by TIAA-CREF. Principal and interest is paid ratably by the participant to TIAA-CREF. The Plan Administrator has concluded that these loans are not plan assets and that such arrangements are exempt transactions.

The balances as of December 31, 2024, and 2023 were \$6,919 and \$6,573, respectively. Under the borrowing terms, plan assets of 110% of the loan amount serves as collateral to these loans.

In the event of default such loans are reportable to plan participants as taxable income but remain outstanding and continue to accrue interest until repaid by the plan participant or the participant becomes eligible to receive a distribution under the terms of the Plan. As of December 31, 2024, and 2023, loans totaling \$6,919 and \$6,573, respectively, were deemed distributed.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting - The accompanying financial statements have been prepared on the accrual basis of accounting.

NOTE 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Management's Use of Estimates - The preparation of financial statements in conformity with generally accepted accounting principles in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual reports may differ from those estimates.

Investment Valuation and Income Recognition - Except for the TIAA Traditional annuity, which is stated at contract value, the Plan's investments are stated at fair value. Fair Value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 for discussion of fair value measurements. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investment bought and sold as well as held during the year.

Employer Contributions Receivable - Contributions due but not paid prior to year end are recorded as contributions receivable. The Plan believes that the receivables are fully collectible; therefore, no allowance for credit losses is recorded.

Plan Administration Costs - The Plan absorbs significant costs of the Plan administration related to audit fees.

NOTE 3. ANNUITY CONTRACT WITH INSURANCE COMPANY

The Plan participates in a fixed annuity contract with Teachers Insurance and Annuity Association of America (TIAA) via an investment in the TIAA Traditional Annuity. Under this contract, participants may direct a portion of their contributions to purchase a specific amount of lifetime income based on the contractual rate schedule in effect at the time of the contribution. Contract value represents accumulated cash contributions to the contract, plus earnings at guaranteed crediting rates, less withdrawals, which approximates fair value. The contract is affected directly between the Plan sponsor and the issuer. The repayment of principal and interest credited to participants is a financial obligation of the issuer. Given these provisions, Plan management considers the contract to be fully benefit-responsive.

The Plan's management has various processes and controls in place to ensure that fair value is reasonably estimated. The investment committee sets the valuation policies for the Plan assets and is responsible for the determination of the fair value. The investment committee 1.) compares price changes between periods to current market conditions, 2.) compares trade prices of securities to fair value estimates, 3.) compares prices from multiple pricing sources, and 4.) performs ongoing due diligence to confirm that independent pricing services use market-based parameters for valuation. Valuation approaches are reviewed on an ongoing basis and revised as necessary based on changing market conditions to ensure values represent a reasonable exit price.

NOTE 4. PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of variable and fixed annuities managed by TIAA - CREF, the custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest. Fees were not paid by the Plan for the investment management services, but rather by the sponsor separately outside the Plan.

NOTE 5. PLAN TERMINATION

Although it has not expressed any intent to do so, the Organization has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6. TAX STATUS

The Plan has been designed to qualify under 403(b) of the IRC. The plan terms have been drafted in reliance on the sample language provided by the Internal Revenue Service in Revenue Procedure 2007-71. The Plan Administrator intends to apply for a determination letter on the plan when the government opens such program. The Plan is required to operate in conformity with the Code to maintain its tax exemption. Plan management believes the Plan is currently designed and operated in compliance with the applicable requirements of the Code. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that, more likely than not, would not be sustained upon examination by the U.S. Federal, state, or local authorities. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. Typically, plan tax years will remain open for three years; however, this may differ depending upon the circumstances.

NOTE 7. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Basis of Fair Value Measurement:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

NOTE 7. FAIR VALUE MEASUREMENTS (continued)

Level 2 - Inputs to the valuation methodology include: quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The assets or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024, and 2023:

Registered Investment Companies: Valued at the net asset value (NAV) of shares held by the Plan.

Pooled Separate Accounts - TIAA Real Estate: Valued at the market value of the underlying real estate holdings or other real estate related investments held by the pool, as determined by external appraisals, or obtained from independent pricing sources. The Plan's management has various processes and controls in place to ensure that fair value is reasonably estimated.

Daily unit values for CREF Accounts and the TIAA Real Estate Account are listed on the NASDAQ each business day.

Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 9. SUBSEQUENT EVENTS

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements are available to be issued, and they have been evaluated in accordance with relevant accounting standards.



