INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of
DMI Companies, Inc. and Affiliated Companies 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of DMI Companies, Inc. and Affiliated Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. The financial statements comprise the statements of assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 5 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP); and
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental schedule of assets held for investment purposes as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to

the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion:

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, is presented, in all material respects, in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.
- the information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

NOTES TO FINANCIAL STATEMENTS

1. DESCRIPTION OF PLAN AND SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The following description of DMI Companies, Inc. and Affiliated Companies 401(k) Plan (the "Plan") provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan, established effective April 1, 1986 and amended and restated effective as recently as January 1, 2022, is a defined contribution plan which covers all non-union, non-leased, full-time employees of DMI Companies, Inc. (the "Sponsor") and affiliated companies. Employees are required to complete 30 days of service to become eligible for the Plan. Employees are then permitted to enter the Plan on the first day of the month coinciding with or next following the completion of 30 days of service. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Basis of Accounting - The Plan's financial statements are prepared on the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

Use of Estimates - The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the dates of the financial statements and the reported amounts of changes in net assets during the reporting periods. Actual results could differ from those estimates.

Investment Valuation and Income Recognition - Investments, other than the guaranteed investment contract, are carried at their fair value based on published quotations or, in the absence of readily ascertainable market values, at such values as the trustee determines. The unrealized appreciation (depreciation) of investments is determined by the change in current market value from the beginning of the year (if held for the entire year) to the end of the year, or from the date of purchase to the end of the year. The realized appreciation (depreciation) of investments is determined by the change in the current market value from the beginning of the year (if held since the beginning of the year) to the date of sale, or from the date of purchase to the date of sale. Gains and losses on securities sold or redeemed are determined on the basis of specific identification. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Investment management fees and operating expenses charged to the Plan for investments in the various funds are deducted from income earned on a daily basis and are reflected as a component of net appreciation (depreciation) in fair value of investments.

The guaranteed investment contract is reported at contract value, which is the relevant measurement attribute because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan (see Note 2).

Contributions - Participants may elect to contribute up to 75% of pre-tax compensation and may also elect to contribute up to 75% of after-tax compensation to a Roth Elective Deferral account, subject to certain limitations under the Internal Revenue Code.

The Plan has an automatic contribution arrangement whereunder participants who have no existing affirmative deferral election automatically defer 3% of their compensation into the Plan. As further detailed in the adoption agreement, participants may elect to contribute less or more than would automatically be deferred. The Plan also has an automatic escalation arrangement whereunder participant deferral elections are subject to an annual 1% increase, not to exceed 6% of compensation.

For non-highly compensated employees, safe harbor employer matching contributions are 100% of the participant's elective deferrals, not to exceed 6% of the participant's compensation. Safe harbor matching contributions for highly compensated employees are discretionary.

The Sponsor may make discretionary profit sharing contributions to the Plan equal to a discretionary percentage of the participant's compensation, which will be determined each year. There were no discretionary contributions for the years ended December 31, 2024 or 2023.

Participant Accounts - Each participant's account is credited with the participant's contribution, the safe harbor matching contribution, an allocation of the Sponsor's discretionary contribution, if applicable, and plan earnings. Earnings are allocated by fund based on the ratio of a participant's account invested in a particular fund to all participants' investments in that fund. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options - Participants may direct their contributions and any related earnings into various investment options. The Plan is invested in funds maintained by Principal Trust Company.

Risks and Uncertainties - The Plan's funds are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in risks in the near term could materially affect participants' account balances and the amounts reported in the statements of assets available for benefits and statements of changes in assets available for benefits.

Distributions - Upon termination of service due to death, disability, retirement or other termination, participants or their beneficiaries may elect to receive an amount equal to the value of the participant's vested interest in his or her account or IRA rollover. If a participant's vested account balance exceeds \$5,000, he or she may elect to receive a distribution in a lump-sum payment (or IRA rollover) or make partial withdrawals. If a participant's vested account balance is less than \$5,000, his or her account will be automatically distributed in a lump-sum IRA rollover unless the participant affirmatively selects direct payment.

Vesting - The accounts for all participants' contributions, safe harbor matching contributions and earnings thereon are fully vested and nonforfeitable at all times. The Sponsor's discretionary contributions vest according to the following schedule:

Forfeitures - When a participant withdraws from the Plan prior to becoming fully vested, the nonvested portion of the participant's account is first utilized to reduce payment of plan expenses, and any remaining balance is applied toward Sponsor contributions. There were no forfeitures for the years ended December 31, 2024 and 2023.

Administrative Expenses - The Plan's expenses are paid by the Sponsor or by the Plan as provided by the plan agreement.

Fair Value Measurements - U.S. GAAP establishes a framework for measuring fair value of financial assets and liabilities. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
- Level 2 Inputs are not quoted prices in active markets but they are observable either directly or indirectly.
- Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's fair value measurement level within the fair value hierarchy is based upon the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes to the methodology used at December 31, 2024 and 2023.

Mutual Funds: Each mutual fund is valued using a quoted price in an active market (Level 1 measurement).

Collective Investment Trusts (CITs): Each CIT invests in a collective trust fund as well as a variety of separate accounts and mutual funds. The collective trust fund and the separate accounts are not valued using publicly quoted pricing inputs; the mutual funds are valued using publicly quoted pricing inputs. The fair values of all of these investments are used to determine the net asset value (NAV) of each CIT. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and each CIT can be redeemed at NAV as of the measurement date. Therefore, each CIT has a readily determinable fair value (Level 1 measurement).

Pooled Separate Accounts (PSAs): Each PSA invests mainly in domestic stocks, which are valued using publicly quoted pricing inputs. The fair values of all of these stocks are used to determine the NAV of each PSA. The NAV is not publicly quoted but is available to current investors. The NAV is the basis for current transactions, and each PSA can be redeemed at NAV as of the measurement date. Therefore, each PSA has a readily determinable fair value (Level 1 measurement).

These methods may produce fair value calculations that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the plan administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting dates.

Assets Attributable to Plan Transfer - During the year ended December 31, 2023, one participant transferred the balance of their account in the amount of \$39,942 from the DMI Companies, Inc. 401(k) Profit Sharing Plan, a defined contribution plan also maintained by the Sponsor, to the Plan.

Subsequent Events - The Sponsor has analyzed subsequent events for recognition and disclosure purposes through August 20, 2025, the date which the financial statements were available to be issued.

2. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan holds a fully benefit-responsive guaranteed investment contract with Principal Life Insurance Company ("PLIC"). PLIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the assets available for benefits attributable to the guaranteed investment contract. Contract value, as reported to the Plan by PLIC, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

Certain events limit the Plan's ability to transact at contract value with PLIC. Such events include the following: (a) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (b) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (c) bankruptcy of the plan sponsor or other plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (d) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The plan administrator does not believe that any events that would limit the Plan's ability to transact at contract value with plan participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

3. PLAN TERMINATION

The Sponsor anticipates and believes that the Plan will continue without interruption but reserves the right to discontinue the Plan at its discretion. In the event that such discontinuance results in the termination of the Plan, all amounts credited to participant accounts become 100% vested. The net assets of the Plan will be distributed by the trustee in accordance with the trust agreement in a uniform and nondiscriminatory manner.

4. INCOME TAX STATUS

The Plan operates under a standardized adoption agreement in connection with a pre-approved 401(k) profit-sharing plan and trust. The Internal Revenue Service has stated in a letter dated June 30, 2020 that the Plan is designed in accordance with the applicable regulations of the

Internal Revenue Code (IRC). The Plan has been amended since the date of the opinion letter. However, the plan administrator believes that the Plan is currently designed and being operated in compliance with the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Management believes there is no liability related to uncertain tax positions at December 31, 2024 and 2023. The Plan is no longer subject to U.S. federal or state income tax examinations by tax authorities for tax years before 2021.

5. CERTIFIED FINANCIAL INFORMATION

Principal Trust Company, the trustee, has certified that the following data included in the accompanying financial statements is complete and accurate.

- Investments, as shown in the statements of assets available for benefits as of December 31, 2024 and 2023.
- Investment income, as shown in the statements of changes in assets available for benefits for the years ended December 31, 2024 and 2023.
- The schedule of assets held for investment purposes as of December 31, 2024, as shown on the accompanying schedule.

6. PARTIES-IN-INTEREST AND RELATED PARTIES

Principal Trust Company provides access to certain investments and, accordingly, is considered a party-in-interest.

Employees of the Sponsor do not receive any compensation from the Plan.
