We have performed audits of the financial statements of The James Skinner Co. 401(k) Retirement Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 2, 2024 and December 31, 2023, and the related statements of changes in net assets available for benefits for the periods then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of and for the periods ended December 2, 2024 and December 31, 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agree to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with U.S. GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the Plan, and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the Financial Statements section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.

- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of U.S. GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with U.S. GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matters

Emphasis of Matter

As discussed in Note 1 to the financial statements, the management of James Skinner, LLC voted and approved in 2024 to merge the Plan into the SuccessWise Pooled Employer Plan (SuccessWise Plan) effective in December 2024. Our opinion has not been modified with respect to this matter.

1. Plan Description

The following brief description of The James Skinner Co. 401(k) Retirement Plan (the Plan) is provided for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan was a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan was established to provide retirement benefits for the employees of The James Skinner Co. (the Company). As of January 30, 2024, the shareholders of the Company approved a plan of entity conversion to convert all the issued and outstanding shares of The James Skinner Co. into a 100% membership interest in The James Skinner LLC.

Effective in 2024, the Company approved the Plan to be merged into a new plan called the SuccessWise Pooled Employer Plan (SuccessWise Plan). Principal Life Insurance Company (Principal) is the custodian of the SuccessWise Plan. The merger into the SuccessWise Plan initiated a "black out" period scheduled from November 22, 2024 to December 29, 2024. During the black out period, funds could not be applied to the employee selected funds or withdrawn from the Plan or the SuccessWise Plan until Principal had time to accurately complete the merger. Plan assets, including participant loans, of \$6,673,875 were transferred to the SuccessWise plan by December 2, 2024.

Employees were eligible to make salary deferral contributions and receive Company safe harbor matching and discretionary matching contributions upon reaching 18 years of age and completing three consecutive months of service. Eligible employees could enroll on the first day of the following month once their age and service requirements had been met.

Additionally, upon meeting the minimum service and age requirements participants were eligible on an annual basis to receive discretionary profit-sharing contributions upon completion of 1,000 hours of service and being employed on the last day of the plan year.

Contributions

Participating employees could make voluntary pre-tax and Roth after-tax salary deferral contributions up to the maximum dollar limits allowable by law. Participants could also contribute amounts representing distributions from other qualified plans.

The Plan was a safe harbor 401(k) Plan whereby the Company made safe harbor matching contributions equaled to 100% on the first 4% of a participant's eligible compensation for the periods ended December 2, 2024 and December 31, 2023. The Company could also make discretionary matching and discretionary profit-sharing contributions and discretionary non-elective contributions. No discretionary contributions were made during the periods ended December 2, 2024 and December 31, 2023.

All participants who were eligible to make deferral contributions and who attained age 50 before the close of the calendar year were eligible to make catch-up contributions. Contributions were subject to certain limitations.

Participant Accounts

Each participant's account was credited with the participant's contribution and an allocation of a) the Company's safe harbor matching contributions, b) the Company's discretionary matching, discretionary, profit-sharing contributions and discretionary non-elective contributions and c) Plan earnings or losses and c) an allocation of administrative expenses.

The Company's safe harbor matching contributions and discretionary matching contributions were allocated based on each eligible participant's elected salary deferral. The Company's discretionary profit-sharing contributions and discretionary non-elective contributions were allocated among participants based upon eligible compensation of participants. Plan earnings or losses were allocated on the basis of actual results of the investments selected by each participant. Investments were maintained in individual member accounts managed by United of Omaha Life Insurance Company (United of Omaha). In July 2024, Ascensus, LLC acquired United of Omaha, as a result the Plan appointed Matrix Trust Company (Matrix) as Custodian.

Vesting

Participants were immediately 100% vested in their contributions and Company contributions, plus actual earnings thereon.

Notes Receivable from Participants

Participants could borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes were secured by the balance in the participant's account and bore interest at rates which were commensurate with local prevailing rates. Principal and interest payments were made through payroll deductions.

Payment of Benefits

Upon termination, retirement, disability, or death, the participant or beneficiary could elect to receive either a lump sum or installment payments equal to the value of the vested funds allocated to the participant's account. Upon attainment of age 59 ½, a participant could withdraw all or a portion of the contributions made to the Plan in which they are 100% vested. The Plan required mandatory distribution payments between \$1,000 and \$5,000, which were directly rolled over to an individual retirement account designated by the plan administrator in the event the participant did not elect otherwise. Distributions under \$1,000 were paid to the participant in the event the participant did not elect a payout option. Benefits were recorded when paid.

Deposits with Insurance Company

The guaranteed investment accounts, which were part of the investment contract with United of Omaha, credited interest daily. The weighted average crediting interest rates during the period ended December 31, 2023 was 5.26%. The crediting interest rate was reset upon the maturity of the contract.

2. Summary of Significant Accounting Policies

A summary of the significant accounting policies consistently applied in the preparation of the accompanying financial statements is set forth below.

Basis of Presentation

The accompanying financial statements have been prepared on the accrual basis and in conformity with accounting principles generally accepted in the United States of America.

Presentation of Participant-Directed Funds

The Plan's presentation of participant-directed investments is in accordance with the Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 962, Plan Accounting – Defined Contribution Plans.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments, except for fully benefit responsive investment contracts, were reported at fair value. Fair value is the price that would be received to sell an investment in an orderly transaction between market participants at the measurement date. See Note 4 for further discussion of fair value measurements.

Fully benefit-responsive investment contracts were reported at contract value. Contract value was the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts because contract value was the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Company invested in investment contracts through a guaranteed interest account.

Purchases and sales of securities were recorded on a trade-date basis. Interest income was recorded on the accrual basis. Dividends were recorded on the ex-dividend date. Net appreciation included the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants were measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes were reclassified as distributions based upon the terms of the Plan document.

Expenses

Certain expenses of maintaining the Plan were paid directly by the Company and were excluded from these financial statements. Other fees specifically incurred or attributable to individual participants were paid from the applicable participant's account and included in administrative expenses. Investment related expenses were included in net appreciation in fair value of investments.

Risks and Uncertainties

The Plan invested in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Subsequent Events

Subsequent events are events or transactions that occur after the statement of net assets available for benefits date, but before the financial statements are available to be issued and may require potential recognition or disclosure in the financial statements. Management has considered such events or transactions through October 7, 2025, noting no items requiring disclosure.

3. Information Certified by United of Omaha and Matrix

The plan administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by United of Omaha/Matrix, except comparing such information certified by the custodian to information included in the Plan's financial statements and supplementary information.

4. Fair Value Measurements

FASB ASC 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 2, 2024 and December 31, 2023.

Pooled Separate Accounts: Valued at the Net Asset Value (NAV) of their underlying investments. FASB ASC 820, *Fair Value Measurement*, allows NAV per share to estimate the fair value as a practical expedient as long as certain requirements are met. It is the Plan's assessment that these accounts meet those requirements. Since the participants had the ability to redeem the amounts at NAV as of the measurement date on a daily basis. There were no unfunded commitments as of December 31, 2023.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

There were no Plan investments valued at fair value as of December 31, 2024.

** The Plan follows ASU 2015-07, therefore, investments measured at fair value using NAV per share (or its equivalent) as a practical expedient have not been classified in the fair value hierarchy above. The fair value amounts presented in the hierarchy tables for such investments were intended to permit reconciliation of the fair value hierarchy to the investments at fair value line item presented in the statements of net assets available for benefits.

5. Investment Contract with Insurance Company

The Plan had entered into an investment contract with United of Omaha and Matrix. United of Omaha and Matrix maintained the contributions in pooled separate accounts and a guaranteed interest account. The accounts were credited with earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by United of Omaha and Ascensus.

The pooled separate accounts, as reported to the Plan by United of Omaha and Matrix, were included in the financial statements at fair value, which represents contributions made under the contract, plus earnings, less withdrawals and administrative expenses.

As the guaranteed interest account was fully benefit-responsive, contract value was the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed interest account. Contract value, as reported to the Plan by United of Omaha and Matrix, represented contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants could ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive contracts was dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic developments. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

6. Tax Status

The Plan was a qualified profit-sharing Plan under Section 401(a) of the Internal Revenue Code and was exempt from federal income taxation under Section 501(a) of the Internal Revenue Code.

The plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, no provision for income taxes has been included in the financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

7. Related-Party Transactions

Certain Plan investments were pooled separate accounts and a guaranteed interest account managed by United of Omaha and Matrix. United of Omaha and Matrix were the custodians as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions.

Lutz
