REPORT OF INDEPENDENT AUDITORS

To the Retirement Plan Committee of the
Brock Enterprises, LLC 401(k) Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Brock Enterprises, LLC 401(k) Plan (the “Plan”), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (“ERISA”), as permitted by ERISA Section 103(a)(3)(C) (“ERISA Section 103(a)(3)(C) audit”). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan’s financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor’s (“DOL”) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (“investment information”) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL’s Rules and Regulations for Reporting and Disclosure under ERISA (“qualified institution”).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note E to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor’s Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (“GAAP”).
- The information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (“GAAS”). Our responsibilities under those standards are further described in the Auditor’s Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management’s election of the ERISA Section 103(a)(3)(C) audit does not affect management’s responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan’s ability to continue as a going concern for one year after the date that the financial statements are issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments, administering the Plan, and determining that the Plan’s transactions that are presented and disclosed in the financial statements are in conformity with the Plan’s provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor’s Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor’s report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audits, significant audit findings, and certain internal control-related matters that we identified during the audits.

Other Matter — Supplemental Schedules Required by ERISA

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

A. Description of the Plan

General

The following brief description of the Brock Enterprises, LLC 401(k) Plan (the “Plan”) is provided for general information purposes only. The Plan is sponsored by Brock Enterprises, LLC (the “Company”). Participants should refer to the Plan document for more complete information. The Company’s corporate offices are located in Houston, Texas.

The Plan was effective January 1, 1995, and most recently amended on May 25, 2021, and is a defined contribution plan available to substantially all employees of the Company, as well as employees of related employers, who have adopted the provisions of the Plan and who have completed sixty days of service, except leased employees, non-resident aliens, and those covered by a collective bargaining agreement (unless the agreements require that the employees participate in the Plan). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Effective April 15, 2023, the Aegion Energy Services, Inc. 401(k) Profit Sharing Plan (“AEG Plan”) merged into the Plan. As a result, a transfer from another plan in the amount of \$30,387,729 is recorded in the Plan’s financial statements during the year ended December 31, 2023.

The purpose of the Plan is to encourage the Company’s employees to save and invest, systematically, a portion of their current compensation so that they and their families may have a source of additional income upon their retirement, or in the event of death.

Contributions

Participants may contribute up to 100% of pre-tax annual compensation, as defined by the Plan. Contributions to the Plan are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code (the “Code”) as defined in the Plan document. Eligible participants may make rollover contributions to the Plan.

Participants who are eligible to make salary deferral contributions under the Plan and who have attained age 50 before the close of the year may make catch-up contributions in accordance with, and subject to, the limitations imposed by the Code.

The Company may make discretionary matching contributions to the Plan as determined annually by its management. The Company may also make discretionary non-elective contributions to the Plan determined annually by management and allocated to qualifying participants on a pro-rata basis based on eligible participant compensation. For the years ended December 31, 2024 and 2023, the Company made discretionary matching contributions at a rate of 50% up to 4% of participant contributions. No discretionary non-elective contributions were made by the Company during 2024 or 2023.

A. Description of the Plan – continued

Contributions – continued

The Company is also required to provide a 3% profit sharing contribution (“Profit Sharing Contribution”) to certain employees who are members of the Chicago & Midwest Regional Joint Board, Affiliated with Workers United/SEIU Union (“Union Employees”). Effective August 15, 2023, this requirement was amended to remove the Profit Sharing Contribution and allow the Union Employees to receive the discretionary matching contribution.

Participant Accounts

Each participant’s account is credited with the participant’s contributions, the Company’s contributions, and allocations of Plan earnings. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s account.

Vesting

Participants are immediately vested in their voluntary contributions and Profit Sharing Contributions plus actual earnings thereon. Vesting in the Company discretionary matching contribution and discretionary non-elective contribution portions of accounts, plus actual earnings thereon, is as follows:

Participants of the AEG Plan who received employer matching contributions and fixed profit sharing and discretionary nonelective contributions (collectively “Prior Employer Contributions”) prior to the plan merger on April 15, 2023, will vest in the Prior Employer Contributions, plus actual earnings thereon, as follows:

In the event of disability, early retirement, or death, the participant will become fully vested.

Notes Receivable from Participants

Beginning January 1, 2009, the Plan no longer permitted loans. Prior to January 1, 2009, participants were permitted to borrow from their accounts a minimum of \$500 up to a maximum amount equal to the lesser of \$50,000 or 50% of their account balances. Loan terms range up to five years, or longer for the purchase of a primary residence. Any loan not repaid within the loan term will be considered in default and will become a taxable distribution to the participant. The loans are secured by the balances in the participants' accounts and bear interest at a rate commensurate with local prevailing rates as determined by the Company. Principal and interest are paid ratably through payroll deductions.

During the year ended December 31, 2023, notes receivable from participants of approximately \$597,000 were transferred into the Plan from the AEG Plan. Interest rates on participant loans range from 4.25% to 9.25% for the years ended December 31, 2024 and 2023.

Benefit Payments

Participants withdrawing during the year for reasons of service or disability, retirement, death, or termination are entitled to their vested account balances. Benefits are distributed in the form of rollovers or lump-sum payments. If withdrawing participants are not entitled to their entire account balances, the amounts not received are forfeited.

Certain in-service withdrawals are allowed. A participant may also elect to withdraw all or a portion of his/her vested account balance while employed after reaching age 59 ½. A participant may receive a hardship distribution from salary reduction contributions, employer matching contributions, Profit Sharing Contributions, and employer non-elective contributions if the distribution is: (1) on account of uninsured medical expenses incurred by the participant, his/her spouse or dependents; (2) to purchase (excluding mortgage payments) a principal residence of the participant; (3) for the payment of post-secondary tuition expenses; (4) needed to prevent eviction of the participant from his/her principal residence or foreclosure upon the mortgage of the participant's principal residence; (5) related to burial or funeral expenses for the participant's deceased parent, spouse, children, primary beneficiary, or dependents; (6) related to casualty losses to the participant's principal residence; or (7) expenses and losses incurred for the participant on account of a disaster declared by the Federal Emergency Management Agency.

Forfeitures

Forfeited balances of terminated participants' non-vested accounts are used to offset Plan expenses, offset employer matching contributions, and offset non-elective contributions for the year. Participants forfeited approximately \$293,000 and \$317,000, respectively, of non-vested account balances during the years ended December 31, 2024 and 2023. In 2024 and 2023, Plan expenses were reduced by forfeited balances by approximately \$102,000 and \$79,000, respectively. There were approximately \$207,000 and \$569,000 of forfeitures used to reduce Company contributions during the years ended December 31, 2024 and 2023, respectively. Unallocated forfeitures as of December 31, 2024 and 2023, were approximately \$83,000 and \$67,000, respectively.

A. Description of the Plan – continued

Investment Options

Upon enrollment in the Plan, a participant may direct his/her salary deferrals and any matching contributions in 1% increments into any of the Plan's investment options.

Plan Expenses

Employees of the Company perform certain administrative functions with no compensation from the Plan. In accordance with the Plan provisions, the Company pays costs relating to asset charges at the Company's discretion. Administrative expenses including recordkeeping, investment advisory, and other professional fees that are paid by the Plan are reflected in the accompanying financial statements.

B. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are presented on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of the financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from these estimates.

Contributions

Contributions from the Company and participants are accrued as they become obligations of the Company, as determined by the Plan's administrator, and in the period in which they are deducted, in accordance with salary deferral agreements.

Investment Valuation and Income

The investments of the Plan are stated at fair value (except for fully benefit-responsive investment contracts, which are reported at contract value) as of the end of the year and are subject to market or credit risks customarily associated with equity investments. Fair value measurements are determined in accordance with GAAP, which defines fair value, establishes a framework for measuring fair value, and expands disclosures about assets and liabilities measured at fair value. See Note C for information related to the Plan's valuation methodologies.

B. Summary of Significant Accounting Policies – continued

Investment Valuation and Income – continued

Investment gains and losses are accounted for using the average cost basis of the securities sold. The net realized and unrealized gains and losses on investments include realized gains and losses on sales of investments during the year and unrealized increases or decreases in the market value of investments held at year-end. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Notes Receivable from Participants

Notes receivable from participants are recorded at the unpaid principal balance plus accrued but unpaid interest.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the Code are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 excess contributions to the applicable participants prior to March 15, 2025.

Payment of Benefits

Benefits are recorded when paid.

C. Fair Value Measurements

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date and establishes a three-tier hierarchy that is used to identify assets and liabilities measured at fair value. The hierarchy focuses on the inputs used to measure fair value and requires that the lowest level input be used. The three levels defined are as follows:

- Level 1 — observable inputs that are based upon quoted market prices for identical assets or liabilities within active markets.
- Level 2 — observable inputs other than Level 1 that are based upon quoted market prices for similar assets or liabilities, based upon quoted prices within inactive markets, or inputs other than quoted market prices that are observable through market data for substantially the full term of the asset or liability.
- Level 3 — inputs that are unobservable for the particular asset or liability due to little or no market activity and are significant to the fair value of the asset or liability. These inputs reflect assumptions that market participants would use when valuing the particular asset or liability.

C. Fair Value Measurements – continued

The methodologies used to measure the fair value of the Plan’s investments are as follows:

- Mutual funds are measured using quoted market prices available on an active market and classified within Level 1 of the valuation hierarchy.
- The Invesco Stable Value Common Trust Fund, a common collective trust, is measured using the fair value reported by the Plan’s third-party trustee and is classified within Level 2 of the valuation hierarchy as of December 31, 2023. As of December 31, 2024, this investment was fully liquidated. Additionally, the common collective trust is composed primarily of fully benefit-responsive investment contracts and is valued at the daily published net asset value (“NAV”) of \$1.00 per unit of the common collective trust. There are no significant restrictions on redeeming this investment at NAV.
- The Plan holds investment funds that are common collective trusts and are measured using NAV (or equivalent) as a practical expedient to determine the fair value. This practical expedient would not be used if it is determined to be probable that the funds would sell the investments for an amount different from the reported NAV. These funds are excluded from the valuation hierarchy as of December 31, 2024. Additionally, the common collective trusts are valued based on the fair value of the underlying investments held by the fund less their liabilities. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months’ notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

There were no changes in the methodologies used at December 31, 2024. The Plan has no investments classified within Level 3 of the valuation hierarchy.

D. Fully Benefit-Responsive Investment Contract

The insurance company general account is a guaranteed income account classified as a traditional investment contract. The contract is based on insurance contracts and is credited with Plan contributions and earnings on the underlying investments and charged for Plan withdrawals and administrative expenses charged by Prudential Retirement Insurance and Annuity Company. The contract meets the fully benefit-responsive investment contract criteria and, therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals and administrative expenses. The contract value of the traditional investment contract was \$5,769,533 and \$5,063,725 as of December 31, 2024 and 2023, respectively.

The key difference between a synthetic investment contract and a traditional investment contract is that the plan owns the underlying assets of the synthetic investment contract. A synthetic investment contract includes a wrap contract, which is an agreement for the wrap issuer, such as a bank or insurance company, to make payments to the plan in certain circumstances. The wrap contract typically includes certain conditions and limitations on the underlying assets owed by the plan. With traditional investment contracts, the plan owns only the contract itself. Synthetic and traditional investment contracts are designed to accrue interest based on crediting rates established by the contract issuers. There are no synthetic investment contracts held by the Plan.

The contract issuer is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract cannot be terminated before the scheduled maturity date.

No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also limit the ability of the Plan to transact at contract value with the participants.

E. Certified Investments

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedules, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net realized and unrealized gains on investments, interest and dividends, and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained by management and agreed to or derived from information certified as complete and accurate by Fidelity Management Trust Company, (the trustee of the Plan).

F. Tax Status

The Plan has adopted the Volume Submitter Plan, which has received a favorable advisory letter from the Internal Revenue Service (“IRS”) dated June 30, 2020. This advisory letter states that the form of the plan is acceptable under Section 401 of the Code. The Company may rely on this letter with respect to the qualification of the Plan under Code Section 401(a) with certain limitations.

Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualification. The plan administrator believes that the Plan is being operated in compliance with the applicable requirements of the Code and, therefore, believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

Plan management evaluates tax positions taken by the Plan and recognizes a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The plan administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

G. Plan Termination

Although it has not expressed any intention to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions set forth in ERISA. In the event the Plan terminates, all amounts credited to participants’ accounts will become 100% vested.

H. Party-in-Interest Transactions

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee organization, or relatives of such persons.

Plan participants have the option of selecting investments offered by affiliates of the trustee. Transactions in such investments, as well as loans made to participants, qualify as party-in-interest transactions, which are exempt from the prohibited transaction rules. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are party-in-interest transactions under ERISA which are exempt from the prohibited transaction rules.

I. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

J. Subsequent Events

In preparing the accompanying financial statements, management of the Plan has evaluated all subsequent events and transactions for potential recognition or disclosure through October 9, 2025, the date the financial statements were available for issuance.
