Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.

Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Allyn International Services, Inc. 401(k) Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.



NOTE A – PLAN DESCRIPTION

The following brief description of Allyn International Services, Inc. (“the Company”) 401(k) Plan (“the Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General

The Plan is a defined contribution plan covering all employees of the Company excluding interns. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

Each year, participants may contribute a percentage of pretax and/or after-tax annual compensation, subject to IRS regulations, as defined in the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. The Company makes a matching contribution equal to 100% of an eligible participant’s deferrals that do not exceed 3% of their compensation plus 50% of an eligible participant’s deferrals between 3% and 5% of participant compensation.

Participant Accounts

Each participant's account is credited with the participant’s contribution and allocations of employer contributions and Plan earnings (losses) and charged with an allocation of administrative expenses. Allocations are based on participant account balances, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are immediately vested in their contributions and employer discretionary profit-sharing contributions, and all “Safe Harbor” matching contributions, plus actual earnings, thereon. Vesting in the Company’s matching contributions is based on a six-year graded vesting schedule.

Forfeited Accounts

Forfeitures may be used to pay Plan expenses, allocated as additional employer contributions or used to reduce other employer contributions under the Plan. Forfeitures used to reduce Company contributions for the years ended December 31, 2024 and 2023 were \$5,846 and \$2,720, respectively. At December 31, 2024 and 2023, there were no non-vested forfeitures held in the Plan.

Benefit Payments

Benefits are recorded when paid. On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in her or his account or annual installments. For termination of service due to other reasons, a participant may receive the value of the vested interest in her or his account as a lump-sum distribution.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared using the accrual method of accounting in accordance with U.S. generally accepted accounting principles (GAAP).

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value except for fully benefit-responsive contracts which are valued at contract value. Fair value is the price that would be received to sell an asset in an orderly transaction between market participants at the measurement date. The units of pooled separate accounts are stated at fair value as determined by the issuer of the account based on the net asset value of the underlying investments, as a practical expedient. The Plan's insurance account is valued at contract value, which is equal to fair value.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits of a defined contribution plan attributable to fully benefit-responsive investment contracts. The contract value is the relevant measurement since it represents the amount that the participant would receive if they were to initiate permitted withdrawal transactions under the terms of the plan.

The Plan presents in the statement of changes in net assets available for benefits, the net appreciation (depreciation) in the fair value of its investments, which consists of realized gains or loss and unrealized appreciation (depreciation) on those investments. Purchases and sales of securities are recorded on a trade-date basis. Gains or losses on sales of investments are determined by specific identification method. Interest income is recorded as earned on an accrual basis. Dividends are recorded on ex-dividend date.

NOTE B – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

Plan Administrative Costs

Direct Plan expenses such as trustee, recordkeeping, and investment management fees and certain administrative expenses are paid from Plan assets. For the plan year ended 2024 and 2023, management fees and operating expenses charged to the Plan for benefits paid and investments in pooled separate accounts and investment contracts are deducted from income earned on a daily basis and not separately charged to an expense. Consequently, management fees and operating expenses are reflected as a reduction of benefits paid and investment return for such investments. Other administrative costs such as auditing fees are paid by the Sponsor.

Payment of Benefits

Benefits are recorded when paid.

Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from those estimates.

Uncertain Tax Positions

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax asset or liability if the plan has taken an uncertain position that more-likely-than-not would not be sustained upon examination by the Internal Revenue Service. The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a tax asset or liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any open tax periods.

Date of Management's Review

The Plan's management has evaluated subsequent events through October 9, 2025, the date which the financial statements were available to be issued.

NOTE D – FAIR VALUE MEASUREMENTS (UNAUDITED)

Financial Accounting Standards Codification (ASC) 820-10-50, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value.

The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under ASC 820-10-50 are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset’s or liability’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value.

Pooled separate accounts (“PSAs”): The PSAs are valued using net asset value (“NAV”) of units held by the Plan at year end. The NAV is used as a practical expedient to estimate fair value. Participant transactions (purchases and sales) may occur daily.

The following table summarizes investments for which fair value is measured using the NAV per share practical expedient as of December 31, 2024 and 2023, respectively.

NOTE E – INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan entered into a traditional fully benefit-responsive investment contract with TRLIC which maintains the contributions in a fixed income account which is part of TRLIC’s general account. The account is subject to the claims of TRLIC’s general creditors.

The contract is included in the financial statements at contract value as reported to the Plan by TRLIC. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value. However, under certain conditions, transfers from the fixed income account may be limited or deferred, and distributions may be subject to a market value adjustment. The investment contract issuer guarantees a minimum rate of interest subject to TRLIC’s claims paying ability. The accounts fair value reported by insurance company is \$962,989 and \$930,634 at December 31, 2024 and 2023, respectively.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with the issuer but may not be less than 3%. Such interest rates are reviewed on a quarterly basis for resetting. The crediting rate as of December 31, 2024 and 2023 was 3%.

NOTE F – INCOME TAX STATUS

The Internal Revenue Service has determined and informed the Plan Sponsor by a letter dated June 7, 2021, that the Plan and related trust are designed in accordance with the applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the advisory opinion, the plan administrator believes the plan is designed and currently being operated in compliance with the applicable requirements of the IRC and, therefore, believe the Plan is qualified, and the related trust is tax-exempt.

NOTE G – FIDELITY BOND COVERAGE

In order to maintain compliance with ERISA rules regarding bond coverage the Plan is covered by a fidelity bond. The bond is current, and the amount of coverage is in excess of ten percent of the total assets of the Plan.

NOTE H – PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA.

NOTE I – RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST

ERISA prohibits plans from engaging in specific transactions with parties-in-interest because of the potential of abuse. These transactions are called prohibited transactions. The Company is not aware of any prohibited transactions related to the Plan for December 31, 2024 and 2023, respectively.

An officer of the company currently participates in the Plan and serves as the trustee and plan administrator. No officer or employee receives compensation from the Plan.

Certain Plan investments represent shares of pooled separate accounts managed by TRLIC. Empower is a current service provider of the Plan and Merrill Lynch Pierce Fenner Smith is an investment advisor, and therefore these transactions qualify as party-in-interest transactions. Contract administration and advisory fees paid by the Plan were \$73,880 and \$62,684 for the years ended December 2024 and 2023, respectively.

NOTE J – RISKS AND UNCERTAINTIES

Investments

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants account balances and the amounts reported in the statements of net assets available for benefits.
