Scope and Nature of the ERISA Section 103(a)(3)(C) Audit of the 2024 Financial Statements

We have performed an audit of the financial statements of Hoover Group, Inc. Employee's Profit Sharing and Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ("ERISA Section 103(a)(3)(C) audit"). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year then ended, and the related notes to the financial statements.

1. DESCRIPTION OF THE PLAN

The following description of Hoover Group, Inc. Employee's Profit Sharing and Savings Plan ("Plan") provides only general information. Participants should refer to the legal plan document for a more complete description of the Plan's provisions.

General

The Plan established effective January 1, 1986, with its latest amendment effective July 1, 2023, is a defined contribution plan generally covering all employees of Hoover Group, Inc. and participating employers as defined in the Plan Document (collectively the "Company" or "Employer"). Principal Trust Company (the "Trustee" or "Principal") serves as the trustee of the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA"), as amended.

Eligibility and Service

The Plan allows participation upon employment to generally all employees except those specifically excluded in the Plan document. The Plan has an automatic enrollment feature for all newly eligible employees starting at 5% of eligible compensation unless the employee affirmatively elects otherwise. The Plan also provides for an automatic 1% annual increase in the deferral rate, up to a maximum 6%, for all participants who have been automatically enrolled in the Plan unless the participant affirmatively elects otherwise.

Participant and Employer Contributions

The Plan provides for voluntary pre-tax and after-tax participant contributions expressed as a percentage of the participant's eligible compensation, as defined, up to the maximum amount allowed by law. The contributions are not to exceed the limits set by the Internal Revenue Code (the "IRC"), which limits the annual amount of salary deferrals that may be made by any participant. Eligible participants may also make catch-up contributions upon attaining 50 years of age, as defined by the IRC.

The Company has elected to make safe harbor matching contributions under the Plan. The Company will make a matching contribution on behalf of each participant in the amount equal to 100% of the employee's elective deferrals that do not exceed 5% of the employee's eligible compensation, as defined for the Plan year.

The Company may also make discretionary match and profit-sharing contributions, in addition to any safe harbor matching contributions (allocated to eligible employees whether or not the employee makes a contribution). The Company did not make any discretionary matching or profit-sharing contributions during 2024.

Participant and employer contributions are presented net of returned excess contributions paid to certain active participants or forfeited in order to satisfy the relevant nondiscrimination provisions of the Plan. During the year ended December 31, 2024, there were no excess contributions that were refunded.

Participant Accounts

Each participant's account is credited with the participant's contribution, an allocation of the Employer's contributions, Plan earnings and losses, and administrative expenses. Allocations are based on participant compensation and account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account balance.

Vesting

Participants are 100% vested at all times in their voluntary contributions and discretionary matching contributions. Safe harbor contributions are 100% vested after participants attain two years of service with the Company. Each participant whose employment terminated for reasons other than death, disability, attainment of normal or early retirement age, is entitled to a nonforfeitable right to his or her employer discretionary profit-sharing contribution account based on a graded vesting schedule.

Discretionary profit-sharing contributions become vested based on years of service as follows:

Forfeitures

Upon termination of service, a participant's vested account balance will be distributed to the participant or directly rolled into other qualified plans depending on the status of the original contribution and participant direction. The unvested amount is forfeited and maintained in the forfeiture cash account and will be used to reduce future employer contributions payable in accordance with Plan provisions. Total forfeitures used to reduce employer contributions were \$44,130 for the year ended December 31, 2024. As of December 31, 2024 and 2023, there were \$67,945 and \$36,629, respectively, of forfeitures available for use.

Investment Options

Plan participants can direct the investment of their account balances into any or all of the investment options available under the Plan. Participants can change their investment allocation among the various investment options either through direct transfer from one option to another or by changing the percentage allocation of future contributions.

Administrative Expenses

All administrative expenses, unless paid by the Company, are paid by the Plan.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 and a maximum equal to the lesser of \$50,000 reduced by the highest outstanding note receivable balance in the participant's account during the prior 12-month period or 50% of the participant's vested account balances. Additionally, a participant may not have more than one note receivable outstanding at any time. Each note receivable under the Plan must mature within five years from the date on which it was made unless the note receivable is used to acquire a principal residence, in which case the note receivable may permit a longer repayment term. The notes receivable are secured by the balance in the participants' accounts and bear interest at a rate commensurate with similar types of loans by other lenders as determined by the Plan administrator.

Distributions to Participants

Participants are eligible for distributions of their vested account balances upon the event of death, disability, retirement, termination of employment, or other reasons.

Distributions may be made in a lump-sum payment or in substantially equal installments. If the vested balance of the participant's account is more than \$1,000 but less than \$5,000, and no election is made, the amount will be automatically rolled over into an individual retirement account established on behalf of the participant. The payment will be made in a single lump-sum payment. Any taxable distribution paid directly to the participant will be subject to mandatory federal income tax withholding of 20% of the requested distribution.

Plan Termination

Although it has not expressed any intent to do so, management of the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants become fully vested and the net assets of the Plan are to be distributed to participants.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("GAAP").

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America ("GAAP") requires the Company to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Unrealized appreciation or depreciation in the fair value of investments held at year-end is determined using the fair value at the beginning of the year or the purchase price if the investment is acquired during the year. The realized gain or loss on the sale of investments is determined using historical cost. Upon the sale of an investment, the current year unrealized appreciation or depreciation is adjusted for unrealized gains and losses recognized in prior years. Unrealized appreciation or depreciation along with realized gains and losses are reported as net appreciation or depreciation in fair value of investments in the statement of changes in net assets available for benefits.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants, if any, are reclassified as distributions based upon terms of the Plan Document.

Financial Instruments and Credit Risk

Financial instruments which are potentially subject to credit risk include investments in money market funds, mutual funds, and common/collective trusts. Investments are exposed to various risks, such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and those changes could materially affect the amounts reported in the statements of net assets available for benefits. Plan participants bear the risk of any investment losses.

Distributions to Participants

Distributions are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through October 6, 2025, which was the date the financial statements were available to be issued.

3. CERTIFIED INVESTMENTS

For 2024 and 2023, the financial information included in the Plan financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held as of December 31, 2024 and 2023, net appreciation in value fair of investments and interest on notes receivable from participants for the year ended December 31, 2024, was obtained by the Company and agreed to or derived from information certified as complete and accurate by Principal in accordance with Section 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for reporting and Disclosure under ERISA.

4. FAIR VALUE INVESTMENTS

The Plan uses a three-level hierarchy for disclosure of fair value measurements of its assets and liabilities, depending on the observability of the inputs employed in the measurement. The hierarchy of fair value measurements is described below:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices in active markets for similar assets or liabilities, quoted prices for identical or similar assets or liabilities in markets that are not active, or other inputs that are observable or can be corroborated by observable market data for substantially the full term of these assets or liabilities.

Level 3 - Inputs that are supported by little or no market activity and that are significant to the fair value of the assets or liabilities.

The fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value:

Money market funds - Valued at the daily closing price as reported by the fund. The money market fund is an open-end mutual fund that is registered with the Securities and Exchange Commission ("SEC"). This fund is required to publish its daily net asset value and to transact at that price. The money market fund is deemed to be actively traded.

Mutual funds - Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/collective trusts - these investments are valued at the net asset value ("NAV") of the fund. The NAV is calculated by the fund based on "net assets" which includes fully benefit-responsive investment contracts at contract value comingled with other investments. This NAV represents the Plan's fair value since this is the amount at which the Plan transacts with the fund. The NAV, as provided by the Trustee, is used as a practical expedient to estimate fair value for the common/collective trust. The investment can be redeemed daily with no prescribed redemption notice period and has no unfunded commitments.

Pooled separate accounts - Valued at NAV of units held. The NAV is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the account less its liability. This practical expedient is not used when it is determined to be probable that the account will sell the investment for an amount different than the reported NAV.

5. TAX STATUS

The prototype plan adopted by the Company received its latest opinion letter dated June 30, 2020, in which the Internal Revenue Service stated that the plan, as then designed, was in compliance with applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

GAAP requires Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. RELATED PARTY TRANSACTION AND PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are managed by Principal. Principal is the trustee for the Plan and, therefore, these transactions qualify as party-in-interest transactions. In addition, the Plan provides for notes receivable from participants, which are party-in-interest transactions that are exempt from the prohibited transaction rules.
