## 1. Description of Plan

The following brief description of the KAAPA Ethanol Holdings, LLC 401(k) & Profit Sharing Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

### **General**

The Plan is a defined contribution plan covering eligible employees who are not non resident aliens or not subject to a collective bargaining agreement of KAAPA Ethanol Holdings, LLC and subsidiaries (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA"), and the Internal Revenue Code ("IRC").

### **Plan Operations**

The Company is the Plan sponsor and administrator of the Plan. Effective July 15, 2024, the Plan changed from Ascensus Trust Company, who was the Plan's trustee, recordkeeper and custodian, to John Hancock Trust Company LLC, who is now the Plan's trustee, recordkeeper and custodian (the "Custodian" or "Trustee"). On July 24, 2024, the majority of the assets were transferred to John Hancock Trust Company LLC from Ascensus Trust Company.

### **Eligibility**

Full-time employees are eligible to participate in the Plan after completing three consecutive months of service with at least 400 hours from their date of hire. Temporary, seasonal or part-time employees are eligible to participate in the Plan after completing one year of service with at least 1000 hours from their date of hire. Eligible employees may enter the Plan quarterly on January 1, April 1, July 1, and October 1, if eligibility requirements are met, or on the date when the eligibility requirements are met as defined by the Plan.

### **Contributions**

Participants may contribute up to 100 percent of their annual earnings to the Plan, as defined by the Plan, subject to the IRC limitations. Participants may roll over amounts representing distributions from other qualified plans into the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions

The Plan makes a safe harbor contribution to the individual account of each eligible employee based on the contributing participant's elective deferral percentage. The safe harbor contribution is a match of 100% of the first 3% of salary deferral plus 50% of the next 2% of salary deferral.

The Plan, at its discretion, may annually contribute a percentage of each participant's pre-tax annual base compensation in the form of profit sharing contributions. The Plan did not contribute any profit sharing contributions for the year ended December 31, 2024. Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

### **Participant Accounts**

Each participant's account is credited with the participant's contribution, the Plan's Safe Harbor contribution and the allocation of Plan earnings or losses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out by the Company.

### **Vesting**

Participants are immediately vested in their voluntary contributions plus actual earnings thereon. Participants are also immediately vested in the Employer Safe Harbor contribution. Employer profit sharing contributions and matching contributions are subject to a graded vesting schedule and are fully vested after six years of service.

## 1. Description of Plan (Continued)

### **Forfeited Accounts**

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is used to reduce future Employer contributions to the Plan. Forfeiture amounts totaled \$2,040 and \$12,630 as of December 31, 2024 and 2023, respectively. Forfeitures of \$12,630 were used during the year ended December 31, 2024.

### **Investment Allocation**

Assets of the Plan are held in various funds as determined by the Plan. All accounts are participant directed. Participants may change their investment allocation daily.

### **Notes Receivable From Participants**

Participants are permitted to borrow up to 50% of their vested account balance with a minimum of \$1,000 up to a maximum loan amount of \$50,000 or one-half of the participant's vested balance in the Plan, whichever is less. Two loans may be outstanding at any given time per participant. The notes are secured by at least 50% of the participant's vested account balance and bear interest at a rate commensurate with the prime rate as used by the Wall Street Journal adjusted by 1% as is determined on the date the loan is disbursed. Principal and interest payments are paid ratably through payroll deductions. Loan terms can range up to five years but can be longer if the loan is used to finance the purchase of a primary residence.

### **Payment of Benefits**

Benefits may be withdrawn from the Plan upon termination of service due to death, disability, retirement, or termination of employment. A participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. The distribution will be in the form of a lump-sum payment if the participant's vested benefit is \$1,000 or less, unless the participant timely elects a direct rollover of the vested account balance. Pre-retirement distributions are allowed under the Plan after attaining the age of 59 1/2. A participant may withdraw any contributions that were rolled into the Plan at any time. Hardship withdrawals, as defined in the Plan document, are allowed for pre-tax elective deferrals. Certain mandatory distribution provisions may apply for smaller account balances of terminated employees. Benefit payments are recorded when paid.

## 2. Summary of Significant Accounting Policies

### **Basis of Accounting**

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

### **Accounting Estimates**

The preparation of the Plan's financial statements in conformity with U.S. GAAP requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the changes in net assets available for benefits during the reporting period, and the changes therein, and, when applicable, the disclosure of contingent assets and liabilities at the date of the financial statements. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

#### **Investment Valuation and Income Recognition**

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year, are presented in the net appreciation in fair value of investments, in the accompanying statement of changes in net assets available for benefits.

#### **Administrative Expenses**

Substantially all administrative expenses are paid by the Company. Investment transaction fees are paid by the Plan.

#### **Notes Receivable from Participants**

Notes receivable from participants are valued at their unpaid principal balance plus any accrued but unpaid interest. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 or 2023.

#### **Fair Value of Financial Instruments**

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds are valued at the net asset value (quoted prices) of shares held by the Plan at year end.

Common collective trusts are valued using the net asset value (NAV) as a practical expedient to fair value of the units held by the Plan at year end.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through October 9, 2025, the date which the financial statements were available to be issued.

The Plan Administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Plan's Trustees have certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value, and notes receivable from participants as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023;
- Investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024;

### 5. Party-In-Interest Transactions

Certain Plan investments are shares of mutual funds and the common/collective trust fund, and are managed by the Trustees. Therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services amounted to approximately \$17,000 for the year ended December 31, 2024.

Notes receivable from participants qualify as party-in-interest transactions. However, the ERISA regulations provide an exemption for such transactions.

### 6. Tax Status

The Plan obtained its latest determination letter on June 30, 2020 in which the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the IRC. The Plan was amended since the plan received the opinion letter. However, the Plan's Administrator and the Plan's tax counsel believe the Plan is currently designed and operated in compliance with the applicable requirements of the IRC.

The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

### 7. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the statements of net assets available for benefits.
