Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of LVC Companies, Inc. 401(k) Retirement Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. 1. Description of Plan

The following brief description of the LVC Companies, Inc. 401(k) Retirement Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

The Plan is a defined contribution plan subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended ("ERISA") and the Internal Revenue Code ("IRC"). The Plan was established on April 1, 1996 and amended in its entirety February 18, 2022. LVC Companies, Inc. (the "Company" and the "Employer") is the Plan Sponsor and Plan Administrator. The trustee is the chief executive officer of the Company.

Eligibility

Substantially all non-union employees who have reached 18 years of age are eligible to participate in the Plan. Eligible employees may enter the Plan on the first day of the next month following their date of hire.

Contributions

Participants may contribute up to 100 percent of their annual earnings to the Plan, as defined by the Plan. Participants who attain age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows participants to designate contributions as Roth 401(k) contributions. Participants may rollover amounts representing distributions from other qualified plans into the Plan.

The Company, at its discretion, may annually contribute a percentage of each participant's pre-tax annual base compensation as a qualified nonelective contribution. There was no Company discretionary contribution for the year ended December 31, 2024 and 2023.

Contributions are subject to a compensation ceiling and annual limitations prescribed by the IRC.

Participant Accounts

Each participant's account is credited with the participant's contribution, discretionary Company contribution, and the allocation of Plan earnings; each participant account is charged an allocation of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Certain expenses and administrative costs incurred in connection with the general administration of the Plan are paid out of Plan assets.

Vesting

Participants are immediately vested in their voluntary contributions, rollover contributions and employer contributions, plus actual earnings thereon.

Payment of Benefits

On termination of service due to death, disability, retirement or termination of employment, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account. A terminated employee with a vested balance of \$5,000 or less will be automatically paid out by the Plan upon termination. A terminated participant with a vested balance between \$1,000 and \$5,000 will have their balances automatically rolled into a qualified Individual Retirement Account. A terminated participant with a vested balance of \$1,000 or less will have their balances automatically paid out in a lump sum distribution.

Distributions may be made at the participant's election prior to termination, upon attainment of age 59½, or due to hardship as defined in the Plan Document.

1. Description of Plan (Continued)

Transfer of Assets

The Company is also the plan sponsor of the LVC Employee Stock Ownership Plan ("ESOP Plan"). Diversification is offered through the ESOP Plan for participants that are close to retirement so they may have the opportunity to move part of the value of their investment in Company stock into investments, which are more diversified. Participants who elect to diversify may roll over funds into the Plan. These amounts are reflected as transfer of assets from LVC Employee Stock Ownership Plan on the Statements of Net Assets Available for Benefits and may result in receivables from LVC Employee Stock Ownership Plan if the diversification rollover is not received by the Plan until after the year in which the distribution was made out of the ESOP Plan.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

Accounting Estimates

Management uses estimates and assumptions in preparing these financial statements in accordance with US GAAP. Those estimates and assumptions affect the reported amounts of assets and liabilities, and the changes therein, and the disclosure of contingent assets and liabilities. The most significant estimate relates to the valuation of investments. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments in registered investment companies - mutual funds, common collective trusts, and pooled separate accounts are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction (that is, not a forced liquidation or distressed sale) between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

Realized gains and losses on investments bought and sold during the year, as well as unrealized gains and losses on investments held during the year are presented in the net appreciation in fair value of investments.

Fixed Income Guaranteed Option

In accordance with generally accepted accounting principles, investment contracts held by a defined contribution plan are required to be reported at contract value. Contract value is the relevant measurement because contract value is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. The Plan invests in the Principal Fixed Income Guaranteed Option which is a guaranteed general account backed group annuity contract that has been issued by Principal Life Insurance Company to Principal Trust Company as custodian.

The contract is included in the financial statements at contract value as reported to the Plan by the custodian. Contract value represents contributions made under contract, plus earnings, less participant withdrawals. Participants may ordinarily direct the withdrawal or transfer or all or a portion of the investment at contract value. There is no reserve against contract value for credit risk of the contract issuer or otherwise.

The composite credit rating contractually guaranteed by Principal Life Insurance Company is credited to account balances. The net credit rate is after the deduction of .45% for fees for administrative and recordkeeping services. At December 31, 2024 and 2023, the net credit rates are 4.85% and 6.05% effective annual rates, respectively. That rate is reset semiannually.

The Plan's ability to execute transaction at contract value is limited in certain circumstances as detailed in the agreement. These circumstances include the termination of the Plan's interest in the Principal Fixed Income Guaranteed Option. The Plan Administrator does not believe that events which would limit the plan's ability to transact at contract value with participants are probable of occurring.

Notes Receivable From Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. Delinquent notes receivable from participants are reclassified as distributions based upon the terms of the Plan document. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. At December 31, 2024 and 2023, the notes bear interest from 5.25% to 10.50% and 5.25% to 9.75%, respectively, which are commensurate with the prevailing interest rates. These notes receivable mature at various dates through September 2029.

Payment of Benefits

Benefit payments are recorded when paid.

Contributions

Participant contributions are recorded in the period the employer makes the payroll deductions. Discretionary nonelective contributions are recorded for the period the Board of Directors authorizes the nonelective contribution.

Administrative Expenses

The Plan's expenses are paid by either the Plan or the Company, as provided by the Plan document. Expenses that are paid directly by the Company are excluded from these financial statements. Certain expenses incurred in connection with the general administration of the Plan that are paid by the Plan are recorded as deductions in the accompanying statement of changes in net assets available for benefits. In addition, certain investment related expenses are included in net depreciation of fair value of investments presented in the accompanying statement of changes in net assets available for benefits.

Fair Value of Financial Instruments

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Company at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

Fair Value of Financial Instruments (Continued)

The level in the fair value hierarchy within which a fair measurement in its entirety falls is based on the lowest level input that is significant to the fair value measurement in its entirety. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Registered Investment Companies – Mutual Funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-ended mutual funds that are registered with the Securities and Exchange Commissions. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trusts – Valued at fair value as reported by the investment manager at year-end, using net asset value (NAV) as a practical expedient. The NAV is based on the fair value of the underlying securities, minus liabilities, and then divided by the number of units held by the Plan at year-end. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV.

Pooled Separate Accounts – Valued at fair value as reported by the investment manager at year-end, using NAV as a practical expedient. The NAV is based on the fair value of the underlying securities, minus liabilities, and then divided by the number of units held by the Plan at year-end. The practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant redemptions can be transacted daily with a one day redemption notice period. There are no unfunded commitments related to these accounts.

The Plan Administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodians, and other third parties.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Subsequent Events

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through October 9, 2025, the date which the financial statements were available to be issued.

Accordingly, the custodian, Principal Trust Company, has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

- Investments, at fair value and contract value, and notes receivable from participants, as shown in the accompanying statements of net assets available for benefits as of December 31, 2024 and 2023.
- Net investment appreciation, dividend income, and interest income on notes receivable from participants, as shown in the statements of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Line 4i – Schedule of Assets (Held at End of Year) as of December 31, 2024.

At the direction of the Plan Administrator, the Plan's independent accountant did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

5. Tax Status

The Plan uses a pre-approved plan document sponsored by Principal Life Insurance Company, which obtained its latest determination letter on June 30, 2020, stating that the volume submitter profit sharing plan document satisfies the applicable provisions of the IRC. The Plan itself has not received a determination letter from the IRS. The Plan has been amended since receiving the opinion letter. However, the Plan's management believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income tax has been included in the Plan's financial statements.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain tax position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

6. Party-In-Interest Transactions

Certain Plan investments are shares of pooled separate accounts and common/collective trusts managed by Principal Trust Company, and a fixed income guaranteed option (Note 1). Principal Trust Company is the custodian of the Plan; therefore, these are party-in-interest transactions. The Plan paid certain expenses related to Plan operations and investment activity to various service providers. These transactions are exempt party-in-interest transactions under ERISA.

7. Risks and Uncertainties

The Plan invests in various investment securities. The Plan's investments are exposed to various risk factors, such as interest rates, market conditions and credit risk. Due to the level of risk associated with certain investments and the level of uncertainty related to changes in the value of investment securities, it is possible that changes in risk factors in the near term could materially affect the amounts reported in the financial statements.

8. Plan Termination

Although the Company has not expressed any intent to do so, it has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become fully vested in their Employer contributions, and the Plan assets will be distributed according to the provisions of the Plan documents.
