### NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

#### NOTE A - DESCRIPTION OF PLAN

The following description of the Equix Holdings, Inc. 401(k) Retirement Savings Plan (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering all eligible nonunion employees of Equix Holdings, Inc., including its subsidiaries, Mi-Tech Services, Inc., Equix Integrity, Inc. Equix Energy Services, LLC, Equix Energy, Inc., Equix Integrity Southeast, Inc., Equix Broadband, Inc., Equix Infrastructure, Inc., Astra Group and Subsidiaries (Astra) and Equix Holdings, Inc. (collectively, the Employer). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA) and subsequent legislation.

Astra plan participant balances were transferred out of the Contractors Retirement Plan of which Astra was previously a participating employer. The Plan was amended to allow for the transfer of loans transferred from Contractors Retirement Plan. No new loans are allowed to be taken out by plan participants.

##### **Contributions**

Employees of the Company are eligible to participate in the Plan with elective deferrals and matching safe harbor contributions after attaining 90 days of employment. Participants may elect to make pretax and/or after-tax contributions as a percentage of their annual compensation, up to 75% of their compensation each year, not to exceed the maximum deferral limits of the Internal Revenue Code (IRC). These deferrals are specifically allocated to the account of the individual participant. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions to the Plan. Participants may also contribute amounts representing distributions from other qualified retirement plans or individual retirement accounts (rollovers).

In 2024 and 2023, the Company matched 100% of employee contributions up to 3% and 50% of employee contributions up to the next 2%. Matching contributions were made by the Employer at an amount equal to a discretionary percentage of the amount of participant's pretax contributions, as determined by the Employer.

##### **Participant Accounts**

Each participant's account is credited or charged with the participant's contribution and an allocation of (a) the Employer's discretionary matching contribution, (b) the Employer's discretionary profit-sharing contribution, (c) plan investment income (loss) and (d) plan administrative expenses. Allocations are based on participant compensation or account balances, as defined in the Plan agreement. The Plan allows participants to invest their account balances between or among separate investment funds established by the trustee within the trust.

The Plan does not allow loans to be taken out by plan participants and beneficiaries. The Plan was amended to allow the loan transfers from Contractors Retirement Plan.

##### **Vesting**

Participants are immediately vested in their voluntary contributions, including rollover amounts, as well as safe harbor matching contributions, plus actual earnings thereon. Employees of Astra, that were participants in Contractors Retirement Plan, maintain a four-year graded vesting schedule for prior and future employer accounts. Such vesting schedule will be as follows: one year of service is 25% vested, two years of service is 50% vesting, three years of service is 75% vested, and four years of service is 100% vested.

***Payment of Benefits***

Any benefits provided by the Plan are paid from the net assets available for benefits. The benefit to which a plan participant is entitled is the benefit that can be provided by the contributions and income thereon (including net realized and unrealized investment gains and losses) allocated to such participant's account. The method of distribution will be determined by an election made by the Plan participant. The participant can elect a lump-sum distribution or installment payments for a specified term as defined in the Plan agreement. Participants experiencing financial hardship may withdraw a portion of this account balance as defined by the Plan agreement.

***Forfeited Accounts***

Forfeited nonvested accounts from Employer contributions reduce non-elective contributions to the Plan. Forfeitures of terminated participants' nonvested account balances used to reduce Employer non-elective contributions and to pay Plan administrative expenses amounted to \$69,197 and \$61,371 for the years ended December 31, 2024 and 2023, respectively. At December 31, 2024 and 2023, the outstanding balance of forfeited nonvested accounts totaled \$0 and \$8,459, respectively.

**NOTE B - SUMMARY OF ACCOUNTING POLICIES**

The significant accounting policies which have been consistently applied in the preparation of the accompanying financial statements follow:

***Basis of Accounting***

The financial statements of the Plan are prepared using the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note F for discussion of fair value measurements.

Purchases and sales are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

***Use of Estimates***

In preparing financial statements in conformity with accounting principles generally accepted in the United States of America (US GAAP), management is required to make estimates and assumptions that affect the reported amounts of assets and liabilities, the disclosure of contingent assets and liabilities at the date of the financial statements, and the reported amounts of additions to net assets and deductions from net assets during the reporting period. Actual results could differ from those estimates.

***Payment of Benefits***

Benefits are recorded when paid.

***Expenses***

Certain plan administrative expenses are paid by the Plan and expensed when incurred. All other administrative expenses are paid by the Employer.

**NOTE C - TAX STATUS**

The Internal Revenue Service (IRS) issued its latest opinion letter for the trustee's prototype plan on March 31, 2014, which stated that the Plan and its underlying trust qualify under the applicable provisions of the IRC and, therefore, are exempt from federal income taxes. The determination letter does not cover all amendments to the Plan. However, in the opinion of the Plan administrator, the Plan and its underlying trust have operated within the terms of the Plan in all material respects and remain qualified under the applicable provisions of the IRC.

US GAAP requires plan management to evaluate tax positions taken by the plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that, as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**NOTE D - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Employer has the right to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants shall become 100% vested in their accounts.

**NOTE E - INVESTMENTS**

In general, the investments provided by the Plan are exposed to various risks, such as interest rate, credit and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

**NOTE F - FAIR VALUE MEASUREMENTS**

The Financial Accounting Standards Board provides a framework for measuring fair value. This framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access;

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability; and

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

***Mutual Funds***

Valued at the net asset value (NAV) of shares held by the Plan at year end, which is obtained from an active market.

***Collective Trust Funds***

Valued at the NAV of units of an insurance company. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.
