**Scope and nature of the ERISA Section 103(a)(3)(C) audit**

We have performed an audit of the financial statements of The Iron Mountain Companies 401(k) Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits as of December 31, 2024, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

#### NOTE 1 - DESCRIPTION OF THE PLAN

The following description of The Iron Mountain Companies 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

##### **General**

The Plan is a defined contribution plan covering substantially all United States employees of Iron Mountain Incorporated and its affiliated participating companies (collectively, Iron Mountain or the Company), as defined in the Plan document. Fidelity serves as the Plan's trustee, recordkeeper and custodian. The Plan is administered by the Retirement Plan Committee of the Company (Plan Administrator), which is appointed by the Board of Directors of the Company. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Effective December 31, 2023, the Clutter 401(k) Plan merged into the Plan. The amounts received from the Clutter 401(k) Plan are presented as interest-bearing cash on the statement of net assets available for benefits in the amount of \$2,339,150 as of December 31, 2023.

##### **Contributions**

Each year participants may contribute up to 75% of their annual compensation on a pre-tax or Roth basis, as defined in the Plan document, subject to certain Internal Revenue Code (IRC) limitations. During 2024, the Company made bi-weekly discretionary matching contributions based on the amount of participant contributions as follows: the Company matched 67% of participant's contributions up to the first 6% of their eligible compensation. At its discretion, the Company may change the amount of the matching contribution it will make. The Plan allows eligible participants to make catch-up contributions in accordance with and subject to the limitations of IRC Section 414(v). Participants may also contribute amounts representing distributions from other qualified retirement plans and accounts.

##### **Participant Accounts**

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Company's discretionary matching contribution, and an allocation of Plan earnings, and charged with withdrawals and an allocation of Plan losses and administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

##### **Investments**

Participants direct the investment of their contributions and Company contributions into various investment options offered by the Plan. The Plan currently offers several mutual funds, collective trust funds, a pooled separate account, and a self-directed brokerage account as investment options for participants. Participants may only invest up to 50% of their account balance in the self-directed brokerage account option.

##### **Vesting**

Participants are vested immediately in their contributions, plus actual earnings thereon. Participants are also vested immediately in any Company matching contributions made for Plan Years beginning January 1, 2020, plus actual earnings thereon. Prior to January 1, 2020, any Company matching contributions were subject to a vesting schedule. Participants with funds transferred to the Plan as a result of a plan merger may be subject to a grandfathered vesting schedule.

***Notes Receivable from Participants***

Participants may borrow the lesser of \$50,000 (reduced by the highest outstanding loan balance in the previous 12 months) or 50% of their vested account balance, with a minimum loan amount of \$500. Loans are repayable through payroll deductions over periods ranging from three months to five years, or up to 20 years if the purpose of the loan is to purchase a principal residence. The loans are secured by the balance in the participant's account and bear interest at the Prime rate plus 1%. Principal and interest are paid ratably through payroll deductions. The interest rate on loans outstanding ranged from 4.25% to 9.50% and 3.75% to 9.50% at December 31, 2024 and 2023, respectively.

***Payment of Benefits***

Upon termination of service, a participant may elect to receive a lump sum amount equal to the value of the vested interest in his or her account. Upon termination of service due to death, disability or retirement, a participant may elect to receive an amount equal to the value of his or her vested account as a lumpsum amount, or equal installment payments. If termination results for any reason other than death and the value of a participant's account exceeds \$7,000, the participant may postpone payment of the account until the age of required minimum distributions as set by the IRC.

Participants may also elect in-service withdrawals upon the attainment of age 59 ½. Participants may withdraw, upon substantial financial hardship as defined in the Plan, the vested portion of his or her account. Effective January 1, 2024, participants may elect to take a distribution up to \$5,000 following the qualified birth or adoption of a child. All distributions are subject to the applicable provisions of the Plan.

***Forfeited Accounts***

Participants who receive a distribution following termination of employment or who incur five consecutive breaks in service or receive a full distribution, as defined in the Plan, will irrevocably forfeit any non-vested employer contributions, plus actual earnings thereon. Forfeitures shall be used first to restore participant accounts, next to adjust contributions and earnings thereon to a participant's account, and then to reduce Company contributions. At December 31, 2024 and 2023, forfeiture accounts totaled \$54,507 and \$292,708, respectively. The forfeiture accounts include both forfeited amounts as well as uncashed participant checks which are not currently forfeitable. Consistent with terms of the Plan, during the year ended December 31, 2024, \$450,700 of forfeitures were used to reduce Company contributions.

***Administrative Expenses***

Investment expenses are borne by participants. In the event any revenue sharing credits become available with respect to a particular investment, that amount is allocated back, as closely as possible and on a quarterly basis, to the participants whose investments generated the credit. A flat fee is also deducted over the course of the year from each participant's account to cover recordkeeping and other operating expenses of administering the Plan. The Retirement Plan Committee regularly reviews both fund investment expenses and other expenses of administering the Plan. Expenses not paid by participants are paid by the Company.

**NOTE 2 - SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

***Basis of Accounting***

The accompanying financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

***Use of Estimates***

The preparation of financial statements in conformity with US GAAP requires the Plan's management to make estimates and assumptions that affect the reported amounts of net assets available for benefits, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

***Investment Valuation and Income Recognition***

Investments are reported at fair value, except for the investments in fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Management fees and operating expenses charged to the Plan for investments in the mutual funds, collective trust funds, the pooled separate account and the self-directed brokerage account are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

***Payment of Benefits***

Benefits are recorded when paid.

**NOTE 3 - INFORMATION CERTIFIED BY THE PLAN'S TRUSTEE**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Fidelity Management Trust Company, the trustee, and New York Life Insurance Company have certified that the following data included in the financial statements and supplemental schedule are complete and accurate:

- Investments, at fair value and contract value and notes receivable from participants, as shown in the statements of net assets available for benefits as of December 31, 2024, and 2023.
- Total investment income and interest income on notes receivable from participants as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H, Part IV, line 4i, schedule of assets (held at end of year) as of December 31, 2024.

**NOTE 4 - FAIR VALUE MEASUREMENTS**

US GAAP establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets
- Quoted prices for identical or similar assets or liabilities in inactive markets
- Inputs other than quoted prices that are observable for the asset or liability
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used on December 31, 2024 and 2023.

***Mutual Funds***

Mutual funds are valued at the quoted market prices, which represents the net asset value (NAV) of the shares held by the Plan. These securities are categorized in Level 1 as they are actively traded and no valuation adjustments have been applied.

***Brokerage Account***

The brokerage account consists of mutual funds, common stocks, warrants and the Fidelity Government Cash Reserves fund. Mutual funds and common stocks are valued at quoted market prices and are categorized as Level 1. The Fidelity Government Cash Reserves fund is valued at NAV and not included in the fair value hierarchy.

***Money Market Funds***

Money market funds are valued at NAV and not included in the fair value hierarchy. There are no unfunded commitments at December 31, 2024 or 2023.

***Interest Bearing Cash***

Interest bearing cash is categorized as Level 1 as there is no stated maturity date and interest rates approximate market.

***Collective Trust Funds***

Collective trust funds are valued at the NAV of shares held by the Plan based on the fair value of their underlying assets reported in the fund's audited financial statements.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There are no unfunded commitments at December 31, 2024 or 2023.

**NOTE 5 - POOLED SEPARATE ACCOUNT**

The investment in the New York Life Insurance Anchor Account IV Stable Value Fund is a pooled account with New York Life. New York Life maintains the Plan's contributions in a separate account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer, New York Life, is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the investment contract. As such, the statements of net assets available for benefits presents the New York Life Insurance Anchor Account IV Stable Value Fund at contract value.

Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The crediting interest rate is based on a formula agreed upon with New York Life, but may not be less than 0%. Such interest rate may be reset not more frequently than daily and not less frequently than quarterly. The interest crediting rate reflects the book yield on the separate account, adjusted to reflect amortization of any realized gains and losses.

The contract has certain restrictions that impact the ability to collect the full contract value; for example, the Plan may not fully withdraw from the account without incurring a penalty, unless the Plan Administrator provides 12 months' advance notice to New York Life.

In the event that the contract is terminated by the Trustee or the Plan Administrator, without advance notice, a market adjustment penalty will apply. The penalty is formula based but is intended to compensate New York Life for the difference between the contract value and the fair market value of the investments in the pooled separate account. In addition, withdrawals initiated by the Plan Administrator including total or partial plan terminations, mergers, spin-offs, lay-offs, early retirement incentive programs, sales or closings, bankruptcy or receivership will be subject to the market rate adjustment to the extent they exceed a predetermined threshold (10% of the Plan's investment in the stable value option). Any transfers out of the stable value fund must first go through a non-competing investment option and reside there for at least 90 days before transfer to a competing investment option, such as fixed income funds including but not limited to, guaranteed investment contracts, money market funds, or short-term bonds. Plan management believes that the occurrence of events that would cause the Plan to transact at less than contract value is not probable. New York Life may not terminate the contract at any amount less than contract value.

**NOTE 6 - PLAN TERMINATION**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**NOTE 7 - INCOME TAX STATUS**

The Plan has received a determination letter from the United States Internal Revenue Service dated May 2, 2016, stating that the Plan, as amended through April 18, 2016, is designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving this determination letter, the Plan Administrator believes the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore, believes that the Plan, as amended, is qualified and is tax exempt.

US GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken any uncertain tax positions that more likely than not would not be sustained upon examination by a tax authority. Management evaluated the Plan's tax positions and concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions that require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are no audits for any tax period in progress.

**NOTE 8 - PARTY-IN-INTEREST TRANSACTIONS**

Certain plan investments, such as shares of registered investment companies in the Fidelity fund family are managed by affiliates of Fidelity. The Plan also permits notes receivable to participants, which are secured by the balances in the participants' accounts. These transactions are considered exempt party-in-interest transactions.

**NOTE 9 - RISKS AND UNCERTAINTIES**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risk. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near-term and such changes could materially affect participant account balances and the amounts reported in the statements of net assets available for benefits.
