### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of The Moscoe Group 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

### 1. DESCRIPTION OF THE PLAN

The following description of The Moscoe Group 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan adoption agreement for a more complete description of the Plan's provisions.

**General** - The Plan was adopted effective January 1, 2009. The Plan is a single-employer, defined contribution, safe harbor 401(k) plan covering substantially all full-time employees of The Moscoe Group, Inc. and Biscayne Sales and Marketing, Inc., (collectively, the Employer) who are age twenty-one or older. An employee enters the Plan the first day of the month coinciding with or next following the date the eligibility requirements are met. Employees are eligible to receive safe harbor matching contributions the first day of the month following the completion of three months of service. The Plan excludes part-time, temporary or seasonal employees whose regularly scheduled service is less than 1,000 hours annually.

The Moscoe Group, Inc. is the Plan Sponsor and Plan Administrator. Hand Benefits & Trust Company has been appointed the Plan's trustee. Benefit Plans Administrative Services, Inc. (BPAS) provides recordkeeping services for the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Investments held with Hand Benefits & Trust Company are invested in mutual funds and a common/collective trust fund. Investments held with Charles Schwab are invested in participant-directed brokerage accounts.

**Contributions** - Participants are allowed to make elective pre-tax and Roth deferral contributions of up to 100% of eligible wages, subject to Internal Revenue Code limitations. The Plan allows participants age 50 and older to make catch up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollover contributions).

### 1. DESCRIPTION OF THE PLAN (Continued)

The Employer makes safe harbor matching contributions to the Plan equal to 3% of the participant's eligible compensation. The Plan allows for additional qualified non-elective contributions in amounts determined at the sole discretion of the Employer. A participant must complete 1,000 hours of service during the Plan year and be employed on the last day of the Plan year in order to be eligible for the qualified non-elective contribution, unless the participant terminates employment because of death, disability, or attainment of early or normal retirement age (65). Any participant who has attained age 59 1/2 and is 100% vested will share in contributions regardless of hours or employment status. There were no additional qualified non-elective contributions made to the Plan for the year ended December 31, 2024.

**Participant Accounts** - Each participant's account is credited with the participant's contributions and allocations of (a) the Employer's safe harbor matching contributions plus the Employer's additional qualified non-elective contributions, if any, and (b) Plan earnings and increases or decreases in the value of investments, net of expenses. Allocations are based on account balances, participant earnings, or specific participant transactions as defined in the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

**Vesting** - The participant's elective deferral and the Employer's safe harbor matching contributions and earnings thereon are always 100% vested. For the Employer's additional qualified non-elective contributions and earnings thereon, vesting is based on years of service. A participant is 100 percent vested after actual time rules have been met for six years of service. An employee must be age 18 or older and annually complete at least 1,000 hours of service during a Plan year to receive credit for a year of service. A participant reaches early retirement age upon the later of attaining age 59 1/2 or the date the participant reaches the fifth anniversary of the first day of the Plan year in which the participant commenced participation in the Plan. A participant becomes fully vested upon reaching the early retirement age. Notwithstanding the above, a participant's account will be fully vested upon death, disability, or reaching age 65.

**Payment of Benefits** - If a participant's employment is terminated and the participant's account value is less than \$5,000, the balance is automatically distributed in a single lump sum payment. If the participant's account value exceeds \$5,000, the Plan allows for single lump-sum payment, installment payments, and partial withdrawals. The Plan also allows for in-service withdrawals and hardship withdrawals subject to Plan provisions.

**Notes Receivable from Participants** - Participants may borrow from their Plan accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The notes are secured by the balance in the participant's account and bear interest at fixed rates of prime plus 2% determined at note inception. The interest rates on notes outstanding at December 31, 2024, were 5.25% to 10.50%. Principal and interest are paid ratably through payroll deductions.

**Forfeitures** - Forfeitures are first used to pay administrative expenses of the Plan. Any remaining amounts may be used to reduce future employer contributions payable under the Plan. Forfeited non-vested accounts totaled \$ - at December 31, 2024 and 2023. In 2024, no administrative expenses or employer contributions were paid out of forfeitures.

**Other Income - Madoff Victim Recovery** - During 2024, the Plan received \$56,567 from the Madoff Victim Fund, a part of the Department of Justice Asset Forfeiture Distribution Program, for investment losses suffered by the Plan participants from the fraud at Bernard L. Madoff Investment Securities.

**Investment Options** - Participants are allowed to direct the investment of their contributions among the various investment options offered by the Plan. Employer contributions are allocated on the same basis as participant contributions.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

**Basis of Accounting** - The accompanying financial statements have been prepared on the accrual basis of accounting.

**Estimates** - The preparation of any financial statements in accordance with U.S. generally accepted accounting principles may require management to make estimates that affect amounts reported and disclosed in the financial statements. Actual results could differ from such estimates.

**Valuation of Investments and Income Recognition** - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned and dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

**Notes Receivable from Participants** - Notes receivable from participants are stated at their unpaid principal balance plus any accrued but unpaid interest. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded.

**Payment of Benefits** - Benefits are recorded when paid.

**Administrative Expenses** - The Employer pays certain administrative expenses on behalf of the Plan. Expenses that are paid from Plan assets are reflected in the statement of changes in net assets available for benefits. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Brokerage fees related to the participant-directed brokerage accounts are charged directly to the participant's account and are included in administrative expenses.

In addition, Hand Benefits & Trust Company, the trustee has certified the data used to derive the information included in the supplementary schedule of assets (held at end of year) as of December 31, 2024, to be complete and accurate, except for the participant-directed brokerage accounts held at Charles Schwab, which were not certified.

### 4. INCOME TAX STATUS

The prototype adopted by the Plan obtained its latest opinion letter on June 30, 2020, in which the Internal Revenue Service stated that the prototype, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code (IRC). The Plan has not received a determination letter specific to the Plan itself. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC. Therefore, no provision for income taxes has been included in the Plan's financial statements.

U.S. generally accepted accounting principles require plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected.

### 5. FAIR VALUE MEASUREMENTS

The fair value measurement accounting literature provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. This hierarchy consists of three broad levels: Level 1 inputs consist of unadjusted quoted prices in active markets for identical assets and have the highest priority; Level 2 inputs consist of quoted prices for similar assets or liabilities in active markets, quoted prices for identical or similar assets or liabilities in inactive markets, inputs other than quoted prices that are observable for the asset or liability, and inputs that are derived principally from, or corroborated by, observable market data by correlation or other means; and Level 3 inputs to the valuation methodology are unobservable and significant to the fair value measurement and have the lowest priority.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the methodologies used to measure the fair value of the Plan's investments. There have been no changes in the methodologies used at December 31, 2024 and 2023.

**Mutual funds:** Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

**Participant-directed brokerage accounts:** These accounts consist of non-employer common stocks, a real estate investment trust, money market mutual funds, and cash. Non-employer common stocks and the real estate investment trust are valued at the closing price reported on the active market on which the individual securities are traded. Money market mutual funds are valued as described above.

**Common/collective trust fund:** The collective trust fund consists of the MetLife Stable Value Fund for which Reliance Trust Company serves as trustee and investment manager. The Fund invests entirely in the MetLife Group Annuity Contract 25053 which consists of separately managed investment portfolios. The Fund is valued at the net asset value of units of the collective trust. Plan management believes using net asset value as a practical expedient to estimate fair value is appropriate for investments in common/collective trusts. This practical expedient would not be used if it is determined to be probable that the Plan will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. Withdrawals prompted by certain events (e.g. layoffs, early retirement windows, plan terminations, changes in laws or regulations) may be paid at the market value of the Fund's separate accounts, which may be less than the unit value. The Plan has no unfunded commitments relating to the common/collective trust fund at December 31, 2024.

The primary investment objective of the MetLife Stable Value Fund is to preserve principal while generating earnings at rates competitive over time with short-term high quality fixed income investments, while maintaining sufficient liquidity to provide participant directed withdrawals at their proportionate share of contract value.
