## Independent Auditor's Report

To the Administrator

### Opinion

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with generally accepted auditing standards.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

### 1. Description of Plan

The following brief description of the LVC Employee Stock Ownership Plan (the "Plan") is provided for general information purposes only. Participants should refer to the Plan document for more complete information regarding the Plan's definitions, benefits, and eligibility requirements and other matters.

#### **General**

LVC Holdings, Inc. and Subsidiaries (the "Company") established the Plan effective January 1, 2008, and the Plan was amended in its entirety on January 1, 2015. The Plan operates, in relevant part, as a leveraged employee stock ownership plan (ESOP) and is designed to comply with Section 4975(e)(7) and the regulations thereunder of the Internal Revenue Code (IRC) of 1986, as amended, and is subject to the applicable provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is administered by a Plan Committee which is appointed by the Board of Directors.

In July 2013, the Company redeemed 593,934 shares of common stock and sold these redeemed shares of common stock to the Plan at a price of \$5.25 per share. As a result of this transaction, the ESOP Trust owns 100% of the Company. The total purchase price for these shares was \$3,118,154. The Plan made an initial cash payment of \$200,000 and entered into a loan agreement with the Company for the remaining \$2,918,154 (Note 4). The Plan owns 1,000,000 shares of common stock of LVC Holdings, Inc.

The unallocated shares of Company stock collateralized the borrowings. The lenders had no rights against the shares once they were allocated under the ESOP. Accordingly, the accompanying financial statements present separately the assets and liabilities and changes therein pertaining to a) the accounts of employees with rights in allocated stock (allocated) and b) stock not yet allocated to employees (unallocated). Shares are released from collateral and become allocated generally in the period in which debt service is actually paid in cash. All shares were allocated at December 31, 2024.

#### **Eligibility**

Substantially all employees of the Company who are not covered under collective bargaining agreements are eligible to participate in the Plan following completion of one year of service and the attainment of age 21. Eligible employees may enter the Plan after the entry date (each January 1 and July 1) coinciding with or following the date which the employee has completed both eligibility requirements. A participant will share in the allocation of contributions and forfeitures only if the participant is employed on the last day of the Plan year and has accumulated 1,000 or more hours of service during the plan year.

#### **Contributions**

Discretionary contributions to the Plan may be made annually up to the maximum amount allowed under Internal Revenue Service regulations. The Company is obligated to make contributions in cash to the Plan which, when aggregated with the Plan's dividends and interest earnings, equal an amount necessary to enable the Plan to make its regularly scheduled payments of principal and interest due on its notes payable. The Company may also make discretionary contributions and S-Corporation distributions to the Plan. In addition, minimum contributions are to be made, if necessary, to cover certain distributions from the Plan.

#### **Participant Accounts**

The Plan is a defined contribution plan under which a separate individual account is established for each participant. Each participant's account is credited as of the last day of each Plan year with an allocation of shares of the Company's common stock released by the trustee from the unallocated account and forfeitures of terminated participants' non-vested accounts. Only those participants who are eligible employees of the Company as of the last day of the Plan year will receive an allocation.

#### **Participant Accounts (Continued)**

As of each valuation date, before allocation of Company contributions for the entire Plan year and after allocation of forfeitures, if any, earnings or losses are allocated to each participant's account in the same proportion that the participant's account bears to the total of all participants' accounts as of such date.

Dividends or "S corporation distributions" received with respect to allocated Company common stock and not used to make a payment on the note payable with the Company related to the acquisition of common stock shall be allocated to each participant based upon the cumulative number of shares allocated to the participant's account to the total cumulative number of shares allocated to all participants, prior to the allocation of shares in the current year. Dividends or "S corporation distributions" received with respect to unallocated Company common stock and not used to make payments on the note payable with the Company related to the acquisition of common stock shall be allocated to each participant based upon the unit allocation as noted below. Such dividend or other income may, at the discretion of the Company, be used to repay an exempt loan.

The allocation of contributions is based on each participant's compensation (as defined by the plan) in comparison to the total compensation of all such participants for that year.

#### **Vesting**

Participants vest in the balance of their account based upon total years of service with the Company. Participants vest 20% per year beginning in year two of service and are 100% vested after six years of service. A participant shall fully vest upon retirement, death, disability, or attainment of normal retirement age as defined in the agreement.

#### **Forfeited Accounts**

If a participant terminates employment before becoming fully vested in their account balance, the forfeited portion of the account balance is allocated to each participant's account based upon the relation of the participant's units to total units for the Plan year (see "Participant Accounts"). At December 31, 2024, there were no unallocated forfeitures. Forfeitures of terminated non-vested account balances allocated to remaining participants for the year ended December 31, 2024 were approximately \$49,000.

#### **Distributions**

Distributions shall be made from the Plan when a participant retires, dies, or otherwise terminates employment with the Company (see also "Diversification"). Distributions of a participant's benefit may be made in cash or Company stock; the stock value is based upon the appraised fair market value determined as of the anniversary date coinciding with or immediately preceding the date of distribution. Because the Company is an S corporation, the administrator may distribute a participant's account entirely in cash without granting the participant the right to demand distribution in shares of Company stock or shall subject a distribution in shares of Company stock to an immediate, mandated put to the Company or ESOP. If the account balance is \$5,000 or less, the distribution will be paid in a simple lump sum. If the account balance exceeds \$5,000, the distribution will be paid in equal installments over a period of five years (unless the account is above certain thresholds as defined by the Plan document).

#### **Diversification**

Diversification is offered to participants close to retirement so they may have the opportunity to move part of the value of their investment in Company stock into investments, which are more diversified. Participants who are at least 55 with at least 10 years of participation in the Plan may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage changes to 50%. Participants who elect to diversify will receive a cash distribution or have the ability to roll over funds into a qualified defined contribution plan maintained by the Company. Amounts rolled over into the plan maintained by the Company are reflected as transfer of assets to LVC Companies, Inc. 401k Retirement Plan on the Statements of Changes in Net Assets Available for Benefits.

#### Put Option

Under federal income tax regulations, the Company's stock that is held by the Plan and its participants is not readily tradable on an established market and includes a put option. The put option is a right to demand the Company buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The Company can fund the repurchase with interest over a period of 5 years. The purpose of the put option is to ensure the participant has the ability to ultimately obtain cash.

#### Voting Rights

All Company stock held by the trust shall be voted by the trustee. Notwithstanding the foregoing, participants shall be entitled to direct the trustee as to the voting of any voting shares of Company stock allocated to their accounts with respect to any vote required for the approval or disapproval of any corporate merger or consolidation, recapitalization, reclassification, liquidation, dissolution, sale of substantially all the assets of a trade or business, or other similar transactions prescribed by regulation. The trustee shall vote any unallocated shares held by the Trust as well as for which a participant has failed to give timely voting direction.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (US GAAP).

#### Accounting Estimates

The preparation of financial statements in conformity with US GAAP requires management to make estimates and assumptions that affect certain reported amounts and disclosures. Significant estimates include the valuation of the Company's common stock. Accordingly, actual results may differ from those estimates.

#### Risks and Uncertainties

The Plan's investments consist of the Company's common stock, which is exposed to various risks such as interest rate, market and credit risks, as well as valuation assumptions based on earnings, cash flows, and other such techniques. Due to the level of risk associated with the investment in common stock and to uncertainties inherent in the estimations and assumptions process, it is reasonably possible that changes in the value of the common stock will occur in the near term and that such changes could materially affect the amounts reported on the statements of net assets available for benefits.

#### Investment Valuation

Investments are reported at fair value as described in Note 3. There has been no change to the methodology used at December 31, 2024 and 2023.

#### Income Recognition

The net appreciation or depreciation in fair value of investments consists of both the realized gains or losses and unrealized appreciation and depreciation of those investments.

The Plan recognizes contributions as they are declared by the Company. Investment gains and losses are recognized when investments are sold and upon changes in the unrealized appreciation or depreciation of investments held.

#### Operating Expenses

Substantially all of the expenses incurred for maintaining the Plan are paid directly by the Company and are excluded from these financial statements.

#### **Payment of Benefits**

Distributions related to diversification elections are recorded in the year in which the diversification election relates to and other benefit payments are recorded when paid.

#### **Fair Value of Financial Instruments**

The Plan's accounting for fair value measurements of assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring or nonrecurring basis adheres to the Financial Accounting Standards Board (FASB) fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to measurements involving significant unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are as follows:

- Level 1 Inputs: Unadjusted quoted prices in active markets for identical assets or liabilities accessible to the Plan at the measurement date.
- Level 2 Inputs: Other than quoted prices included in Level 1 inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3 Inputs: Unobservable inputs for the asset or liability used to measure fair value to the extent that observable inputs are not available, thereby allowing for situations in which there is little, if any, market activity for the asset or liability at measurement date.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The following is a description of the valuation methodology used for the assets measured at fair value at December 31, 2024 and 2023:

- The fair value of the Company common stock was determined by an independent third-party appraisal. Methods for the valuation included discounted cash-flow, guideline public company, and merger and acquisition methods.

The methods described above include significant estimates and may produce a fair value calculation which may change in the near term and which may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### **Subsequent Events**

The Plan has evaluated subsequent events for recording or disclosure in the financial statements through October 9, 2025, the date which the financial statements were available to be issued.

### 4. Note Payable

In 2013, the Plan entered into a \$2,918,154 term loan agreement with the Company. The loan was used to purchase Company common stock. Unallocated shares served as collateral for the loan. Shares are released from collateral and allocated to participants as payments of principal and interest are made. The number of shares released in any year is the number of shares held as collateral times the ratio of the current year payments divided by the total of this year's payment, plus all future years' principal and interest payments. This resulted in 18,595 shares being released and allocated for the plan year ended December 31, 2024. The agreement provided for the loan to be repaid over 15 years. The note allowed for prepayments. All prepayments were to be first applied to accrued interest and then to principal in inverse order of maturity. Borrowings carried interest at 3%. The note was paid in full during 2024. The note payable balance was approximately \$108,000 at December 31, 2023.

### **5. Tax Status**

The Internal Revenue Service has determined and informed the Company by a letter dated September 15, 2016 that the Plan is qualified and the trust established under the Plan is tax-exempt under the appropriate sections of the IRC. The Plan has been amended since receiving the determination letter. The Plan Administrator believes the Plan and trust are operating in a manner that does not jeopardize this tax status.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

During 2022, the Company identified that the Plan used the incorrect definition of compensation for plan years 2016, 2017, and 2018. To adjust the definition of compensation to match the definition used for allocation of contributions, the Company has prepared a retroactive plan amendment to amend the definition of compensation for 2016, 2017, and 2018. The retroactive amendment was filed with the Internal Revenue Service for approval through the Voluntary Compliance Program as prescribed by the Rev. Proc. 2021-30 and the Plan has received approval from the IRS.

### **6. Administration of Plan Assets**

The Plan assets, which consist principally of Company common stock, are held by the trustee of the Plan.

Company contributions are held and managed by the trustee, which invests cash received and interest and dividend income, and makes distributions to participants.

Certain administrative functions are performed by officers or employees of the Company. No such officer or employee receives compensation from the Plan. Administrative expenses of the Plan are paid by the Company.

### **7. Related Party Transactions**

The Plan invests in Company common stock. These are related party and exempt party-in-interest transactions. The Plan also has a number of service providers. Such providers are parties-in-interest under ERISA.

### **8. Plan Termination**

Although the Company has expressed no intent to do so, it reserves the right to terminate the Plan at any time, subject to Plan provisions. Upon complete or partial termination of the Plan, the entire interest of each of the affected participants shall become 100% vested. The trustee shall distribute the interest of each participant in the trust fund to such participant, or his or her beneficiary at the time, prescribed by the Plan terms and the IRC.
