### **Note 1: Description of Plan**

The following description of Luihn VantEdge Partners, LLC 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan established on March 20, 2019. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All salaried employees, hourly assistant general managers, and hourly corporate office employees of Luihn VantEdge Partners, LLC (the Company or the Plan Sponsor) who are 21 years of age and have completed six months of service are eligible to participate in the Plan on the first day of each Plan quarter coincident with or following the date eligibility requirements are met. Employees covered by a collective bargaining agreement, leased employees, highly compensated and hourly employees, as defined, and non-resident aliens are not eligible to participate in the Plan.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined by the Plan. Participants may also rollover amounts representing distributions from other qualified plans. The Company has elected to make matching contributions of 25% of each participant's pretax contributions, up to 8% of the participant's compensation. The Company may also make an additional profit sharing contribution at the option of the Company's board of directors. In order to participate in the profit sharing contribution, employees must be an active employee of the Company on the last day of the Plan year or employees who terminated employment due to death, disability, or upon attainment of normal retirement date (age 65). No profit sharing contribution was made for the year ended December 31, 2024. Contributions are subject to annual limitations established by the Internal Revenue Service (IRS). Additionally, participants who have attained age fifty before the end of the taxable year are eligible to make catch-up contributions in accordance with and subject to the limitations under the IRS.

#### **Administration**

The Company serves as the Plan Administrator. The Plan Administrator has the responsibility to administer the Plan for the exclusive benefit of the participants and their beneficiaries. These duties include, but are not limited to, establishing procedures, maintaining records, interpreting provisions of the Plan and making determinations regarding questions which may affect eligibility for benefits. Voya Financial (Voya or the Trustee) serves as trustee and third-party administrator of the Plan.

Voya receives all contributions made under the Plan, holds Plan assets, pays benefits to participants and executes other transactions as directed by the Plan Administrator and assists in the administration of the Plan. The Trustee serves as the intermediary for all asset purchases and redemptions. Additionally, the Trustee manages certain investment options of the Plan (Note 6).

## **Participant Accounts**

Each participant's account is credited with the pretax and rollover contributions made by the participant, any employer matching contributions, any profit sharing contributions, and the participant's earnings or losses. Administrative expenses are allocated to each participant. Allocations are based on participant earnings (losses) or account balances as described in the Plan Document. Any profit sharing contribution is allocated to participants' accounts based on participants' compensation.

## **Vesting**

Participants are vested immediately in their voluntary, rollover contributions, plus actual earnings thereon. Vesting of the Company's matching and profit sharing contribution portion of their accounts is based on years of continuous service as follows:

Participants also become 100% vested upon termination of the Plan, upon reaching the normal retirement age of sixty-five, or upon disability or death while an employee of the Company.

## **Investment Options**

Upon enrollment in the Plan, participants are required to make participant-directed contributions in any whole percentage increments totaling 100% among various investment options selected by the Plan Administrator. Participants may change their allocation to the various investment options at any time.

## **Payment of Benefits**

Benefits are paid according to the vested interest in the account upon normal retirement age of sixty-five, termination, disability, or death. Benefits are distributed to the participant or beneficiary as a single lump-sum payment, as defined in the Plan Document.

In general, a participant may withdraw up to 100% of the participant's elective deferrals in the event of a heavy and immediate financial hardship, as defined in the Plan Document. Hardship distributions may not exceed the amount of the participant's financial hardship and may not be repaid by the participant.

Participants withdrawing from the Plan due to termination of employment with the Plan Sponsor, other than due to retirement, disability, or death, may receive the value of their vested account by transfer to another qualified plan or individual retirement account or through a lump sum distribution. In general, if the participant's account balance, as defined in the Plan Document, is greater than the involuntary cash-out amount of \$5,000, the account may not be distributed without the participant's consent.

Distributions from the Plan will normally be subject to income taxes and, in certain circumstances, may also be subject to IRS penalties, unless the distribution is transferred to another qualified plan or individual retirement account.

## **Forfeitures**

Forfeitures of terminated participants' nonvested accounts are used to pay plan expenses or reduce the Company's future contributions, as directed by the Company. During the year ended December 31, 2024, forfeitures totaled \$9,160. Forfeitures available for future use as of December 31, 2024 and 2023 were \$4,968 and \$308, respectively. During 2024, forfeitures amounting to \$4,500 were used to reduce the Company's contributions or pay plan expenses.

## **Note 2: Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements are prepared using the accrual method of accounting in accordance with accounting principles generally accepted in the United States of America (U. S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the financial statements and accompanying notes. Actual results could differ from those estimates.

### **Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits and statement of changes in net assets available for benefits.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value, excluding the Voya Fixed Account that is a fully benefit-responsive investment contract reported at contract value (see Note 5). Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded when earned. Dividends are recorded on the ex-dividend date. Net appreciation in the fair value of the investments represents the change in fair value during the year, including realized and unrealized gains and losses.

### **Benefit Payments**

Benefits paid include payments by the Plan to participants or their beneficiaries. Benefit payments are recorded when paid by the Plan.

### **Administrative Expenses**

Administrative expenses of the Plan are liabilities of the Plan but may be paid by the Company. These expenses include, but are not limited to, the Plan's asset management, administrative, and transactional costs. The Company pays for legal and accounting fees on behalf of the Plan.

### Note 3: Information Certified by the Trustee (Unaudited)

The Company has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Company instructed the Plan's independent auditors not to perform any auditing procedures with respect to the following information certified by the Trustee, except for comparing such information certified by the Trustee to information included in the Plan's financial statements and supplemental information:

### Note 4: Fair Value Measurements

Financial Accounting Standards Board (FASB) Accounting Standards Codification (ASC) 820-10, *Fair Value Measurements*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

The Trustee offers the Plan certain services exclusively through a group annuity contract. This contract holds a separate account that invests in various mutual funds, as defined in the contract. All contributions to the separate account are maintained in pooled separate accounts that invest in mutual funds. Voya owns the shares of the mutual funds, and the contract is assigned rights of ownership based on units in the pooled separate accounts. Investments in the pooled separate accounts are valued at fair value, which has been determined by Voya based on the unit values of the underlying investments. The net asset value (NAV) is used as a practical expedient to estimate fair value of the investments and is not classified in the fair value hierarchy. The practical expedient would not be used if it is determined to be probable that the investments will sell for an amount different from the reported net asset value. There are currently no redemption restrictions or unfunded commitments on these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

At December 31, 2024 and 2023, none of the Plan's assets were classified in the fair value hierarchy.

#### **Note 5: Fully Benefit Responsive Investment Contract**

The Voya Fixed Account is a traditional investment contract. This contract meets the benefit-responsive investment contract criteria and therefore is reported at contract value. In accordance with Accounting Standards Update (ASU) 2015-12, contract value is the only relevant measure for fully benefit-responsive investment contracts, because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. The contract value of the Voya Fixed Account represents contributions plus earnings, less participant withdrawals and administrative expenses. The contract issuer, Voya, is contractually obligated to repay the principal and interest at a specified interest rate that is guaranteed to the Plan. The contract value of investment contract accounts totaled \$53,861 and \$36,362 as of December 31, 2024 and 2023, respectively, and is reported as investments at contract value on the statements of net assets available for benefits.

The Voya Fixed Account guarantees principal and a minimum guaranteed interest rate for the life of the product as well as featuring two declared interest rates: a current rate, determined at least monthly, and a guaranteed minimum floor rate declared for a defined period - currently one calendar year. The guaranteed minimum floor rate may change after the defined period, but it will never be lower than the minimum guaranteed interest rate.

The Plan's ability to receive amounts due in accordance with fully benefit-responsive investment contracts is dependent on the third-party issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments. Certain events such as plan termination or a plan merger initiated by the Plan Sponsor may limit the ability of the Plan to transact at contract value. The Plan Sponsor does not believe that any events that may limit the ability of the Plan to transact at contract value are probable.

#### **Note 6: Party-in-Interest Transactions**

The Plan's Trustees and their affiliates perform services for, sell products to, and maintain certain investments for the Plan for which fees were charged to the Plan. Such transactions, while considered party-in-interest transactions under ERISA, are permitted under the provisions of the Plan and are specifically exempt from the prohibition of party-in-interest transactions under ERISA.

## **Note 7: Prohibited Transactions**

During 2024 and 2023, the Plan Sponsor deducted, via payroll withholding, an aggregate of \$34,632 and \$11,376, respectively, from participants' gross wages that were not remitted in a timely manner to the Plan in accordance with DOL regulations. In 2024 and 2025, the Plan Sponsor made restoration contributions to the Plan to restore lost earnings for the 2023 late remittances and a portion of the 2024 late remittances. The Plan Sponsor filed Form 5330 with the IRS and paid the required excise tax on the transactions. The Plan Sponsor intends to make a restoration contribution to restore lost earnings for the remaining portion of late remittances in 2025.

## **Note 8: Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The excess contributions as of December 31, 2024 were distributed by the Plan to the applicable participants within the allowable time frame as required by ERISA.

## **Note 9: Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, assets of the Plan will be distributed to the participants in an accordance with Plan provisions.

## **Note 10: Tax Status**

The Plan Sponsor has adopted a prototype plan. The prototype plan received a favorable opinion letter from the IRS dated June 1, 2021, which stated that the prototype plan and related trust were designed in accordance with the applicable sections of the IRC.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Company has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

## **Note 11: Subsequent Events**

The Plan Sponsor has evaluated for subsequent events between the date of the statement of net assets available for benefits as of December 31, 2024 and the report date, which is the date the financial statements were available for issuance and has concluded that all subsequent events requiring recognition or disclosure have been incorporated into these financial statements.
