## INDEPENDENT AUDITOR'S REPORT

To the Board of Directors and Participants  
ACTEGA North America 401(k) Plan  
Cinnaminson, New Jersey

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audits

We have performed audits of the accompanying financial statements of ACTEGA North America 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. #### Note A - Plan Description

The following description of the ACTEGA North America 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

##### General

The Plan is a defined contribution plan, covering all full-time employees of ACTEGA North America (the Company, Employer, or Plan Sponsor) who are eighteen or older and have completed two months of employment.

##### Contributions

Each year, participants may make elective deferrals up to the maximum amount allowed by Internal Revenue Code (IRC) regulations. The Company matches 100 percent of the first 3 percent of employee deferrals and 50 percent of the next 2 percent of employee deferrals. The Company may also contribute to the Plan, at the option of the Company's board of directors, a discretionary amount. The Company's discretionary contribution totaled \$89,400 for the year ended December 31, 2024, which was paid subsequent to December 31, 2024.

##### Participant Accounts

Each participant's account is credited with the participants' contributions, the employer's contributions, and an allocation of Plan earnings and charged with benefits paid to participants and an allocation of Plan losses and administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's respective vested account balance.

##### Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the remainder of their accounts is based on years of continuous service. A participant is 100 percent vested after two years of service in the Company match and 100 percent vested after four years of service in the discretionary contributions.

##### Forfeitures

At December 31, 2023, forfeited non-vested accounts totaled \$10,807. During the year ended December 31, 2024, forfeitures used to reduce employee contributions or administrative expenses amounted to \$17,128. There were no forfeited non-vested accounts at December 31, 2024.

Notes Receivables from Participants

Participants may borrow from their fund accounts a minimum of \$1,000 and up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. Loan repayment terms are for a period up to five years or up to 25 years for the purchase of the primary residence. The loans are secured by the participant's vested account balance and bear interest at rate commensurate with local prevailing rates as determined by the Plan Administrator. Principal and interest is paid ratably through monthly payroll deductions.

Benefits Paid to Participants

On termination of service due to death, disability or retirement, a participant may elect to receive either a lump-sum amount equal to the value of the participant's vested interest in their account or installments as determined by the Plan. For termination of service for other reasons, participants may receive the value of the vested interest as a lump-sum distribution.

Note B - Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America (GAAP).

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred. As of December 31, 2024 and 2023, no allowance for uncollectible amounts has been recorded. If a participant does not make loan repayments and the Plan Administrator considers the participant loan to be in default, the loan balance is reduced, and the delinquent participant note receivable is recorded as a benefit payment based on the terms of the Plan document.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors, trustee, custodian, and insurance company. See Note E for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits Paid to Participants

Benefits are recorded when paid.

Subsequent Events

The Plan has evaluated subsequent events through September 8, 2025, the date the financial statements were available to be issued.

Note C - Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

Note D - Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

Note E - Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means

If the asset or liability has specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for assets measured at fair value.

During the year ended December 31, 2024, the Plan changed its valuation methodology for BlackRock LifePath Index investments from mutual funds to common collective trusts.

*Mutual funds:* Valued at the daily closing price as reported by the fund. The mutual funds held by the Plan are deemed to be actively traded.

The preceding method described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

A majority of the common collective trusts consist of BlackRock LifePath Index investments which are target date investments. The common collective trusts also consist of an investment in the Reliance Trust/New York Life Anchor Account Class O. The fund seeks to preserve principal and maintain a stable crediting rate that is responsive to changes in interest rates. The fund invests in a variety of group annuity contracts, with the fund's interest rates subject to change daily. Net appreciation in the Reliance Trust/New York Life Anchor Account Class O was \$48,503 for the year ended December 31, 2024.

Note G - Party-In-Interest Transactions

Certain cash and investments of the Plan are managed by State Street Bank and Trust Company. Purchases and sales of these assets qualify as party-in-interest transactions. Administrative expenses paid to the recordkeeper, Transamerica Retirement Solutions, amounted to \$37,882 for the year ended December 31, 2024. Other administrative expenses amounting \$16,946 which paid to the Plan's auditor and investment advisor.

Note H - Income Tax Status

The Company has adopted the Transamerica Retirement Solutions, LLC specimen plan document for 401(k) Profit Sharing Plans. The Company is therefore relying on the determination letter, dated June 30, 2020 that was received by Transamerica Retirement Solutions, LLC. The Plan has been amended since this determination letter was received. The Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Internal Revenue Code.

The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for tax years prior to December 31, 2021.
