INDEPENDENT AUDITORS' REPORT

To the Plan Administrator of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Centivo Corporation 401(k) Profit Sharing Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of Centivo Corporation 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 4 to the financial statements, is complete and accurate.

Opinion

NOTES TO FINANCIAL STATEMENTS

AS OF DECEMBER 31, 2024 AND 2023 AND FOR THE YEAR ENDED DECEMBER 31, 2024

1. PLAN DESCRIPTION

The following is a brief description of the Centivo Corporation 401(k) Profit Sharing Plan (the “Plan”) provided for general informational purposes. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General – The Plan is a defined contribution plan as permitted under Section 401(k) of the Internal Revenue Code (“IRC”). The Plan is funded by employee and employer contributions and covers all employees of Centivo Corporation (the “Company” or “Plan Sponsor”) who have attained 21 years of age and have completed 1,000 hours of service as defined by the Plan. Employees covered by a collective bargaining agreement, nonresident aliens, and leased employees are not eligible to participate in the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

Contributions – Participants may elect to defer a specified percentage of compensation as well as make Roth contributions to the Plan, not to exceed 100% of pretax annual compensation, or IRC limitations. In addition, the Company may make discretionary matching contributions and additional discretionary contributions to the Plan. Contributions are subject to certain limitations. No discretionary contributions were made for the year ended December 31, 2024.

Contributions received from participants are net of \$9,562 for the year ended December 31, 2024, for payments made during March 2025 to active participants to return excess deferred contributions as required to satisfy the relevant nondiscrimination provisions of the Plan. This amount is also included in the statement of net assets available for benefits as excess contributions payable as of December 31, 2024. There was no such payable required as of December 31, 2023.

Vesting – Participants are immediately vested in their voluntary contributions and earnings thereon. Employer discretionary matching and additional discretionary contributions and earnings thereon fully vest over six years of service. Regardless of years of service, participants are fully vested upon death or disability.

Notes Receivable from Participants – Participants may borrow from their accounts up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. Note terms range from one to five years or up to thirty years for the purchase of a primary residence and are secured by the balance in the participant’s account and bear interest commensurate with local prevailing rates. Principal and interest are paid ratably through regular payroll deductions. At December 31, 2024, interest rates ranged from 4.25% to 9.50%, maturing through November 2034.

Participant Accounts – Each participant’s account is credited with the participant’s contribution and an allocation of the employers’ contributions and Plan earnings. Plan earnings are allocated to the participants’ accounts based on the performance of the participants’ investment selections.

Forfeitures – Participants not fully vested in employers’ discretionary contributions upon separation from the Company, as defined in the Plan document, forfeit their non-vested balances. Forfeitures are available to offset the employer matching contributions or Plan administrative expenses. There were no forfeitures utilized during the year ended December 31, 2024. As of December 31, 2024, forfeitures available to the Plan were \$1,062. There were no forfeitures available as of December 31, 2023.

1. PLAN DESCRIPTION (continued)

Plan Termination – Although it has not expressed any intent to do so, the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA. In the event of termination, participants shall become 100% vested in their accounts at the date of such termination.

Payment of Benefits – Employees are eligible for retirement at age 65. Benefits are determined by the final value of the participant’s account at the time of payment. For termination of service for other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. Unless a participant elects otherwise, distributions will be made as soon as practical after a participant’s normal retirement date or actual retirement date. Distributions are also permitted in the event of financial hardship, as defined by the Plan, and after the age of 59 ½.

Participants may receive their accumulated benefits upon termination of employment or elect to keep their account in the Plan until the earlier of normal retirement age, death or disability if their account balance exceeds \$5,000. If the participant elects to keep their account in the Plan, the account will continue to receive its respective allocation of Plan earnings and expenses.

Administrative Expenses – Administrative expenses are primarily paid by the Plan.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting – The accompanying financial statements have been prepared on the accrual basis of accounting.

Investment Valuation and Income Recognition – The Plan determines the fair value of assets and liabilities which are subject to reporting at fair value based on standards established within generally accepted accounting principles. These standards establish a hierarchy for the determination of fair value, as well as disclosure requirements relative to those assets and liabilities. The hierarchy identifies three levels of input. Level 1 inputs are generally quoted market prices for identical assets or liabilities, which are actively traded on an exchange. Level 2 inputs generally consist of market prices for identical assets which are not actively traded or market prices of similar assets or liabilities which are actively traded on an exchange. Level 3 inputs are referred to as unobservable inputs and consist primarily of information derived by management where Level 1 and Level 2 inputs are not available. These may include such things as present value of expected future cash flows or other valuation methodologies. Under the hierarchy, Level 1 inputs are the most preferred, followed by Level 2, and Level 3 are to be used only where neither Level 1 nor Level 2 inputs are available.

An investment’s fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for investments measured at fair value as of December 31, 2024 and 2023:

Mutual funds: Valued based on quoted market prices available on an active market, which represent the net asset values (“NAV”) of the shares held by the Plan at year-end.

Common collective trust: This fund primarily holds guaranteed and other similar investment contracts that are fully-benefit responsive. The fund is valued based on the NAV of the shares held by the Plan at year-end using NAV contract value. This fund generally has no redemption restrictions or unfunded capital commitments.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (continued)

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

The Plan presents in the statement of changes in net assets available for benefits the net appreciation in fair value of investments, which includes unrealized and realized gains and losses on investments that were held or sold during the year.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividend income is recognized on the ex-dividend date and is presented separately in the accompanying statement of changes in net assets available for benefits.

Payment of Plan Benefits – Benefits are recorded when paid.

Use of Estimates – The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets at the date of the financial statements and the reported amounts of changes in net assets during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties – The Plan provides for various investment options. Investment securities are exposed to various risks, such as interest, market and credit risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

Subsequent Events – Management has evaluated the effects of all subsequent events through September, 22, 2025, the date the financial statements were available to be issued, to determine if events or transactions occurring through that date require potential adjustment or disclosure in the financial statements.

3. FAIR VALUE MEASUREMENTS

The Plan uses fair value measurements to record fair value adjustments to certain assets and to determine fair value disclosures. For additional information on how the Plan measures fair value, refer to Note 2 – Summary of Significant Accounting Policies. The following table sets forth, by level within the fair value hierarchy, the Plan's assets that are measured at fair value as of December 31, with the exception of the common collective trust, which is measured at fair value using the NAV practical expedient.

The fair value for the common collective trust is provided below to permit reconciliation of the fair value hierarchy to the amounts presented in the statements of net assets available for benefits.

5. PARTY IN INTEREST TRANSACTIONS

The Plan's investments include certain mutual funds and a common collective trust fund managed by Fidelity Investments, an affiliate of Fidelity Management Trust Company. As Fidelity Management Trust Company is the Plan trustee, as defined in the Plan document, transactions with Fidelity Investments qualify as party in interest transactions.

6. INCOME TAX STATUS

The Plan received a determination letter from the Internal Revenue Service (“IRS”) stating the Plan is qualified under applicable sections of the IRC, and therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualifications. The Plan was amended subsequent to the IRS determination letter. The Plan Administrator believes the Plan is being operated in compliance with the applicable requirements of the IRC, and therefore, believes that the Plan is qualified, and the related trust net investment income is tax exempt.
