### 1. Description of Plan

The following description of the Electric Glass Fiber America, LLC 401(k) Plan ("the Plan") provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### ***General***

The Plan, established September 1, 2017, is a defined contribution plan under Section 401(k) of the Internal Revenue Code, covering all employees of Electric Glass Fiber America, LLC. ("the Company") with three consecutive months of service, except for employees covered by a collective bargaining agreement, non-resident aliens with no U.S. source income, and leased employees. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

#### ***Contributions***

Each year, participants may contribute amounts up to the allowable deferral limit defined by the Internal Revenue Service. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans. The Plan has an auto-enrollment feature which enrolls eligible employees hired on or after September 1, 2017 into pre-tax elective deferrals of 4 percent. The Plan has discretionary matching contributions. The Company matches a percentage of participants' compensation contributed to the Plan each year. In 2024, the Company matched 100 percent up to 6 percent of eligible compensation for all participants other than production and maintenance employees hired after July 1, 2016, who receive 50 percent up to 6 percent of eligible compensation. The Company also makes discretionary "Employer Additional Contributions" in which the Company deposits contributions ranging from 2 percent to 5 percent of eligible compensation to all eligible participants. The applicable contribution percentage is based on a combination of each participant's age and years of service. Contributions are subject to certain limitations.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions, the Company matching, Employer Additional contributions, an allocation of plan earnings, and charged with an allocation of administrative expenses. Allocations are based upon participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants direct the investment of their contributions into various mutual funds, which are offered as investment options by the Plan.

#### ***Vesting***

Participants are vested immediately in their elective contributions and employer matching contribution plus actual earnings thereon. After 3 years of service, participants become 100 percent vested in any Employer Additional Contributions. Effective with any contributions made after May 1, 2022, employer matching contributions are also subject to a 3 year vesting schedule.

#### ***Notes Receivable from Participants***

Until May 2022, participants could have borrowed from their mutual fund Plan accounts from all sources other than their Roth accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their account balance. The loans are secured by the balance in the participant's account and bear interest at the prime rate plus 1 percent. Principal and interest is paid ratably through payroll deductions.

### ***Payment of Benefits***

On termination of service due to death, disability, retirement, or due to other reasons, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in a lump-sum, partial payment, or installment payment. In-service withdrawals are available from all participant accounts upon attaining age 59 ½ and due to deemed severance from employment. The Plan also allows distributions from employee pre-tax and roth accounts for reasons of hardship. Involuntary distributions may be made by the Plan Sponsor for terminated participants with account balances less than \$7,000.

### ***Forfeited Accounts***

Forfeiture balances at December 31, 2024 and 2023 were \$127,306 and \$7,182, respectively. Forfeitures may be used to reduce future Company contributions or pay for plan expenses. In 2024, \$96,103 in forfeitures were used to offset Plan expenses and \$184,434 were used to offset employer matching contributions.

## **2. Summary of Accounting Policies**

### ***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting.

### ***Use of Estimates***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### ***Investment Valuation and Income Recognition***

The Plan's investments are reported at fair value. The fair value of a financial instrument is the amount that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation/(depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual Funds:* Mutual funds are valued at the net asset value (NAV) of shares held by the Plan at year end.

*Cash Equivalents:* Contributions are held temporarily in the Contribution Account at Ascensus Trust Company prior to purchasing investments.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### ***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be in default, the participant loan balance is reduced and a benefit payment is recorded. Loans amounting to \$116,010 were deemed to be in default during the year ended December 31, 2024.

### ***Payment of Benefits***

Benefits are recorded when paid.

### ***Expenses***

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. The Plan may pay for other administrative costs and may use forfeitures to fund those expenses. Investment related expenses are included in net appreciation of fair value of investments.

### **3. Unaudited Information**

The Plan Administrator has elected the method of annual reporting compliance permitted by 29 CFR 2520.103-5(c) of the Department of Labor Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Ascensus, LLC, as agent of Ascensus Trust Company ("Ascensus") has certified that the following data included in the accompanying financial statements is complete and accurate.

### 4. Fair Value Measurements

Financial Accounting Standards Board (FASB) *Accounting Standards Codification* (ASC) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1:** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets.

**Level 2:** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability; and
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3:** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. Any unallocated assets of the Plan should be allocated to participant accounts and distributed to each participant in such a manner as the Company may determine.

### 6. Tax Status

The Plan Administrator and the Plan's management believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe the Plan is qualified and the related trust is tax-exempt. The Plan is using a Non-standardized Plan Document and a Custom Non-standardized Adoption Agreement.

### **8. Risks and Uncertainties**

The Plan invests in various investments. Investments are exposed to various risks such as interest rate, market, and credit volatility. Market risks include U.S. and global events that could impact the value of Plan investments. Such events may include public health emergencies, as well as international conflicts, cybersecurity attacks, supply chain disruptions, global monetary policy decisions, inflation, significant economic influences, and other adverse credit and market events and conditions. Due to the level of risk associated with certain investments, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

### **9. Related Party Transactions and Party-In-Interest Transactions**

Certain Plan investments are shares of mutual funds managed by Ascensus Trust, the trustee. Transactions with this party qualify as party-in-interest transactions. Participant loans also qualify as party-in-interest transactions.

### **10. Subsequent Events**

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

The Employer Additional Contributions were temporarily suspended for the 2025 plan year.
