The information included in the supplemental schedules, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedules that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

**Note 1
Description of the Plan**

The following description of the Bowlin Travel Centers, Inc. 401(k) Profit Sharing Plan (the “Plan”) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all full-time employees of Bowlin Travel Centers, Inc. (the “Company”, “Plan Sponsor”, and “Plan Administrator”). The Plan is subject to certain provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”), as amended.

Eligibility

The Plan covers substantially all full-time employees who have attained the age of twenty-one and completed six months of service. Employees then become eligible for participation in the Plan on the first entry date following the date the eligibility requirements are met. Entry dates are the first day of each Plan year and the first day of the seventh month of each Plan year, coincident with the date the requirements are satisfied.

Contributions

Participants may defer a percentage of pretax annual compensation under Section 401(k) of the Internal Revenue Code, subject to certain IRS limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (roll-over). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan has a discretionary matching contribution determined by the Board of Directors on an annual basis. For the year ended December 31, 2024, the employer made a discretionary matching contribution equal to 50% of the participant’s deferral, not to exceed 15% of total compensation. Additional profit sharing amounts may be contributed at the option of the Company’s management. No such additional contributions were made during 2024.

Participant Accounts

Each participant’s account is credited with the participant’s contribution, the Company’s matching contributions and allocations of the Plan’s earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings or account balances, or participant transactions, as defined by the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

Note 1
Description of the Plan (Continued)

Vesting

Participants are immediately vested in their voluntary contributions, plus actual earnings thereon. Vesting in the Company's matching and profit sharing contributions is based on the participant's years of continuous service and the vesting schedule as follows:

<u>Years of service</u>	<u>Vesting Percent</u>
Less than 3	0%
3 or more	100%

A participant's account also becomes fully vested upon the participant's death, total disability, or attaining normal retirement age while an employee.

Notes Receivable from Participants

Participant loans are not allowed under the provisions of the Plan document.

Payment of Benefits

Participants may receive a distribution of the vested portion of some or all of their account in the Plan when employment is terminated. On termination of service due to death, disability, or retirement, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account, or installments as allowable by the Plan. A participant attains normal retirement age under the plan at 65 years of age. Early retirement age is the later of the date a participant has attained age 55 or the 10th anniversary of the first day of the Plan year in which the participant commenced participation in the Plan. Certain post-severance distributions and death benefits payable that exceed \$5,000 may be paid in a single lump-sum cash payment or annual installments.

Forfeited Accounts

Forfeitures are created when participants terminate employment before becoming entitled to their full benefits under the Plan. Any forfeiture balances related to accounts not fully vested may be used to reduce employer matching contributions, to pay Plan expenses, and/or to restore previously forfeited account balances as provided for under the Plan. At December 31, 2024 and 2023, forfeited non-vested accounts amounted to \$13,226 and \$7,451, respectively. During the year ended December 31, 2024, there were no forfeitures used to reduce employer contributions.

Note 2

Summary of Significant Accounting Policies and Use of Estimates

Basis of Accounting

The financial statements have been prepared in accordance with accounting principles generally accepted in the United States of America (“GAAP”), using the accrual method of accounting.

Use of Estimates

The preparation of financial statements in accordance with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities at the date of the financial statements. Accordingly, actual results could differ from those estimates and assumptions.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is that price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan determines its valuation policies by utilizing information provided by the custodian. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan’s gains and losses on investments bought and sold as well as held during the year.

Contributions Receivable

Participant contributions and any related employer matching contributions are recognized in the period during which the Company makes the respective payroll deduction from the participant’s compensation.

Payment of Benefits

Benefits are recorded when paid.

Payment of Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Note 3
Certified Investments

Certain information related to investments disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments held at December 31, 2024 and 2023, and net appreciation in fair value of investments, and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by BOKF, NA (the Custodian of the Plan).

Note 4
Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant for the asset or liability.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts: Valued at the net asset value of units held by the Plan at year end. The common collective trusts are made up of a wide variety of underlying investments such as foreign and domestic stocks and bonds, preferreds, convertibles, cash and other. The net asset value per share ("NAV" as a practical expedient) of common collective trusts are determined on the market value of its underlying investments, which are estimated to be primarily level 1 and level 2 measurements. The common collective trusts' net asset value is not a publicly-quoted price in an active market.

Fair Value Measurements (Continued)**

Pooled separate account: Comprised of the Federated Capital Preservation Fund, which is a collective investment fund that seeks to maintain a stable value of \$10.00 per Unit. The fund cannot guarantee that the value of its Units will always remain at \$10.00. The fund’s investment objective is stability of principal and high current income, which it pursues by investing primarily in guaranteed investment contracts (GICs), money market mutual funds and other stable value products that can be carried at contract value. Because the stable value fund is not available as a publicly traded fund, the unit values are not published. Due to the factors noted, the stable value fund is valued at net asset value (“NAV”) as a practical expedient to fair value and are exempt from classification within the fair value hierarchy.

**Note 5
Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their employer contributions.

Note 6
Tax Status

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the Plan administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

Note 7
Related Party and Party-In-Interest Transactions

Certain plan investments are managed by Bank of Oklahoma. Bank of Oklahoma, a division of BOKF, is the custodian as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Bank of Oklahoma also charges asset management fees, which are paid by the Plan. Bowlin Travel Centers, Inc. has been designated as the Plan Administrator and has assigned particular duties that are normally performed by the Plan Administrator to Bank of Oklahoma.

In general, the administrative expenses for the Plan are paid from the Plan's assets. From time to time certain expenses of the Plan, including legal and accounting fees, are paid by the Plan Sponsor. In addition, certain services to the Plan by the Plan Sponsor were performed at no charge. Administrative fees paid by the Plan or netted against investment returns in 2024 qualify as party-in-interest transactions.

Note 8
Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 9
Subsequent Events

Management has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued.
