## NOTES TO FINANCIAL STATEMENTS

December 31, 2024

### 1. Description of the Plan

The following description of the BAE Systems Applied Intelligence GCS Inc. 401(k) Plan (the Plan), is provided for general information only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) plan sponsored by BAE Systems Applied Intelligence GCS, Inc. (the Company). Eligible employees must attain the age of 21 to participate and can enter the Plan the first day of the month coinciding with or next following the date the employee satisfies the eligibility requirements. Employees covered by a collective bargaining agreement and nonresident aliens are excluded from the Plan. The Plan is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

#### Contributions

Participants may elect to contribute to the Plan up to 100% of their eligible compensation subject to the limitations established by the Internal Revenue Service. Employees are also allowed to make Roth contributions on an after-tax basis. Participants may also rollover amounts from other qualified benefit plans. Rollover contributions are subject to conditions stated in the Plan and the appropriate sections of the Internal Revenue Code (IRC).

Effective January 1, 2024, the Company switched from a safe harbor contribution to an employer matching contribution of 75% of employee deferrals up to a maximum of employee deferrals of 6 percent.

The Company may also make a discretionary profit-sharing contribution to the Plan. The discretionary contribution is determined annually by the Company and is credited to participants' accounts based on a percentage of their compensation. An employee must be employed by the Company on the last day of the Plan year to share in the profit-sharing contribution. The Company did not elect to make any profit-sharing contributions related to 2024.

#### Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of (a) the Company's contribution and (b) Plan earnings or losses, and charged with an allocation of administrative expenses. Allocations are based on participant earnings or losses on account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### 1. Description of the Plan (Continued)

#### Vesting

Participants are immediately vested in their contributions, employer matching contributions and the employer safe harbor matching contributions plus actual earnings or losses thereon. Employer discretionary profit-sharing contributions are vested as follows:

1 year	33%
2 years	66%
3 years or more	100%

Participants are immediately vested in all accounts in the event of death or permanent disability.

#### Forfeitures

Forfeitures of amounts attributable to the nonvested portion of employer contributions may be used to reduce employer contributions or reduce Plan expenses. The balance of unallocated forfeitures as of December 31, 2024 and 2023 were \$1,094 and \$681, respectively. During the year ended December 31, 2024, \$749 of forfeitures were used for Plan expenses.

#### Notes Receivable from Participants

The Plan allows participants to borrow against their accounts. Such loans shall not exceed the lesser of \$50,000 or 50% of the participants' vested interest in their account. The Plan has established a minimum loan request of \$1,000 per loan and the Plan permits only one note per participant at a time. Note terms generally may not exceed five years. The interest rate on the outstanding loan at December 31, 2023 was 6.50% with a maturity of February 2024. Principal and interest are paid ratably through payroll deductions.

#### Benefits

Upon death, disability, or retirement on or after the age 65, participants are entitled to a distribution of the balance of their accounts. Participants are permitted to take in-service distribution upon reaching age 59 ½ and also for hardship withdrawals as determined in accordance with the Plan's provisions. Vested account balances of \$1,000 which do not exceed \$7,000 may be automatically distributed by rollover to an individual retirement account or annuity unless the participant elects a direct distribution or a rollover to an eligible retirement plan. Vested account balances less than \$1,000 will automatically be distributed in the form of a lump sum cash payment.

#### Administrative Expenses

Administrative expenses are paid by the Plan to the extent they are not paid by the Company. Certain expenses relating to purchases, sales or transfers of investments are charged to the investment fund to which the expenses relate.

#### *Plan Termination*

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their total balances.

### 2. **Summary of Significant Accounting Policies**

#### *Basis of Accounting*

The financial statements of the Plan are prepared under the accrual basis of accounting.

#### *Use of Estimates*

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

#### *Investment Valuation and Income Recognition*

Investments in pooled separate accounts are presented at net asset value (NAV), as a practical expedient. See note 6 for further discussion and disclosure related to fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

#### *Notes Receivable from Participants*

Notes receivable are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned on an accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses had been recorded as of December 31, 2024 or 2023. If a participant ceases to make loan repayments and the plan administrator deems the loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

#### *Benefit Payments*

Benefit payments are recorded when paid.

##### Risks and Uncertainties

The Plan provides for various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, liquidity, and credit risk. Due to the level of risk associated with certain investment securities and the level of uncertainty related to changes in the value of investment securities, it is at least reasonably possible that changes in the value of investment securities in the near term would materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits and the statement of changes in net assets available for benefits.

##### Subsequent Events

Events occurring after the statements of net assets available for plan benefits date are evaluated by the Plan to determine whether such events should be recognized or disclosed in the financial statements. The plan administrator has evaluated subsequent events through October 8, 2025 the date the financial statements were available to be issued.

#### 3. Information Certified by Trustee

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the United States Department of Labor's Rules and Regulations for Report and Disclosure under ERISA. Accordingly, as permitted under such election, the plan administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by The Standard Insurance Company as of December 31, 2024 and for the year ending December 31 2024, and by Minnesota Life Insurance Company as of December 31, 2023, except for comparing such information with the related information included in the accompanying financial statements and supplemental schedules. The plan administrator has obtained certifications, stating that the information provided to the plan administrator by the Custodian is complete and accurate. Such certified Plan information includes investments, notes receivable from participants, net appreciation in fair value of investments, interest income on notes receivable from participants, investment transactions and note receivable transactions.

#### 4. Tax Status

The underlying pre-approved profit sharing plan has received an opinion letter from the Internal Revenue Service (IRS) dated June 30, 2020, stating that the form of the Plan is qualified under Section 401 of the Internal Revenue Code (the Code). Any employer adopting this form of the plan will be considered to have a plan qualified under section 401 of the Code, and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the Code to maintain its qualified status. Plan management has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the Code.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken or expected to be taken. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### 5. Party-in-Interest Transactions

The Standard Insurance Company and Minnesota Life Insurance Company, the Custodians of the Plan, manage certain Plan investments; therefore, these transactions qualify as party-in-interest transactions, however, they are exempt from the prohibited transaction rules under ERISA. In addition, notes receivable from participants qualify as party-in-interest transactions.

Administrative expenses include amounts paid for investment management fees and recordkeeping fees to The Standard Insurance Company and Minnesota Life Insurance Company. Certain administrative expenses are included in net appreciation in fair value of investments on the statement of changes in net assets available for benefits, as they are paid through revenue sharing rather than direct payment. The transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transactions rule under ERISA.

#### 6. Fair Value Measurements

The fair value framework establishes a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active exchange markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation method include:

- Quoted prices for similar assets or liabilities in active exchange markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Pooled separate accounts* – Valued at the net asset value of units of a pooled separate account. The net asset value, as provided by the contract issuer, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Pooled separate accounts can be redeemed daily, have daily redemption notice periods and have no unfunded commitments. Plan level redemption from the Stable Value fund may be delayed up to 12 months and participants may be delayed up to 30 days.

#### 7. Late Remittances of Participant Contributions

During 2024, 2023 and 2022, the Company failed to transmit certain participant contributions and loan repayments to the Plan in the amounts of \$32,941, \$13,419 and \$8,871, respectively within the time period prescribed by ERISA. Late transmissions of participant contributions and loan repayments constitute a prohibited transaction under ERISA section 406, regardless of materiality. The Company has transmitted all delinquent participant contributions and loan repayments to the Plan.

#### 8. Other Employer Contribution Receivable

In 2024 and 2023, it was determined that the Plan missed certain contributions. Accordingly, the Plan Sponsor calculated and recorded other employer contributions to correct the operational failures. Other employer contributions receivable of \$12,306 for the year ending December 31, 2024 and \$7,613 for the year ending December 31, 2023.
