Independent Auditor's Report

1. DESCRIPTION OF PLAN

The following description of the Fisher Brothers Employees' Savings Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan established effective August 1, 1990, as restated January 1, 2024. The Plan was set up as a controlled group covering all Fisher Brothers Management Company LLC's (the Plan Sponsor) related entities. The benefits available to each entity within the controlled group are the same. Union employees are not eligible to participate. The Plan has a 401(k) feature and allows for profit sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

Contributions - Each year, participants may contribute up to 80 percent of pretax annual compensation, as defined in the plan document, up to the maximum limits of the Internal Revenue Code (IRC). Participants also may designate all or a portion of their deferral contributions as after-tax contributions into a Roth account. Participants who have attained age 50 before the end of the plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. The Plan includes an automatic enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their deferral rate set at 6 percent of eligible compensation and their contributions invested in a designated fund until changed by the participant. The Plan allows for the Plan Sponsor to make matching contributions based on a percentage determined annually by the Partnership Committee (as defined). For the year ended December 31, 2024, the matching percentage was 50 percent of the first 6 percent of the participating employee's eligible compensation. For 2024, the matching contribution amounted to \$817,387. Additional profit sharing amounts may be contributed at the option of the Partnership Committee. For the year ended December 31, 2024, there were no profit sharing contributions to the Plan.

Participant accounts - An individual participant's account is comprised of the participant's elective deferred contributions, including rollovers, the employer's matching contributions, the employer's profit sharing contributions, applicable fund earnings, an allocation of administrative expenses, and unrealized fair value adjustments. Unrealized fair value adjustments are based on quoted market prices as of the last business day of each year. Allocations are based on participant earnings or account balances, as defined. The ultimate benefit to be received by a participant depends on the aggregate amount contributed to each participant's vested account over the years and the investment earnings allocated to his or her account.

Vesting - Each participant has a fully vested interest in his or her pretax 401(k), rollovers into the Plan from other qualified plans, and after-tax voluntary contributions to the Plan. A participant's vested interest in the employer-matched contribution and profit sharing contribution accounts will be 100 percent under any of the following conditions:

- Death or disability of an employee of the company;
- Termination of the Plan;
- Attainment by an employee of his or her normal retirement date (age 65); and
- Completion of five years of service.

On termination of service, a participant is eligible to receive a single lump sum amount equal to the value at his or her vested account balance.

If the above 100 percent vesting conditions do not apply, a participant's vested interest in the matching contribution and profit sharing contribution accounts will be as follows:

<u>Years of Service</u>	<u>Vested Percentage</u>
Less than 1 year	0%
1 years, but less than 2 years	20%
2 years, but less than 3 years	40%
3 years, but less than 4 years	60%
4 years, but less than 5 years	80%
5 years or more	100%

A year of service is defined as 1,000 hours of service within a calendar year.

Any forfeitures will be used to offset expenses and employer contributions. Forfeitures in the amount of \$34,800 were used to offset investment fees for the year ended December 31, 2024. During 2024, there were \$24,120 in forfeitures, and earnings totaled \$271. At December 31, 2024 and 2023, the forfeited nonvested account totaled \$5,027 and \$15,436, respectively.

Notes receivable from participants - Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50 percent of their vested account balance. The loans are secured by the balance in the participant's account. The interest rate charged will be the current prime lending rate, plus 1 percent, or such other rate as prescribed by the plan administrator based on periodic reevaluations of the adequacy of such rate (rates on existing loans range from 4.25 percent to 9.50 percent for each of the years ended December 31, 2024 and 2023). Principal and interest are paid ratably through payroll deductions. Terms range up to five years or greater for the purchase of a primary residence. If a participant ceases to make loan repayments and the Plan deems the participant's loan to be in default, the participant's loan balance is reduced and a benefit payment is recorded.

Payment of benefits - On termination of service due to death, disability, or retirement, a participant may elect to receive either a lump sum amount equal to the value of the participant's vested interest in his or her account or installment payments, as provided in the plan document. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump sum distribution. If a terminated participant's vested balance is less than or equal to \$5,000, the amount may be automatically distributed in the form of lump sum cash payment. In addition, the Plan allows for hardship distributions if certain criteria are met.

Hardship withdrawals - The Plan permits for hardship withdrawals of a participant's vested account balance. Permissible circumstances for hardship withdrawals include education, purchase of a principal residence, medical expenses, funeral expenses, repairs of damage to a principal residence, and to prevent foreclosure of a principal residence.

Investment options - The plan trustee and custodian determines and approves the investment options set up for the Plan. Upon enrollment in the Plan, a participant can direct contributions into various offered investment options. Empower Trust Company, LLC (Empower), as the trustee and custodian of the Plan, invests monies according to participant directions.

2. SUMMARY OF ACCOUNTING POLICIES

Basis of accounting - The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of estimates - The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment valuation and income recognition - Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 3 for discussion of fair value measurements.

Shares of mutual funds are valued at quoted market prices which represent the net asset value (NAV) of shares held by the Plan at year end. Common collective trusts' fair value is estimated by using NAV as a practical expedient. This is based on information reported by Empower, using the audited financial statements of the collective investment trusts at year end.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes receivable from participants - Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed as incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Payment of benefits - Benefits are recorded when paid.

Expenses - Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements.

Subsequent events - Subsequent events were evaluated through October 3, 2025, the date the financial statements were available to be issued.

3. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification (FASB ASC) 820, *Fair Value Measurement*, are described as follows:

Level 1 - Inputs to the valuation technique are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation technique include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability; and
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation technique are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques used for assets measured at fair value. There have been no changes in the techniques used at December 31, 2024 and 2023.

Mutual funds: Valued at the closing price reported in the active market in which the individual security is traded.

Common collective trusts: Funds composed primarily of fully benefit-responsive investment contracts that are valued at the NAV of units of the bank's collective trust. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund will sell the investments for an amount different from the reported NAV.

4. INFORMATION CERTIFIED BY TRUSTEE

The plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA for 2024 and 2023. Accordingly, Empower, the Trustee of the Plan, has certified to the completeness and accuracy of all investments and notes receivable from participants reported in the accompanying Statements of Net Assets Available for Benefits as of December 31, 2024 and 2023, and the supplemental Schedule H, Line 4i - Schedule of Assets (Held at End of Year) as of December 31, 2024, and the related investment activity and interest income on notes receivable from participants reported in the Statement of Changes in Net Assets Available for Benefits for the year ended December 31, 2024.

5. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS

Empower, as trustee and custodian of the Plan, is considered a party in interest. Fees paid to Empower for the year ended December 31, 2024, totaled \$58,693 and are included in administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits.

Additionally, the Plan issues loans to participants, which are secured by the participant's account balances. These transactions qualify as party in interest transactions.

Certain administrative functions of the Plan are performed by officers or employees of the Plan Sponsor. No such officer or employee receives compensation from the Plan.

Marsh McLennan Agency (MMA), as investment advisors of the Plan, is considered a party in interest. Investment fees paid to MMA for the year ended December 31, 2024, were \$34,800 and are included in administrative expenses in the accompanying Statement of Changes in Net Assets Available for Benefits.

6. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

7. TAX STATUS

The Plan adopted a volume submitter plan offered by Empower Trust Company LLC. The volume submitter plan received an IRS Determination Letter dated November 14, 2022, which stated that the Plan and related trust are designed in accordance with the applicable sections of the IRC. Although the Plan has been amended since receiving the IRS Determination Letter, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax exempt.

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

8. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

9. DELINQUENT PARTICIPANT CONTRIBUTIONS

For the years ended December 31, 2024 and 2023, the Plan Sponsor did not remit certain participant contributions to the Plan on a timely basis as defined by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Untimely remittances identified on the Schedule of Delinquent Participant Contributions, which totaled \$68,848 and \$119,237, were corrected in 2025 and 2024, respectively, using the Voluntary Fiduciary Corrective Program.
