INDEPENDENT AUDITORS' REPORT

To the Investment Committee of

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of The Time Group 401(k) Profit Sharing Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of The Time Group 401(k) Profit Sharing Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Opinion

Note 1: Description of Plan

The following description of The Time Group 401(k) Profit Sharing Plan (the Plan) provides only general information. Participants should refer to the Plan Agreement for a more complete description of the Plan's provisions. Copies of the Plan Agreement are available from the human resources department of The Time Group, Inc.

General

The Plan is a defined contribution Plan covering all eligible employees of The Time Group, Inc., Madison Capital, LLC and WP&M Real Estate Group, LLC (collectively, the Employer). The Plan became effective January 1, 1994 and is subject to the provisions of ERISA. The Investment Committee (Plan management) oversees governance of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Eligibility

All permanent, full-time and selected part-time employees who are grandfathered in under old eligibility rules set by the Employer, who have reached age 21 and have completed 60 days of service, are eligible to participate in the Plan. The Plan allows eligible participants to enter the Plan anytime after the first of the month following 60 days of service.

Contributions

A participant in the Plan may elect to enter into a salary reduction agreement with the Employer, which shall be applicable to such Plan year and subsequent Plan years unless canceled or modified. Under the agreement, the participant agrees to accept a reduction in annual compensation equal to any whole percentage of annual compensation that is not less than 3% and does not exceed the limitations of the Internal Revenue Code (IRC). The Plan also includes an automatic enrollment and salary deferral feature equal to 6% of compensation, unless the participant opts out. In August 2017, the Plan implemented an automatic 1% increase for any participants contributing less than 7%. In 2018, the percentage was increased from 7% to 10%. The Participants have the option to opt out of the automatic deferral option. Participants who are 50 or older may contribute additional catch-up contributions. The salary reduction amount shall then be contributed to the Plan by the Employer on behalf of the participant. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (Rollover). Participants direct the investment of their contributions into various investment options offered by the Plan. In addition, the Employer may make a discretionary matching contribution. During 2024, the Employer made a matching contribution equal to 50% of the participant's elective deferral up to 6% of the participant's salary. For the year ended December 31, 2024, the Employer match totaled \$486,469.

Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contributions and Employer discretionary contributions. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Employer's contribution portion of their accounts is based on years of continuous service. A participant is 100% vested after five years of credited service. Employer matching contributions become fully vested in the event of death, disability, or reaching the Plan's normal retirement age.

Notes Receivable from Participants

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. Loan terms may not exceed five years, except for the purchase of a principal residence of the participant. The loans are secured by the vested balance in the participant's account and bear interest at a rate commensurate with prevailing rates as determined by the Plan Administrator. Principal and interest are paid ratably through payroll deductions.

Payment of Benefits

Upon termination of service due to death, disability, retirement or termination, participants or beneficiaries can elect to receive a lump sum amount equal to the value of the participant's vested interest in his or her account less taxes and penalties, as applicable.

Hardship Withdrawals

Hardship withdrawals are permitted in accordance with the Plan Agreement.

Forfeited Accounts

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$39,468 and \$50,316, respectively. These accounts may be used to pay Plan administrative expenses and Employer contributions. In 2024, employer contributions and Plan expenses were reduced by \$77,954 from forfeited nonvested accounts.

Note 2: Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosures of contingent assets and liabilities. Actual results could differ from those estimates.

Contributions

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

Note 2: Summary of Significant Accounting Policies (Continued)

Investment Valuation and Income Recognition

Investments are reported at fair value except for direct investments in fully benefit-responsive investment contracts (FBRIC), which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The Plan's investment committee determines the Plan's valuation policies utilizing information provided by the investment advisors and trustees. See Note 3 for discussion of fair value measurements.

Indirect investments in FBRIC, i.e., investments in stable value common or collective trusts (CCT's), are not in the scope of the FBRIC guidance. As such, the contract value is presented as fair value and is reported on the statements of net assets available for benefits with investments at fair value.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balances plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are charged directly to the borrowing participant's account and are included in administrative expenses when incurred.

Contributions Receivable

Contributions from the Employer and participants of the Plan are accrued in the period in which they become obligations under provisions of the Plan Agreement. The contributions not received by the Plan for the years ended December 31, 2024 and 2023 amounted to \$63,238 and \$68,427, respectively, and are reported as receivables on the statements of net assets available for benefits.

Excess Contributions Payable

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions. The Plan distributed the 2024 and 2023 excess contributions to the applicable participants prior to March 15, 2025 and 2024, respectively.

Payment of Benefits

Benefits are recorded when paid.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employer. Expenses that are paid by the Employer are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

Date of Management's Review

The Plan has evaluated events and transactions that occurred during the period from the date of the financial statements through October 2, 2025, the date the Plan's financial statements were available to be issued. There were no events or transactions that occurred during the period, other than those disclosed in Note 4, that materially impacted the amounts or disclosures in the Plan's financial statements.

Note 3: Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Fair Value Measurements

Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Fair Value Measurements

Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Fair Value Measurements

Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual Funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common/Collective Trust: A stable value fund that is comprised primarily of fully benefit-responsive investment contracts that is valued at the net asset value of units of the collective trust. The net asset value is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the collective trust, the issuer reserves the right to require 12 months notification in order to ensure that securities liquidations will be carried out in an orderly business manner.

Money Market Funds: Valued at cost which approximates fair value.

The trustees also certified the completeness and accuracy of \$1,512,250 of the net appreciation (depreciation) in fair value of investments, \$522,292 of dividend and interest income, and \$14,061 of interest on notes receivable related to the aforementioned investments and notes receivable from participants for the year ended December 31, 2024.

During February 2025, Principal Trust Company became the trustee and recordkeeper of the Plan. All Plan assets and liabilities were transferred to Principal Trust Company.

Note 5: Common/Collective Trust

The Plan invests in a common/collective trust, T. Rowe Price Stable Value Fund, which invests in fully benefit-responsive investment contracts. A holding in these funds is considered an indirect investment in fully benefit-responsive contracts, which are reflected at fair value in the accompanying statements of net assets available for benefits.

As of December 31, 2024 and 2023, there were no reserves against the wrap contracts' carrying values for credit risk of the contract issuers. Interest rates are reviewed on a quarterly basis for resetting.

Certain events could limit the ability of the Plan to transact at contract value with the issuer of the contracts held by the T. Rowe Price Stable Value Fund. Such events could include, but are not limited to, the following: the establishment of a defined contribution plan that competes with the Plan for contributions, substantive modification to the T. Rowe Price Stable Value Fund or the administration of the T. Rowe Price Stable Value Fund, change in law, regulation or administrative ruling applicable to the Plan that could have a material adverse effect on cash flow, transfer to a competing investment option, and failure of the Plan to qualify under the applicable sections of the IRC. Withdrawals initiated by the Plan Administrator will normally be provided at contract value as soon as feasible within 15 days following written notice. The Plan does not believe that the occurrence of any of these events, which could limit the Plan's ability to transact at contract value with participants, is probable.

Note 6: Plan Termination

Although it has not expressed any intent to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their Employer contributions.

Note 7: Tax Status

The Plan is a qualified Plan under §401(a) and §401(k) of the IRC and is, therefore, exempt from federal income taxes under the provisions of IRC §501(a).

The IRS has informed the Company by opinion letter dated June 1, 2015, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan is subject to routine audits by tax authorities; however, there are currently no audits for any tax periods in progress. The previous three tax years remain subject to examination by the IRS.

Note 8: Related Party Transactions and Party-in-Interest Transactions

Certain Plan investments are interests in registered investment companies managed by T. Rowe Price Trust Company. T. Rowe Price Trust Company is a trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Certain fees incurred by the Plan for the investment management services are included in net appreciation (depreciation) in fair value of the investment, as they are paid through revenue sharing, rather than a direct payment. As described in Note 2, the Plan made a direct payment for certain administrative expenses of \$37,123, which was not covered by revenue sharing. The Plan sponsor pays directly any other fees related to the Plan's operation.

Some trustees of the Plan are also participants in the Plan.

All of these party-in-interest transactions are exempt from the prohibited transaction rules of ERISA.

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

Note 11: Rollover Contributions

In accordance with the Plan Agreement, qualified direct rollovers are permitted by the Plan. There were \$26,599 in contributions rolled into the Plan during the year ended December 31, 2024.

Note 12: Prohibited Transactions
