## **INDEPENDENT AUDITOR'S REPORT**

To the Plan Administrator of  
Employee Benefit Plan of Community Mental Health Centers of Warren County Inc.

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

I have performed audits of the accompanying financial statements of Employee Benefit Plan of Community Mental Health Centers of Warren County Inc., an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net asset available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

### **Opinion**

Notes to Financial Statements

Years Ended December 31, 2024 and 2023

**1. DESCRIPTION OF THE PLAN:**

The following brief description of the Employee Benefit Plan of Community Mental Health Centers of Warren County Inc. (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

**General**—The Plan, which became effective January 1, 2002, is a defined contribution plan. Employees of Solutions Community Counseling and Recovery Centers (the "Sponsor"), are eligible for entry into the Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

Prior to 2015, the Plan was called Solutions Community Counseling and Recovery Centers 401(k) Plan.

Prior to 2011, the Plan was called the Mental Health & Recovery Center 401(k) Plan, and its sponsor was Mental Health & Recovery Center of Clinton County, Inc. During 2011, Mental Health & Recovery Center of Clinton County, Inc. merged with the current sponsor and the Plan's name was changed.

**Contributions**—Participant contributions are limited to not exceed a dollar limit that is set by law. Participants may contribute amounts representing distributions from other qualified defined benefit or contribution plans. In addition, the Plan provides for Roth Elective Deferrals.

The Sponsor will make matching contribution equal to 100% of their deferrals not to exceed 3% of annual compensation to participants who have attained age 21 and completed 1,000 hours of service with the twelve month time period following their date of hire.

There is a limit placed on the percent of compensation deferred by participants. The Sponsor determines that the salary deferral percentage, the employer matching percentage, and the total defined contribution percentage comply with several tests as prescribed by law. If the tests are not met, the Sponsor reduces the contribution percentage of those individuals that exceed the limits and refunds the excess contributions to the individual.

**Participant accounts**—Each participant account is credited with the participant's contribution and allocations of the sponsor contributions and the plan earnings. The benefit to which a participant is entitled is the amount that can be provided from the participant's vested account.

**Vesting**—Participants are immediately vested in their salary deferrals plus actual earnings thereon.

For matching contributions, participants are 25% vested after two years of service, 50% after three years, 75% after four years, and 100% after five years. Also, matching contributions are fully and automatically vested when participants reach age 65 or are totally and permanently disabled or die.

**Loans**—No loans are permitted under the Plan.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

The following are the significant accounting policies of the Plan:

**Basis of accounting**—The financial statements of the Plan are prepared using the accrual method of accounting.

**Asset valuation and income recognition**—Assets are valued at fair value. Fair value is reported by Mutual of America, the custodian, based on the market value of underlying securities. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Net appreciation/depreciation in the fair value of assets represents net realized gains/losses on assets sold during the year and net unrealized gains/losses on assets held at the end of the year. These assets, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain assets, it is reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

A participant may direct the investment of the portion of their account attributable to deferral and matching contributions. Forty-one funds are available, which include large, med, and small cap funds, international funds, fixed income funds, and balanced funds. Participants may change their investment options at any time.

**Withdrawals and payment of benefits**—Withdrawals and benefits are recorded upon distribution.

**Administrative expenses**—Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. The Sponsor has elected to pay certain costs associated with plan administration from its operating assets.

**Estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **3. INFORMATION CERTIFIED BY THE CUSTODIAN:**

All financial data related to investments used in the preparation of the statements of net assets available for benefits, statements of changes in net assets available for benefits and supplemental schedule of assets (held at end of year) have been certified as to accuracy and completeness by the Plan's custodian, Mutual of America.

### **4. TAX STATUS:**

The Sponsor adopted a Defined Contribution Prototype Plan & Trust, for which a letter from the Internal Revenue Service has been received indicating that an employer who adopts this prototype plan will be considered to have a plan qualified under applicable sections of the Internal Revenue Code (IRC). The Sponsor has elected not to request a separate determination letter for the Plan. The Sponsor and the plan's administrator believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, they believe the Plan was qualified as of the financial statement date.

With few exceptions, the Plan's federal information returns are no longer subject to examination by the Internal Revenue Service for the years before 2021.

### **5. PLAN TERMINATION:**

See Note 8. Subsequent Events for discussion of plan termination.

### **6. RELATED-PARTY TRANSACTIONS:**

Certain plan investments are units of exchange traded funds managed by Mutual of America, which is the custodian as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions.

## **7. FAIR VALUE MEASUREMENTS:**

The Plan applies accounting principles generally accepted in the United States of America (GAAP) for fair value measurements of financial assets that are recognized or disclosed at fair value in the financial statements on a recurring basis. Fair value is defined as the price that would be received for an asset or paid to transfer a liability, in the principal or most advantageous market for the asset or liability, in an orderly transaction between market participants at the measurement date. GAAP establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. This hierarchy requires entities to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of inputs used to measure fair value are as follows:

- Level 1: Observable inputs such as quoted prices in active markets;
- Level 2: Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The Plan has determined that the only material financial assets or liabilities that are measured at fair value on a recurring basis and categorized using the fair value hierarchy are investments. Investments are made up of equity securities, fixed income securities, and real estate. These investments are valued using quoted market prices for similar assets. All investments at December 31, 2024 are measured at Level 1 inputs. Significant transfers between fair levels are determined at the end of the reporting period. There were no significant transfers in 2024.

## **8. SUBSEQUENT EVENTS:**

The Sponsor terminated the Plan in 2025. All benefits were to be distributed to participants and beneficiaries in proportion to their respective account balances in 2025, as stipulated in the termination resolution.

The Sponsor evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements considered events through October 7, 2025, the date on which the financial statements were available to be issued.

**Vesting**—Participants are immediately vested in their salary deferrals plus actual earnings thereon.

For matching contributions, participants are 25% vested after two years of service, 50% after three years, 75% after four years, and 100% after five years. Also, matching contributions are fully and automatically vested when participants reach age 65 or are totally and permanently disabled or die.

**Loans**—No loans are permitted under the Plan.

## **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:**

The following are the significant accounting policies of the Plan:

**Basis of accounting**—The financial statements of the Plan are prepared using the accrual method of accounting.

**Asset valuation and income recognition**—Assets are valued at fair value. Fair value is reported by Mutual of America, the custodian, based on the market value of underlying securities. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 6 for discussion of fair value measurements.

Net appreciation/depreciation in the fair value of assets represents net realized gains/losses on assets sold during the year and net unrealized gains/losses on assets held at the end of the year. These assets, in general, are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain assets, it is reasonably possible that changes in the values of investment securities will occur in the near term and, that such changes could materially affect the amounts reported in the statements of net assets available for benefits.

A participant may direct the investment of the portion of their account attributable to deferral and matching contributions. Forty-one funds are available, which include large, med, and small cap funds, international funds, fixed income funds, and balanced funds. Participants may change their investment options at any time.

**Withdrawals and payment of benefits**—Withdrawals and benefits are recorded upon distribution.

**Administrative expenses**—Certain administrative functions are performed by officers or employees of the Sponsor. No such officer or employee receives compensation from the Plan. The Sponsor has elected to pay certain costs associated with plan administration from its operating assets.

**Estimates**—The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

### **3. INFORMATION CERTIFIED BY THE CUSTODIAN:**

All financial data related to investments used in the preparation of the statements of net assets available for benefits, statements of changes in net assets available for benefits and supplemental schedule of assets (held at end of year) have been certified as to accuracy and completeness by the Plan's custodian, Mutual of America.

### **4. TAX STATUS:**

The Sponsor adopted a Defined Contribution Prototype Plan & Trust, for which a letter from the Internal Revenue Service has been received indicating that an employer who adopts this prototype plan will be considered to have a plan qualified under applicable sections of the Internal Revenue Code (IRC). The Sponsor has elected not to request a separate determination letter for the Plan. The Sponsor and the plan's administrator believe that the Plan is currently designed and being operated in compliance with applicable requirements of the IRC. Therefore, they believe the Plan was qualified as of the financial statement date.

With few exceptions, the Plan's federal information returns are no longer subject to examination by the Internal Revenue Service for the years before 2021.

### **5. PLAN TERMINATION:**

See Note 8. Subsequent Events for discussion of plan termination.

### **6. RELATED-PARTY TRANSACTIONS:**

Certain plan investments are units of exchange traded funds managed by Mutual of America, which is the custodian as defined by the Plan and, therefore, these transactions qualified as party-in-interest transactions.

## **7. FAIR VALUE MEASUREMENTS:**

The Plan applies accounting principles generally accepted in the United States of America (GAAP) for fair value measurements of financial assets that are recognized or disclosed at fair value in the financial statements on a recurring basis. Fair value is defined as the price that would be received for an asset or paid to transfer a liability, in the principal or most advantageous market for the asset or liability, in an orderly transaction between market participants at the measurement date. GAAP establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. This hierarchy requires entities to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of inputs used to measure fair value are as follows:

- Level 1: Observable inputs such as quoted prices in active markets;
- Level 2: Inputs, other than the quoted prices in active markets, that are observable either directly or indirectly; and
- Level 3: Unobservable inputs in which there is little or no market data, which require the reporting entity to develop its own assumptions.

The Plan has determined that the only material financial assets or liabilities that are measured at fair value on a recurring basis and categorized using the fair value hierarchy are investments. Investments are made up of equity securities, fixed income securities, and real estate. These investments are valued using quoted market prices for similar assets. All investments at December 31, 2024 are measured at Level 1 inputs. Significant transfers between fair levels are determined at the end of the reporting period. There were no significant transfers in 2024.

## **8. SUBSEQUENT EVENTS:**

The Sponsor terminated the Plan in 2025. All benefits were to be distributed to participants and beneficiaries in proportion to their respective account balances in 2025, as stipulated in the termination resolution.

The Sponsor evaluates events and transactions occurring subsequent to the date of the financial statements for matters requiring recognition or disclosure in the financial statements. The accompanying financial statements considered events through October 7, 2025, the date on which the financial statements were available to be issued.
