INDEPENDENT AUDITOR'S REPORT

To the BVPV Styrenics LLC Benefits Committee as Administrator of the  
BVPV Styrenics LLC Capital Accumulation Plan

**Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the financial statements of the BVPV Styrenics LLC Capital Accumulation Plan (Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of and for the years ended December 31, 2024 and 2023, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

**Opinion**

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section:

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

## NOTES TO FINANCIAL STATEMENTS

(All amounts in U.S. dollars, unless otherwise noted)

### 1. Description of the Plan

The following description of BVPV Styrenics LLC Capital Accumulation Plan (the “Plan”) provides only general information. Participants should refer to the Plan document and the Summary Plan Description for a complete description of the Plan’s provisions.

#### General

The Plan is a defined contribution plan that was established by NOVA Chemicals Inc. on October 1, 1996, to provide the union employees of the Beaver Valley Plant and the Indian Orchard Site (who joined the amended plan on January 1, 2000) the opportunity to save for their future financial needs. On April 1, 2008, the Indian Orchard Site employees became employees of INEOS NOVA LLC and ceased participation in the Plan at that time. On October 30, 2020, NOVA Chemicals Inc. divested its Expandable Styrenics business to Styropek USA, Inc. As part of this transaction, all active employees of NOVA Chemicals Inc.’s Beaver Valley site transferred to BVPV Styrenics LLC (the “Company”). Effective October 30, 2020, the Company assumed sponsorship of the Plan, and the name of the Plan was changed from NOVA Chemicals Inc. Capital Accumulation Plan to BVPV Styrenics LLC Capital Accumulation Plan. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”).

On November 1, 2024, the Company announced and issued WARN notices that its Beaver Valley facility will cease production beginning January 2025 and permanently idle the facility by early 2026.

On December 16, 2024, the Company entered into a plant shutdown agreement with the associated union. Employee layoffs began in January 2025 and continued to occur in phases, with the last union terminations in July 2025.

The Company anticipates that the turnover rate associated with these terminations will exceed 20% of Plan participants, thereby triggering a partial termination of the Plan in 2025. The Company has not expressed the intent of fully terminating the Plan.

#### Eligibility

Employees are eligible to participate in the Plan on their date of hire.

#### Contributions

Participants may make voluntary contributions to the Plan through payroll deductions of not less than one percent (1%) or more than one hundred percent (100%) of their pre-tax total pay, with such contributions not exceeding \$23,000 and \$22,500 in total, per year, in calendar years 2024 and 2023, respectively. Additionally, participants age 50 and older may make “catch-up” contributions not to exceed \$7,500 for calendar years 2024 and 2023. All participant contributions are subject to contribution limitations as determined by the Internal Revenue Service (“IRS”). Participants may also rollover into the Plan amounts representing distributions from other qualified retirement plans or individual retirement accounts. Contributions and any investment earnings are not taxable until withdrawn.

Effective January 1, 2010, the Plan was amended to reduce the Company contribution to zero percent (0%).

Voluntary contributions and employee rollovers are directed by the individual participants to investment choices offered under the Plan. Participants who do not select new investment options are defaulted to the Schwab Target Index fund with the maturity date closest to the participant’s 65<sup>th</sup> birthday at the close of the re-enrollment window.

#### Participant Accounts, Vesting and Distributions

Each participant’s account is credited with the participant’s contributions and account earnings. Each participant is, at all times, one hundred percent (100%) vested in his or her participant account. Upon retirement or termination of employment, participants may receive the value of their account. Distributions are made in lump-sum payments.

#### Notes Receivable from Participants

Loans are available to all participants, other than participants who have terminated employment from the Company, enabling them to borrow from their account in an amount not in excess of the lesser of (a) \$50,000 reduced by the participant’s highest outstanding loan balance from the Plan during the preceding 12-month period; or (b) 50% of the value of their account as of the date of which the loan is approved. The loans bear interest at a rate commensurate with prevailing rates as determined by the Plan administrator. Loans bear interest at rates of prime plus two percent (prime + 2%), are secured by the assets in the participant’s account and must be repaid within five years. At December 31, 2024 and 2023, the prime rate was 7.50% and 8.50%, respectively. Interest rates on outstanding participant loans are currently 5.25% to 10.50%.

## 1. Description of the Plan (Continued)

### Administration

The Company is the designated administrator of the Plan. The Company may delegate its administrative responsibilities to another person or persons but shall remain the named fiduciary under ERISA.

### Trustee

The investments are held under the terms of a trust agreement with Charles Schwab Trust Bank.

## 2. Summary of Significant Accounting Policies

### Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with U.S. Generally Accepted Accounting Principles ("GAAP").

### Use of Estimates

The preparation of financial statements in conformity with GAAP requires management to make estimates that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### Investment Valuation and Income Recognition

Investments held by the Plan are stated at fair value, which is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). See Note 4 for further discussion and disclosures related to fair value measurements.

Investment contracts held by the Plan are reported at contract value, which is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan.

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, or (5) premature termination of the contract. No events are probable of occurring that might limit the ability of the Plan to transact at contract value with the contract issuers and that also would limit the ability of the Plan to transact at contract value with the participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without the consent of the issuer.

As of December 31, 2024 and 2023, the Plan invests in the New York Life Anchor Acct IV group annuity contract, a fully benefit-responsive annuity contract. New York Life maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The guaranteed investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Because the guaranteed investment contract meets the criteria to be considered fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to the guaranteed investment contract. The guaranteed investment contract is presented on the face of the statements of net assets available for benefits at contract value. Contract value, as reported to the Plan by New York Life, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer or otherwise. The contract value of the investment contract at December 31, 2024 and 2023 was \$1,657,645 and \$1,660,287, respectively.

The fully benefit-responsive contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on an accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold, as well as held, during the year.

## 2. Summary of Significant Accounting Policies (continued)

### Payment of Benefits

Benefit payments are recorded as distributed.

### Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest, which approximates fair value. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as a distribution based upon the terms of the Plan document. Interest income on notes receivable from participants is recorded when it is earned.

### Administrative Costs

Certain expenses of maintaining and administering the Plan are paid by the Plan, unless otherwise paid by the Plan sponsor. Fees related to origination of notes receivable from participants are paid directly by the participant.

### Subsequent Events

Management has evaluated subsequent events for the Plan through October 3, 2025, the date the financial statements were available to be issued, and concluded that all events that would require recognition or disclosure are appropriately reflected in these financial statements.

## 3. Investments and Certification by the Trustee (Unaudited)

Management has elected the method of annual reporting permitted by ERISA Section 103(a)(3)(c) pursuant to 29 CFR 520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Charles Schwab Trust Bank, a qualified institution, has certified that the following investment information included in the accompanying financial statements and the ERISA-required supplemental schedule is complete and accurate:

- Investments and notes receivables from participants shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Interest (including interest on notes receivable from participants), dividends and net appreciation of investments as shown in the statements of changes in net assets available for benefits for the years ended December 31, 2024 and 2023.
- Investment information included in the schedule of assets (held at end of the year) as of December 31, 2024, as shown on the ERISA-required supplemental schedule.

At the request of management, the Plan's independent auditor did not perform auditing procedures with respect to this certified investment information, except for comparing such certified investment information to the related investment information included in the financial statements and ERISA-required supplemental schedule.

## 4. Fair Value Measurement

Financial Accounting Standards Board ("FASB") Accounting Standards Codification ("ASC") 820 *Fair Value Measurement and Disclosures* defines fair value, provides the framework for measuring fair value and expands disclosure about fair value measurements. The framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described below:

Level 1	Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.
Level 2	Inputs to the valuation methodology include: (i) quoted prices for similar assets or liabilities in active markets; (ii) quoted prices for identical or similar assets or liabilities in inactive markets, (iii) inputs other than quoted prices that are observable for the asset or liability; or inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.
Level 3	Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

#### 4. Fair Value Measurement (Continued)

The asset's fair value measurement level within the fair value measurement hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value.

*Shares of registered investment companies:* Valued based on net asset values reported on the active market and shares held by the Plan at year-end.

*Shares of common collective trust funds:* Valued based on the units of the collective trust funds held by the Plan at year-end times the respective unit value. Based on the net asset valuation of these funds, they are not classified within the fair value hierarchy. The unit values are based on significant observable inputs, although they are not based on quoted market prices in an active market. The Plan's investment in the collective trust funds is not subject to any withdrawal or redemption restrictions. The Plan has no unfunded commitments relating to the collective trust funds for the years then ended.

The methods described above might produce a fair value calculation that might not be indicative of net realizable value or reflective of future fair values. Furthermore, even though the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date. There have been no changes in the methodologies used at December 31, 2024 and 2023.

#### 5. Risks and Uncertainties

The Plan invests in various investment securities that are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the accompanying statements of net assets available for benefits.

#### 6. Income Tax Status

The Plan has received a determination letter from the IRS dated June 24, 2014, stating that the Plan is qualified under Section 401(a) of the Internal Revenue Code ("IRC") and, therefore, the related trust is exempt from taxation. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualification. The Plan has been amended since receiving its determination letter. However, the Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and has no income subject to unrelated business income tax.

## **6. Income Tax Status (Continued)**

Plan management is required to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the organization has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes that the Plan is no longer subject to income tax examinations for years prior to 2021.

## **7. Related-Party Transactions**

Certain Plan investments are managed by the trustee of the Plan. Transactions in these investments are exempt from the party-in-interest transaction prohibition. Certain administrative functions are performed by employees of the Company at no cost to the Plan.
