Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed an audit of the financial statements of General Hotels Corporation Retirement Savings Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audit of General Hotels Corporation Retirement Savings Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosures under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audit need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from Voya Retirement Insurance and Annuity Company (Voya) as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 6 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section

- the amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the accompanying financial statements related to assets held by and certified to by Voya agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditors' Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of General Hotels Corporation Retirement Savings Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America; and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free of material misstatement, whether due to fraud or error. 

1. DESCRIPTION OF PLAN

The following brief description of the General Hotels Corporation Retirement Savings Plan (the Plan) provides only general information. Plan participants should refer to the Plan Agreement for a more complete description of the Plan's provisions.

GENERAL

The Plan was organized effective January 1, 1996, as a defined contribution profit-sharing and retirement savings plan covering all employees of certain affiliated inns (Employer) managed by General Hotels Corporation (Company, Sponsor) who have completed one (1) year of service or 1,000 hours in a 12-month period and who are at least 21 years of age. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The assets of the Plan are held and recordkeeping services are provided by Voya Retirement Insurance and Annuity Company (Voya).

CONTRIBUTIONS

The participating Employers may contribute annually to the Plan a percentage of the participant's elective deferral, not to exceed 2% of the participant's compensation. Participants may elect to contribute up to an annual maximum prescribed under the Internal Revenue Code (IRC). Participants may also elect to defer to the Plan any Employer paid cash bonus for the plan year. Participants may also contribute amounts distributed from other qualified plans. Participants over age 50 may make additional contributions as provided by the IRC. Participants who do not complete a salary deferral agreement upon Plan eligibility will automatically be enrolled in the Plan with salary deferral of 4% of eligible earnings contributed to the Plan increasing 1% each year until the salary deferral reaches 10%.

PARTICIPANT ACCOUNTS

Individual accounts are maintained for each participant and are credited with each participant's contributions, Employer matching contributions and the Plan's earnings or losses. Participants may direct their contributions into several pooled separate accounts or a guaranteed interest account.

BENEFITS

Distribution of a participant's interest or partial interest in the Plan may occur after attainment of age 59½, upon retirement at age 65, early retirement at age 55 with 5 years of service, termination of employment, disability or death, or the participant's ability to demonstrate an immediate and heavy financial need. Benefits are recorded when paid.

VESTING

Participants are always 100% vested in their account balances arising from participant contributions. Employer contributions vest 100% after 3 years of service. Forfeitures are used first to pay administrative expenses and next to reduce Employer contributions.

NOTES RECEIVABLE FROM PARTICIPANTS

Participants may borrow from their accounts a minimum of \$1,000 and up to the lesser of \$50,000 or 50% of the vested account balance. Only one note may be granted each year and only one note may be outstanding. The interest rate is based on similar notes from commercial lending institutions. Notes must be repaid ratably as to principal and interest over a period not to exceed five years through payroll withholdings. The note is secured by the participant's account balances.

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

PLAN TERMINATION

While the Company hopes and expects the Plan to continue indefinitely, it reserves the right to terminate, discontinue making contributions to, amend or modify the Plan at any time, acting through written resolution of the Company's board of directors. In the event the Company terminates its participation in the Plan, the affected participants who are actively employed by the Company at the time of termination, shall be fully vested for amounts credited their accounts on the termination date. The Plan will arrange for distributions upon Plan termination as soon as administratively possible.

FORFEITED ACCOUNTS

Upon a participant's separation from services, nonvested accounts are forfeited to the Plan and are used to pay administrative expenses and reduce employer contributions. At December 31, 2024 and 2023, forfeited nonvested accounts were \$49,414 and \$59,294 respectively. During the year ended December 31, 2024, \$14,212 and \$50,813 of participant nonvested account forfeitures were used to cover administrative costs and employer contributions, respectively.

2. SIGNIFICANT ACCOUNTING POLICIES

BASIS OF ACCOUNTING

The financial statements of the Plan are prepared on the accrual basis of accounting whereby additions and deductions are recorded in the year in which they are incurred rather than in the year in which they are received or paid.

ESTIMATES

The Plan Administrator uses estimates and assumptions in preparing financial statements in conformity with accounting principles generally accepted in the United States of America. Those standards require the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits, the disclosure of contingencies and the reported additions to and deductions from net assets available for benefits. Accordingly, actual results could differ from those estimates.

INVESTMENTS

Voya Retirement Insurance and Annuity Company (Voya) maintains the Plan's investment funds. Investments in pooled separate accounts are credited with earnings and gains or losses on the pooled investments. The separate accounts are stated at fair value as reported to the Plan by Voya based on the quoted market prices of the underlying mutual funds. The unit value of the separate account is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the net asset value (NAV), or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares.

Those separate accounts investing in mutual funds or equity securities are measured using quoted market prices in active markets for identical assets.

Those separate accounts directly investing in fixed maturity securities are measured based on the pricing data provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

EXPENSES OF THE PLAN

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses. Investment-related expenses are included in net appreciation of fair value of investments.

3. INCOME TAXES

The Plan is a prototype plan, and is relying on a determination letter dated June 30, 2020, received by the prototype sponsor, in which the Internal Revenue Service stated that the prototype plan is designed in accordance with applicable sections of the IRC. Although the prototype plan has been amended since receiving the determination letter, the Plan Administrator and the Plan's tax counsel believe that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believe that the Plan is qualified and tax exempt.

The Plan evaluates all significant tax positions as required by accounting principles generally accepted in the United States of America. As of December 31, 2024, the Plan does not believe that it has taken any tax positions that would require the recording of any additional tax liability nor does it believe that there are any unrealized tax benefits that would either increase or decrease within the next twelve months. The Plan's income tax returns are subject to examination by the appropriate regulatory authorities; there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to tax examinations for years prior to 2021.

Party-in-interest transactions include those with fiduciaries of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50% or more of such an employer or employee association, or relatives of such a person.

At December 31, 2024 and 2023, certain investments of the Plan were held in investment funds managed by Voya. Agresta, Storms & O'Leary, PC served as the Plan's auditors. Transactions with these parties qualify as exempt party-in-interest transactions. The Company provides certain accounting, recordkeeping and administrative services to the Plan for which it receives no compensation.

5. STABLE VALUE INVESTMENTS

The Plan had an investment in the Voya Fixed Account (the Fund) at December 31, 2024 and 2023. The Fund is a fully benefit-responsive investment fund for the collective investment of qualified plans. Because this investment is fully benefit-responsive, contract value is the relevant measurement attribute for that portion of the net assets available for benefits attributable to this fully benefit-responsive contract. Contract value represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct withdrawal or transfer of all or a portion of their investment at contract value. There are no reserves against contract value for credit risk of the contract issuer or otherwise.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events include the following: (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another Plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the plan sponsor or other Plan sponsor events (for example, divestures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the fund to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA. The Plan Administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contract value of the investment in the Voya Fixed Account was \$643,033 and \$825,343 at December 31, 2024 and 2023, respectively.

6. INVESTMENTS

The Plan Administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, Voya, the custodian of the Plan at December 31, 2024 and 2023 has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits and the schedule of assets (held at end of year) as of December 31, 2024 and 2023, and the related investment activity reflected in the statement of changes in net assets available for benefits for the year ended December 31, 2024.

7. FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board ASC 820, *Fair Value Measurements and Disclosures*, defines fair value, establishes a framework for measuring fair value under accounting principles generally accepted in the United States of America and expands disclosures about fair value measurements. ASC 820 establishes a three-level fair value hierarchy that prioritizes the inputs used to measure fair value. The hierarchy requires the Plan to maximize the use of observable inputs and minimize the use of unobservable inputs. The three levels of the inputs used to measure fair value are as follows:

Level 1 – Quoted prices in active markets for identical assets or liabilities.

Level 2 – Observable inputs other than quoted prices in Level 1, such as quoted prices for similar assets and liabilities in active markets, similar assets and liabilities in markets that are not active or can be corroborated by observable market data.

Level 3 – Unobservable inputs that are supported by little or no market activity and that are significant to the fair value of the assets and liabilities. This includes certain pricing models, discounted cash flow methodologies and similar techniques that use significant unobservable inputs.
