## Independent Auditor's Report

To the Plan Administrator  
Trinity Health 401(k) Retirement Savings Plan

### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audits**

We have performed audits of the financial statements of Trinity Health 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statement of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023 and the related statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024 and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from qualified institutions as of December 31, 2024 and 2023 and for the year ended December 31, 2024 stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

### **Opinion**

In our opinion, based on our audits and on the procedures performed as described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.
- The information in the accompanying financial statements related to assets held by and certified to by qualified institutions agrees to, or is derived from, in all material respects, the information prepared and certified by institutions that management determined meets the requirements of ERISA Section 103(a)(3)(C).

### **Basis for Opinion**

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the *Auditor's Responsibilities for the Audits of the Financial Statements* section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

### ***Basis of Accounting***

We draw attention to Note 2 to the modified cash basis financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on a modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

### ***Responsibilities of Management for the Financial Statements***

Management is responsible for the preparation and fair presentation of the financial statements in accordance with the modified cash basis of accounting described in Note 2 and for determining that the modified cash basis of accounting is an acceptable basis for the preparation of the financial statements in the circumstances. Management is also responsible for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of modified cash basis financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

Management is also responsible for maintaining a current plan instrument, including all plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or that may become due to such participants.

### ***Auditor's Responsibilities for the Audits of the Financial Statements***

Except as described in the *Scope and Nature of the ERISA Section 103(a)(3)(C) Audits* section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and, therefore, is not a guarantee that audits conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

- Exercise professional judgment and maintain professional skepticism throughout the audits.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Our audits did not extend to the certified investment information except for obtaining and reading the certifications, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of the modified cash basis of accounting described in Note 2.

Accordingly, the objective of the ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with the modified cash basis of accounting described in Note 2.

### Note 1 - Plan Description

The following description of Trinity Health 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### **General**

Trinity Health Corporation (the "Plan Sponsor") maintains the Plan for eligible participating employers affiliated with the Plan Sponsor.

The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

#### **Employee Eligibility**

All full- and part-time employees of currently participating employers are eligible to participate in the Plan as soon as administratively feasible following their date of hire. Employees are eligible to receive employer contributions after meeting certain eligibility criteria.

#### **Administration**

The Plan Sponsor is the plan administrator and a named fiduciary and has responsibility for the administration of the Plan. The benefits committee of the Plan (the "Benefits Committee") is a named fiduciary of the Plan and has been appointed by the Plan Sponsor to assist in administration of the Plan. Fidelity Management Trust Company (Fidelity) performs certain administrative record keeping for the Plan and is also named a fiduciary. Investment management fees and trustee fees are paid by the Plan in accordance with the plan document.

#### **Contributions**

The Plan provides for employee salary deferral contributions up to a maximum of 75 percent of annual eligible compensation subject to maximum tax-deferred limitations established by the Internal Revenue Code. Participants may also make contributions to the Plan in the form of a rollover of funds from another qualified plan. New employees of participating employers are automatically enrolled in the Plan after 30 days of employment. Auto-enrolled employees defer a specified percentage outlined in the plan document. However, the Plan permits participants to opt out of contributing to the Plan.

The Plan provides for employer matching contributions to contributing participants with 1,560 scheduled hours. Part-time employees are eligible for the match upon attainment of 1,000 hours in the plan year. Certain participants are grandfathered into the employer match, as defined in the plan document. The employer matching percentage is determined based on the following formula:

<u>Employee Elective Deferral</u>	<u>Employer Matching Contribution</u>
1% - 3%	100% of elective deferral contributions on the first 3% of compensation
4% - 10%	50% of elective deferral contributions on the next 7% of compensation
Greater than 10%	0% of elective deferral contributions greater than 10%

The Plan also provides for an employer core contribution for eligible individuals who are employed on the last day of the plan year unless otherwise defined by the plan document. The employer core contribution is equal to the greater of 3 percent of compensation or a fixed dollar amount of \$1,400, prorated for less than 1,800 hours of service. Effective January 1, 2024, the Plan was amended to remove the employer core contribution.

#### ***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Plan Sponsor's contributions and plan earnings and charged with an allocation of administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account. Participants may direct the investments of their account balances into various investment options offered by the Plan.

#### ***Participant Notes Receivable***

Participants may borrow from their accounts a minimum of \$1,000 up to a maximum of 50 percent of their vested account balances, subject to a maximum of \$50,000. Participant notes receivable are supported by the participants' promissory notes for the amount of the principal and interest payable. Generally, notes receivable must be repaid within five years at the prevailing interest rate of prime plus 1 percent. Notes receivable repayments are made through payroll deductions for active participants. Terminated participants may make repayments using an electronic (ACH) arrangement through Fidelity (cashier checks or money orders are also acceptable).

#### ***Vesting***

Participants are immediately 100 percent vested in employee salary and rollover contributions and any income or loss thereon. Vesting in the Plan Sponsor's matching and core contribution portion of their accounts, plus actual earnings thereon, is based on years of service. Participants typically vest in contributions made by the Plan Sponsor after three years of service. Provisions vary based on participating employer, as outlined in the plan document.

#### ***Forfeitures***

If a participant is not fully vested on his or her termination date, the nonvested amount of the account is forfeited. Forfeitures are used to reduce future employer contributions or to pay administrative expenses of the Plan. Forfeited account balances totaled \$1,029,085 and \$793,388 at December 31, 2024 and 2023, respectively.

#### ***Benefit Payments***

The current market value of the vested balance of a participant's individual account may be distributed if the participant retires, makes a divorce settlement, terminates employment at Trinity Health Corporation or one of the participating employers, attains age 59½, or dies. The normal form of distribution is a lump sum; however, a participant or beneficiary may elect a partial distribution of his or her assets, to roll over his or her distribution, or periodic cash installments (monthly, quarterly, semiannually, or annually). Participants may request that a portion of their accounts be distributed in the case of severe financial hardship, as defined in the plan document. Certain amounts invested in the TIAA Traditional Annuity group annuity contract may not be distributed in a lump sum. See redemption restrictions below.

#### ***Redemption Restrictions***

Certain contracts under the TIAA Traditional Annuity investment have limits on the ability of the participant to transfer or withdraw from the fund. Transfers from the Retirement Annuity (RA), Transfer Payout Annuity (TPA), and Group Retirement Annuity (GRA) contracts must be paid out in 10 annual installments. Transfers from the Retirement Choice (RC) contract must be paid over 84 monthly systematic payments. Withdrawals from the RA contract must be paid out in 10 annual installments. Withdrawals from the GRA and RC contracts are available within 120 days after termination of employment, subject to a 2.5 percent surrender charge; otherwise, they must be paid over 10 annual installments or 84 monthly systematic payments, respectively.

#### ***Party-in-interest Transactions***

Certain plan assets are in investment funds managed by The Variable Annuity Life Insurance Company (VALIC), Teachers Insurance and Annuity Association (TIAA) and College Retirement Equities Fund (CREF) (collectively, TIAA-CREF), and Fidelity or their affiliates. VALIC, TIAA-CREF, and Fidelity are the custodians of the Plan; therefore, these transactions qualify as party-in-interest transactions, as defined under ERISA guidelines.

#### ***Termination***

While it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions set forth in the plan agreement and ERISA. Upon termination of the Plan, participants become 100 percent vested in their account balances. Furthermore, each participating employer may, at any time, by action of the benefits committee, terminate participation in the Plan or discontinue its contributions.

#### ***Policy Loans***

Certain participants may borrow from VALIC using the vested portion of their unallocated contract balances as collateral for the loan in an amount not to exceed 50 percent of the group annuity contract balance. Participants may borrow a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or one-half of the present value of the participant's vested account balance, subject to plan provisions. Loans must be repaid within 5 years or up to 10 years if used for the purchase of the participant's primary residence. Loans bear interest at market rates. Principal and interest are paid ratably by the participant to VALIC, and each payment will reduce amounts collateralized by the participant's unallocated contract.

### Note 2 - Summary of Significant Accounting Policies

#### ***Basis of Accounting***

The Plan prepares its financial statements on the modified cash basis of accounting. Revenue is recorded when received rather than when earned, expenses are recorded when paid rather than when the obligation is incurred, and investments are recognized at fair value. Accordingly, the financial statements are not intended to be in conformity with accounting principles generally accepted in the United States of America.

#### ***Use of Estimates***

The preparation of financial statements in conformity with the modified cash basis of accounting requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions and deductions during the reporting period. Actual results could differ from those estimates.

#### ***Risks and Uncertainties***

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

#### ***Benefit Payments***

Benefits are recorded when paid.

#### ***Administrative Expenses***

Administrative expenses of the Plan are generally paid by the Plan except for certain fees paid by the Plan Sponsor. In addition, the fund options have investment management fees. These fees vary by fund, as described in the respective fund prospectus.

#### ***Allocated Insurance Contracts***

The Plan has allocated insurance contracts for retirees who were covered under the Plan in prior years. These contracts remain intact, and no additional contracts have been purchased during 2024. The activity related to the allocated insurance contracts for retirees receiving benefits is excluded from the financial statements. The Plan receives no income from these allocated insurance contracts.

#### ***Investment Valuation***

The Plan's investments are stated at fair value except for certain unallocated contracts. The unallocated contracts with TIAA are not considered benefit responsive and are presented at fair value. These non-benefit-responsive unallocated contracts invest in the general assets of TIAA; however, since there are no specific securities in their general account related to this contract and due to the contract terms, including the frequency of the interest rate reset intervals, contract value approximates fair value. Contract value represents deposits made to the contract, plus earnings at guaranteed crediting rates, less withdrawals and fees. The fully benefit-responsive unallocated contracts are valued at contract value. See Note 6 for additional information.

The registered investment companies, pooled separate accounts, common/collective trust funds, and variable separate accounts are valued at net asset value per share (NAV) (or its equivalent) of the funds, which is based on the fair value of the funds' underlying net assets. There are no redemption restrictions or unfunded commitments on these investments. All other investments are valued based on quoted market prices reported in active markets. See Note 5 for additional information.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded as earned. Dividends are recorded on the ex-dividend date.

#### ***Participant Notes Receivable***

Participant notes receivable are recorded at their unpaid principal balances. Participant notes receivable are written off when deemed uncollectible.

#### ***Subsequent Events***

The financial statements and related disclosures include evaluation of events up through and including September 26, 2025, which is the date the financial statements were available to be issued.

Subsequent to year end, the Genesis Employer Contribution Plan of \$136,725,360 merged into the Trinity Health 401(k) Retirement Savings Plan effective July 1, 2025.

### Note 3 - Certified Information

VALIC, TIAA-CREF, and Fidelity (collectively, the "Custodians") hold the Plan's investments and participant notes receivable and execute all related transactions. The investment balances as of December 31, 2024 and 2023 and related income and losses for the year ended December 31, 2024 included in the accompanying financial statements and the supplemental schedule of assets held at end of year - modified cash basis are based solely on information certified by the Custodians.

### Note 4 - Tax Status

The Plan has received a determination letter from the Internal Revenue Service indicating that the Plan, as designed, is qualified for tax-exempt treatment under the applicable section of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC.

### Note 5 - Fair Value Measurements

Accounting standards require certain assets and liabilities be reported at fair value in the financial statements and provide a framework for establishing that fair value. The framework for determining fair value is based on a hierarchy that prioritizes the valuation techniques and inputs used to measure fair value.

#### ***Level 1***

Fair values determined by Level 1 inputs use quoted prices in active markets for identical assets that the Plan has the ability to access.

#### ***Level 2***

Fair values determined by Level 2 inputs use other inputs that are observable, either directly or indirectly. These Level 2 inputs include quoted prices for similar assets in active markets, quoted prices for identical or similar assets in markets that are not active, and inputs other than quoted prices that are observable for the asset.

#### ***Level 3***

Level 3 inputs are unobservable inputs, including inputs that are available in situations where there is little, if any, market activity for the related asset.

In instances where inputs used to measure fair value fall into different levels of the fair value hierarchy, fair value measurements in their entirety are categorized based on the lowest level input that is significant to the valuation. The Plan's assessment of the significance of particular inputs to these fair value measurements requires judgment and considers factors specific to each asset.

### Note 6 - Unallocated Contracts

#### *Lincoln National Life Insurance Company (Lincoln)*

The Plan held a Lincoln Stable Value Separate Account, a benefit-responsive unallocated fixed annuity contract, with Lincoln. Lincoln maintains the contributions in a separate account that is part of the general assets of the insurance company. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The investment contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan.

Interest crediting rates are reviewed on a quarterly basis for resetting. When establishing interest crediting rates for this product, Lincoln considers many factors, including current economic and market conditions, the general interest rate environment, and both the expected and actual experience of a reference portfolio within the issuer's general account. The guaranteed minimum interest rate under the contract is 2.8 percent.

#### **VALIC**

The Plan has benefit-responsive group annuity contracts with VALIC. VALIC maintains the contributions in a general account. The account is credited with earnings on the underlying investments and charged for participant withdrawals and administrative expenses. The insurance contract issuer is contractually obligated to repay the principal and a specified interest rate that is guaranteed to the Plan. There are no reserves against contract value for credit risk of the contract issuers or otherwise. The interest crediting rate for the VALIC Fixed Account Plus contract is based on a formula agreed upon with the contract issuers but may not be less than 3 percent for participant accounts set up before December 1, 2003 and 2 percent for participant accounts set up on or after December 1, 2003. The minimum crediting rate for the VALIC Short Term Fixed Account is 4.5 percent. Interest crediting rates are reviewed on a periodic basis for resetting.

#### **Unallocated Contracts**

Certain events limit the ability of the Plan to transact at contract value with the contract issuers. Such events include the following: (i) amendments to the plan documents (including complete or partial plan termination or merger with another plan), (ii) bankruptcy of the Plan Sponsor or other plan sponsor events (e.g., divestitures or spinoffs of a subsidiary) that cause a significant withdrawal from the Plan, or (iii) the failure of the Plan to qualify for exemption from federal income taxes. The plan administrator does not believe that the occurrence of any such value event, which would limit the Plan's ability to transact at contract value with participants, is probable.

The contracts do not permit the contract issuers to terminate the contracts prior to the scheduled maturity date, if any. If an event of default occurs and is not cured, the nondefaulting party may terminate the contracts. The following may cause the Plan to be in default: a breach of material obligation under the contracts, a material misrepresentation, or a material amendment to the plan agreement. The contract issuers may be in default if they breach a material obligation under the contracts, make a material misrepresentation, have a decline in their long-term credit rating below a threshold set forth in the contracts, or are acquired or reorganized and the successor contract issuers do not satisfy the investment or credit guidelines applicable to the contract issuers.

As described in Note 2, because the unallocated insurance contracts are fully benefit responsive, contract value is the relevant measurement attribute for the portion of net assets attributable to the unallocated insurance contracts. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

### **Note 7 - Plan Merger**

Effective December 2024, and pursuant to an acquisition made by the Company, the North Ottawa Community Hospital 401(k) Retirement Plan, a plan sponsored by Trinity Health Corporation, was merged with the Plan. Accordingly, assets of approximately \$14 million were transferred into the Plan in 2024.

The financial statements exclude the activity of the merged plan prior to the date of the merger.
