## NOTES TO FINANCIAL STATEMENTS

### Haltec Corporation 401(k) Profit Sharing Plan

#### 1 Description of Plan

The following description of the Haltec Corporation 401(k) Profit Sharing Plan (“Plan”) provides only general information. Participants should refer to the Plan document for a complete description of the Plan's provisions.

##### *General:*

The Plan is a defined contribution plan covering all employees of Haltec Corporation (“Company”) who meet the age and service requirements. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The Plan was restated as of July 22, 2021 to comply with IRS legislative and regulatory requirements.

Effective January 10, 2025, the Plan was amended to change the Trustee of the Plan from Empower Trust Company, LLC to First National Bank. Effective January 1, 2026, the Plan was amended to one year of service for employer safe harbor contributions.

##### *Eligibility:*

All employees of the Company age twenty-one and older are eligible to participate in the Plan after one year of service. Effective, January 1, 2024, participants are eligible to participate in the Plan immediately upon hire date for employee contributions and employer safe harbor contributions and employer non-elective contributions after one year of service. Employees who are subject to a collective bargaining agreement, non-residents and residents of Puerto Rico are not eligible to participate in the Plan.

##### *Contributions:*

**Employee Contributions** - Participants may elect a portion of their compensation to be contributed to the Plan by the Company. The Plan also allows for Roth contributions. The Plan also allows catch-up contributions up to the Internal Revenue Service limits for certain participants who are eligible.

**Employer Safe Harbor Contributions** - The Company contributes 3% of each employee’s eligible compensation as safe harbor contributions.

**Employer Non-Elective Contributions** - The Company may also make additional contributions. Such additional contributions, if any, shall be allocated to each Participant in proportion to his or her compensation for the calendar year. During 2024 and 2023, the Company contributed 2% (2024) and 3% (2023) of each employee’s eligible compensation.

Rollover contributions from other Plans are also accepted, providing certain specified conditions are met.

Contributions are subject to limitations on annual additions and other limitations imposed by the Internal Revenue Code, as defined in the Plan agreement.

**1 Description of Plan, Continued**

***Participants' Accounts:***

Each participant's account is credited with the participant's elective contributions, employer safe harbor contributions, employer non-elective contributions, earnings and losses thereon and administrative expenses.

***Vesting:***

All participants are 100% vested in elective deferrals, employer safe harbor contributions and rollover contributions made to the Plan.

Vesting in employer non-elective contributions is based on years of service. A participant is vested as follows:

Years of Service	Vested %
2	20%
3	40%
4	60%
5	80%
6	100%

***Forfeitures:***

Forfeited non-vested accounts totaled \$7,666 (2024) and \$14,522 (2023). Forfeitures can be used to pay Plan expenses or reduce future employer contributions. Forfeitures of \$17,595 (2024) and \$0 (2023) were used pay employer contributions and \$1,000 (2024) and \$1,325 (2023) were used to pay Plan expenses.

***Other Plan Provisions:***

Normal retirement age is 65. The Plan also provides for early payment of benefits after reaching age 59-1/2.

***Payment of Benefits:***

Upon termination of service for any reason, the participant or their beneficiary may elect to receive his or her account balance as a lump-sum payment or in-period installments. The Plan Administrator may automatically make a lump-sum distribution upon termination of service account balances less than \$5,000 or an automatic rollover distribution to an IRA for account balances between \$1,000 and \$5,000.

***Hardship Withdrawals:***

Hardship withdrawals are permitted in accordance with Internal Revenue Service guidelines.

#### **1 Description of Plan, Continued**

##### ***Investment Options:***

Upon enrollment in the Plan, a participant may direct any contributions to any of the investment options offered by the Plan.

##### ***Reclassifications:***

Certain prior year amounts have been reclassified to conform with the current year presentation.

#### **2 Summary of Significant Accounting Policies**

##### ***Basis of Accounting:***

The Plan's transactions are reported on the accrual basis of accounting.

##### ***Valuation of Investments:***

Investments are stated at fair value. Mutual funds are reported at fair market value as of the balance sheet date. Fair market values represent quoted market prices or, if quoted market prices are not available, estimated fair values as determined by the Plan's investment broker. The common collective trust is based on the underlying assets of the fund. The fair value is expressed in units and they can be redeemed at their net asset value on their measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net unrealized/realized appreciation (depreciation) includes the Plan's gains and losses on investments purchased and sold as held during the year.

##### ***Use of Estimates:***

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and disclosures of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenue and expenses during the reporting period. Actual results could differ from those estimates.

##### ***Administrative Fees:***

Certain expenses of the Plan are paid by the Company and are not included in the Statement of Changes in Net Assets Available for Benefits.

##### ***Plan Termination:***

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100 percent vested in their accounts.

## 2 Summary of Significant Accounting Policies, Continued

### *Risks and Uncertainties:*

The Plan's investments include investments in mutual funds and a common collective trust with varying degrees of risk, such as interest rate, credit, and overall market volatility risks. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and such changes could materially affect the amounts reported in the Statement of Net Assets Available for Plan Benefits.

### *Contributions:*

Contributions from Plan participants and the matching contributions from the Employer are recorded in the year in which the employee contributions are withheld from compensation.

### *Subsequent Events:*

Management evaluates events occurring subsequent to the date of the financial statements in determining the accounting for and disclosure of transactions and events that affect the financial statements.

Subsequent events have been evaluated through October 7, 2025, which is the date the financial statements were available to be issued.

## 3 Tax Status

On November 14, 2022, the Internal Revenue Service stated that the Plan, as then designed, was in compliance with the applicable requirements of the Internal Revenue Code. The Plan has been amended, however, the Plan Administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. Therefore, they believe that the Plan was qualified, and the related trust was tax-exempt as of the financial statement date.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken uncertain tax positions that more-likely-than-not would not be sustained upon examination by applicable taxing authorities. The Plan Administrator has analyzed tax positions taken by the Plan and has concluded that, as of December 31, 2024, there are no uncertain tax positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions. However, currently no audits for any tax periods are in progress.

#### 4 Fair Value Measurements

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Topic 820 are described as follows:

Level 1: Inputs to the valuation methodology are quoted prices (unadjusted) in active markets for identical assets or liabilities that the Plan can access at the measurement date.

Level 2: Inputs other than quoted prices included within Level 1 that are observable for the asset or liability, either directly or indirectly, such as:

- \* Quoted prices for similar assets or liabilities in active markets;
- \* Quoted prices for identical or similar assets or liabilities in inactive markets;
- \* Inputs other than quoted prices that are observable for the asset or liability;
- \* Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs that are unobservable inputs for the asset or liability.

The following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

#### ***Mutual Funds:***

The fair value of the mutual funds is based on quoted market prices and is classified as Level 1.

#### ***Common Collective Trusts:***

This fund is valued at the NAV of units of the underlying common collective fund. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the fund would sell the investment for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. If the Plan initiates a full redemption of the common collective trust, the issuer reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner. There were no unfunded commitments at December 31, 2024 or 2023.
