### 1. Description of the Plan

The following description of Sanborn, Head & Associates, Inc. 401(k) Retirement Plan (the Plan) provides only general information. Participants should refer to the plan document for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution plan sponsored by Sanborn, Head & Associates, Inc. (the Company) covering substantially all employees. The Plan was adopted on January 1, 1995 and is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended. Vanguard Fiduciary Trust Company (VFTC) and The Vanguard Group, Inc. (VGI) were the trustee and recordkeeper of the Plan, respectively, as of December 31, 2023 and for the period from January 1, 2024 through August 14, 2024. Principal Trust Company (PTC) and Principal Financial Group (PFG) became the trustee and recordkeeper, respectively, as of August 15, 2024.

#### Eligibility

All employees of the Company, except for (i) employees covered by a collective bargaining agreement, (ii) nonresident aliens, (iii) leased employees, and (iv) interns, become eligible for participation in the Plan on the date of hire and upon attaining age 21.

#### Contributions

Contributions to the Plan are made by both participating employees and the Company. Participants may contribute up to 100% of their gross compensation on a pre-tax or after-tax Roth basis, as defined by the Plan, subject to the Internal Revenue Code (the Code) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants also may contribute amounts representing distributions from other qualified retirement plans. Participants direct the investment of their contributions into various investment options offered by the Plan.

The Plan provides that the Company may elect to make a discretionary profit-sharing contribution to all eligible employees who have completed at least 500 hours of service and who are employed on the last day of the plan year. In 2024, the Company approved a profit-sharing contribution of \$664,500.

#### Participant Accounts

Each Participant's account is credited with the Participant's contributions and allocations of the Company's contributions, the Plan's earnings or losses, and charged with an allocation of administrative expenses, if any. Allocations are based on Participant earnings or account balances, as defined. The benefit to which a Participant is entitled is the benefit that can be provided from the Participant's vested account.

### **Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's discretionary nonelective profit-sharing contribution portion of their accounts is based on years of continuous service with 100% vesting after six years of credited service.

Participants are 100% vested upon the occurrence of death, permanent disability, or attainment of early retirement age.

### **Notes Receivable from Participants**

Participants may borrow from their accounts up to the lesser of \$50,000, reduced by the excess of the participant's highest outstanding balance of loans from the Plan during the one-year period prior to the date of the loan, or 50% of the participants' vested account balance. A participant may not have more than two notes outstanding at any point in time. Note terms generally may not exceed five years. Principal and interest are paid ratably through payroll deductions.

### **Forfeited Accounts**

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$77,739 and \$55,102, respectively. These accounts may be used at the discretion of the Company. In 2024, \$68,034 of forfeited funds were used to pay Plan expenses and reduced administrative expenses.

### **Payment of Benefits**

Participants shall become eligible to withdraw their vested account balances upon retirement (normal retirement age is 65), death, disability or termination of employment. Participants may receive their benefit payments in a single lump sum or in installment payments.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements were prepared using the accrual basis of accounting in accordance with U.S. generally accepted accounting principles (U.S. GAAP).

### **Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### **Investment Valuation and Income Recognition**

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. Delinquent notes receivable from participants are recorded as distributions on the basis of the terms of the Plan agreement.

### **Payment of Benefits**

Benefit payments to Participants are recorded when paid.

### **Administrative Expenses**

Administrative expenses paid by the Plan are further described in Note 5. Certain expenses incurred maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Certain expenses relating to purchases, sales or transfers of investments are charged to the particular investment fund to which the expenses relate.

### **Subsequent Events**

Management has considered transactions or events occurring through October 9, 2025, the date the financial statements were available to be issued. Management has not evaluated subsequent events after that date for inclusion in the financial statements.

### **3. Information Prepared and Certified by the Trustees**

The investments, investment transactions, net appreciation in fair value of investments, notes receivable from participants and interest and dividends were obtained by management and agreed to or derived from information certified by VFTC and PTC, collectively the trustees, as complete and accurate. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs. The three levels of the fair value hierarchy under Financial Accounting Standards Board Accounting Standards Codification Topic 820, *Fair Value Measurement*, are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Mutual funds and money market fund:* Valued based on quoted market prices of shares held by the Plan at year-end.

*Collective trust:* Valued at the net asset value (NAV) of units held by the Plan at year-end. The NAV is used as a practical expedient to estimate fair value and is excluded from the fair value hierarchy. The NAV is based on the fair value of the underlying investments in the collective trust.

## 5. Parties-in-Interest

The Plan allows participants to invest in mutual funds managed by VGI related affiliates and, therefore, these investments qualify as parties-in-interest to the Plan. In 2024, the Plan incurred administrative expenses with the recordkeeper amounting to \$50,318, prior to forfeiture offsets. In addition, \$21,250 and \$6,550 was paid to the Plan's investment advisor and general consultants, respectively.

## 6. Plan Termination

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, the participants would become fully vested in their accounts.

## 7. Tax Status

The Company has adopted the Principal Financial Group nonstandardized profit sharing/401(k) plan, which received a favorable opinion letter dated June 30, 2020 stating that the Plan, as then designed, was in compliance with the applicable requirements of the Code. The Plan has been amended since receiving the opinion letter; however, the Plan Administrator believes that the Plan and the related trust are currently being operated in compliance with the applicable provisions of the Code.
