Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Pinnacle Oil Holdings 401(k) Plan (the Plan), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

Basis for Opinion on the Financial Statements

We conducted our audits in accordance with auditing standards generally accepted in the United States of America (GAAS). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Basis of Accounting

We draw attention to Note 2 to the financial statements, which describes the basis of accounting. The financial statements and supplemental schedule are prepared on the modified cash basis of accounting, which is a basis of accounting other than accounting principles generally accepted in the United States of America. Our opinion is not modified with respect to this matter.

Responsibilities of Management for the Financial Statements

NOTES TO FINANCIAL STATEMENTS DECEMBER 31, 2024 AND 2023

1. DESCRIPTION OF THE PLAN

The following description of Pinnacle Oil Holdings 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan sponsored by Pinnacle Oil Holdings, LLC (the Employer or Plan Sponsor) and covers employees of Pinnacle Oil Holdings, LLC and Indiana Lubricant Transport, LLC (collectively referred to as the Employers). The Plan covers employees who are not leased employees and are not subject to collective bargaining agreements, who are age 18 years or older and have completed 500 hours of service in a 6 month period. Employees must be an active participant in the Plan to be eligible for safe harbor and discretionary profit-sharing contributions. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Board of Directors is responsible for oversight of the Plan and determines the appropriateness of the Plan's investment offerings and monitors investment performance.

Contributions

Each year, participants may defer a portion of their annual compensation, up to the maximum amount allowable by the Internal Revenue Code (IRC). These contributions can be made through a combination of pre-tax contributions and after-tax contributions (Roth). Participants may also contribute amounts representing qualified rollover distributions from other qualified plans. Contributions are subject to certain Internal Revenue Service (IRS) limitations.

The Plan includes an auto-enrollment provision whereby all newly eligible employees are automatically enrolled in the Plan unless they affirmatively elect not to participate in the Plan. Automatically enrolled participants have their elective deferral rate set at one percent of eligible compensation and their contributions are invested in a designated balanced fund until changed by the participant.

The Plan provides for a safe harbor matching contribution equal to 100% of the amount of the participant's elective deferrals that do not exceed 3% of the participant's compensation, plus 50% of the amount of the participant's elective contributions that exceed 3% of the participant's compensation but do not exceed 5% of the participant's compensation. The Plan also allows for discretionary non-safe harbor matching and profit-sharing contributions. No such discretionary contributions were made during plan year 2024.

Participants direct the investments of their contributions and their respective allocation of the Employers' contributions into various investment options offered by the Plan. They may change their investment options among those investments provided at any time during the plan year.

Individual accounts are maintained for each plan participant. Each participant's account is credited with the participant's contributions and Employers' safe harbor matching contributions, as well as allocations of plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions and the Employers' safe harbor matching contributions plus actual earnings thereon. Vesting in the Employers' discretionary non-safe harbor matching contribution and profit-sharing portion of their accounts plus actual earnings (or losses) thereon is based on years of continuous service. A participant is 100% vested after six years of credited service. If not already vested, a participant becomes fully vested upon the occurrence of the participant's attainment of normal retirement age, death while employed by the Employer, or satisfying the requirements of disability retirement.

Payment of Benefits

On termination of service due to attainment of normal retirement age (as defined), death, disability, or other reasons, a participant with an account balance greater than \$5,000 may elect to receive a lump-sum distribution, have the balance directly rolled over to an eligible retirement plan, or leave the funds in the Plan for distribution at a later time. A participant who has terminated employment and has a vested balance that does not exceed \$1,000 will receive a lump-sum distribution. A participant who has terminated employment and has a vested balance between \$1,000 and \$5,000 may elect to receive either a lump-sum distribution or have the account balance rolled over to an eligible retirement plan.

Forfeited Accounts

Forfeited nonvested accounts may be used to pay plan expenses or to reduce the employers' contributions. At December 31, 2024 and 2023, there were no forfeited nonvested accounts. For the year ended December 31, 2024, no forfeited nonvested amounts were used to pay plan expenses or to reduce the employers' contributions.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements of the Plan have been prepared on the modified cash basis of accounting. The modified cash basis differs from accounting principles generally accepted in the United States of America in that contributions and investment income are recorded when received and benefit payments and administrative expenses are recorded when paid.

Although the modified cash basis of accounting represents a departure from accounting principles generally accepted in the United States of America, it is an allowable method of accounting for employee benefit plans under the reporting requirements of ERISA.

Use of Estimates

The preparation of financial statements in conformity with the modified cash basis of accounting requires the plan administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes in those assets and liabilities, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. The plan administrator determines the Plan's valuation policies utilizing information provided by the investment advisors, custodian, and insurance company.

John Hancock Life Insurance Company (U.S.A.) (John Hancock) maintains the Plan's investment funds. Investments in pooled separate accounts are credited with earnings and gains and losses on the pooled investments. The separate accounts are stated at fair value as reported to the Plan by John Hancock, based on the quoted market prices of the underlying mutual funds. The unit value of the separate account is calculated by dividing the total value of the assets of the separate account by the number of units in the separate account. For separate accounts that invest exclusively in mutual funds, the total value of the assets of the separate account is based on the net asset value (NAV), or price per share, of the underlying mutual fund. The mutual fund calculates its NAV by dividing the mutual fund's net assets by the mutual fund's outstanding number of shares.

The investment strategies for the pooled separate accounts investing in mutual funds or equity securities vary based on the degree of investment risk chosen by the fund manager and the criteria of the fund or security's investment goal. See Note 4 for discussion of fair value measurements.

Investment transactions are recorded as of the settlement date, which does not differ materially from the trade date. Net change in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses of the Plan

The Plan Sponsor provides administrative and accounting services to the Plan at no cost. Administrative expenses incurred by the Plan include third-party administrator fees, independent investment advisor fees, and distribution fees charged directly to participants' accounts.

Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Market risks include global events which could impact the value of investment securities, such as a pandemic or international conflict. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits (modified cash basis).

Subsequent Events

The Plan has evaluated events and transactions occurring subsequent to the statement of net assets available for benefits date for recognition and disclosure in the accompanying financial statements through the date the financial statements were available to be issued, which is October 2, 2025.

3. INFORMATION CERTIFIED BY THE PLAN'S CUSTODIAN

The plan administrator has elected the method of annual reporting compliance permitted by ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, John Hancock, the custodian of the Plan, has certified to the completeness and accuracy of all investments reflected on the accompanying statements of net assets available for benefits (modified cash basis) as of December 31, 2024 and 2023, the schedule of assets at December 31, 2024, and the related investment activity reflected in the statement of changes in net assets available for benefits (modified cash basis) for the year ended December 31, 2024.

4. FAIR VALUE MEASUREMENTS

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). However, in accordance with Subtopic 821-10, certain

investments that are measured at NAV per share (or its equivalent) have not been classified in the fair value hierarchy.

The description of the valuation methodologies used for assets measured at fair value on a recurring basis are included in Note 2. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

5. RELATED PARTY TRANSACTIONS AND PARTY-IN-INTEREST TRANSACTIONS

Parties-in-interest are defined under DOL regulations as any fiduciary of the Plan, any party rendering service to the Plan, the Employers and certain others.

John Hancock is the custodian of the Plan and receives payment from the Plan for contract administrative services. Benefit Plans Plus is the third-party administrator and receives payment from the Plan for those services. Hurlow Wealth Management is the investment advisor for the Plan and receives payment from the Plan for those services. Blue & Co., LLC is the independent auditor for the Plan and receives payment from the Plan Sponsor for its services.

6. PLAN TERMINATION

Although they have not expressed any intent to do so, the Plan Sponsor has the right to discontinue their contributions at any time and terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants would become fully vested in their employers' contributions.

7. TAX STATUS

The Plan has adopted a pre-approved plan document sponsored by CCH Incorporated d/b/a ftwilliam.com (ftwilliam), which has received an opinion letter from the IRS dated June 30, 2020, stating that the form of the pre-approved plan document, as then designed, was in compliance with the applicable requirements of the IRC. Although the Plan has been amended since adopting the pre-approved plan document, the plan administrator believes the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC, and, therefore, believes that the Plan is qualified, and the related trust is tax-exempt.

The plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken or expected to be taken that would require disclosure in the accompanying financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.
