NOTE 1 - DESCRIPTION OF PLAN

The following description of CyberData Tech 401(k) Plan (the Plan) provides only general information about the Plan's provisions. Participants should refer to the plan agreement and summary plan description for a more complete description of the Plan's provisions, copies of which may be obtained from the plan sponsor.

General

The Plan is a defined contribution plan covering substantially all employees of CyberData Technologies, Inc. (the "Company"). Employees who are more than 21 years or age, except for hourly-paid employees, employees covered by a collective bargaining agreement, leased employees and nonresident aliens as defined in the Plan, are eligible to participate in the Plan. Plan entry dates are the first of each month.

The Company is the administrator of the Plan. As administrator, the Company has exclusive authority and responsibility for all matters in connection with the operation and administration of the Plan (including the authority and responsibility to invest, manage and control the assets of the Plan specifically allocated to the trustee). Fidelity Management Trust Company is the appointed trustee of the Plan and acts at the direction of the Plan's administrator. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA), as amended.

Plan Contributions

Participants may elect to contribute up to 80% of eligible compensation not to exceed the limits of the Internal Revenue Code. Participants direct the investment of their contributions into various investment options offered by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans.

The Plan Sponsor has elected to make matching contributions to all participants in the amount equal to 100 percent of the first three percent of eligible compensation for each payroll period. Additionally, the Plan provides for discretionary profit-sharing employer contributions. The Plan Sponsor elected to make no profit-sharing contributions during the 2024 or 2023 Plan years. A participant must be employed on the last day of the Plan year with 1,000 hours of service to receive the non-elective contribution. These contributions may be suspended or discontinued at any time.

Participant Accounts

Each participant's account is credited with the participant's contributions and the Company's contributions and allocations of plan earnings, and is charged with an allocation of administrative expenses. Plan earnings are allocated based on the participant's share of net earnings or losses of their respective elected investment options. Allocations of administrative expenses are based on the participant's account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

NOTE 1 - DESCRIPTION OF PLAN (CONTINUED)

Investment Options

The Plan offers investment options that are comprised of mutual funds (registered investment companies). The Plan also offers a self-directed brokerage account investment alternative called Fidelity BrokerageLink which offers participants additional investment choices beyond the core investment options. Participants are responsible for paying trading fees and commissions, when applicable, in their self-directed brokerage accounts. Self-directed brokerage account investments are regulated by ERISA and Plan policies. Participants may choose to invest all or part of their Plan balance in a self-directed brokerage account.

Vesting

Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the matching Plan Sponsor and profit sharing contributions is as follows:

The nonvested balance is forfeited upon termination of service. Participants become fully vested upon death, termination of the Plan, normal retirement age, or total disability.

At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$69,598 and \$135,686, respectively. These accounts can be used to pay expenses under the Plan, or to reduce employer contributions at the discretion of the Plan Sponsor. For the year ended December 31, 2024, employer contributions totaling \$202,611 were paid from forfeited nonvested accounts. For the year ended December 31, 2023, no forfeitures were used.

Participant Loans

Participants may borrow from their accounts a minimum of \$1,000 up to the maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The plan document does not specify the maximum number of loans available to any participant. The loans are secured by the balance in the participant's account and bear interest at prime plus 1%. Principal and interest are paid ratably through payroll deductions. If a participant terminates employment with the Company, the loan becomes due and payable in full immediately. If the loan is not repaid, it will automatically be treated as a distribution at the end of the quarter subsequent to the quarter in which the default occurs.

Payment of Benefits

Prior to separation from service with the Plan Sponsor, a participant may request a distribution of rollover contributions. In the event of a financial hardship, certain participant funds, as defined in the plan document, may be requested for distribution. Inservice distributions may also be requested by participants who are at least age 59 1/2. Upon attainment of normal retirement age, total disability, or death, the amount credited to a participant's account is payable in a lump sum or installments. Upon termination of employment for reasons other than

retirement, total disability, or death, the participant's account balance will be distributed in a manner based on the value of the account. If a separated participant's account does not exceed \$7,000, the benefit will be distributed in a lump sum within a reasonable time after termination of employment. If the participant's account balance exceeds \$7,000, the participant may elect to receive the benefit in a lump sum or installments in accordance with the plan document.

Plan Termination

Although the Company has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. However, no such action may deprive any participant or beneficiary under the Plan of any vested right.

NOTE 2 - SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The accompanying financial statements have been prepared on the accrual basis of accounting.

Payment of Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 and 2023. If a participant ceases to make loan repayments and the plan administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded.

Use of Accounting Estimates

The preparation of financial statements in conformity with generally accepted accounting principles requires management to make estimates that affect the amounts reported in the financial statements and accompanying notes and supplemental schedule. Actual results could differ from those estimates.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. See Note 4 for discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation in fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Investment Valuation and Income Recognition (Continued)

Management fees and operating expenses charged to the Plan for investments in the registered investment company shares, are deducted from income earned on a daily basis and are not separately reflected. Consequently, management fees and operating expenses are reflected as a reduction of investment return for such investments.

Administrative Expenses

Certain expenses of maintaining the Plan, such as audit and legal fees, are paid directly by the Company and are excluded from these financial statements.

Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

Subsequent Events

The Plan has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued. None were noted.

NOTE 3 - INVESTMENTS

All investment information disclosed in the accompanying financial statements and supplemental Schedule of Assets (Held at End of Year) including investments held and notes receivable from participants at December 31, 2024 and 2023, and net appreciation or depreciation in fair value of investments, dividends and interest income on notes receivable from participants for the years ended December 31, 2024 and 2023, was obtained or derived from information provided to the plan administrator and certified as complete and accurate by Fidelity Management Trust Company, the trustee of the Plan.

NOTE 4 - FAIR VALUE MEASUREMENTS

Fair value is defined as the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (i.e., an exit price). The fair value hierarchy prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described below:

- Level 1 - Unadjusted quoted prices in active markets that are accessible to the reporting entity at the measurement date for identical assets and liabilities.
- Level 2 - Inputs other than Level 1 that are observable, either directly or indirectly, such as quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in markets that are inactive; or other inputs that are observable or can be corroborated by observable market data for substantially the full term of the assets or liabilities.

- Level 3 - Unobservable inputs for the asset or liability (i.e., supported by little or no market activity). Level 3 inputs include management's own assumption about the assumptions that market participants would use in pricing the asset or liability (including assumptions about risk).

The level in the fair value hierarchy within which the fair value measurement is classified is determined based the lowest level input that is significant to the fair value measure in its entirety.

Investments in registered investment company shares are valued at the closing price reported in the active market in which the mutual funds are traded.

The underlying investments in self-directed brokerage accounts consist of common stocks, mutual funds and exchange traded funds which are valued at the closing price reported on the active market on which the individual securities are traded.

NOTE 5 - RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market volatility, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

NOTE 5 - RISKS AND UNCERTAINTIES (CONTINUED)

The Plan's exposure to a concentration of credit risk is limited by the diversification of investments across all participant-directed fund elections. Additionally, the investments within each participant-directed fund election are further diversified into varied financial instruments. As of December 31, 2024, approximately 14%, 12% and 11% of the plan's net assets were invested in Fidelity Advisor Freedom 2035 Fund, Fidelity Advisor Freedom 2025 Fund and Fidelity 500 Index, respectively. As of December 31, 2023, approximately 14% and 12% of the plan's net assets were invested in Fidelity Advisor Freedom 2035 Fund and Fidelity Advisor Freedom 2025 Fund, respectively.

NOTE 6 - TAX STATUS

The Plan utilizes a prototype plan provided by FMR, LLC. The prototype plan received a favorable opinion letter from the Internal Revenue Service on June 30, 2020 stating that the prototype plan is designed in accordance with the applicable sections of the IRC. The Plan has been amended since the date of the opinion letter. Plan Sponsor management believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

In accordance with GAAP, the Plan Sponsor is required to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authorities. The Plan Sponsor has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024 and 2023, there are no uncertain positions taken, or expected to be taken, that would require recognition of a liability or disclosure in the financial statements. The Plan Sponsor believes the Plan is no longer subject to income tax examinations for years prior to 2021. The Plan is also subject to routine audits by the Department of Labor, generally for six years after the statutory due date of the annual information return. There are currently no audits in progress for any tax periods.

NOTE 7 - RELATED-PARTY TRANSACTIONS

The Plan engages in transactions with parties who may perform services or have fiduciary responsibilities to the Plan, including the Plan Sponsor and service providers. Plan investments are managed by Fidelity Management Trust Company, the trustee and record keeper of the Plan. Fees paid by the Plan for the investment management services are included in net appreciation in fair value of investments. The Plan also issues participant loans, which are secured by the participants' account balances.

The Company also paid certain other administrative expenses of the Plan, including audit fees. These transactions qualify as party-in-interest transaction under ERISA; however, they are exempt from the prohibited transactions rules.
