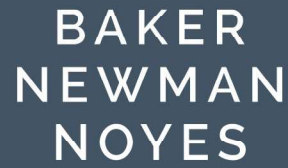

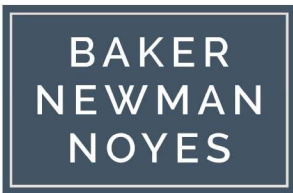

INDEPENDENT AUDITORS' REPORT

The Plan Administrator and Participants
Markforged, Inc. Retirement Plan

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of the Markforged, Inc. Retirement Plan (the Plan), an employee benefit plan subject to the *Employee Retirement Income Security Act of 1974* (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA (qualified institution).

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditors' Responsibilities for the Audit of the Financial Statements section:

- The amounts and disclosures in the accompanying financial statements, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America (U.S. GAAP).

NOTES TO FINANCIAL STATEMENTS

December 31, 2024 and 2023

1. Description of Plan

The following description of the Markforged, Inc. Retirement Plan (the Plan) provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a 401(k) plan covering substantially all employees of Markforged, Inc. (the Company). It is subject to the provisions of the *Employee Retirement Income Security Act of 1974* (ERISA).

Effective April 25, 2025, the Plan Sponsor was acquired by Nano Dimension Technologies, Ltd. (Nano). The Plan was amended effective July 1, 2025 to allow participation of Nano employees based in the United States of America and waives all eligibility requirements for these employees and credited such employees for prior years of service under Nano.

Eligibility and Participation

An employee is eligible to participate in the Plan upon attaining age 21. A participant can enter the Plan on the first day of each month upon meeting eligibility requirements and is also eligible to receive matching contributions upon Plan entry.

Contributions

Participant Salary Deferral: Participants in the Plan may contribute to the Plan up to 80% of their annual compensation, as defined, not to exceed the maximum amount allowable under the Internal Revenue Code (IRC) in any calendar year. Participants are also permitted to make Roth elective 401(k) contributions. Employees 50 years or older may elect to defer additional amounts (catch-up contributions, which are subject to Internal Revenue Service (IRS) limitations). Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (rollover contributions). In addition, the Plan has an automatic enrollment feature whereby participants who have not completed an enrollment or opt-out form are automatically enrolled into the Plan with a 3% deferral once they meet the eligibility requirements. On an annual basis, participants who are automatically enrolled are also subject to auto-escalation features, whereby their deferral will increase by 1% per year up to a maximum of 10% deferral.

Employer's Nondiscretionary Safe Harbor Matching Contribution: Effective January 1, 2024, the Employer makes a nondiscretionary safe harbor contribution equal to a uniform percentage of the participants' salary deferrals. In 2024, a matching safe harbor contribution was made equal to 100% of the participants' deferral up to 4% of compensation (as defined).

Employer's Discretionary Contributions: The Employer may make a discretionary matching contribution equal to a uniform percentage of the participants' salary deferrals. In 2023, a matching contribution was made equal to 100% of the participants' deferral up to 4% of compensation (as defined). The Employer's discretionary contribution was discontinued beginning January 1, 2024.

1. Description of Plan (Continued)

Profit Sharing: The Company may make an annual profit sharing contribution in any plan year at the discretion of the Company's Board of Directors. The profit sharing contribution is allocated to each participant's account based on relative compensation, as defined in the Plan Document. Only participants employed by the Company and meeting the eligibility requirements as of the last day of the Plan year are eligible to receive these contributions. There were no profit sharing contributions made in 2024.

Participant Accounts

Each participant's account is credited with the participant's contributions and allocations of Plan earnings or losses, net of certain investment and management fees. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Benefits

The Plan provides benefits to participants upon death, disability, retirement or termination of employment. Benefits will be paid to the participant in a lump-sum payment or by transfer to another qualifying plan.

Participants are permitted to take in-service distributions upon attaining the age of 59½.

Participants are permitted to take hardship withdrawals from their account provided they meet certain criteria.

Vesting

Participants are immediately 100% vested in their own contributions and the Company's safe harbor matching contributions, plus actual earnings thereon. Vesting in the Company's discretionary matching contributions and earnings thereon is based on a rate of 50% after one year of service and 100% after two years of service.

Forfeitures

A participant who terminates employment and is less than 100% vested forfeits the non-vested portion of their account. Forfeitures may be first used to pay any administrative expenses and can also subsequently be used to reduce any employer contributions. Forfeitures available for future use were \$1,315 and \$9,680 at December 31, 2024 and 2023, respectively. Forfeitures used were \$84,535 in 2024.

Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate or amend the Plan subject to the provisions of ERISA. In the event of a Plan termination, participants will become 100% vested in their balances. During the year ended December 31, 2024, the Plan determined that it had incurred a partial plan termination. All terminated participants became fully vested in the Company's discretionary matching contributions.

Notes Receivable from Participants

The Plan allows participants to borrow against their accounts. Such loans shall not exceed the lesser of \$50,000 or 50% of the participants' vested interest in their account. The loans are secured by the balance in the participant's account and bear interest at the Prime Rate. Principal and interest is paid ratably through payroll deductions, normally within five years. If the loan is for the purchase of a primary residence, repayment is required within any reasonable period commensurate with the period permitted by commercial lenders for similar loans.

2. Summary of Significant Accounting Policies

Basis of Accounting

The financial statements of the Plan are prepared under the accrual basis of accounting.

Investments

The Plan's investments in mutual funds and a money market fund are stated at fair value based upon quoted market prices which represent the net asset value of shares held by the Plan. Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative Expenses

Administrative expenses are paid by the Plan to the extent they are not paid by the Plan Sponsor.

Contributions

Contributions from participants are recorded when payroll deductions are made. Employer nondiscretionary safe harbor contributions are recorded in the period in which they relate to the participant contributions.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest, if material.

Payment of Benefits

Benefits are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America (U.S. GAAP) requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of net assets available for benefits at the date of the financial statements and the reported amounts of changes in net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Risks and Uncertainties

The Plan provides for investment options in a money market fund and mutual funds. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

Subsequent Events

Events occurring after the statement of net assets available for benefits date are evaluated by management to determine whether such events should be recognized or disclosed in the financial statements. Management has evaluated subsequent events through October 3, 2025, which is the date the financial statements were available to be issued.

3. Information Certified by the Custodian

The Plan's investments, including dividends and interest, net appreciation in fair value of investments and investment transactions, and notes receivable from participants, related transactions and the interest associated with the notes receivable as of December 31, 2024 and 2023 and for the year ended December 31, 2024 were certified by Ascensus LLC, authorized representative for Ascensus Trust Company and Newport Trust Company, LLC, custodians of the Plan. The Plan Administrator has elected the method of compliance as permitted by 29 CFR 2520.103-8 of the United States Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the Plan Administrator instructed the Plan's independent auditors not to perform any auditing procedures with respect to the information certified by Ascensus LLC, authorized representative for Ascensus Trust Company and Newport Trust Company, LLC, except for comparing such information certified by the custodians, to information included in the Plan's financial statements.

4. Tax Status

A qualifying plan is one for which the employer may currently deduct contributions on its income tax return, the employee is not currently taxed on the contribution, and the plan income is not taxable.

4. **Tax Status (Continued)**

The Plan adopted a pre-approved non-standardized adoption agreement in accordance with the changes set forth in IRS notice 2017-37 and is a qualified plan under Section 401(a) of the IRC. The non-standardized pre-approved plan has received an opinion letter from the IRS as to the pre-approved plan's qualified status, dated June 30, 2020. The Plan Administrator believes that the Plan, as amended, is currently designed and being operated in compliance with the applicable requirements of the IRC.

U.S. GAAP requires Plan management to evaluate tax positions taken by a plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination. Management evaluated the Plan's tax positions and concluded that the Plan had maintained its tax exempt status and had taken no uncertain tax positions that require adjustment to the financial statements. Therefore, no provision or liability for income taxes has been included in the financial statements.

5. **Related Party and Party-in-Interest Transactions**

The Plan is responsible for administrative fees to the extent they are not paid by the Plan Sponsor. Administrative fees consist of amounts paid to the third-party administrator for various administrative services. These transactions qualify as party-in-interest transactions. Various plan investments are in Vanguard Mutual funds and a Vanguard money market fund, which qualify as party-in-interest, as Vanguard serves as Plan recordkeeper. Vanguard has retained Ascensus LLC and Newport Trust Company, LLC to provide these services on their behalf. Fees paid by the Plan for investment management services are paid indirectly by Plan participants as a reduction of the return earned on each fund. Additionally, notes receivable from participants qualify as party-in-interest transactions.

At December 31, 2024, the Plan recorded a receivable from Vanguard for amounts due back to Plan for uncashed participant distribution checks.

6. **Fair Value Measurements**

Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). For disclosures, a fair value hierarchy has been established that prioritizes the input to valuation techniques used to measure fair value into three levels:

Level 1 – Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 – Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;

- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 – Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

There have been no changes in the methodologies used at December 31, 2024 and 2023.
