Our audit also did not include a consideration of internal control related to the investment information. We did, however, audit the form and content of the information included in the financial statements and supplemental schedule, other than that derived from the information certified by the trustee, in accordance with auditing standards generally accepted in the United States of America and found them to be presented in compliance with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Certain financial statement disclosures are particularly sensitive because of their significance to financial statement users. The most sensitive disclosure affecting the financial statements was:

- Note 3 - Information Certified by the Plan's Trustee
- Note 4 - Fair Value Measurements

The financial statement disclosures are neutral, consistent, and clear.

### **Form 5500 Procedures**

We are required to obtain and read a substantially complete draft of Form 5500 prior to dating our auditor's report. The purpose of this procedure is to identify any material inconsistencies between the draft Form 5500 and the Plan's financial statements. We identified no material inconsistencies in performing and completing our audit.

### **Difficulties Encountered in Performing the Audit**

We encountered no significant difficulties in dealing with management in performing and completing our audit.

### **Corrected and Uncorrected Misstatements**

Professional standards require us to accumulate all misstatements identified during the audit, other than those that are clearly trivial, and communicate them to the appropriate level of management.

Our audit detected no misstatements.

### **Disagreements with Management**

For purposes of this letter, a disagreement with management is a financial accounting, reporting, or auditing matter, whether or not resolved to our satisfaction, that could be significant to the financial statements or the auditor's report. We are pleased to report that no such disagreements arose during the course of our audit.

### **Management Representations**

We have requested and received certain representations from management that are included in the management representation letter dated October 9, 2025.

### **Other Audit Findings or Issues**

We generally discuss a variety of matters, including the application of accounting principles and auditing standards, with management each year prior to retention as the Plan's auditors. However, these discussions occurred in the normal course of our professional relationship and our responses were not a condition to our retention.

**Other Matters**

### NOTES TO FINANCIAL STATEMENTS

DECEMBER 31, 2024 and 2023

#### DESCRIPTION OF THE PLAN:

The following description of the Mechanical Contractors, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

The Plan is sponsored solely by Mechanical Contractors, Inc. (the Employer).

**General** - The Plan is a defined contribution retirement savings plan under Section 401(k) of the Internal Revenue Code and covers all full-time employees who have at least three months of service and are at least eighteen years of age at the plan entry date. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). The Plan is not covered by the Pension Benefit Guarantee Corporation. Additionally, the Plan assets have no other form of insurance. The Plan provides several investment options, all of which are participant directed. The Employer allows eligible employees to enter the Plan on the first of each month.

**Contributions** - Salary deferral contributions may be made by all eligible employees. Salary deferral contributions shall not exceed the amounts prescribed by the Secretary of the Treasury. Employer matching contributions equal a percentage as determined annually by the Employer. In 2024 and 2023, the Company's matching contribution is equal to 50% of the participant's elective deferral which is not to exceed 5% of gross earnings. Additional profit-sharing contributions may be contributed to the Plan at the Employer's discretion. All Employer contributions are subject to the vesting percentage. Voluntary contributions by plan participants in excess of salary deferral contributions are not permitted.

**Participant accounts** - Each participant's account is credited with the participant's contributions, the Employer's contributions and the net earnings or losses of the participant's investment account. Allocated earnings are based on participant account balances as defined in the Plan. The benefits to which a participant is entitled are the benefits that can be provided from the participant's account. Changes in the underlying value of investments selected by participants will affect the benefits to which a participant is entitled.

**Vesting** - Participants are immediately vested in their contributions and the Company's matching contributions plus actual earnings thereon. A participant is 100% vested in the Company's discretionary contributions after six years of service. Forfeitures are used to reduce employer matching contributions and to pay administrative expenses.

**Payment of benefits** - Participants are eligible for the payment of benefits in the event of separation of service, death or disability, retirement, and severe financial hardship, as well as for in-service disbursements once the participant has achieved the age of 59 and 1/2 and is fully vested. Upon termination of employment with the Employer, any participant account with a vested account balance that is less than \$5,000 will automatically be paid to the participant as a lump sum distribution unless otherwise directed by the terminated employee/participant.

**Administrative expenses** - Administrative expenses of the Plan are paid by the Employer and the participants.

## 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

**Basis of accounting** - The financial statements of the Plan are prepared under the accrual method of accounting in conformity with accounting principles generally accepted in the United States of America (“GAAP”).

**Use of estimates** - The preparation of financial statements in conformity with GAAP requires the plan administrator to make estimates and assumptions that affect the reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investments** - Investments of the Plan are held by the trustee, Fidelity Management Trust Company, and consist of funds held in common and collective trust funds and mutual funds which are stated at fair value. See Note 4 for discussion of fair value measurement.

**Payment of benefits** - Benefits are recorded when paid.

## 3. INFORMATION CERTIFIED BY PLAN CUSTODIAN:

The plan administrator has elected the alternative method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor’s Rules and Regulations for Reporting and Disclosure under the Employee Retirement Income Security Act of 1974. Accordingly, the custodian and the agent on behalf of the custodian has certified that the following data included in the accompanying financial statements and supplemental schedule is complete and accurate:

The Plan's independent accountants did not perform auditing procedures with respect to this information, except for comparing such information to the related information included in the financial statements and supplemental schedule.

#### 4. FAIR VALUE MEASUREMENTS:

The Fair Value Measurements Topic of the Financial Accounting Standards Board Codification establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1 measurements) and the lowest priority to unobservable inputs (Level 3 measurements). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets and liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in active markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the assets or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurements.

The asset or liability's fair value measurement level within the hierarchy is based on the lowest level of input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

*Money market funds:* Valued based on quoted net asset values of the shares held by the Plan at year-end.

*Common/collective trust:* Valued at the net asset value (NAV) of units of a bank collective trust. The NAV, as provided by the trustee, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchased and sales) may occur daily. Were the Plan to initiate a full redemption of the collective trust, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

*Mutual funds:* Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the Security and Exchange Commission. These funds are required to publish their daily NAV and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan administrator believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

#### 5. INCOME TAX STATUS:

The Plan administrator has chosen to rely on an opinion letter from the third-party administrator that the Plan is qualified under Internal Revenue Code Section 401. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain tax position that more than likely than not would not be sustained upon examination by the IRS. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain tax positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan administrator believes it is no longer subject to income tax examinations prior to 2021.

There were no material differences between the 2024 and 2023 financial statements and the 2024 and 2023 Forms 5500.

#### 6. PLAN TERMINATION:

Although it has not expressed any intention to do so, the Employer has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their accounts.

#### 7. FORFEITURES:

As of December 31, 2024 and 2023, the Plan had forfeiture amounts of approximately \$21,000 and \$300, respectively, available to reduce future employer matching contributions and to pay administrative expenses. Forfeiture amounts of approximately \$18,000 were used to reduce employer matching contributions during the year ended December 31, 2023, respectively. No forfeiture amounts were used during the year ended December 31, 2024.

**8. PARTIES-IN-INTEREST:**

Party-in-interest transactions occurred with the Plan's auditors. The Employer pays the auditor's fees.

**9. RISKS AND UNCERTAINTIES:**

The plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.

**10. SUBSEQUENT EVENTS:**

Events and transactions occurring after December 31, 2024 have been evaluated to determine proper recognition and disclosure in the financial statements. Subsequent events and transactions were evaluated through October 9, 2025, which represents the date the financial statements were available to be issued.
