## Independent Auditor's Report

To the Trustees

### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Kimrad Transport 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Kimrad Transport 401(k) Plan financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. **December 31, 2024 and 2023**

**1. Description of plan**

The following description of the Kimrad Transport (the “Company”) 401(k) Plan (the “Plan”), adopted effective January 1, 2009, and amended and restated on October 1, 2015, provides only general information. Effective January 1, 2012, this Plan is referred to as “qualified automatic contribution arrangement 401(k) plan” also known as a “QACA”. A QACA is a plan design where the Company commits to making certain contributions described below. This commitment to make contributions enables the Company to simplify the administration of the Plan by ensuring that nondiscrimination regulations are met, which is why it is called a “safe harbor” plan. Refer to the plan document for a more complete description of the Plan’s provisions.

Although not formally amended, the Plan Sponsor applied requirements for the Setting Every Community up for Retirement Enhancement (SECURE) Act of 2020, the Coronavirus Aid, Relief, and Economic Security (CARES) Act, and the SECURE 2.0 Act of 2022 at the respective effective dates.

**General**

The Plan is a salary deferral (401(k)) and profit sharing defined contribution plan covering all employees of the Company. There are currently no age or service requirements to be eligible to participate in the Plan. It is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Contributions**

The Company, at its sole discretion, may contribute to the Plan each year an amount which it deems advisable. Participants may contribute up to 100% of their annual compensation subject to certain limitations of the Internal Revenue Code. Effective January 1, 2021, the Company elected to make a safe-harbor matching contribution equal to 100% of the first 1% of compensation contributed by the participant and 50% of the next 5% of compensation contributed by the participant.

Employees who become participants and do not affirmatively elect to have a specified amount of compensation contributed to the Plan automatically have 6% of their compensation deferred as contributions to the Plan. This provision does not apply to existing participants. There is no escalation of the automatic 6% compensation deferral.

**Participant accounts**

Each participant’s account is credited with the participant’s contribution and allocations of 1) the Company’s matching contribution, and 2) Plan earnings. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are immediately vested in their voluntary and rollover contributions plus actual earnings thereon.

Vesting in the Company’s matching and discretionary contribution portion of each participant’s account, plus actual earnings thereon, is based on years of continuous service. A participant is 20% vested after two years of service, increasing 20% per year until 100% vested after six years of credited service. For the Company’s safe-harbor matching contributions, a participant is 100% vested after two years of service.

**1. Description of plan, continued**

**Notes receivable from participants**

Participants may borrow from their fund accounts a minimum of \$500 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the related participant's account and bear interest of 4.75% - 8.50%, which is commensurate with local prevailing rates as determined quarterly by the Plan administrator. Principal and interest are paid ratably through payroll deductions.

**Payment of benefits**

If employment is terminated for reasons other than normal retirement, the participant will be entitled to receive only the "vested percentage" of their account balance.

Participants may elect to have their vested account balance distributed as soon as administratively feasible following termination of employment. However, if the value of the vested account balance does not exceed \$5,000, then a distribution will be made regardless of whether the participant consents to receive it or not.

In the event of death or disability, the beneficiary receives the vested account balance. Upon obtaining normal retirement age the participant becomes 100% vested in all accounts. If the vested account balance does not exceed \$5,000, then the vested account balance may only be distributed in a single lump-sum payment. In addition, if the vested account balance exceeds \$5,000, the participant must consent to any distribution before it may be made. If the vested account balance exceeds \$5,000, the participant may elect to receive a distribution of the vested account balance in either a single lump-sum payment, partial withdrawals, or installments subject to legal requirements and limitations.

**Forfeitures**

Forfeitures of the non-vested accounts are determined on the last day of the Plan year of distribution and are allocated in the Plan year following the Plan year in which they are determined. Forfeitures are applied to reduce administrative expenses of the Plan and then to reduce any employer contributions. The amount of forfeitures used to reduce expenses totaled \$24,559 and \$7,018 for the years ended December 31, 2024 and 2023, respectively.

**2. Summary of significant policies**

**Basis of accounting**

The financial statements of the Plan are prepared using the accrual method of accounting.

**Estimates**

The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

**Investment valuation**

The Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted prices of shares held by the Plan at year-end. All investments are participant directed.

**Payment of benefits**

Benefits are recorded when paid.

**2. Summary of significant policies, continued**

**Operating expenses**

The Plan permits the payment of Plan expenses to be made from the Plan's assets. If the Company does not pay these expenses, then the expenses paid out of the Plan's assets will generally be allocated among the accounts of all participants in the Plan. These expenses will be allocated proportionately based on the value of the account balances.

**4. Plan termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**5. Tax status**

The Plan is covered by a Mass-Submitter Prototype Document which received a letter from the Internal Revenue Service on March 31, 2014, in which it stated that the Plan, as then designed, was in compliance with the applicable requirement of the Internal Revenue Code. The Plan has been amended since receiving the determination letter. However, the Plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code.

**6. Risks and uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**7. Transactions with parties in interest**

Certain plan investments are shares of mutual funds managed by the custodian as defined by the Plan and, therefore, these transactions qualify as party in interest transactions. Fees paid by the Plan for investment management services were netted against investment returns. Certain administrative fees related to the administration of the Plan were paid by the Plan or by the Company. These transactions qualify as party in interest transactions.

**8. Fair value measurements**

**Cash and receivables**

The carrying amount approximates fair value because of their short maturities or due dates.

**Investments**

The fair values of investments are based on quoted market prices for actively traded securities.

The framework for measuring fair value produces a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- quoted inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from, or corroborated by, observable market data by correlation or other means.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs. Following is a description of the valuation methodologies used for the level 3 assets measured at fair value. There have been no changes in methodologies used at December 31, 2024 and 2023.

The fair value of participant loans receivable is based on amortized cost, which represents beginning balance, plus loan withdrawals and interest, less repayments and defaults.

The fair value of the stable value fund is based on the contract value, which represents contributions made, less withdrawals and administrative expenses, plus interest earned.

**9. Subsequent events**

Effective August 15, 2025, the Plan's sponsorship transitioned from the Standard Insurance Company to Transamerica Corporation, as part of a pooled employer plan (PEP) structure. Under the new arrangement, Transamerica serves as the plan sponsor and assumes certain administrative and fiduciary responsibilities for the Plan. This change occurred after the plan year ended December 31, 2024 and therefore has no effect on the Plan's financial position as of that date.

Subsequent events were evaluated through September 30, 2025, the date the financial statements were available to be issued.
