We have performed audits of the financial statements of Sampson Construction Co., Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). 



NOTES TO FINANCIAL STATEMENTS

NOTE 1
DESCRIPTION OF PLAN

The following description of the Sampson Construction Co., Inc. (the Company) 401(k) Profit Sharing Plan & Trust (the Plan) provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General - The Plan is a defined contribution plan which is funded by a trust. The Plan covers employees of Sampson Construction Co., Inc. and Sundance Aviation, LLC (a wholly-owned subsidiary of Sampson Construction Co., Inc.). All full-time employees who have at least one year of service are eligible to receive employer contributions. All employees may elect to make participant contributions beginning six months after employment commences. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). Management of the Company oversees the governance of the Plan. The assets of the Plan are maintained under an agreement with Union Bank & Trust Company (custodian). Union Bank & Trust Company is also the trustee of the Plan. This company also performed record keeping functions related to the employee account balances.

Contributions - Each year, participants may contribute any portion of annual compensation, as defined by the Plan. Participants direct the investment of their contributions into various investment options offered by the Plan. Additional profit sharing amounts may be contributed at the option of the Company's board of directors and are invested in the same ratio as the participants' contributions. Employer and employee contributions are subject to certain limitations prescribed by the Internal Revenue Code.

On May 1, 2018, the Plan was amended to include an automatic deferral feature. Beginning at that time, the Company automatically withholds three percent of compensation for each eligible participant who was currently contributing less than two percent to the Plan as well as all employees hired after this date. The automatic contribution amount will increase one percent per year on May 1st until it reaches four percent of compensation before May 1, 2023, and increases until it reaches six percent of compensation beginning on May 1, 2023. A participant may elect out of the automatic deferral feature by completing a salary reduction agreement specifying the amount to be withheld.

Participant accounts - Each participant's account is credited with the participant's contribution and allocations of (a) the Company's contribution and (b) the Plan earnings, and charged with an allocation of administrative expenses. Allocations of Company contributions are based on participant compensation as defined in the Plan. Allocations of Plan earnings and expenses are based on participant account balances and investments held. Certain expenses of the Plan are participant-specific, and are allocated only to the participants to whom they relate. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant directed investments are maintained in individual member accounts managed by Union Bank & Trust Company.

Vesting - Participants are immediately vested in their contributions plus actual earnings thereon. Vesting in the Company's contribution portion of their accounts plus actual earnings thereon is based on years of continuous service. A participant is 100% vested after six years of credited service.

Payment of benefits - On termination of service due to death, disability or retirement, a participant or beneficiary may elect to receive any or all of the participant's vested interest in his or her account on any distribution date following his or her separation from service. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. The Plan does not provide for annuity payments.

Forfeitures - Non-vested amounts from separated participants are re-allocated to active participants.

NOTE 2
SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Estimates - The preparation of financial statements in conformity with generally accepted accounting principles requires the Plan administrator to make estimates and assumptions that affect certain reported amounts and disclosures. Accordingly, actual results may differ from those estimates.

Basis of accounting - The Plan prepares its financial statements on the accrual basis of accounting.

Contributions Receivable - The Plan considers participant contributions receivable to the Plan on the date they are withheld from the participant's paycheck. Employer contributions receivable include all profit-sharing contributions allocable to compensation paid for a given year. No allowance for credit losses exists as all receivables were subsequently collected.

Risks and uncertainties - The Plan utilizes various investments. Investment securities in general are exposed to various risks, such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect the amounts reported in the financial statements.

Investment valuation and income recognition - The Plan's investments are stated at fair value. Shares of common/collective trusts are valued daily by the custodian using a unit valuation method which takes into account the net asset value, declared dividends and asset management charges for each fund. The fair value of mutual funds is based on quoted net asset values of shares.

Purchases and sales of securities are recorded on a trade-date basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of benefits - Benefits are recorded when paid.

Corrective distributions - The Plan records corrective distributions as an expense in the year of the distribution rather than recording the amount as liabilities when incurred. The corrective distributions are recognized as deductions from net assets in the statement of changes in net assets available for benefits. Corrective distributions of \$25,632 were paid for the 2022 Plan year in 2023 and are recorded as distributions in the year paid. Corrective distributions of \$63,315 were paid for the 2023 Plan year in 2024 and are recorded as distributions in the year paid. An additional \$4,491 corrective distribution for the 2024 year was recorded and paid in 2024. Additional corrective distributions to be made for the 2024 Plan year were \$77,968 and will be recorded in the 2025 Plan year when paid.

Operating expenses - All investments, including the ones utilized by the Plan, have expenses associated with their management and operations. All expenses of the Plan are paid by either the Plan or the Company, as provided by the Plan document.

NOTE 3
PLAN TERMINATION

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

NOTE 6
TAX STATUS

Effective July 1, 2021, the Plan adopted the Union Bank and Trust Company Defined Contribution Pre-Approved Plan. The volume submitter profit sharing plan received notification from the Internal Revenue Service by a letter dated June 30, 2020, that it is acceptable under Section 401 of the Internal Revenue Code for use by employers for the benefit of their employees. Although the Plan has been amended since receiving the advisory opinion, the Plan administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the Internal Revenue Code and that the Plan is qualified, and the related trust is tax-exempt.

NOTE 7
FAIR VALUE MEASUREMENTS

Financial Accounting Standards Board Accounting Standard Codification (FASB ASC) 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted process in active markets for identical assets (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described below:

- Level 1 Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

- Level 2 Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the Level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measurement at fair value. There has been no change in the methodologies used at December 31, 2024 or 2023.

Level 1 Assets: The fair value of mutual funds is based on quoted net asset values of shares held by the Plan at year-end. The mutual funds held by the Plan are considered to be actively traded.

Level 2 Assets: *Common/Collective Trust* - The Plan's custodians uses net asset values reported by the bonds and insurance contracts to value the Plan's investments each day. The custodian uses unit values to perform daily account valuations for these investments.

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

ADMINISTRATIVE EXPENSES

Administrative expenses consist of administrative charges, custodial fees, trustee fees, professional fees, and investment advisory fees. Total administrative expenses for 2024 and 2023 were \$142,697 and \$125,953, respectively, which were paid directly by the Plan. Investment fees charged by funds that participants are invested in are included in net appreciation (depreciation) in fair value of investments.

PLAN ADOPTIONS

During the year ended December 31, 2020, the Plan adopted provisions of the Coronavirus Aid, Relief, and Economic Security (CARES) Act including coronavirus-related distributions, repayment of coronavirus-related distributions, and suspension of required minimum distributions. Provisions of the Setting Every Community Up for Retirement Enhancement (SECURE) Act also went into effect on January 1, 2020. There were no significant provisions of the SECURE Act that affected the Plan from 2020 through 2024. The Plan has not yet been amended for these provisions. Management plans on formally amending the plan for these provisions before the federally required due date.
