We have performed audits of the accompanying financial statements of Positive Promotions Inc. 401(k) Profit Sharing Plan & Trust, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) [ERISA Section 103(a)(3)(C) audit]. #### **Note 1 – Description of Plan**

The following description of the Positive Promotions Inc. 401(k) Profit Sharing Plan & Trust (the “Plan”) provides only general information. Participants should refer to the plan agreement for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of Positive Promotions, Inc. (the “Company”) who have attained the age of 21, completed two consecutive months of service with the Company and who are not covered by a collective bargaining agreement, as defined. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”). The entry date for participants is the first day of the month after you meet all of the applicable age and service requirements.

#### **Contributions**

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, not to exceed annual dollar limitations imposed by the Internal Revenue Service (“IRS”). Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified defined benefit or defined contribution plans (“rollovers”). During the year ended December 31, 2024, there were \$280,572 of rollovers into the Plan.

Annually, the Company may contribute a matching contribution to be determined each year on behalf of each participant who is eligible to share in the matching contributions. In addition, the Company may contribute a profit sharing contribution at such amounts as may be determined at its discretion, with any such amount allocated to eligible participants, pro rata, based on compensation. Participants are eligible for the Company’s contributions if they have at least one year of service and are employed on the last day of the plan year. Participants direct the investment of their contributions and those provided to them by the Company into various investment fund options offered by the Plan.

Total matching contributions for the year ended December 31, 2024 were \$152,823, which were funded by the Company subsequently. There were no profit sharing contributions for year ended December 31, 2024.

#### **Participant Accounts**

Each participant's account is credited with the participant's contributions and Company matching contributions, as well as allocations of the Company’s profit sharing contribution and plan earnings. Participant accounts are charged with an allocation of administrative expenses that are paid by the Plan. Allocations are based on participant earnings, account balances, or specific participant transactions, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant’s vested account.

**Vesting**

Participants are vested immediately in their contributions plus actual earnings thereon. Vesting in the Company's matching and discretionary contribution portions of their accounts, plus actual earnings thereon, is based on years of continuous service. With respect to the Company's matching and discretionary portions, a participant is 20% vested after two years of continuous service increasing to 100% after six years. Additionally, a participant becomes 100% vested automatically upon retirement, death, disability or upon attaining age 65 while employed or if the Plan is terminated.

**Notes Receivable from Participants**

Participants may borrow from their fund accounts up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance in the Plan. The notes are secured by the balance in the participant's account and bear interest at rates ranging from 4.25% to 10.50% and maturing through August 2052. Interest on notes is charged at a reasonable rate, as determined by the administrator, based on reviewing the interest rates charged for similar types of notes by other lenders. Principal and interest are paid ratably through weekly and biweekly payroll deductions over a reasonable period of time. Any outstanding loans are due and payable upon termination of employment.

**Excess Contributions Payable**

Amounts payable to participants for contributions in excess of amounts allowed by the IRS are recorded as a liability with a corresponding reduction to contributions.

**Payment of Benefits**

On termination of service due to death, disability or normal retirement age of 65, a participant or beneficiary may elect to receive benefits in a lump-sum or non-recurring partial payments in amounts equal to the value of the participant's vested interest in his or her account. Additionally, participants may also request a distribution while still employed for financial hardships or after you reach 59 ½ years of age.

**Forfeited Accounts**

As of December 31, 2024 and 2023, forfeited non-vested accounts totaled \$11,500 and \$6,080, respectively. Forfeitures of non-vested account balances of terminated employees are used to reduce future employer contributions. Forfeitures of \$11,500 were utilized to reduce employer contributions for the year ended December 31, 2024.

**Basis of Accounting**

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America ("U.S. GAAP").

**Use of Estimates**

The preparation of financial statements in conformity with U.S. GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

**Investment Valuation and Income Recognition**

Investments held by a defined contribution plan are required to be reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 7 - Fair Value Measurements.

Purchases and sales of securities are recorded on a trade date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

**Payment of Benefits**

Benefits are recorded when paid.

**Expenses**

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participant's account and are included in administrative expenses.

**Note 3 - Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their employer contributions.

**Note 4 - Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits.

#### **Note 5 - Tax Status**

The Internal Revenue Service has determined and informed the Company, by a letter dated August 31, 2020, that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (“IRC”) and is exempt from income taxes. Although the Plan has been amended since receiving the determination letter, the Plan’s administrator and the Plan’s tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax-exempt.

U.S. GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the applicable taxing authority. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **Note 6 - Information Prepared and Certified by the Custodian (unaudited)**

Certain information related to investments in the accompanying financial statements and supplemental schedule, including investments at fair value and notes receivable from participants held as of December 31, 2024 and 2023, net appreciation in fair value of investments and interest income on notes receivable from participants for the year ended December 31, 2024, were obtained or derived from information supplied to management and certified as complete and accurate by Charles Schwab Trust Bank (the “Trustee”), respectively.

#### **Note 7 - Fair Value Measurements**

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3).

The three levels of the fair value hierarchy under U.S. GAAP are described as follows:

**Level 1 -** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2 -** Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; and inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** - Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset's or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value:

There have been no changes in the methodologies used as of December 31, 2024 and 2023.

***Mutual funds*** – Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

***Common/collective trust*** – Common collective trust (“CCT”) is valued at NAV of units held by the Plan and is not publicly quoted. The NAV, as provided by the Custodians of the CCT, is used as a per share practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Classification within the fair value hierarchy table is based on the lowest level of any input that is significant to the fair value measurement.

The Plan's investment strategy for investments measured at NAV are to preserve principal while generating earnings over time.

**Note 8 – Party-In-Interest Transactions**

The Plan engages various service providers to perform administrative, recordkeeping and investment advisory services. These providers include entities that meet the definition of a party in interest under U.S. GAAP because they provide services to the Plan or have fiduciary or other relationships with the Plan.

For the year ended December 31, 2024, the Plan paid recordkeeping fees to CEP Consultants, Inc. and Charles Schwab Trust Bank (the “Recordkeepers”) \$40,779 and \$7,827, respectively. The Recordkeepers provide participant account administration, processing and reporting services and are considered party in interests.

The Plan also paid \$19,618 in investment advisory fees to CFM Advisors, Inc., an ERISA registered investment advisor and fiduciary to the Plan. CFM provides asset allocation guidance, fund monitoring and investment consulting. Fees were allocated either as a direct charge to participant accounts or paid from plan forfeitures.
