In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about Sheet Metal Workers' Local 33 Profit Sharing Annuity Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditors' Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditors' report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with generally accepted auditing standards will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with generally accepted auditing standards, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.
- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of Sheet Metal Workers' Local 33 Profit Sharing Annuity Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about Sheet Metal Workers' Local 33 Profit Sharing Annuity Plan's ability to continue as a going concern for a reasonable period of time.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Supplemental Schedule Required by ERISA

Our audits were conducted for the purpose of forming an opinion on the financial statements as a whole. The supplemental schedule of assets (held at end of year) as of December 31, 2024 is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information has been subjected to the auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, including its form and content, is presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

In our opinion, the information in the accompanying schedule is fairly stated, in all material respects, in relation to the financial statements as a whole, and the form and content are presented in conformity with the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA.

1. DESCRIPTION OF THE PLAN:

The following description of the Sheet Metal Workers' Local 33 Profit Sharing Annuity Plan ("Plan") is provided for general information purposes only. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

General

The Plan is a multiemployer defined contribution plan maintained pursuant to various collective bargaining agreements between the International Association of Sheet Metal Air, Rail, and Transportation Workers, Local Union No. 33 (Union) and different chapters of the Sheet Metal and Air Conditioning Contractors National Association (Association) on behalf of the individual participating contractors. Individuals are eligible to participate in the Plan immediately if they work for an Employer that has been accepted as a contributing employer to the Plan. The Plan is subject to the Employee Retirement Income Security Act of 1974 (ERISA).

Contributions

In accordance with collective bargaining agreements, employers are required to remit monthly contributions at a fixed dollar amount for each hour worked by participants. No participant contributions to the Plan are permitted. The Plan accepts rollover contributions from other qualified plans.

Participant accounts

Each participant's account is credited with the employer contributions and allocations of (a) Plan earnings and (b) administrative fees. Allocations are based on the provisions of the Plan. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Participant-directed investment options

Upon enrollment in the Plan, participants may direct the investment of their contributions into any of several investment options with varying degrees of risk and volatility, allowing participants to allocate their investments in accordance with their own risk tolerances and time horizons. Participants may change their investment options at any time.

Payment of benefits

Upon termination of service due to death, disability, retirement, or other termination of employment, a participant may elect to receive benefits in the form of qualified joint and survivor annuity, a lump-sum amount up to the value of the participant's account, or annual installments over a future period. Distributions of a participant's account balance may be authorized at any time by the plan administrator under certain hardship conditions. In the event a participant becomes eligible to receive a distribution under the terms of the Plan, and the participant's account balance is less than \$1,000, then the Plan shall pay the participant the full value of the account without the participant's consent.

Vesting

A participant becomes 100% vested upon completion of 350 hours of work in a twelve consecutive month period.

1. DESCRIPTION OF THE PLAN (CONTINUED):

Forfeited accounts

Employees of participating employers immediately receive employer contributions to the Plan upon employment. If an employee does not complete the initial requirement to become a participant in the Plan, employer contributions are forfeited and used to defray expenses of the Plan, as defined in the plan document. At December 31, 2024 and 2023, forfeited nonvested accounts totaled \$45,906 and \$1,548 respectively.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of accounting

The accompanying financial statements of the Plan have been prepared on the accrual basis of accounting.

Use of estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

Benefits

Benefit payments to participants are recorded upon distribution.

Investment valuation and income

Investments are reported at fair value, except for fully benefit-responsive investment contracts, which are reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Administrative expenses

Expenses of maintaining the Plan, including participant recordkeeping, are paid by the Plan and are included in these financial statements. Certain fees related to distributions are charged directly to the participant's account and are included in administrative expenses.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONTINUED):

Employer contributions receivable

Employer contributions receivable represents amounts due from employers that were received subsequent to year end. Therefore, the carrying amount of these receivables is not reduced by an allowance for amounts that will not be collected. In addition, it is impractical to estimate revenue recognition for amounts due but erroneously unreported by employers.

Reciprocity contributions

Participants of the plan and participants of the benefit plans of other affiliated local unions may have temporary employment assignments outside the jurisdiction of their local union. Therefore, the Plan has entered into reciprocity agreements with other affiliated locals to ensure that employer contributions are forwarded to the benefit plans of the participant's local union. Reciprocal contributions received and reciprocal contributions paid have been included in the statements of changes in net assets available for benefits.

Subsequent events

The Plan has evaluated subsequent events through October 8, 2025, the date the financial statements were available to be issued. There were no subsequent events that required adjustment to the financial statements or additional disclosure.

3. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are described as follows:

Level 1: Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2: Inputs to the valuation methodology include:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3: Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

3. FAIR VALUE MEASUREMENTS (CONTINUED):

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds: Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Pooled separate accounts: Separate investment accounts are established by Empower to invest directly in individual mutual funds. Empower calculates an internal unit value in order to allocate investment activity among investors in these funds. As a result, the NAVs of the mutual funds provided through public sources will not match the unit values reported by Empower. However, Empower utilizes the NAVs directly from fund companies and other public sources to validate the calculated unit values of the separate investment accounts.

Common/collective trusts: Valued at the net asset value of units of the collective trusts. The NAV, as provided by the custodian, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported NAV.

(a) Fund is a direct filing entity (DFE). The Plan is not required to disclose the investment strategies of DFE's that file a Form 5500 annual report directly with the U.S. Department of Labor.

4. GUARANTEED INTEREST ACCOUNT:

Through a group annuity contract, the Plan offers a guaranteed interest account ("GIA") as a stable value option. The amount outstanding at December 31, 2024 and 2023 under this investment option is \$9,945,316 and \$9,741,263, respectively. Participant accounts invested in the GIA are paid out at contract (or "book") value for participant-initiated transactions, such as transfer to other permissible investment options and other distributions. The GIA account balances are backed by the general assets of Great-West Life & Annuity Insurance Company. There are no reserves against the contract value of this account for credit risk of Great-West Life & Annuity Insurance Company.

The GIA is credited with earnings at an interest rate that is subject to semiannual adjustments in June and December of each year. As of December 31, 2024 and 2023, the guaranteed interest rate was 3%.

The GIA meets the fully benefit-responsive investment contract criteria and therefore, is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported to the Plan by Great-West Life & Annuity Insurance Company, represents contributions made under the contract, plus earnings, less participant withdrawals, and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. The Plan's ability to receive amounts due is dependent on the issuer's ability to meet its financial obligations. The issuer's ability to meet its contractual obligations may be affected by future economic and regulatory developments.

4. GUARANTEED INTEREST ACCOUNT (CONTINUED):

Certain events might limit the ability of the Plan to transact at contract value with the issuer. Such events include (1) amendments to the Plan documents (including complete or partial Plan termination or merger with another plan), (2) changes to the Plan's prohibition on competing investment options or deletion of equity wash provisions, (3) bankruptcy of the Plan sponsor or other Plan sponsor events (for example, divestitures or spin-offs of a subsidiary) that cause a significant withdrawal from the Plan, or (4) the failure of the trust to qualify for exemption from federal income taxes or any required prohibited transaction exemption under ERISA, (5) premature termination of the contract. The Plan administrator believes that no events are probable of occurring that might limit the ability of the Plan to transact at contract value with participants.

In addition, certain events allow the issuer to terminate the contract with the Plan and settle at an amount different from contract value. Such events include (1) an uncured violation of the Plan's investment guidelines, (2) a breach of material obligation under the contract, (3) a material misrepresentation, (4) a material amendment to the agreement without consent of the issuer.

5. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS:

The Plan has common trustees with, and pays the Sheet Metal Workers' Union Local No. 33 Benefit Funds, Inc. for administrative services under an administrative fee arrangement. The Sheet Metal Workers' Union Local No. 33 Benefit Funds, Inc. charges the Plan an administration fee based upon specified criteria as set forth in the board minutes of the respective funds. Certain investments are managed by Empower, the custodian and recordkeeper of the Plan. BeneSys, Inc. provided third-party administrative services to the Plan. Morgan Stanley provides investment advisory services to the Plan. Such transactions and associated administrative expenses qualify as party-in-interest transactions.

Empower provides certain administrative services to the Plan pursuant to an Administrative Services Agreement (ASA) between the Plan and Empower. Empower receives revenue from mutual fund and collective trust fund service providers for services Empower provides to the funds. This revenue is used to offset certain amounts owed to Empower for its administrative services to the Plan.

If the revenue received by Empower exceeds the quarter target revenue set forth in the ASA, Empower will credit the difference to the Plan's trust on a quarterly basis provided the revenue from unaffiliated funds is sufficient for such difference. Such amounts will be applied to pay Plan administrative expenses. During 2024 and 2023 there were excess amounts of \$99,326 and \$253,513, respectively, credited to the Plan and included in the statement of changes in net assets available for benefits. The Plan may make a payment to Empower for administrative expenses not covered by revenue sharing.

6. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Union and Association have the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants shall continue to be 100% vested in their accounts.

7. TAX STATUS:

The Internal Revenue Service (IRS) has determined and informed the Plan's Board of Trustees by a letter dated December 8, 2015 that the Plan and related trust are designed in accordance with applicable sections of the Internal Revenue Code (IRC). Although the Plan has been amended since receiving the determination letter, the plan administrator and the Plan's tax counsel believe that the Plan is currently designed and being operated in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified and the related trust is tax exempt.

8. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the December 31, 2024 and 2023 statements of net assets available for benefits.
