The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

1. DESCRIPTION OF PLAN

The following description of 403(b) Thrift Plan of Resources for Seniors (the "Plan") provides only general information. Participants should refer to the Plan document for a more complete description of the Plan's provisions.

- a. General – The Plan is a defined contribution plan, established on July 1, 1991 to provide retirement benefits for employees of Resources for Seniors, Inc. (the "Plan Sponsor" and "Employer") and their beneficiaries. The Plan is designed to conform to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA). All employees of the Plan Sponsor are eligible to participate in the Plan upon their hire, except for employees who are non-resident aliens with no U.S. source income or employees who are eligible to make contributions to another qualified Plan of the employer. Participation in the Plan is voluntary.
- b. Contributions – Each year, participants may contribute between 1% and 100% of pre-tax or after-tax annual compensation, as defined by the Plan. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans (rollovers) as defined under Section 402 of the Internal Revenue Code.

The Plan document provides for a discretionary base contribution by the Employer. The Employer elected to contribute 2% of compensation for all eligible employees for the year ended December 31, 2024. Annual contributions to the Plan may not exceed the amounts permitted under Section 415 of the Internal Revenue Code. Participants direct the investment of contributions into various investments offered by the Plan.

- c. Participant Accounts - Each participant's account is credited with (1) participant's contributions, (2) employer contributions and (3) allocations of net Plan earnings and administrative expenses. Allocations are based on participant account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.
- d. Vesting - Participants are vested immediately in their contributions plus actual earnings thereon. Employer contributions vest according to the following schedule:

Participants will automatically become 100% vested upon attainment of normal retirement age (65) or retirement due to disability or death.

- e. Payment of benefits - Upon termination of employment, retirement, death, or disability, a participant or beneficiary may elect to receive a single lump-sum payment of their account balance. If a terminated participant is 55 years of age or older, payment of their account balance can also be requested in either installment payments over a period that does not exceed life expectancy, or payment in the form of an annuity. At any time, a participant may make a one-time election to withdraw pre-1988 deferrals, excluding earnings on such contributions credited after December 31, 1988. In addition, during active service, a participant can take hardship distributions if certain conditions are satisfied. Effective January 1, 2019, upon taking a hardship distribution, the participant is no longer suspended from the Plan for six months.
- f. Forfeited accounts - Forfeited balances of terminated participants' non-vested accounts are used to reduce future employer contributions or pay Plan administrative expenses. At December 31, 2024 and 2023, forfeited non-vested accounts totaled \$1,750 and \$0, respectively. In 2024 \$1,549 of forfeited non-vested accounts were used to reduce employer contributions.
- g. Plan loans – Participants may borrow against their investment accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. All Plan loans are issued directly by funds owned by Mutual of America Life Insurance Company (Mutual of America) and are secured by the value held in the participant's investment account within the Plan (i.e., loan proceeds are not removed from a participant's account balance). At any time, the participant's account value in the Plan must be equal to 120% of the Plan loan in order to ensure adequate collateralization. Plan loans bear interest at a variable rate as determined by Mutual of America equal to the interest crediting rate of the Interest Accumulation Account plus 3%. Interest rates are adjusted by Mutual of America no less than once a year. Plan loans must be repaid within 5 years. If the loan is used for the purchase of a principal residence, the loan term can be extended to a period of no more than 10 years. Principal and interest is paid through semi-monthly installments deducted through payroll. As of December 31, 2024 and 2023, there were Plan loans due to Mutual of America secured by Plan assets of \$39,202 and \$40,806, respectively. As of December 31, 2024 and 2023, there were no defaulted Plan loans due to Mutual of America.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America ("GAAP") requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results may differ from those estimates.

Investment Valuation and Income Recognition

Investments are reported at fair value, except for the fully benefit-responsive investment contract, which is reported at contract value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by Mutual of America. See Note 5 for a further discussion on fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Net appreciation (depreciation) in the fair value of investments includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Payment of Benefits

Benefits are recorded when paid.

Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Plan Sponsor. Expenses that are paid by the Plan Sponsor are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) in fair value of investments.

3. PLAN ADMINISTRATOR AND TRUSTEE INFORMATION

The plan administrator and trustee is the Plan Sponsor, Resources for Seniors, Inc. The plan administrator has designated Mutual of America Life Insurance Company, the insurance company, to hold the Plan's invested assets and to execute investment transactions.

4. GROUP ANNUITY CONTRACT

The plan administrator has designated Mutual of America Life Insurance Company, the insurance company, to administer plan investments under a group annuity contract. In addition to executing investment transactions, the group annuity contract provides for benefit payments to be made from the Plan upon the direction and request of the plan administrators.

5. FAIR VALUE MEASUREMENTS

The Plan follows FASB ASC 820, *Fair Value Measurements*, which defines fair value as the price that would be received from selling an asset in an orderly transaction between market participants at the measurement date. When determining the fair value measurements for assets required to be recorded at fair value, the Plan considers the principal or most advantageous market in which it would transact and considers assumptions that market participants would use when pricing the asset or liability, such as inherent risk, transfer restrictions, and risk of nonperformance.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Pooled Separate Accounts

Pooled separate accounts are valued at the net asset value (“NAV”) of units of a fund. The NAV, as provided by Mutual of America, is used as a practical expedient to estimate fair value. The NAV is based on the fair value of the underlying mutual funds registered with the Securities and Exchange Commission held by the fund, as determined by quoted prices of identical assets in an active market, less its liabilities. This practical expedient is not used when it is determined to be probable that the fund will sell the investment for an amount different than the reported NAV. Participant transactions (purchases and sales) may occur daily. Were the Plan to initiate a full redemption of the pooled separate account, the investment advisor reserves the right to temporarily delay withdrawal from the trust in order to ensure that securities liquidations will be carried out in an orderly business manner.

In accordance with ASC 820-10, certain investments measured at fair value using the net asset value per share (or its equivalent) practical expedient are not classified in the fair value hierarchy.

7. GUARANTEED INVESTMENT CONTRACT WITH INSURANCE COMPANY

The Plan has a fully benefit-responsive guaranteed investment contract with Mutual of America totaling \$944,009 at December 31, 2024 and \$918,792 at December 31, 2023. Mutual of America maintains the contributions in their general account and is contractually obligated to repay the principal and a specified rate of interest. A guaranteed minimum interest rate is determined by Mutual of America annually. Each contract is fully and unconditionally guaranteed by Mutual of America.

This contract meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount participants would receive if they were to initiate permitted transactions under the terms of the Plan. Contract value, as reported by Mutual of America, represents contributions made under the contract, plus earnings, less participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value.

There are no reserves against contract value for credit risk of the contract issuer. Interest is credited to the contract at interest rates that reflect the performance of the underlying portfolio. Such interest rates are reviewed no less than once a year for resetting, at which time a guaranteed rate is elected for the year. For 2024, the guaranteed interest rate was 2.85%. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value. Participants will receive the principal and earnings credited to their accounts on withdrawal for allowed events. These events include transfer to other Plan investment options, and payments because of retirement, termination of employment, disability, death and in-service withdrawals as permitted by the Plan.

The average yield and crediting interest rate to the Mutual of America Interest Accumulation Account for the years ending December 31, 2024 and 2023 was approximately 2.87% and 1.56%, respectively.

Certain events limit the ability of the Plan to transact at contract value with the issuer. Such events could include, but are not limited to the following (a) the Plan Sponsor fails to meet the requirements of the contract or to abide by the terms of the contract (b) a modification in the contract is necessary in order to comply with federal or state requirements, including ERISA, and the Plan Sponsor refuses to accept a substantially similar contract offered by the contract issuer. The Plan's administrator does not believe that any events which would limit the Plan's ability to transact at contract value with participants are probable of occurring.

The guaranteed investment contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

8. PLAN TERMINATION

Although it has not expressed any intent to do so, the Plan Sponsor has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100 percent vested in their employer contributions.

9. TAX STATUS

The Plan has not been submitted to the Internal Revenue Service for tax exempt determination. However, the plan administrator believes that the Plan was designed and is being operated in compliance with the applicable requirements of the Internal Revenue Code.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

10. RELATED PARTY AND PARTY-IN-INTEREST TRANSACTIONS

The Plan invests in certain funds managed by Mutual of America. Mutual of America is the custodian of the Plan's assets and therefore, these transactions qualify as party-in-interest transactions. Fees incurred by the plan for investment management services are included in net appreciation in fair value of pooled separate accounts.

Mutual of America issues Plan loans to participants of the Plan in exchange for a guaranteed interest in the participant's account equal to 120% of the value of the Plan loan, see Note 1. As of December 31, 2024 and 2023, there were Plan loans due to Mutual of America secured by Plan assets of \$39,202 and \$40,806, respectively.

11. RISKS AND UNCERTAINTIES

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the financial statements.

12. CONCENTRATIONS

At December 31, 2024, 23% and 12%, of investments were held in the Mutual of America Interest Accumulation Fund and DWS Capital Growth VIP Fund, respectively. At December 31, 2023, 26% and 11%, of investments were held in the Mutual of America Interest Accumulation Fund and DWS Capital Growth VIP Fund, respectively.

13. SUBSEQUENT EVENTS

The Plan has evaluated events and transactions that occurred between December 31, 2024 and October 7, 2025 which is the date the financial statements were available to be issued, for possible recognition or disclosure in the financial statements.

Effective January 1, 2025 the plan was amended to allow for employer matching contributions equal to 100% of the first 4% of employee contributions. Employees must have a minimum of one year of service to be eligible for the matching contribution.
