### Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Merani Hotel Group Inc 401(k) Retirement Savings Plan (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statements of changes in net assets available for benefits for the years then ended, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's (DOL) Rules and Regulations for Reporting and Disclosure under ERISA (ERISA Section 103(a)(3)(C) audit). As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan (investment information) by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency (qualified institution), provided that the investment information is prepared and certified to by the qualified institution in accordance with 29 CFR 2520.103-5 of the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023, and for the years then ended, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

## Notes to Financial Statements

### 1. Description of the Plan

The following plan description of the Merani Hotel Group Inc ("MHG") (the "Company" or "Employer") 401(k) Retirement Savings Plan (the "Plan") provides only general information. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

#### General

The Plan is a defined contribution 401(k) plan available to qualifying employees of MHG, as well as qualifying employees of the related participating employers including LaSalle Hospitality, Inc., Merani Hospitality, Inc. and Merani Holdings, LLC. MGH is the plan sponsor and plan administrator of the Plan. To be eligible to participate in the Plan, an employee must have attained the age of 18 and have completed one year (1,000 hours) of service. The same age and service minimums are required for employees to be eligible for the Company contributions. The plan allows for an auto enroll provision whereby newly eligible participants will be automatically enrolled in a deferral agreement at 1% of eligible compensation. All participants have the ability to opt out of this agreement. Related to this is a provision to automatically increase the deferral percentage for all participants automatically enrolled by 1% annually to a maximum of 5% of compensation. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 ("ERISA").

Effective in August 2025, the Company adopted an Actuarial Consulting Services, Inc. pre-approved plan replacing the existing plan document. Plan assets were transferred to Transamerica Retirement Solutions ("Transamerica") and Transamerica became custodian and assumed recordkeeping responsibilities for the Plan at that time.

#### Contributions

Each year, participants may contribute up to 100% of pretax annual compensation, as defined in the Plan, up to the maximum allowable under the Internal Revenue Code. Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans. Participants direct the investment of their contributions into various investment options offered by the Plan. For the 2024 and 2023 Plan years, the Company contributed 50% of up to 5% and 4% of compensation that a participant contributes to the Plan, respectively. The Company may also make an additional discretionary contribution. Participants may also contribute after-tax contributions to the Plan up to 100% of annual compensation. The Company contributed \$81,099 and \$62,798 to the Plan during the years ended December 31, 2024 and 2023, respectively.

#### Participant Accounts

Individual accounts are maintained for each Plan participant. Each participant's account is credited with the participant's contribution, the Employer's contribution, if any, the participant's share of Plan earnings and loss, and charged with participant transaction specific fees and an allocation of certain administrative expenses. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

## Notes to Financial Statements

### 1. Description of the Plan (Continued)

#### Vesting

Participants are immediately vested in their contributions, certain qualified matching contributions, and rollover contributions, plus actual earnings thereon. Participants become vested in matching contributions and discretionary employer contributions based on years of continuous service, as defined. Participants are 100% vested in matching contributions after five years, and are 100% vested in other discretionary contributions after six years.

#### Payment of Benefits

Upon termination of service due to death, disability, retirement or separation, a participant may elect to receive a lump-sum amount equal to the value of the participant's vested interest in his or her account.

#### Forfeitures

At December 31, 2024 and 2023, forfeited non-vested accounts were not material to the Plan. Forfeitures may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. During the years ended December 31, 2024 and 2023, Company contributions were reduced by \$6,088 and \$5,516, respectively, from forfeited non-vested accounts.

#### Notes Receivable From Participants

Participants are not permitted to borrow against their account balances.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

#### Investment Valuation

The investments of the Plan are reported at fair value in accordance with Accounting Standards Codifications ("ASC") 820, *Fair Value Measurements and Disclosures*. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (the exit price). See Note 7 for discussion of fair value measurements.

### 2. Summary of Significant Accounting Policies (Continued)

#### Investment Transactions and Income

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. In accordance with the policy of stating investments at fair value, net appreciation for the year (including both realized and unrealized gains and losses) is reflected in the statement of changes in net assets available for benefits.

#### Contributions

Participant contributions are made through payroll deductions and are recorded as additions to net assets available for benefits when the deduction is made. Employer contributions are recorded as additions to net assets available for benefits when such liability arises. Participant contributions not yet deposited and amounts not funded by the Employer are recorded as contributions receivable.

#### Payment of Benefits

Benefits are recorded when paid.

#### Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation (depreciation) of fair value of investments.

#### Subsequent Events

The Plan has evaluated subsequent events through October 8, 2025, the date on which the financial statements were available to be issued.

#### Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets, liabilities, and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

### 3. Information Certified by the Plan's Custodian

### 4. Related Party and Party-In-Interest Transactions

Administrative fees paid by the Plan to the third-party administrator and the investment advisor totaled \$7,329 and \$5,239 during the years ended December 31, 2024 and 2023, respectively. Certain costs of administering the Plan are paid by the Company.

### 5. Plan Termination

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants are 100% vested in their account balances.

### 6. Income Tax Status

Based upon the third-party administrator's receipt of a favorable determination letter from the Internal Revenue Service dated June 30, 2020 with respect to a Non-Standardized Pre-Approved plan on which the Plan is based, the Plan Administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the Code. The Plan Administrator believes that the Plan is currently designed and being operated in accordance with the applicable requirements of the Internal Revenue Code and that the Plan and related trust continue to be tax-exempt. Therefore, no provision for income taxes has been recorded.

### 6. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more than likely would not be sustained upon examination by the Internal Revenue Service. The Plan Administrator has analyzed the tax positions taken by the Plan and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability (or asset) or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021, the year of Plan commencement.

### 7. Fair Value Measurements

ASC 820, *Fair Value Measurements and Disclosures*, establishes a framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

**Level 1** Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

**Level 2** Inputs to the valuation methodology include:

- Quoted prices for similar assets or liabilities in active markets;
- Quoted prices for identical or similar assets or liabilities in inactive markets;
- Inputs other than quoted prices that are observable for the asset or liability;
- Inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

**Level 3** Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

### 7. Fair Value Measurements (Continued)

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds and fixed income funds - valued at the daily closing price as reported by the fund. Mutual funds and fixed income funds held by the Plan are open-end funds that are registered with the SEC. These funds are required to publish their daily net asset value ("NAV") and to transact at that price. The funds held by the Plan are deemed to be actively traded.

Common/Collective Trust - the fair market value of the PIMCO Stable Income Fund (the "Fund"), a common/collective trust (CCT) is based on the net asset value, as reported by the manager of the collective trust fund, SEI Trust Company, and as supported by the unit prices of actual purchase and sale transactions occurring as of or close to the financial statement date. The objective of the Fund is to seek to provide current income in excess of money market investments and reduce the risk of principal loss over time. The Fund is an actively managed, diversified investment strategy which invests through the use of PIMCO Funds Private Account Portfolio Series ("PAPS") investments in the Low Duration Fund and Moderate Duration Fund. The PAPS investments each primarily invest in various investment grade fixed income investments. The average duration of the Fund's investments will vary over time, but is typically expected to be between two to three years. Other Trust investments may include a variety of stable value investment contracts issued by insurance companies, banks, and other financial intuitions, which are intended to help reduce principal volatility of, while providing steady income from, any associated Fund fixed income investments. The CCT generally provides for daily redemptions by the Plan at reported net asset value, with no advance notice requirements.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

### 8. Risks and Uncertainties

The Plan invests in various investment securities. Investment securities are exposed to various risks such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
