**1. Description of Plan**

The Variantyx, Inc. 401(k) Profit Sharing Plan (the Plan) is a defined contribution plan of Variantyx, Inc. (the Plan Administrator or the Company). The following description of the Plan provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

**General**

The Plan, effective January 1, 2017, is a defined contribution profit sharing plan covering all eligible employees of Variantyx, Inc. (the Company). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (ERISA).

**Eligibility**

Participation in the Plan is available to eligible employees who have reached age 21. Employees may participate in the Plan following the date on which the eligibility requirements are met. Eligible employees include all full-time employees and excludes part time employees whose regularly scheduled service is less than 1,000 hours of service in one year.

**Contributions**

Plan participants may make salary deferral contributions to the Plan based on a percentage of their annual compensation, as defined by the Plan, limited by the requirements of the Internal Revenue Code (IRC), which was \$23,000 and \$22,500 for the years ended December 31, 2024 and 2023, respectively. Participants who are age 50 or older are eligible to make catch-up contributions. The maximum amount a participant may contribute as catch-up contributions is \$7,500 in the years ended December 31, 2024 and 2023. Participants may also make Roth 401(k) after-tax contributions to the Plan. The Plan Administrator submits all withheld employee contributions to the Plan for all pay cycles at a reasonable time after the employee contributions have been calculated.

The Plan includes a flexible discretionary employer match which the Company in its sole discretion elects to make to the Plan. These matching contributions are determined annually based on a discretionary percentage of a participant's compensation or a discretionary dollar amount as a basis for the matching contribution. The Company elected to make an employer matching contribution of \$315,103 for the 2024 plan year. The Company did not elect to make any employer matching contributions pertaining to the 2023 plan year.

In addition, the Company may make non-elective employer contributions. These non-elective profit-sharing contributions are discretionary determined by management annually based on business units or location. In order to be eligible for non-elective employer contribution, the participant must complete at least 500 hours of service. The Company did not elect to make non-elective employer contributions pertaining to the 2024 and 2023 plan years.

### **Contributions (continued)**

For the year ended December 31, 2024, the Plan recorded an employer receivable for \$53 in related earnings on corrective contributions in accordance with the necessary compliance requirements to employees whose deferral elections were not appropriately withheld. There was no corrective contributions required for the year ended December 31, 2023.

Participants may also contribute amounts representing distributions from other qualified defined benefit or contribution plans under the rollover provisions of the Plan. Participants may change their salary deferral percentage at any time during the year. Participants may also change their investment options or cease contributing to the Plan at any time. Participants direct the investment of their contributions into various investment options offered by the Plan.

### **Participant Accounts**

All employer and participant contributions to the Plan are invested in accordance with investment elections specified by each participant. Each participant's account is credited or charged with the participant's contribution and allocations of the Company's contribution, Plan earnings or losses, and Plan expenses. Allocations are based on participant earnings or account balances, as defined.

The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

### **Vesting**

Participants are immediately vested in their own contributions plus actual earnings thereon. Vesting in the Company's employer matching contributions and non-elective employer contributions within their accounts plus actual earnings thereon is based on years of continuous service, as defined. Participants become 20% vested after two years of credited service, and continue to vest at 20% per year for each year of credited service, becoming fully vested after six years. In the event of termination due to death, total and permanent disability, participants shall become 100% vested in the Company profit sharing contribution portion of their account.

### **Payments of Benefits**

Upon termination of service due to death, a participant's entire account balance will be paid to all beneficiaries by the end of the fifth year. For termination of service due to other reasons, a participant may receive the value of the vested interest in his or her account as a lump-sum distribution. Partial withdrawals or installments are only permitted for participants or beneficiaries who must receive required minimum distributions according to the requirements of the Internal Revenue Code (IRC). Terminated vested participants with account balances valued between \$1,000 and \$5,000 do not require spousal consent for distribution, and such accounts will be distributed as a lump sum. Participant consent is required if the distribution is over \$5,000.

### 1. Description of Plan (continued)

#### Forfeitures

If a participant terminates employment with the Company at a time when the participant does not have fully vested interest, the non-vested employer contributions and actual earnings thereon are forfeited. Forfeited balances of terminated participants' non-vested accounts are used to reduce future Company contributions. The balance in the forfeiture account was \$7,409 and \$7,328 at December 31, 2024 and 2023, respectively. Forfeiture additions and related earnings totaled \$19,635 and \$19,467 for the years ended December 31, 2024 and 2023, respectively. For the years ended December 31, 2024 and 2023, \$19,554 and \$14,000, respectively, of forfeitures from non-vested accounts were used to pay for certain Plan expenses.

#### Plan Termination

Although it has not expressed any intent to do so, the Plan Administrator has the right under the Plan to discontinue its contributions at any time or to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants will become 100% vested in their accounts.

### 2. Summary of Significant Accounting Policies

#### Basis of Accounting

The financial statements of the Plan are prepared in accordance with accounting principles generally accepted in the United States of America (GAAP).

#### Use of Estimates

The preparation of the financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and the changes therein, and, when applicable, disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

#### Risks and Uncertainties

The Plan provides for various investment options in any combination of shares of mutual funds and a guaranteed investment contract with various investment objectives. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**2. Summary of Significant Accounting Policies (continued)**

**Investment Valuation and Income Recognition**

With the exception of the Plan's investment in the Voya Fixed Account, the Plan's investments are stated at fair value. Shares of mutual funds are valued at quoted market prices, which represent the net asset value of shares held by the Plan at year-end.

The Plan's guaranteed investment contract (the Voya Fixed Account) is fully benefit-responsive and accounted for in accordance with Financial Accounting Standards Board (FASB), Accounting Standards Codification (ASC) 962 (ASC 962), *Reporting of Fully Benefit-Responsive Contracts Held by Certain Investment Companies Subject to the AICPA Investment Company Guide and Defined-Contribution Health and Welfare and Pension Plans*.

As required by ASC 962, as updated by Accounting Standards Update (ASU) No. 2015-12, the Statement of Net Assets Available for Benefits presents the contract value of the investments in the Voya Fixed Account. The Statement of Changes in Net Assets Available for Benefits represents the changes in contract value for the Voya Fixed Account.

Contract value represents guaranteed principal plus the minimum guaranteed interest. The market interest rate credited is determined monthly, however the guaranteed minimum floor rate is determined on an annual basis and will not drop below that rate. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investment at contract value less certain surrender charges.

The Plan presents in the Statements of Changes in Net Assets Available for Benefits the net appreciation (depreciation) in fair value of investments, which consists of undistributed realized gains and losses and unrealized appreciation (depreciation) on these investments.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date.

**Administrative Expenses**

Certain expenses of maintaining the Plan are paid directly by the Company and are excluded from these financial statements. Fees related to Plan administration and investment advisory services are charged directly to the participant's account and are included in administrative expenses.

**Payments of Benefits**

Benefits are recorded when paid by the Plan.

**Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make loan repayments and the Plan Administrator deems the participant loan to be a distribution, the participant loan balance is reduced and a benefit payment is recorded. Loans outstanding at December 31, 2024 bear interest of 8.50%.

**3. Information Prepared and Certified by Custodian**

All investment information disclosed in the accompanying financial statements, including investments held as of December 31, 2024 and 2023, net appreciation (depreciation) in fair value of investments and interest for the years then ended, were obtained or derived from information supplied to the Plan Administrator and certified as complete and accurate by the Voya Retirement Insurance and Annuity Company (VRIAC), the Custodian of the Plan's assets.

**4. Fair Value Measurements**

The Plan follows Accounting Standards Codification (ASC) 820, *Fair Value Measurements and Disclosures* (ASC 820), for all financial assets and liabilities and nonfinancial assets and liabilities that are recognized or disclosed at fair value in the financial statements on a recurring basis. ASC 820 defines fair value, establishes a fair value hierarchy, and expands disclosures about fair value measurements.

ASC 820 defines fair value as the price that would be received upon sale of an asset or paid upon transfer of a liability in an orderly transaction between market participants at the measurement date and in the principal or most advantageous market for that asset or liability.

The fair value should be calculated based on assumptions that market participants would use in pricing the asset or liability, not on assumptions specific to the entity. In addition, the fair value of liabilities should include consideration of non-performance risk including the Plan's own credit risk.

**4. Fair Value Measurements (continued)**

Fair value measurements are determined by maximizing the use of observable inputs and minimizing the use of unobservable inputs. The hierarchy places the highest priority on unadjusted quoted market prices in active markets for identical assets or liabilities (Level 1 measurements) and gives the lowest priority to unobservable inputs (Level 3 measurements). The three levels of inputs within the fair value hierarchy are defined as follows:

*Level 1* - Quoted prices (unadjusted) for identical assets or liabilities in active markets that the Plan has the ability to access as of the measurement date.

*Level 2* - Significant other observable inputs other than Level 1 prices such as quoted prices for similar assets or liabilities; quoted prices in markets that are not active; or other inputs that are observable or can be corroborated by observable market data.

*Level 3* - Significant unobservable inputs that reflect the Plan's own assumptions about the assumptions that market participants would use in pricing an asset or liability.

In some cases, a valuation technique used to measure fair value may include inputs from multiple levels of the fair value hierarchy. The lowest level of significant input determines the placement of the entire fair value measurement in the hierarchy.

The following represents the valuation methods and assumptions used by the Plan to estimate the fair values of investments:

*Mutual Funds:* The fair values of mutual fund investments are determined by obtaining quoted prices on nationally recognized securities exchanges (Level 1 inputs).

The methods described above may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, while the Plan Sponsor believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

**5. Fully Benefit Responsive Investment Contract**

The Plan holds a fully benefit-responsive (no maturity date) group annuity contract with VRIAC (a traditional investment contract). The group annuity contract is reported at contract value, which is generally the amount a participant would receive if he or she would initiate a withdrawal or transfer from the contract under the provisions of the Plan. Contract value represents contributions made to the contract, plus earnings, less participant withdrawals and administrative expenses. VRIAC maintains the contributions in its general account. The issuer guarantees the Plan a return of principal and interest under the terms of the contract. The interest crediting rate is semi-annually based upon contract provisions, and it may not be less than 1.0%.

VRIAC's general account is credited with earnings on the underlying investments and is charged for participant withdrawals and administrative expenses. Participants may ordinarily direct the withdrawal or transfer of all or a portion of their investments at contract value.

Generally, there are not any events that could limit the ability of the Plan to transact at contract value paid within 90 days or, in rare circumstances, contract value paid overtime. The Plan's investment contract specifies certain conditions under which distributions from the contract would be payable beyond 90 days from the requested distribution. Such circumstances include Plan termination, Plan merger, termination initiated by the Company, and certain other Company initiated events that result in distributions exceeding a set amount. The group annuity contract does not permit the insurance company to terminate the agreement prior to the scheduled maturity date.

**6. Party-in-Interest and Related Party Transactions**

During 2024 and 2023, certain Plan investments were held and managed by the Voya Retirement Insurance and Annuity Company (VRIAC), the Custodian of the Plan's assets, and therefore, purchases and sales of these securities, as well as related expenses disclosed in the statement of changes (including participants loans) qualify as party-in-interest transactions. Expenses paid by the Plan for administrative and investment advisory expenses amounted to \$29,744 and \$16,944 for the years ended December 31, 2024 and 2023, respectively.

**7. Tax Status**

The IRS has determined and informed the Company by a letter dated June 30, 2020, that the Plan and related trust, as designed, are in accordance with applicable sections of the Internal Revenue Code (the IRC). The Plan Administrator and the Plan's tax counsel believe that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believe that the Plan is qualified, and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress. The Plan Administrator believes it is no longer subject to income tax examinations for years prior to 2021.
