Notes to Financial Statements December 31, 2024

Note 1 – Description of Plan

The following description of the Arcade Beauty 401(k) Plan (the “Plan”) is provided for general information only. Participants should refer to the Plan document and enrollment materials for a more complete description of the Plan’s provisions.

General

The Plan, which was adopted as of May 1, 1977, and subsequently amended and restated, is a multiple employer defined contribution plan, covering all eligible employees who have completed three months of service and attained 21 years of age prior to October 1, 2022. Effective October 1, 2023, the Plan covers eligible employees, except those from Ileos Beauty USA Corp, who have completed three months of service and attained 18 years of age. Effective October 1, 2022, eligible employees of Ileos Beauty USA Corp. are eligible upon hire provided they have attained 18 years of age. The following entities participate in the Plan, referred to collectively as the “Employers”:

- AKI, Inc. d/b/a Arcade Beauty (“AKI, Inc.”) (“Plan Sponsor”)
- Le Papillon, Ltd. d/b/a Arcade Beauty (“Le Papillon, Ltd.”)
- Ileos Beauty USA Corp.
- Phoenix Glass, LLC
- Dixon Direct, LLC d/b/a Arcade Beauty (“Dixon Direct, LLC”)

Any employee who was a participant in the Plan prior to the effective date of the restatement, or became a participant in this Plan as a result of the Plan being merged with and into this Plan, continued to participate in the Plan provided such employee was an eligible employee. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

The Plan Administrator is responsible for oversight of the Plan and determines the appropriateness of the Plan’s investment offerings and monitors investment performance.

Contributions

Upon eligibility, participants may make pre-tax and Roth contributions to the Plan subject to certain Internal Revenue Code (“IRC”) limitations. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. The Plan allows for rollover contributions from other qualified plans. Participants may change their contribution amounts as of the first day of each payroll period, as defined in the Plan document. Participants may revoke their election to contribute to the Plan at any time during the Plan year. Employees who become eligible to participate in the Plan are automatically enrolled to contribute 6% of compensation unless otherwise elected. The Employers may make matching contributions equal to a discretionary percentage of participants’ elective deferrals, which is then allocated to each participant’s account. Effective for payroll periods commencing on or after January 1, 2021, the Employers match contributions of 3% of participants’ annual compensation for participating employees for all participating employers, with the exception of the participation of Ileos Beauty USA Corp, at a 100% match up to 6% of qualified wages.

Each participant may direct the investment of their account into certain investment options offered by the Plan. The assets of the Plan are allocated to the applicable funds at the direction of the participants. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are vested immediately in their contributions, rollovers and employer matching contributions plus actual earnings thereon.

Forfeitures

The Plan had no forfeiture balances as of December 31, 2024 and December 31, 2023.

Participant accounts

Each participant's account is credited with (i) the participant's contributions and an allocation of (ii) the Plan's earnings on his or her specific investments and any (iii) Employers' matching. Allocations of Plan earnings are based on each participant's account balance while Employers' contribution allocations are based on each participant's pre-tax contribution and compensation, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's account.

Payment of benefits

On termination of service due to death, disability, severance of employment, retirement or other reasons, a participant or their beneficiary with a vested balance greater than \$1,000 may elect to receive either a lump sum or equal monthly installments over a reasonable time. A participant with a balance of less than \$1,000 will receive the balance in his or her account as a lump sum distribution. Effective June 1, 2025, the mandatory lump sum distribution amount was increased from \$1,000 to \$7,000.

Participants in the Plan may make in-service or hardship withdrawals from their account balances subject to the provisions of the Plan. After a hardship withdrawal, participants may not make contributions to the Plan for six months.

The amount of any taxable withdrawal that is not rolled into an Individual Retirement Account or another qualified employer retirement plan will be subject to federal and state income taxes. A 10% IRC early withdrawal penalty tax may apply to the amount of the withdrawal if the participant is under the age of 59½ and does not meet one of the IRC exceptions. Minimum required distributions also apply per the IRC.

Although they have not expressed any intent to do so, the Employers have the right under the Plan as defined, to discontinue their contributions at any time and the Plan Sponsor has the right to terminate the Plan subject to the provisions of ERISA.

Note 2 – Summary of significant accounting policiesBasis of accounting

The financial statements of the Plan are prepared using the accrual method of accounting with the exception of benefit payments which are on a cash basis.

Investment valuation and income recognition

The Plan's investments are reported at fair value with the exception of the stable value fund which is valued at contract value.

Realized and unrealized gains and losses from the assets in each account are credited to or charged against each account.

Purchases and sales of securities are recorded on a trade-date basis. Interest and dividends are recorded on an accrual basis.

Management fees and operating expenses charged to the Plan for investments are deducted from individual investments and are not reflected separately. Consequently, management fees and operating expenses are reflected as a reduction of return for such investments.

Contributions

Contributions from participants are recorded as they are withheld from participants' wages. Contributions from the Employers are recorded as they are earned.

Notes receivable from participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued and unpaid interest. Delinquent loans are classified as distributions based upon the terms of the Plan document.

Payment of benefits

Benefit payments to participants or their beneficiaries are recorded when paid.

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Employers. Expenses that are paid by the Employers are excluded from these financial statements. Fees related to the administration of notes receivable from participants are charged directly to the participants' accounts and are included in administrative expenses.

Certain administrative functions are performed by employees of the Employers. No such employees receive compensation from the Plan.

Risks and uncertainties

The Plan's investments are exposed to various risks such as interest rate, market, credit and liquidity risks. Due to the level of risk associated with the investments, it is reasonably possible that changes in the values of the investments will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits as of December 31, 2024. The Plan's investments are not insured or protected by the Pension Benefit Guaranty Corporation, or any other governmental agency, accordingly, the Plan is subject to the normal investment risks associated with these types of investments. Any default on notes receivable from participants is treated as a taxable distribution to the participant.

Use of estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires the Plan Administrator to make estimates and assumptions that affect the reported amounts of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of additions to and deductions from net assets available for benefits during the reporting period. Actual results could differ from those estimates.

Subsequent events

The Plan has evaluated events and transactions for potential recognition or disclosure through September 18, 2025, which is the date the financial statements were available to be issued.

Note 3 – Fair value measurements

For assets measured at fair value on a recurring basis, accounting standards require quantitative disclosures about the fair value measurement separately for each major class of assets. The fair value hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets and the lowest priority to unobservable inputs. The three levels of the fair value hierarchy are as follows:

Level 1 - Unadjusted quoted prices in active markets for identical assets.

Level 2 - Quoted prices for identical assets in markets that are not active, quoted prices for similar assets in active markets, inputs other than quoted market prices, and inputs derived principally from observable market data.

Level 3 - Prices or valuations that require inputs that are both significant to the fair value measurement and unobservable.

Mutual funds are valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the U.S. Securities and Exchange Commission. These funds are required to publish their daily net asset value (“NAV”) and to transact at that price.

Note 4 – Investments, at contract value

The Plan holds a portfolio of investment contracts that comprises a stable value fund under a group annuity contract. This investment meets the fully benefit-responsive investment contract criteria and therefore is reported at contract value. Contract value is the relevant measure for fully benefit-responsive investment contracts because this is the amount received by participants if they were to initiate permitted transactions under the terms of the Plan. Contract value represents contributions made under each contract, plus earnings, less participant withdrawals, and administrative expenses. The contract value of the guaranteed stable value fund as of December 31, 2024 and December 31, 2023 is \$957,444 and \$1,115,303, respectively.

Note 5 – Notes receivable from participants

Participants may borrow, from their fund accounts, a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000 or 50% of their account balance. The loans are secured by the balance in the participant’s account and bear interest at rates that range from 4.25% to 9.50%. These interest rates are based on the prime rate published in the Wall Street Journal plus 1%. Principal and interest are paid ratably through semi-monthly payroll deductions within five years unless the funds are used to purchase a primary residence, which can be payable over 30 years. Plan participants are required to pay a loan initiation fee which is deducted directly from their account at the onset of the loan. Participants are permitted up to two outstanding loans at any one time.

December 31, 2024****Note 6 – Party-in-interest transactions**

The Plan's investments are mutual funds and a stable value fund managed by Capital Bank and Trust Company. Capital Bank and Trust Company is the Trustee as defined by the Plan, and therefore, these transactions qualify as party-in-interest.

Trustee, advisory and other similar type fees related to the administration of the Plan were paid by the Plan or by the Employers. These transactions also qualify as party-in-interest transactions.

Note 7 – Information certified by the Trustee

The Plan Administrator has elected the method of reporting compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, the Trustee has certified that the following information included in the financial statements and supplemental schedule is complete and accurate.

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and December 31, 2023.
- Investment return as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Schedule H-Part IV-Line 4(i) – Schedule of Assets (Held at End of Year) as of December 31, 2024 (except for notes receivable from participants).

Note 8 – Tax status

The Plan utilizes a prototype Plan document which the IRS has opined and informed the prototype Plan Sponsor by a letter dated June 30, 2020, that the prototype Plan document complies with section 401(a) of the IRC. Although the Plan does not have an IRS determination letter, the Plan Administrator believes that the Plan is designed, and is currently being operated, in compliance with the applicable requirements of the IRC and, therefore, believes that the Plan is qualified and the related trust is tax exempt.
