Independent Auditor's Report

To the Plan Administrator of The Boston Globe Media Partners, LLC Retirement Savings Plan:

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

- the information in the accompanying financial statements related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America ("GAAS"). Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities, in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of the financial statements in accordance with GAAP, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern within one year after the date that the financial statements are issued or available to be issued.

Management is also responsible for maintaining a current plan instrument, including all plan amendments, administering the plan, and determining that the plan's transactions that are presented and disclosed in the financial statements are in conformity with the plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Auditor's Responsibilities for the Audit of the Financial Statements

Except as described in the Scope and Nature of the ERISA Section 103(a)(3)(C) Audit section of our report, our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance but is not absolute assurance and therefore is not a guarantee that an audit conducted in accordance with GAAS will always detect a material misstatement when it exists. The risk of not detecting a material misstatement resulting from fraud is higher than for one resulting from error, as fraud may involve collusion, forgery, intentional omissions, misrepresentations, or the override of internal control. Misstatements are considered material if, there is a substantial likelihood that, individually or in the aggregate, they would influence the judgment made by a reasonable user based on the financial statements.

In performing an audit in accordance with GAAS, we:

- Exercise professional judgment and maintain professional skepticism throughout the audit.

- Identify and assess the risks of material misstatement of the financial statements, whether due to fraud or error, and design and perform audit procedures responsive to those risks. Such procedures include examining, on a test basis, evidence regarding the amounts and disclosures in the financial statements.
- Obtain an understanding of internal control relevant to the audit in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the Plan's internal control. Accordingly, no such opinion is expressed.
- Evaluate the appropriateness of accounting policies used and the reasonableness of significant accounting estimates made by management, as well as evaluate the overall presentation of the financial statements.
- Conclude whether, in our judgment, there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for a reasonable period of time.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of GAAP.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with GAAP.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

Other Matter - Supplemental Schedule Required by ERISA

The supplemental Schedule H, Line 4(i) - Schedule of Assets (Held at End of Year) as of December 31, 2024, is presented for purposes of additional analysis and is not a required part of the financial statements but is supplementary information required by the DOL's Rules and Regulations for Reporting and Disclosure under ERISA. Such information is the responsibility of management and was derived from and relates directly to the underlying accounting and other records used to prepare the financial statements. The information included in the supplemental schedule, other than that agreed to or derived from the certified investment information, has been subjected to auditing procedures applied in the audits of the financial statements and certain additional procedures, including comparing and reconciling such information directly to the underlying accounting and other records used to prepare the financial statements or to the financial statements themselves, and other additional procedures in accordance with GAAS. For information included in the supplemental schedule that agreed to or is derived from the certified investment information, we compared such information to the related certified investment information.

In forming our opinion on the supplemental schedule, we evaluated whether the supplemental schedule, other than the information agreed to or derived from the certified investment information, including its form and content, is presented in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.

- the form and content of the supplemental schedule, other than the information in the supplemental schedule that agreed to or is derived from the certified investment information, are presented, in all material respects, in conformity with the DOL's Rules and Regulations for Reporting and Disclosure under ERISA.
- the certified information in the supplemental schedule related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

A. PLAN DESCRIPTION:

The following description of The Boston Globe Media Partners, LLC Retirement Savings Plan (the "Plan") is presented for general information purposes only. Participants should refer to the Plan agreement for a more complete description of the Plan's provisions.

General

The Plan is a defined contribution plan covering substantially all employees of Boston Globe Media Partners, LLC (the "Company"). The Plan is subject to the provisions of the Employee Retirement Income Savings Act of 1974, as amended ("ERISA").

The Plan was originally established October 20, 2013, in connection with a trust to trust transfer from The New York Times Companies Supplemental Retirement and Investment Plan. Algonquin Acquisition Company, LLC ("Algonquin") entered into an agreement with The New York Times Company and other members of its controlled group to purchase the assets of the New England Media Group (the "Agreement"). In connection with the Agreement, Algonquin agreed to establish, or have a member of its controlled group establish, a defined contribution plan with a 401(k) feature to cover the transferred employees, as defined in the Plan. The Plan was established by the Company, a member of Algonquin's controlled group, for the benefit of the transferred employees. The Plan Sponsor directed the former trustee to accept an in-kind trust to trust transfer in accordance with Section 414(1) of the Internal Revenue Code ("IRC") of the account balances of the transferred employees.

Eligibility

The Plan Sponsor has various groups of both union and non-union employees who are eligible to participate in the Plan, including non-union employees of the Plan Sponsor ("Non-Union Employees"); employees who are members of BNG/TNG CWA Local 31245 Union ("BNG Union Employees"); employees who are members of the Graphic Communications Conference I.B.T. Local 600M, Boston Newspaper Printing Pressman's Union Local No. 3, Providence Newspaper Guild TNGCWA Local 31041, Boston Mailers/Teamsters Union Local 1, Teamsters Local 259, IBEW Local 103, Boston Printing Pressman Union #3, GCIU/Local #600, Boston Typographical Union 423, IAMAW Boston Lodge #3-5, Teamsters Local 425 (International Brotherhood of Teamsters Local 25, effective September 1, 2018), P.A.C.E. Local I-366, Sheetmetal Workers Union Local 417, Painters District Council 435, Pipefitters Union Local #537, Plumbers Union Local #12 and Massachusetts State Carpenters ("MUST Union Employees"); and employees who are members of the Boston Typographical Union No. 13 ("BTU Union Employees"). Eligibility requirements for each of the respective groups of employees is outlined below:

Non-Union Employees are eligible to participate in the Plan immediately if they are scheduled to work at least 30 hours per week upon commencement of employment. If an employee is scheduled to work less than 30 hours per week, the employee must complete one year of eligibility service to become a participant. A transferred employee became a participant when his or her account was transferred from the New York Times Companies Supplemental Retirement and Investment Plan to this Plan in a trust to trust transfer.

BNG Union Employees are eligible to become participants of the Plan as of the first day of the month following their attainment of age 21 and completion of one year of eligibility service. Non-resident aliens, leased employees and independent contractors may not participate in the Plan.

Certain MUST Union Employees (Graphic Communications, Boston Newspaper Printing Pressman, and Providence Newspaper Guild) are eligible to become participants of the Plan on the first day of the month following his or her completion of one year of eligibility service. The remaining MUST Union Employees are eligible to participate in the Plan as of the first day of the month following his or her attainment of the age 21 and completion of one year of eligibility service.

BTU Union Employees are eligible to participate in the Plan on the first day of the month coincident with or next following becoming an employee.

Contributions

Participants may elect to defer between 1% to 75% of their compensation depending on each employee's union, as defined by the Plan, on a pre-tax, after-tax or after-tax Roth basis, subject to IRS limitations. Participants who are at least age 50 may also make additional catch-up contributions subject to IRC limitations. Participants may also contribute funds from another qualified retirement plan ("rollover contributions"), subject to certain requirements.

The Company shall make matching employer contributions to eligible participants. The Plan is designed to be a safe harbor plan for Non-Union and MUST Union Employees. The safe harbor employer contributions are calculated as 100% of participant contributions up to 3% of eligible compensation, 75% of participant contributions that are in excess of 3% but do not exceed 5% of eligible compensation, and 50% of participant contributions that are in excess of 5% but do not exceed 6% of eligible compensation, for a maximum match of 5% of compensation.

BNG Union Employees are eligible to receive a matching employer contribution from the Company. The matching employer contribution is calculated as 33% of the first 6% of participant contributions, for a maximum match of 1.98% of compensation up to \$3,000. Effective December 5, 2021, the matching contribution was amended to 50% of participant contributions up to 6% of eligible compensation, for a maximum match of 3%.

Certain MUST Union Employees shall receive a matching employer contribution equal to 50% of a participant's contributions up to 6% of eligible compensation, for a maximum match of 3% of compensation and a 3% employer basic contribution from the Company.

BTU Union employees are eligible to receive an employer contribution of \$9.68 per shift.

The Plan also permits non-elective and qualified employer contributions for Non-Union Employees, BNG Union Employees and certain MUST Union Employees. There were no such employer contributions for the year ended December 31, 2024.

Participant Accounts

Each participant's account is credited or charged with contributions, investment income, and administrative expenses. Investment income, including realized and unrealized gains and losses, and expenses are allocated to participants' accounts based on each participant's account balance within each fund. Participants determine the percentage in which contributions are to be invested in each fund. Participants may change their investment options as set forth in the plan document. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Vesting

Participants are fully vested in that portion of their account which relates to their contributions, Safe Harbor contributions, and the income earned thereon. Certain MUST Union Employees and all BTU Union Employees are 100% vested in employer contributions and any earnings thereon. Participants also become 100% vested in company contributions, other than safe harbor contributions, upon death, total and permanent disability, or attainment of normal retirement age.

BNG Union Employees' interest in matching contributions, other than Safe Harbor contributions, and earnings thereon vests as follows:

Forfeitures

When certain terminations of participation in the Plan occur, the nonvested portion of the participant's account represents a forfeiture, as defined by the Plan. Forfeited balances are first used to restore re-employed participants' accounts. Any remaining forfeitures may be used to pay plan expenses or to reduce company contributions. During 2024, \$162,679 of forfeitures were used to reduce company contributions. Unallocated forfeitures at December 31, 2024 and 2023 were \$11,707 and \$118,071, respectively.

Unallocated Account

The Plan holds assets in an unallocated account which receives deposits as a result of a revenue sharing agreement with John Hancock Trust Company LLC. During 2024, there were \$68,466 of deposits to the account, which is included in net appreciation (depreciation) in fair value of investments in the statement of changes in net assets available for benefits. Funds in the account may be used to pay plan expenses or allocated to participants. During 2024, \$59,652 of deposits were used to pay plan expenses. Unallocated assets were \$71,247 and \$59,246 at December 31, 2024 and 2023, respectively.

Notes Receivable from Participants

A participant may request a loan in an amount not less than \$1,000. The loan amount is limited to the lesser of 50% of the participant's vested account balance or \$50,000. Loans must bear interest at a rate of Prime plus 1%. All loans are collateralized by the participant's account and must be supported by a promissory note. All loans must be repaid within five years unless the proceeds are used to acquire a principal residence, in which case a longer repayment period is allowed. No more than two loans may be outstanding at any time.

Distribution of Benefits

Benefits may be distributed to participants upon termination of employment by reason of retirement, disability, death or other separation from service. Distributions under the Plan may be made in lump sums or installment payments.

A participant may also request a withdrawal upon attainment of age 59½ or upon demonstration by the participant to the plan administrator that the participant is suffering from "hardship", as defined in the plan document.

B. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES:

Basis of Accounting

The accompanying financial statements have been prepared using the accrual basis of accounting.

Investment Valuation and Income Recognition

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants on the measurement date. See Note C for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Benefits

Benefits are recorded when paid.

Notes Receivable from Participants

Participant loans are valued at the unpaid principal balance plus any accrued but unpaid interest and categorized as notes receivable from participants on the statements of net assets available for benefits. Principal and interest is generally paid ratably through payroll deductions each pay period. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

Contributions

Contributions from plan participants and company contributions are recorded in the year in which the participant contributions are withheld from compensation.

Expenses

Participant transaction fees, investment expenses, and annual administrative fees incurred by the Plan are paid by the participants. Investment related expenses are included in net appreciation (depreciation) in fair value of investments. Any remaining fees not paid from plan assets are paid by the Company. Expenses that are paid by the Company are excluded from these financial statements.

Use of Estimates

The preparation of financial statements in accordance with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts of assets and liabilities and changes therein, and disclosure of contingent assets and liabilities. Actual results could differ from those estimates.

C. FAIR VALUE MEASUREMENTS:

The framework for measuring fair value provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1) and the lowest priority to unobservable inputs (level 3). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1 - Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2 - Inputs to the valuation methodology include quoted prices for similar assets or liabilities in active markets; quoted prices for identical or similar assets or liabilities in inactive markets; inputs other than quoted prices that are observable for the asset or liability; inputs that are derived principally from or corroborated by observable market data by correlation or other means. If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3 - Inputs to the valuation methodology that are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques maximize the use of relevant observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used by the Plan. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Mutual funds – Valued at the daily closing price as reported by the fund. Mutual funds held by the Plan are open-end mutual funds that are registered with the SEC. These funds are required to publish their daily net asset value (NAV) and to transact at that price. The mutual funds held by the Plan are deemed to be actively traded.

Common collective trusts – Valued at the net asset value of units of a collective trust. The net asset value, as provided by the fund manager, is used as a practical expedient to estimate fair value. The net asset value is based on the fair value of the underlying investments held by the fund less its liabilities. This practical expedient would not be used if it is determined to be probable that the fund will sell the investment for an amount different from the reported net asset value.

There are no unfunded commitments for the common collective trusts held by the Plan. The Putnam Stable Value Fund is subject to a 12 month redemption notice period, but participants may withdraw funds daily. The American Century common collective trust held by the plan has no withdrawal restrictions.

D. RELATED-PARTY AND PARTY IN INTEREST TRANSACTIONS:

Section 3(14) of ERISA defines a party in interest to include, among others, fiduciaries or employees of the Plan, any person who provides services to the Plan or an employer whose employees are covered by the Plan. Accordingly, loans to participants and the management of investments held by the trustee are considered party in interest transactions.

E. TAX STATUS:

The Internal Revenue Service ("IRS") has determined and informed the Company in a letter dated May 24, 2018 that the plan document and related trust adopted by the plan sponsor and related trust are designed in accordance with applicable sections of the IRC. Although the Plan has been amended since receiving the determination letter, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable requirements of the IRC and therefore believes that the Plan is qualified and the related trust is tax-exempt.

Accounting principles generally accepted in the United States of America require plan management to evaluate tax positions taken by the plan and recognize a tax liability if the plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

F. CERTIFIED INVESTMENTS:

Certain information related to investments and notes receivable from participants disclosed in the accompanying financial statements and ERISA-required supplemental schedule, including investments and notes receivable from participants held at December 31, 2024 and 2023, and net appreciation (depreciation) in fair value of investments and interest and dividends for the year ended December 31, 2024, was obtained by management and agreed to or derived from information certified as complete and accurate by John Hancock Trust Company, LLC, the trustee of the Plan.

G. PLAN TERMINATION:

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan subject to the provisions of ERISA. In the event of plan termination, participants become 100% vested in their accounts.

H. RISKS AND UNCERTAINTIES:

The Plan invests in various investment securities. Investment securities are exposed to various risks, such as interest rate, market and credit risks. Market risks include global events which could impact the value of investment securities. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the value of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

I. SUBSEQUENT EVENTS:

The Plan has evaluated subsequent events through October 6, 2025, the date these financial statements were available for issuance.
