## Notes to Financial Statements

December 31, 2024

### **1. Description of Plan**

The following description of the LSB Industries, Inc. 401(k) Plan (the Plan) provides only general information. Participants should refer to the Plan Document for a more complete description of the Plan's provisions.

#### **General**

The Plan is a defined contribution plan covering all employees of LSB Industries, Inc. and designated subsidiaries (collectively, the Company) who have at least 30 days of service and are at least 18 years old, except for nonresident aliens, leased employees, independent contractors, and employees covered by certain collective bargaining agreements (CBA). Employees covered by a CBA may be included in the Plan if such bargaining agreement requires coverage under the Plan. The Plan is designed to provide for a deferred compensation arrangement of the type described in Section 401(k) of the Internal Revenue Code (IRC). The purpose of the Plan is to provide retirement benefits and permit employees to systematically save a portion of their compensation and defer income taxes on that portion. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA).

The Plan provides for automatic deferrals, except that any employees who are covered by a CBA at any facility are excluded from the Plan's automatic deferral provisions. Participants are deemed to have elected to contribute 5% of their compensation to the Plan, unless the participant elected a different percentage, or elected not to participate. The automatic deferral is directed to the appropriate target-date fund based on the participant's age. The Plan also includes an automatic escalation deferral amount of 1% annually, up to a maximum of 10% of compensation. Employees who are covered by a CBA at any facility are subject to the terms of the CBA, including any terms related to automatic deferrals, as these terms are incorporated into the Plan. The Company has three 3-year CBAs of which approximately 28% of our workforce is covered by these agreements as of December 31, 2024.

#### **Plan Administration**

The Plan Administrator is the LSB Industries, Inc. 401(k) Committee (Plan Administrator) appointed by the Company. The Plan's trustee and recordkeeper is Vanguard Fiduciary Trust Company (Vanguard). The Plan's investment advisor is IMA Wealth, Inc.

## **1. Description of Plan (continued)**

### **Contributions**

Each year, participants may contribute from 0% to 75% of pretax annual compensation, as defined in the Plan, subject to certain other limitations. Participants who attain age 50 before the end of the Plan year may also make catch-up contributions. Participants may contribute amounts representing rollover distributions from other qualified defined benefit or defined contribution plans. The Plan allows for certain participants to receive Company matching and/or discretionary contributions. Both the matching contribution and the separate discretionary contribution may vary by business location.

The Company made matching contributions at the El Dorado Chemical facility (the EDC Facility) and the Cherokee Nitrogen facility (the CNC Facility) as required by CBAs effective during the Plan year, January 1, 2024 through December 31, 2024.

The Company made matching contributions for employees at the EDC Facility covered by an International Association of Machinists and Aerospace Workers (IAMAW) CBA and United Steelworkers of America International Union (USW) CBA. The Company made matching contributions for employees covered by the IAMAW CBA at the rate of fifty cents (\$0.50) per one dollar (\$1.00) for all worked hours plus all paid-time-off (PTO) hours used up to 6% of base earnings. Base earnings is defined as the regular hourly payrate as set forth in the CBA, excluding premium pay. Through September 21, 2024, the company made matching contributions for employees covered by the USW CBA at the rate of fifty cents (\$0.50) per one dollar (\$1.00) for all of the employees worked hours plus all PTO hours used up to 6% of base earnings. Base earnings is defined as the regular hourly payrate as set forth in the CBA, excluding any premium pay. Beginning September 22, 2024 through December 31, 2024, the Company made matching contributions of fifty cents (\$0.50) per one dollar (\$1.00) up to 6% of the employee's earnings, based on total hours worked including PTO.

The Company made matching contributions for employees at the CNC Facility covered by a USW CBA at a rate of fifty cents (\$0.50) per one dollar (\$1.00) up to 5% of the employee's earnings, based on total hours worked including PTO.

With respect to all other employees that are not covered by a CBA, the Company made discretionary matching contributions of one dollar (\$1.00) per one dollar (\$1.00) of the employee's contribution for up to 5% of compensation.

## **1. Description of Plan (continued)**

The Company did not make discretionary profit-sharing contributions for any of its employees in 2024.

All contributions are subject to certain limitations of the IRC.

### **Participant Accounts**

Each participant in the Plan has his or her unique account. Each participant's account receives the participant and Company contributions and an allocation of investment earnings and losses and charged with any benefits paid and expenses. Allocations are based on participant account investment balances, as defined in the Plan Document.

### **Investment Options**

Upon enrollment in the Plan, a participant may direct contributions to various investment options offered by the Plan. Participants may change their investment options daily. If no investment option is selected by the participant, the contributions are directed to the appropriate target-date fund based on the participant's age.

### **Vesting**

Participants immediately vest in their contributions plus actual earnings and losses thereon. Employer matching and profit-sharing contributions made to all qualifying participants are 100% vested when made to the participant's account.

### **Participant Loans**

Notes receivable from participants represent participant loans.

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum of the lesser of \$50,000 or 50% of their vested account balance. The participant is responsible for loan application fees which range from \$50 to \$100, depending on the application method. The participant also pays an annual maintenance fee of \$25. Loan fees are subject to change periodically. Loan terms range from one to five years or more than five years for the purchase of a primary residence. Participants may have one outstanding loan at a time. The Participant's remaining account balance secures their loan. The loans bear interest at a rate commensurate with local prevailing rates. Principal and interest are remitted ratably to the Plan through biweekly payroll deductions.

## **1. Description of Plan (continued)**

### **Payment of Benefits**

When entitled to a distribution, a participant may receive a lump-sum payment equal to the value of his or her account, equal installments, or partial withdrawals. In the event of death, the beneficiary may receive a distribution. Withdrawals by the Participant for hardships as defined in the Plan Document are permissible. Participants may request an in-service distribution upon attainment of age 59 ½ or hardship.

### **Administrative Expenses**

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the Plan's provisions. Administrative expenses paid by the Plan may include recordkeeping and trustee fees. Expenses relating to purchases, sales, or transfers of the Plan's investments are charged to the particular investment fund to which the expenses relate. Participants' accounts will be allocated fees related to distributions, installments, qualified domestic relation order, hardship loans, etc. The Company may pay all other administrative expenses of the Plan. Expenses that are paid by the Company are excluded from these financial statements.

### **Forfeiture balance**

The forfeiture balance, which is included in Plan assets, primarily consists of amounts resulting from corrections to overmatched participants. The balance was \$760 and \$161,314 at December 31, 2024 and 2023, respectively. The Plan Administrator will allocate the forfeited funds in accordance with the terms of the Plan and applicable law.

### **Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to terminate the Plan and discontinue its contributions subject to the provisions of ERISA. In the event of Plan termination, participants will continue to be 100% vested in their accounts.

## **2. Summary of Significant Accounting Policies**

### **Basis of Accounting**

The accompanying financial statements have been prepared on the accrual basis of accounting. Benefits paid to participants are recorded when paid.

### **Use of Estimates**

The preparation of financial statements in conformity with accounting principles generally accepted in the United States requires management to make estimates that affect the amounts reported in the financial statements, accompanying notes, and supplemental schedule. Actual results could differ from those estimates.

## **2. Summary of Significant Accounting Policies (continued)**

### **Risk and Uncertainties**

The Plan provides for participant-directed investment of their voluntary contributions and Company contributions in various investment securities. Investments are subject to risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the Statements of Net Assets Available for Benefits and the Statement of Changes in Net Assets Available for Benefits.

### **Investment Valuation and Income Recognition**

The Plan's investments are presented at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date (an exit price). Shares of mutual funds are valued at published market prices, which represent the net asset values of shares held by the Plan at year end.

The Plan holds an investment in a Common Collective Trust (CCT). The CCT publishes a daily Net Asset Value (NAV) per unit and the daily NAV is available to the Plan. The Plan determines that the investment in the CCT has a readily determinable fair value because the investment is in a structure similar to a mutual fund in which the fair value per unit is determined and published and is the basis for current transactions. The Plan measures the investment at the published NAV because it concludes that the quoted NAV per unit represents the price at which the investment would be sold in transactions between independent market participants. Therefore, the Plan includes the investment in its fair value measurement disclosures, including the fair value hierarchy table.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

### **Notes Receivable from Participants**

Notes receivable from participants represent participant loans that are recorded at their unpaid principal balance plus any accrued but unpaid interest. Interest income on notes receivable from participants is recorded when it is earned. If a participant ceases to make a note repayment and the Plan Administrator deems the note to be a distribution, the note receivable balance is reduced, and a benefit payment is recorded.

### 3. Fair Value Measurements

Inputs used in the valuation techniques to derive fair value are classified based on a three-level hierarchy that prioritizes the inputs used in the valuation techniques to derive fair values. The hierarchy assigns the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (Level 1) and the lowest priority to unobservable inputs (Level 3). The three levels of the fair value hierarchy are as follows:

Level 1: Quoted prices in active markets for identical securities.

Level 2: Other significant observable inputs, including, but not limited to, quoted prices for similar securities, interest rates, prepayment speeds, and credit risk.

Level 3: Significant unobservable inputs.

#### **4. Income Tax Status**

The Plan has received a determination letter from the Internal Revenue Service (IRS) dated July 13, 2023, stating that the Plan is qualified under Section 401 of the IRC and, therefore, the related trust is tax-exempt. Once qualified, the Plan is required to operate in conformity with the IRC to maintain its qualified status. The plan administrator has indicated that it will take the necessary steps, if any, to bring the Plan's operations into compliance with the IRC.

Accounting principles generally accepted in the United States require plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that would more likely than not be sustained upon examination by the IRS. Plan management has analyzed the tax positions taken by the Plan and has concluded that there are no uncertain positions taken. The Plan has recognized no interest or penalties related to uncertain tax positions. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

#### **5. Related-Party and Party-in-Interest Transactions**

Vanguard manages certain investments of the Plan. These transactions qualify as party-in-interest transactions; however, they are exempt from the prohibited transaction rules under ERISA.

#### **6. Subsequent Events**

Management has reviewed subsequent events through October 8, 2025, the date the financial statements were available to be issued.

On May 19, 2025, Milliman and Matrix Trust Company replaced Vanguard as the recordkeeper and trustee, respectively.

A new agreement was reached between the EL Dorado Facility and the International Association of Machinists Union, which was ratified on August 1, 2025. The new agreement states the Company will match one dollar for every dollar up to 3% of annual earnings. The matching will begin on the third payroll after ratification which was September 12, 2025.
