Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the financial statements of Fort Wayne Wire Die Corporate 401(k) Plan, an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 (ERISA), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. The Fort Wayne Wire Die Corporate 401(k) Plan ("the Plan") is a defined contribution plan. The Plan covers all eligible non-union employees of Fort Wayne Wire Die, Inc. and Wayne Wire Die, Inc. (collectively the "Company") who have completed at least 30 days of service. Employees may enter the Plan immediately upon meeting the eligibility requirements. Employees may transfer their balances to/from the Fort Wayne Wire Die Company 401(k) Plan when a change in eligibility occurs. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (ERISA). The provisions of the Plan are included in the official Plan document, which legally governs the operations of the Plan.

Contributions

Employees may make voluntary pre-tax or Roth contributions of 1% to 25% of compensation up to the dollar limits set by the Internal Revenue Code. Participants are automatically enrolled at 4% of pre-tax annual compensation unless the participant elects not to participate or modifies the withholding percentage. The Company makes a safe harbor contribution of 3% of employees' compensation. In addition, the Company made a discretionary match of 50% of an employee's deferrals up to 4% of an employee's compensation for the Plan year for the periods January 1 through May 15 and August 15 through December 31, 2024.

Participant Accounts

Each participant's account is credited with the participant's voluntary contribution, Company contributions, if provided, plus an allocation of Plan earnings, and is charged with certain fees, administrative expenses, and withdrawals. Plan earnings are allocated to participants' accounts on a pro rata basis. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

Investment Options

Upon enrollment in the Plan, a participant may direct contributions into a variety of investment options offered by Charles Schwab Bank, the custodian of the Plan. The Plan also has an individually directed account option. All amounts in participant accounts are participant-directed. Participants may change their investment options each pay period.

Notes Receivable from Participants

The Plan allows participants to borrow from their accounts a maximum equal to the lesser of \$50,000 or 50% of their vested account balance. The duration of any loan shall be no more than five years unless such loan is for the purchase of a participant's primary residence, in which case the repayment period may not exceed ten years. Repayments are made through payroll deductions. The loans are secured by the balance in the participant's account and bear interest at a fixed rate commensurate with prevailing rates as determined by the Plan administrator at time of origination. Loans outstanding at December 31, 2024, mature through November 2029 and bear interest at rates ranging from 6.25% through 12.00%.

Note 1. Plan Description (Continued)

Benefit Payments

Upon termination of employment, retirement, disability, or death, distributions are made in lump-sum, installment payments, or annuity contracts equal to the value of the participant's vested interest in his or her account. In-service distributions from vested amounts may be made to a participant who has not separated from service provided he or she has attained age 59 1/2. Hardship distributions are also allowed as described in the Plan.

Vesting

Participants are always 100% vested in any salary deferral contributions to the Plan as well as any Company contributions to the Plan.

Termination of the Plan

Although the Company has not expressed any intent to terminate the Plan, it may do so at any time, subject to the provisions set forth in ERISA.

Note 2. Significant Accounting Policies

Basis of Financial Statements

The accompanying financial statements have been prepared on the accrual basis of accounting in accordance with accounting principles generally accepted in the United States of America.

Investment Valuation and Income Recognition

The Plan's investments are stated at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurements.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation or depreciation includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Interest income is recorded on the accrual basis. Related fees are recorded as administrative expenses and are expensed when they are incurred. No allowance for credit losses has been recorded as of December 31, 2024 or 2023. Delinquent loans are reclassified as distributions based upon the terms of the Plan document.

Payment of Benefits

Benefit payments to participants are recorded when paid.

Use of Estimates

The preparation of financial statements in conformity with accounting principles generally accepted in the United States of America requires management to make estimates and assumptions that affect the reported amounts in the financial statements and accompanying notes. Actual results could differ from those estimates.

Administrative Expenses

Certain expenses of maintaining the Plan are paid by the Plan, unless otherwise paid by the Company. Expenses that are paid by the Company are excluded from these financial statements. Investment related expenses are included in net appreciation of fair value of investments.

Subsequent Events

Management of the Plan has evaluated events and transactions for possible recognition or disclosure through October 9, 2025, the date the financial statements were available to be issued.

Note 3. Information Certified by the Plan's Custodian

The Plan administrator has elected the method of compliance permitted by 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. Accordingly, as permitted under such election, the following information was certified by the custodian, Charles Schwab Trust Bank, and was not subjected to any auditing procedures performed by the independent public accountants.

- a. Total investments, cash and notes receivable from participants as shown in the accompanying statements of net assets available for benefits.
- b. Net investment earnings, as shown in the accompanying statement of changes in net assets available for benefits, including interest and dividends and net realized and unrealized appreciation in fair value of investments and interest income on notes receivable from participants.
- c. Schedule of assets (held at end of year).

Note 4. Fair Value Measurements

Fair value measurements are based upon the exit price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants, and are determined by either the principal market or the most advantageous market.

Inputs used in the valuation techniques to derive fair values are classified based on a three-level hierarchy to prioritize the inputs used in the valuation techniques to derive fair values. The basis for fair value measurements for each level within the hierarchy is described below with Level 1 measurements having the highest priority and Level 3 measurements having the lowest priority.

- Level 1: Fair value is based on unadjusted quoted prices for identical assets or liabilities in an active market that the Plan has the ability to access at the measurement date.
- Level 2: Fair value is based on quoted prices in markets that are not active, quoted prices for similar assets and liabilities in active markets, and inputs that are observable for the asset or liability, either directly or indirectly, for substantially the full term of the asset or liability.
- Level 3: Fair value is based on prices or valuation techniques that require inputs that are both significant to the fair value measurement and unobservable.

The asset's or liability's level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation techniques and inputs used for each major class of assets measured at fair value. There have been no changes in the methodologies used at December 31, 2024 and 2023.

Money market funds: Valued at \$1 per dollar held by the Plan at year end.

Mutual funds: Valued at quoted market prices, which represent the net asset values (NAV) of shares held by the Plan at year end.

Self-directed brokerage account: Accounts primarily consist of mutual funds, common stock and exchange traded funds that are valued on the basis of readily determinable market prices.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan believes its valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

Note 5. Transactions with Parties-In-Interest

Party-in-interest transactions include those with fiduciaries or employees of the Plan, any person who provides services to the Plan, an employer whose employees are covered by the Plan, an employee organization whose members are covered by the Plan, a person who owns 50 percent or more of such an employer or employee association, or relatives to such persons.

Notes receivable from participant transactions are party-in-interest transactions. The Plan holds investments that are affiliated with the Trustee. Certain administration expenses are paid by the Company on behalf of the Plan. The Company also provides certain administrative services at no cost to the Plan.

Note 6. Income Tax Status

The Plan, which is a prototype plan, obtained its latest opinion letter from the Internal Revenue Service on June 30, 2020, which stated that the Plan is designed in accordance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan is currently designed and being operated in compliance with the applicable requirements of the Internal Revenue Code. The Plan administrator believes that the Plan was qualified and the related trust was tax exempt as of the financial statement date. Therefore, no provision for income taxes has been included in the Plan's financial statements.

Note 6. Income Tax Status (Continued)

Accounting principles generally accepted in the United States of America require Plan management to evaluate tax positions taken by the Plan and recognize a tax liability if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the Internal Revenue Service. The Plan administrator has analyzed the tax positions taken by the Plan, and has concluded that as of December 31, 2024, there are no uncertain positions taken or expected to be taken that would require recognition of a liability or disclosure in the financial statements. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits in progress for any tax periods. The Plan administrator believes it is no longer subject to income tax examinations for years prior to 2021.

Note 7. Risks and Uncertainties

The Plan may invest in various types of investment securities. Investment securities are exposed to various risks, such as interest rate, market, and credit risks. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term and that such changes could materially affect participants' account balances and the amounts reported in the statement of net assets available for benefits.
