### **Scope and Nature of the ERISA Section 103(a)(3)(C) Audit**

We have performed audits of the accompanying financial statements of VFP, Inc. Employee Stock Ownership and Savings Plan (the "Plan"), an employee benefit plan subject to Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) (ERISA Section 103(a)(3)(C) audit). The financial statements comprise the statements of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's ("DOL") Rules and Regulations for Reporting and Disclosure under ERISA. **Note 1. Description of the Plan**

The following description of the VFP, Inc. (the “Company”) Employee Stock Ownership and Savings Plan (the “Plan”) provides only general information. Participants should refer to the plan document for a more complete description of the Plan’s provisions.

***General***

The Company established the Plan effective January 1, 1990, as a 401(k) Plan. The Plan was amended and restated effective January 1, 2000, to include provisions for the Employee Stock Ownership Plan (“ESOP”). The Plan is a defined contribution plan covering all eligible employees of the Company. Employees who have 60 consecutive days of service and are age 21 or older are eligible for employee pretax contributions and Company matching contributions. For all other accounts, an employee will become eligible after one year of service. Participants who do not have at least 1,000 hours of service and are not employed on the last working day of the Plan year are not eligible for an allocation of Company contributions under the ESOP. Empower Trust Company, LLC serves as the trustee of the Plan (the “trustee”). The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974 (“ERISA”).

***Contributions***

Each year, participants may elect to contribute the maximum amount allowed by the Internal Revenue Code (“IRC”), as defined in the plan document. Participants who have attained age 50 before the end of the Plan year are eligible to make catch-up contributions. Participants may also contribute amounts representing distributions from other qualified plans. Effective July 1, 2022, the Plan was amended to include an automatic enrollment provision for newly eligible participants in which a participant is automatically enrolled in the Plan to make 401(k) contributions equal to 3% of his or her compensation, unless elected otherwise. The automatic enrollment provision includes an automatic escalation provision of 1% of a participant’s compensation annually up to a maximum contribution percentage of 8%. Effective September 1, 2023, the Plan was amended to automatically enroll all eligible employees whose 401(k) contribution rate is less than 3% to make 401(k) contributions equal to 3% of his or her compensation, unless elected otherwise by the participant. The amendment also applied the automatic escalation provision of 1% per year up to a maximum of 8% to all participants under the automatic enrollment provision.

For the year ended December 31, 2024, the Company matched 25% of the participant’s contributions up to 4% of eligible compensation. In addition, the Company makes a safe harbor contribution, which matches one dollar in Company stock for every dollar deferred by participants up to a maximum of 3% of eligible compensation, then 50% up to 5% of eligible compensation. Additional profit-sharing amounts may be contributed at the discretion of the Company’s Board of Directors and are invested in a portfolio of investments as directed by the Company. There were no additional profit-sharing contributions for the year ended December 31, 2024. Contributions are subject to certain limitations.

***Investment Options***

Participants direct the investment of their contributions and the Company’s matching contributions into various investment options offered by the Plan. The Plan currently offers various mutual funds and common collective trust funds as investment options for participants.

***Participant Accounts***

Each participant's account is credited with the participant's contributions and allocations of the Company's contributions, ESOP contributions, Plan's earnings (losses), and forfeitures of terminated participants' nonvested accounts, and charged with benefit payments and allocations of administrative expenses. Allocations are based on participant earnings or account balances, as defined. The benefit to which a participant is entitled is the benefit that can be provided from the participant's vested account.

***Vesting***

Participants are immediately vested in their voluntary contributions, rollover contributions, and the Company's safe harbor contribution portion of their accounts, plus actual earnings thereon. Effective September 1, 2023, the Plan was amended to immediately vest all participants in the Company matching contribution portion of their accounts. Prior to September 1, 2023, vesting in the Company's matching contribution and ESOP portion of their account plus earnings thereon was based on years of continuous service as set forth in the following schedule:

Participants' accounts also became fully vested upon attainment of the normal retirement age of 65 or in the event of death or disability.

***Notes Receivable from Participants***

Participants may borrow from their fund accounts a minimum of \$1,000 up to a maximum equal to the lesser of \$50,000, reduced by the excess of the highest outstanding balance of loans from the Plan to the participant during the past 12 months, or 50% of their vested account balance. The loans are secured by the balance in the participant's account and bear interest equal to the prime lending rate plus 1%. At December 31, 2024, outstanding loans bore interest rates ranging from 4.25% to 9.50%. Principal and interest are paid ratably through payroll deductions.

***Payment of Benefits***

On termination of service, a participant may elect to receive an amount equal to the value of the participant's vested interest in his or her account in either a lump-sum amount or various installment and annuity options, as provided by the Plan. The Company is required to repurchase shares allocated to participants at fair value. ESOP distributions are paid out in installments for a period of at least five years and not longer than ten years. All fully vested balances are available for distribution after the participant reaches the age of 59½.

***Voting Rights***

The trustee shall vote all shares of Company stock held by the Plan at the direction of the plan administrator. Each participant is entitled to exercise voting rights attributable to the shares allocated to his or her account and is notified by the trustee prior to the time that such rights are to be exercised. The trustee shall vote such allocated shares of Company stock as instructed by participants. Allocated shares for which no direction is received shall be voted by the trustee in its discretion.

***Put Option***

Under Federal income tax regulations, the Company stock that is held by the Plan and its participants and is not readily tradable on an established market, or is subject to trading limitations, includes a put option. The put option is a right to demand that the trust buy any shares of its stock distributed to participants for which there is no market. The put price is representative of the fair market value of the stock. The trust can pay for the purchase with interest over a period of five years. The purpose of the put option is to ensure that the participant has the ability to ultimately obtain cash.

***Diversification***

Diversification is offered to participants close to retirement so that they may have the opportunity to move part of the value of their investment in Company common stock into investments offered through the VFP, Inc. Employee Stock Ownership and Savings Plan. Participants who are at least age 55 with at least ten years of participation in the Plan and whose account balance exceeds \$500 may elect to diversify a portion of their account. Diversification is offered to each eligible participant over a six-year period. In each of the first five years, a participant may diversify up to 25% of the number of shares allocated to his or her account, less any shares previously diversified. In the sixth year, the percentage increases to 50%.

***Forfeited Accounts***

At December 31, 2024 and 2023, forfeited non-vested accounts of the savings plan totaled approximately \$8,035 and \$418, respectively. These amounts will be used to pay administrative expenses or reduce future Company contributions. No Forfeitures were used to pay administrative expenses during 2024. Forfeited balances associated with the ESOP in the amount of \$46,777 were reallocated to participants for the year ended December 31, 2024.

**Note 2. Summary of Significant Accounting Policies**

***Basis of Accounting***

The financial statements of the Plan are prepared on the accrual basis of accounting in conformity with accounting principles generally accepted in the United States of America ("GAAP").

***Estimates***

The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect certain reported amounts of assets, liabilities and changes therein, and disclosure of contingent assets and liabilities. Accordingly, actual results may differ from those estimates and assumptions.

***Investment Valuation and Income Recognition***

Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. Plan management determines the Plan's valuation policies utilizing information provided by independent appraisers and the trustee. See Note 3 for discussion of fair value measurements.

Purchase and sales of securities are recorded on a trade-date basis. Interest income, including interest income on notes receivable from participants, is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation includes the Plan's gains and losses on investments bought and sold, as well as held during the year.

The ESOP is designed to be invested primarily in the common stock of the Company. The common shares of the Company are valued at fair value determined by an annual independent appraisal. The ESOP portion of the Plan's assets include the Company's common stock and cash and cash equivalents.

***Notes Receivable from Participants***

Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the plan document.

***Payment of Benefits***

Benefits are recorded upon distribution.

***Administrative Expenses***

The Plan's administrative expenses are paid by either the Plan or the Company, as provided by the plan document. Certain administrative functions are performed by employees of the Company. No such employee receives compensation from the Plan. Expenses relating to specific participant transactions (notes receivable from participants and distributions) are charged directly to the participant's account.

***Subsequent Events***

The Plan has evaluated subsequent events through October 9, 2025, the date the financial statements were available to be issued.

**Note 3. Fair Value Measurements**

Fair value, as defined under GAAP, is an exit price representing the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. GAAP establishes a three-tier fair value hierarchy which prioritizes the inputs used in measuring fair value. These tiers include:

- Level 1**      Observable inputs such as quoted prices in active markets.
- Level 2**      Inputs other than quoted prices in active markets that are either directly or indirectly observable.
- Level 3**      Unobservable inputs about which little or no market data exists, therefore requiring an entity to develop its own assumptions.

Assets and liabilities are classified in their entirety based upon the lowest level of input that is significant to the fair value measurement. The Plan's assessment of the significance of a particular input to the fair value measurement requires judgment and may affect the valuation of fair value assets and liabilities, and their placement within the fair value hierarchy levels.

There have been no changes in the methodologies used at December 31, 2024 and 2023. The following is a description of the valuation methodologies used for assets measured at fair value.

***Interest-Bearing Cash***

Interest-bearing cash is valued daily at its closing balance as reported by the trustee.

**Mutual Funds**

Mutual funds are publicly traded investments and are valued daily at the closing price reported on the active market on which the funds are traded.

**Common Collective Trust Funds**

These funds are valued at the net asset value ("NAV") of units of the collective funds, as determined by the trustee. The NAV is used as a practical expedient to estimate fair value. This practical expedient would not be used if it is determined to be probable that the funds will sell the investments for an amount different from the reported NAV. Participant transactions (purchases and sales) may occur daily. These funds are not required to be classified within a level on the fair value hierarchy.

**Company Common Stock**

Due to significant unobservable inputs included in the valuation model for the sponsor company common stock, the resulting fair value of this investment is classified as Level 3. The fair value of the investment in common stock of VFP, Inc. held by the Plan is valued at an estimated fair value as determined by an independent annual appraisal of the stock. This appraisal was based upon a combination of the market and income valuation techniques consistent with prior years. During the year ended December 31, 2024, there were purchases and sales of this Level 3 investment in the amounts of \$3,000,000 and \$3,131,361, respectively.

**Note 5. Exempt Party-in-Interest Transactions**

Certain Plan investments are managed by the trustee as defined by the Plan and, therefore, these transactions qualify as party-in-interest transactions. Fees paid to the trustee by the Plan for administrative services were \$3,405 for the year ended December 31, 2024.

**Note 6. Plan Termination**

Although it has not expressed any intent to do so, the Company has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event of Plan termination, participants would become 100% vested in their accounts.

**Note 7. Tax Status**

The Internal Revenue Service (the "IRS") has determined and informed the Company by a letter dated May 12, 2016, that the Plan and related trust are designed in accordance with the applicable sections of IRC. The Plan has been amended since receiving the determination letter. However, the plan administrator believes that the Plan is designed and is currently being operated in compliance with the applicable provisions of the IRC. Therefore, the plan administrator believes that the Plan was qualified and the related trust was tax-exempt as of the financial statement date.

GAAP requires plan management to evaluate tax positions taken by the Plan and recognize a tax liability (or asset) if the Plan has taken an uncertain position that more likely than not would not be sustained upon examination by the IRS. The Plan is subject to routine audits by taxing jurisdictions; however, there are currently no audits for any tax periods in progress.

**Note 8. Risks and Uncertainties**

The Plan invests in various investment securities. Investment securities, in general, are exposed to various risks such as interest rate, credit, and overall market volatility. Due to the level of risk associated with certain investment securities, it is at least reasonably possible that changes in the values of investment securities will occur in the near term, and that such changes could materially affect participants' account balances and the amounts reported in the statements of net assets available for benefits.

**Note 9. Non-Exempt Party-in-Interest Transactions**

During the 2022 plan year, there were unintentional delays by plan management in submitting participant contributions and loan repayments to the trustee in the amount of \$26,860, respectively. These delinquent contributions constitute prohibited transactions, and the Company will make contributions to the affected participants accounts to compensate those participants for potential lost income due to the delays in 2025.
