INDEPENDENT AUDITOR'S REPORT

To the Plan Administrator of the

Scope and Nature of the ERISA Section 103(a)(3)(C) Audit

We have performed audits of the accompanying financial statements of Paylocity 401(k) Profit Sharing Plan and Trust (the "Plan"), an employee benefit plan subject to the Employee Retirement Income Security Act of 1974 ("ERISA"), as permitted by ERISA Section 103(a)(3)(C) ["ERISA Section 103(a)(3)(C) audit"]. The financial statements comprise the statement of net assets available for benefits as of December 31, 2024 and 2023, and the related statement of changes in net assets available for benefits for the year ended December 31, 2024, and the related notes to the financial statements.

Management, having determined it is permissible in the circumstances, has elected to have the audits of the Plan's financial statements performed in accordance with ERISA Section 103(a)(3)(C) pursuant to 29 CFR 2520.103-8 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA. As permitted by ERISA Section 103(a)(3)(C), our audits need not extend to any statements or information related to assets held for investment of the Plan ("investment information") by a bank or similar institution or insurance carrier that is regulated, supervised, and subject to periodic examination by a state or federal agency, provided that the statements or information regarding assets so held are prepared and certified to by the bank or similar institution or insurance carrier in accordance with 29 CFR 2520.103-5 of the Department of Labor's Rules and Regulations for Reporting and Disclosure under ERISA ("qualified institution").

Management has obtained certifications from a qualified institution as of December 31, 2024 and 2023 and for the year ended December 31, 2024, stating that the certified investment information, as described in Note 3 to the financial statements, is complete and accurate.

Opinion

In our opinion, based on our audits and on the procedures performed as described in the Auditor's Responsibilities for the Audit of the Financial Statements section—

- the amounts and disclosures in the financial statements referred to above, other than those agreed to or derived from the certified investment information, are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.
- the information in the financial statements referred to above related to assets held by and certified to by a qualified institution agrees to, or is derived from, in all material respects, the information prepared and certified by an institution that management determined meets the requirements of ERISA Section 103(a)(3)(C).

Basis for Opinion

We conducted our audits in accordance with auditing standards generally accepted in the United States of America. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are required to be independent of the Plan and to meet our other ethical responsibilities in accordance with the relevant ethical requirements relating to our audits. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our ERISA Section 103(a)(3)(C) audit opinion.

Responsibilities of Management for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with accounting principles generally accepted in the United States of America, and for the design, implementation, and maintenance of internal control relevant to the preparation and fair presentation of financial statements that are free from material misstatement, whether due to fraud or error. Management's election of the ERISA Section 103(a)(3)(C) audit does not affect management's responsibility for the financial statements.

In preparing the financial statements, management is required to evaluate whether there are conditions or events, considered in the aggregate, that raise substantial doubt about the Plan's ability to continue as a going concern for one year after the date the financial statements are available to be issued.

Management is also responsible for maintaining a current Plan instrument, including all Plan amendments; administering the Plan; and determining that the Plan's transactions that are presented and disclosed in the financial statements are in conformity with the Plan's provisions, including maintaining sufficient records with respect to each of the participants, to determine the benefits due or which may become due to such participants.

Our audits did not extend to the certified investment information, except for obtaining and reading the certification, comparing the certified investment information with the related information presented and disclosed in the financial statements, and reading the disclosures relating to the certified investment information to assess whether they are in accordance with the presentation and disclosure requirements of accounting principles generally accepted in the United States of America.

Accordingly, the objective of an ERISA Section 103(a)(3)(C) audit is not to express an opinion about whether the financial statements as a whole are presented fairly, in all material respects, in accordance with accounting principles generally accepted in the United States of America.

We are required to communicate with those charged with governance regarding, among other matters, the planned scope and timing of the audit, significant audit findings, and certain internal control-related matters that we identified during the audit.

The Paylocity 401(k) Profit Sharing Plan and Trust (the “Plan”) was established on January 1, 1999. The following description provides only general information regarding the Plan. Participants should refer to the Plan agreement for a more complete description of the Plan’s provisions.

General. The Plan is a defined contribution plan sponsored by Paylocity Corporation (“Paylocity”, “Employer” and “Plan Administrator”) covering all employees of Paylocity, who are at least 19 years of age with monthly entry dates. The Plan is subject to the provisions of the Employee Retirement Income Security Act of 1974, as amended (“ERISA”). Delaware Charter Guarantee & Trust Company d/b/a Principal Trust Company (“Principal” or “Custodian”) serves as the investment custodian and record keeper of the Plan. The Custodian is a qualified institution pursuant to ERISA.

Contributions. Participants may elect to make contributions pursuant to salary reduction arrangements up to a maximum of 100% of annual compensation, subject to Internal Revenue Service (“IRS”) deferral limitations. As of January 1, 2020, the Plan has been amended to allow for voluntary post-tax deferrals as well. The Plan includes an automatic deferral feature whereby Paylocity will automatically withhold 5% of participant’s compensation and contribute that amount to the Plan. Employees can withdraw or change their contribution rate at any time. Paylocity matches 50% of the first 8% of participants’ contributions. Participants over 50 years of age may make catch-up contributions to the Plan. Annual compensation is defined as salaries and wages, including overtime, bonuses, commissions, and other compensation but excluding holiday bonuses paid by Paylocity.

Paylocity may make Employer discretionary contributions for all participants who are employed at the end of the year, which is funded subsequent to year end. Any Employer discretionary contributions are based upon participants’ annual compensation subject to IRS deferral limitations. There were no Employer discretionary contributions elected for the year ended December 31, 2024.

Participant Accounts. Each participant is provided a salary deferral account, an Employer match account, an Employer discretionary contribution account, and other accounts as necessary. Each account is credited with their respective contributions. Investment earnings and losses are allocated to participant accounts based on participants’ account balances, as defined in the Plan agreement, and are made on a daily basis to all active fund participants as of the date of the allocation. Participant accounts are charged with any benefit payment made on behalf of the participant and allocation of Plan expenses. The benefit to which a participant is entitled is the vested balance of the participant’s accounts.

Investment Options. Each participant directs the investment of their account balances into any combination of the various investment options offered by the Plan. All investments are maintained with Principal. Investment options consist of mutual funds and numerous pooled separate investment accounts with Principal.

Vesting. Participants vest in any Employer discretionary contributions over a two-year period starting with the participants’ date of hire.

Notes Receivable from Participants. Each participant may borrow from the Plan against their account balance. Loan amounts are restricted to 50% of the participant’s vested account balances subject to a maximum loan of \$50,000. Loans are secured by the participants’ account balances and the minimum loan amount is \$1,000. Interest rates on loans are determined by Principal at the time of loan issuance. Permitted loan repayment periods range from one to five years, unless the loan is for the purchase of a principal residence, which may permit a longer repayment term.

NOTE 1 – DESCRIPTION OF PLAN (Concluded)

Payment of Benefits. On termination of service, a participant may elect to receive either a lump-sum amount equal to the vested balance of their accounts or other optional forms of distributions available under the Plan. Terminated participants with a total balance of less than \$5,000 must take a lump-sum cash distribution. For terminated participants with a balance greater than \$5,000, their balances will be automatically rolled over to an individual retirement account with Principal if no distribution election is made by the participant. Benefit payments are generally made immediately following the participant's request for benefit distribution. Upon death or disability, a participant's account balance becomes fully vested and distributed, as defined.

Forfeited Accounts. Forfeited balances of terminated participants may be used to pay Plan expenses or to reduce amounts otherwise required to be contributed to the Plan. The Plan had \$412,058 and \$442,892 of forfeited accounts as of December 31, 2024 and 2023, respectively. The Plan used forfeitures of \$152 to fund administrative expenses and \$408,586 to reduce Employer contributions during the year ended December 31, 2024.

Recent Legislation. The SECURE Act 2.0 was signed into law on December 23, 2022. The SECURE Act 2.0 allows more part-time workers to participate, increases the age for required minimum distributions and reduces the penalty for missed minimum distributions, permits plan participants to elect to receive vested employer contributions on an after-tax basis, and allows penalty free withdrawal for terminal illness, effective January 1, 2023. Additionally, it will allow for higher catch-up contributions, allow for matching contributions on student loan payments, permit plan sponsors to add an emergency savings account to their retirement plans, increase the availability of penalty-free withdrawals, and add automatic enrollment error relief provisions, effective January 1, 2024.

NOTE 2 – SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of Accounting. The accompanying financial statements have been prepared on the accrual basis of accounting.

Use of Estimates. The preparation of financial statements in conformity with GAAP requires management to make estimates and assumptions that affect the reported amounts of net assets available for benefits and changes therein. Actual results could differ from these estimates. The Plan utilizes various investment instruments. Investment securities, in general, are exposed to various risks, such as interest rate risk, credit risk, and overall market volatility. Due to the level of risk associated with certain investment securities, it is reasonably possible that changes in the values of investment securities will occur in the near term and that such change could materially affect the amounts reported in the financial statements.

Investment Valuation and Income Recognition. Investments are reported at fair value. Fair value is the price that would be received to sell an asset or paid to transfer a liability in an orderly transaction between market participants at the measurement date. See Note 4 for discussion of fair value measurement.

Purchases and sales of securities are recorded on a trade-date basis. Interest income is recorded on the accrual basis. Dividends are recorded on the ex-dividend date. Net appreciation (depreciation) includes the Plan's gains and losses on investments bought and sold as well as held during the year.

Notes Receivable from Participants. Notes receivable from participants are measured at their unpaid principal balance plus any accrued but unpaid interest. Delinquent participant loans are reclassified as distributions based upon the terms of the Plan document.

Administrative Expenses. The Plan’s administrative expenses are deducted from participant accounts. However, forfeitures from non-vested participants’ accounts may be used to pay the Plan’s administrative expenses in accordance with the Plan document. Certain administrative expenses, including functions performed by officers or employees of the Company and professional fees, are provided by the Company at no charge to the Plan, and the Company’s management has no plans to obtain reimbursement of these expenses from the Plan.

Payment of Benefits. Benefits are recorded when paid. There were no assets allocated to the accounts of participants who have elected to withdraw from the Plan that were unpaid at December 31, 2024 and 2023.

NOTE 3 – INFORMATION CERTIFIED BY THE CUSTODIAN

The following is a summary of the unaudited information regarding the Plan, included in the Plan’s financial statements and supplemental schedule, which was prepared by the Custodian and furnished to the Plan Administrator. The Plan Administrator has obtained certifications from the Custodian that such information is complete and accurate:

- Investments, as shown in the statements of net assets available for benefits as of December 31, 2024 and 2023.
- Investment income (loss) as shown in the statement of changes in net assets available for benefits for the year ended December 31, 2024.
- Note 4: All investment balances.
- Investments, as shown in the schedule of assets held for investment purposes at end of year as of December 31, 2024, as shown on Form 5500, Schedule H, Part IV, Line 4i.

NOTE 4 – FAIR VALUE MEASUREMENTS

FASB Accounting Standards Codification (“ASC”) 820, *Fair Value Measurements and Disclosures*, provides the framework for measuring fair value. That framework provides a fair value hierarchy that prioritizes the inputs to valuation techniques used to measure fair value. The hierarchy gives the highest priority to unadjusted quoted prices in active markets for identical assets or liabilities (level 1 measurements) and the lowest priority to unobservable inputs (level 3 measurements). The three levels of the fair value hierarchy under FASB ASC 820 are described as follows:

Level 1. Inputs to the valuation methodology are unadjusted quoted prices for identical assets or liabilities in active markets that the Plan has the ability to access.

Level 2. Inputs to the valuation methodology include the following:

- quoted prices for similar assets or liabilities in active markets;
- quoted prices for identical or similar assets or liabilities in inactive markets;
- inputs other than quoted prices that are observable for the asset or liability;
- inputs that are derived principally from or corroborated by observable market data by correlation or other means.

If the asset or liability has a specified (contractual) term, the level 2 input must be observable for substantially the full term of the asset or liability.

Level 3. Inputs to the valuation methodology are unobservable and significant to the fair value measurement.

The asset or liability's fair value measurement level within the fair value hierarchy is based on the lowest level of any input that is significant to the fair value measurement. Valuation techniques used need to maximize the use of observable inputs and minimize the use of unobservable inputs.

Following is a description of the valuation methodologies used for assets measured at fair value. There have been no changes in the methodologies used as of December 31, 2024 and 2023.

Mutual Funds. Valued at the quoted market prices.

Pooled Separate Investment Accounts. Accounts that invest exclusively in mutual funds are valued at the net asset value ("NAV") of the underlying mutual fund. The NAV is used as a practical expedient to estimate fair value.

Common Collective Trust ("CCT"). Accounts that invest exclusively in CCT that invest in underlying insurance contracts are valued at NAV of the underlying insurance contracts. The NAV is used as a practical expedient to estimate fair value. Those accounts directly investing in fixed maturity securities are measured based on the pricing date provided by outside valuation service providers who in turn generally use the mean of bid and ask prices but may also use alternative observable pricing inputs for certain securities.

The preceding methods described may produce a fair value calculation that may not be indicative of net realizable value or reflective of future fair values. Furthermore, although the Plan Administrator believes the valuation methods are appropriate and consistent with other market participants, the use of different methodologies or assumptions to determine the fair value of certain financial instruments could result in a different fair value measurement at the reporting date.

NOTE 5 – PLAN TERMINATION

Although it has not expressed any intent to do so, Paylocity has the right under the Plan to discontinue its contributions at any time and to terminate the Plan subject to the provisions of ERISA. In the event the Plan is terminated, participants would become 100% vested in their accounts.

NOTE 6 – FEDERAL INCOME TAX STATUS

The prototype plan sponsor has obtained an opinion letter dated June 30, 2020, in which the IRS stated that the restated prototype plan document was in compliance with applicable requirements of the Internal Revenue Code (“IRC”). The Plan Administrator timely adopted the restated prototype plan. The Plan Administrator believes that the Plan is currently being operated in accordance with the IRC.

NOTE 7 – EXEMPT PARTY-IN-INTEREST TRANSACTIONS

Certain Plan investments are shares of pooled separate investment accounts and guaranteed interest accounts managed by Principal. Principal is the investment custodian as defined by the Plan, and therefore, these transactions qualify as party-in-interest transactions. Fees paid by the Plan for investment management services were included as a reduction of the return earned on each fund.
